





Rizql and Quezon. PRO4A Regional Director Chief Supt Edward Carranza said affected in the revamp is 1 Senior Superintendent, and 2 Chief Inspectors who were re-assigned to different areas within the region.

Laguna Provincial Director Sr Supt Kirby John Kraft was replaced by Sr Supt Eleazar Matta. The Chiefs of Police of major cities like Calamba, Tanauan and Lipa were also replaced.

Carranza said the reorganization is the result of the regular performance assessment of the region by the Oversight Committee Members on Illegal Drugs and Illegal Gambling and the Enhanced Managing Police Operations composed of the Regional Investigation and Detective Management Division, Regional Operations and Plans Division, Regional Police Community Relations Division, Regional Intelligence Division and Regional Personnel and Human Resource Development Division headed by its Chairman and Deputy Regional Director for Operations Sr Supt Marlon Madrid.

The said assessment of the performance of the Chiefs of Police covers the period from June to September 2018.

"We in PRO4A is still at its peak in terms of our anti-criminality and illegal drugs campaign in line with President Rodrigo Roa Duterte's directive and with our Chief PNP, Dir Gen Oscar Albayalde's leadership focus on the eradication of illegal drugs in our country. Despite our strong standing, we will not rest on our laurels but instead we want to make sure that our men on the ground especially our Chiefs of Police could deliver what is expected of them and if not then we will replace them with those who could." Carranza also said.

It is also our policy in the PNP to look into the career advancement of our officers. This is part of preparing them for their future assignments especially as managers and leaders. We want to make sure that we put the right person on the right job where they could perform their best in serving the community," Carranza further added.

Carranza further sent letters to the Local Chief Executives informing them of the relief of their COPs and re-assignment of new officers in their respective cities/ municipalities.

"I have the full trust and confidence to these officers that they will lead by example for their people on the field and expect them to deliver effectively," the Regional Director added.





The PTFoMS was created through Administration Order No.

01 signed by President Rodrigo Duterte in October 2016 to address media killings and harassments.

It is headed by the Department of Justice, cochaired by the Presidential Communications Operations Office, with the Department of National Defense, Department of the Interior and Local Government, Office of the Solictor General, Presidential Human Rights Committee, Armed Forces of the Philippines, Philippine National Police and National Bureau of Investigation, as members.
