





BARANGAY CAPTAIN NABBED FOR DRUGS, GUN IN CAVITE

amp Vicente Lim, Laguna - The incumbent chairman of Barangay Sta Fe, Dasmariñas City in Cavite was nabbed for drugs and Wednesday gun night.

Cavite Provincial Director Sr Supt Wil-

liam Segun in a report to PRO4A Regional Director Chief Supt Edward Carranza identified arrested suspect as Randy Noora, 44 years old and a resident of Block 10 Lot 18 same barangay.

Segun said joint personnel of Cavite Provincial Intelligence Board, Special **Operations**

Group and Dasmariñas City Police conducted a joint buy bust operation which resulted in the arrest of the said barangay captain.

During the operation, the police officer who acted as poseur buyer was able to buy a sachet of shabu from the suspect.

When frisked, police recovered from the chairman 14 more sachets of shabu and a caliber 45 pistol.

Meanwhile in Biñan CIty, a suspected drug pusher was killed after the buy-bust operation resulted in an armed encounter Thursday morn-

Laguna Provincial Director Sr Supr Eleazar Matta identified the suspect as Aries Dimaranan who is included in the drug watch list of PNP Directorate for I telligence.

Matta said elements of Biñan City Police conducted a buy-bust operation against the suspect in Barangay Calalay.

As the transaction, the suspect noticed that he is transacting with an under cover policeman who posed as a buyer and immediately drew his caliber 38 pistol and fired at the lawmen who was force to return fire wounding the suspect.

Police called an emergency ambulance to bring the wounded suspect to the nearest hospital for immediate medical attention.

Matta added that the suspect is subject of complaints from the cluster

6 ARRESTED FOR HIGH-GRADE MARIJUANA AND COCCAINE

amp Vicente Lim, Laguna -Six drug sonalities were arrested in an anti-illegal drugs operation in Cavite Sunday.

Provincial Cavite Director Sr Supt William Segun in a report to PRO4A Regional Director Chief Supt Edward Carranza said combined elements of Bacoor City Police and PDEA Cavite conducted a drug buybust operation at Molino Road, Brgy. Molino 3, Bacoor City that resulted to the arrest of the suspects

Segun identified them as Ma. Bianca Balagtas, Ron Michael Aguillon. Raymond Ghosh, Joseph Benjamin Vehano, Ariel John Bautista and Neil Granfiel.

During the operation, the team managed to confiscate 4 plastic sachets containing marijuana (Kush) weighing 10.45 grams amounting to ₱71, 0000.00, 4 sachets of suspected cocaine weighing more or

less 4.77 amounting to ₱ 32, 436.00 and 1 TOY-WIGO with Plate Number AAW 5026 used by the suspects during the transaction. The arrested suspects were brought to Bacoor City Police Station for investigation while the confiscated pieces of evidence were submitted to PNP Crime Laboratory Office, Imus City for chemical analysis together with the suspects who will be subjected for drug test examination.

A hot pursuit operation was immediately conducted by SWAT and Mobile Patrol against the carnappers. The suspects fired at the pursuing lawmen prompting them to retaliate killing the two.

2 KILLED IN AN ANTI-ILLEGAL DRUGS OPERATION IN LAGUNA

amp Vicente Lim, Laguna - Two drug personalities were killed after an illegal drugs operation in San Pedro City resulted in an armed confrontation Tuesday morning.

Newly-installed Laguna Provincial Director Šr Supt Eleazar Matta identified the suspects as Joseph Santos and Ronald Gonzales, both included in police drug watch list.

Matta said elements of San Pedro City Police conducted a buy-bust operation at Landayan Access Road, Barangay Landayan against the suspects in coordination with PDEA.

As the buy bust was consummated, sensed that he transacting on a policeman who posed as the buyer and immediately drew his .45 caliber pistol and fired upon the lawmen who was forced to returned fire.

During the brief gunfight, Gonzales, one of the companion Santos, also fired his .45 caliber pistol.

The lawmen retaliated hitting the two who were decalred dead on

arrival in a hospital.

Police recovered 1 sachet of shabu and 2 cal .45 pistols from the suspects.

Matta said that the suspects, who are based in Barangay Canlalay, Biñan City are subject of complaints from the cluster leaders in Pacita 1, San Pedro City because of their involvement in illegal drug trade in San Pedro City and Binan City.Matta added that the neutaralization of the suspects will create a reduction of supply of illegal drugs in Binan City and San Pedro City.

1 KILLED, 13 ARRESTED IN PRO MIMAROPA'S ANTI CRIMINALITY CAMPAIGN

Calapan City - The personnel of PRO MIMAROPA under the stewardship of Regional Director Chief Supt Tomas Apolinario, Jr arrested 13 personalities 6 of which is for violation of 9165 or Illegal Drugs, 1 was killed in an armed encounter, 4 wanted persons were arrested; 1 is for illegal possession of firearms and 2 for illegal logging.

He was brought to San Teodoro Municipal Health Center but was pronounced dead-on-arrival by the attending physician.

His cohort was able to evade arrest using a motorcycle.

Recovered from the crime scene were one unit of Cal .45 pistol and 12 sachets of shabu.

Apolinario further said that 1 of the 6 arrested for illegal drugs is a High-Value Target he identified as Fernan Estaño, driver of Provincial Capitol of Marinduque.
