GO, OTHER HNP BETS REAP SUPPORT IN QUEZON

LUCENA CITY – The province of Quezon on Monday vowed to go “all-out” for former Special Assistant to the President Christopher Lawrence “Bong” Go as



well as his fellow candidates endorsed by the Hugpong ng Pagbabago (HNP) regional party led by Davao Mayor Sara Duterte.

Go thanked the leaders of the province and its residents after seeing the overwhelming display of support for him and other candidates of the HNP during their kickoff rally at the Quezon Convention Center.

“Maraming salamat po sa mga kapatid ko dito sa Quezon,” said Go, who is gunning for a senatorial slot in the 2019 midterm polls.

Last February 10, the provincial governors of Cavite, Laguna, Batangas, Rizal, and Quezon (CALABARZON) issued a manifesto expressing their support for Go’s senatorial bid and declaring him an adopted son of the region.

Welcoming Go and

cal leaders and the residents of the province to support Go, including the other candidates endorsed by the HNP.

"Straight ang laban sa Quezon... ang tagumpay nila (HNP candidates) ay tagumpay ninyo, tagumpay ng lalawigan ng Quezon," Suarez said. Link to PRRD

Go told the attendees that they can count on him to be their link to President Rodrigo Duterte, as he also vowed all-out support for the programs of the Duterte administration.

"Asahan nyo po, patuloy ninyo akong magiging tulay kay Pangulong Duterte. Wala po kaming ibang hangarin ni Pangulong Duterte kundi kabutihan ng Pilipino dahil mahal namin kayo," Go said.

Among others, Go said he believes in President Duterte's fight against illegal drugs, criminality, and corruption. He noted for exam-

ple that people now feel safer in the streets and in their homes.

"Kung masaya kayo (sa nakaraang tatlong taon) ipagpapatuloy ko po ang mga pagbabagong nasimulan ni Pangulong Duterte. Hindi po ako nangangako sa inyo, hintayin nyo na lang po ang resulta ng serbisyong tatak Duterte," Go said.

Malasakit Center

Go also said he wants to improve the delivery of health services in the country, adding that part of this advocacy is the establishment of Malasakit Center.

A program of the Duterte administration based on Go's idea, the Malasakit Center makes it easier and faster for poor patients to avail of medical and financial assistance from the government by bringing together in one room all concerned agencies such as the DOH, DSWD, PSCO, and Philhealth.

"Meron na tayong Malasakit Center dito sa Quezon, binuksan po ni Gov. Suarez recently lang po," Go said, adding he wants a law to enable the establishment of Malasakit Center in more provinces and key urban centers of the country in order to continue the program even after Duterte's term ends.

"Yan po ang gusto ko, palawakin, paramihin natin ang Malasakit Center sa bansa. Pera nyo po ito ibinabalik lang sa inyo," Go stressed. There are already 29 Malasakit Centers operating in different areas of the country.

Other key agenda Go said his legislative priorities also include programs on agriculture, education, long-term sports development, fire protection and prevention, localized peace talks, creation of a Department of OFW, barangay

welfare, and improved benefits for senior citizens.

In his message, Go explained to the audience his legislative agenda, including the enactment of a Magna Carta for the benefit of barangay officials.

He also vowed to continue helping members of the Tricycle Operators and Drivers Association (TODA), many of whom he met during his visits to various areas to help fire victims.

"Asahan nyo rin po ang kapakanan ng TODA isusulong ko rin pagdating ng panahon," he said.

During the HNP rally, Quezon's political leaders signed a formal manifesto of support for Go and the rest of the

HNP senatorial ticket, which Gov. David "Jayjay" Suarez presented to Mayor Sara Duterte, as well as the symbolic key to the city of Lucena.

It was signed by Gov. Suarez of the Nacionalista Party, the House Minority Leader who belong to Lakas-CMD, 4th District Rep. Angelina Tan of Nationalist People's Coalition, and 1st District Rep. Anna Enverga, also of NPC.

"Sa abot ng aming kakayahan, itataguyod namin at ibabandera ang mga kandidato sa ilalim ng partido ng Hugpong ng Pagbabago kaalinsabay ang maigting na kampanya para sa tapat, malinis at payapang halalan 2019," the manifesto read. (PNA)

The top Quezon leaders said they believe in the objective of HNP to provide effective assistance to President Rodrigo Duterte in his quest for a peaceful and progressive Philippines.

"Upang mas higit na magkaroon ng katuparan ang mga pagbabagong sinimulan ng administrasyong Duterte, napapanahon at nararapat lamang na ang maihalal ng sam-bayanang Pilipino na mga senador ay tunay na nagpapakita ng tapang, malasakit at pagmamamahala at pagkalinga sa mga mamamayan lalo at higit ay yung nagsusulong ng kapakanan ng maralitang mga Pilipino," the manifesto added. Ayon pa kay Angara, may mga employers na umiiwas sa pagbabayad ng maternity leaves lalupa't pinahaba ang araw nito. Mula sa orihinal na 60 days, naging 105 days na ang maternity leave

ayon sa bagong batas o R.A. 11210.

Binanggit din ni Angara ayon sa isang survey ng Employers Confederation of the Philippines o ECOP na nagsasabing malaki ang magiging epekto ng Expanded Maternity Leave sa desisyon ng mga kumpanya na kunin ang serbisyo ng mga babaeng manggagawa.

Sa naturang survey, 66 porsiyente ng employer ay nagsabing appektado ng naturang batas ang kanilang pagdededisyon na mag hire ng female employees. Gayunpaman, hindi naman nila nilinaw kung tatanggihan na nila

ang mga aplikasyon ng babaeng empleyado o lilitimahan na lamang nila ang bilang nito.

Katuwiran naman ni Angara na dapat bigyan ng mga kumpanya ng patas na oportunidad ang mga babae laluna't kwalipikado ang mga ito sa inaaplayan trabaho. Paglilinaw din ng Senador na hindi binuo ang batas hindi para mas paboran ng mga employer ang pagkuha sa serbisyo ng mga kalalakhian kundi para lamang ibigay sa mga kababaihan ang nauukol na benepisyo at karapatan mapangalagaan ang kanilang sarili matapos makapanganak.

CAVITE HOLDS INT'L CONFERENCE ON AGUINALDO'S 150TH BIRTH ANNIVERSARY

Historians, scholars and members of the academe convened on March 19-21, 2019 at the Lyceum of the Philippines University-Cavite Campus Auditorium in the City of Gen. Trias for the International Conference on the 150th Birth Anniversary of Emilio Aguinaldo

Participants who gathered in commemoration of the life and works of the most illustrious son of the province were welcomed by LPU-Cavite Vice President Ms. Teresa O. Pilapil on behalf of the University President Atty. Roberto P. Laurel, telling how our heroes in the past can be considered as best teachers from whom we learn what it means to be Filipino.

Meanwhile, humbled to be given the opportunity to deliver a message during the opening program of the conference, Cavite Governor Boying Remulla paid his respects to the guests and attendees, especially to former Prime Minister Cesar EA Virata and National Historical Commission of the Philippines (NHCP) Chairman Dr. Rene R. Escalante. The governor also acknowledged the collaborative efforts of the NHCP, the Provincial Tourism and Cultural Affairs Office (PTCAO)

and the Cavite Historical Society in rekindling the heroism of Aguinaldo. Likewise, the governor encouraged members of the academe to further understand the process of history, as well as to teach history in the right perspective.

Former Prime Minister Cesar EA Virata, Chairman of the Cavite Historical Society, and a descendant of Aguinaldo shared stories of political events during President Emilio Aguinaldo's time and called to settle the issues to collectively gain peace and strength towards nation-building.

On the other hand, Dr. Manny Calairo of De La Salle University-Dasmariñas and member of the NHCP Advisory Committee provided the overview of the conference to further stir the interest of the participants in revisiting and understanding more of Aguinaldo's contributions and legacy of as one of the main pillars of our nation.

Among the resource speakers and scholars who shed light on various issues related to heroism and independence by sharing their historical insights and research were Dr. Reynaldo Ileta of the Australian National University who tackled "The Multiple Roles of Emilio Aguinaldo in the History of Nation Build-



ing"; Dr. Lance Collins of the Hawaii Institute for Philippine Studies with his "Ontology of Statecraft: Studying the Ideas of the Malolos Constitution"; and, Dr. Karl-Heinz Wionzek of Dr. Lutke Foundation based in Germany on his work "Emilio Aguinaldo, the Germans and the Australian Ferdinand Blumentritt: Contacts and Mutual Relations between 1897 and 1901, plus many other studies related to the life of the Father of Philippine Independence.

Other sessions include topics on Emilio Aguinaldo before the revolution, behind the uniform and traces on Freemasonry, and different views on him from the northern Luzon, Visayas and Mindanao.

The three-day conference that honored the life, achievements and enduring legacy of Agui-

naldo concluded with an educational tour to the heritage sites in Cavite spearheaded by OIC-Provincial Tourism Officer Rozelle Sangalang.

The NHCP, the Cavite Studies Center and the Provincial Tourism also invited everyone to join them on March 22,

2019 to celebrate the 150 years of the First President of the Republic of the Philippines at the Aguinaldo Shrine in Kawit, Cavite. Among the activities lined-up are musical performances from the Kawit Singing Ambassadors and the Campus Medley, the

Bayanihan Dance Troupe cultural presentation, karakol competition and the Aguisaysayan 2019 (Aguinaldo sa Kasaysayan: Tagisan ng Kaalaman sa Buhay at Kasaysayan ng Unang Pangulo ng Republika ng Pilipinas), a module writing competition. (PICAD)

CEASE AND DESIST ORDER

Madam:

This has reference to the field investigation conducted by this Office through the Mines and Geosciences Bureau (MGB) Embedded Technical Personnel in PENRO - Cavite together with PENRO - Cavite personnel on February 8, 2019 regarding the alleged illegal quarrying activities in Brgy. Pinagsanhan B, Maragondon, Cavite.

Field findings disclosed that you are operating outside your Quarry Permit denominated as QP-005-S-2018 issued by the Provincial Government of Cavite on August 16, 2018. Be informed that such activity is a clear violation of Section 79 of DENR Administrative Order (DAO) No. 2010-21, otherwise known as the "Revised Implementing Rules and Regulations of R.A. 7942."

In view thereof, you are hereby issued this **Cease and Desist Order** to immediately refrain from such illegal operation. Non-compliance with this Order shall compel this Office to file charges against you for violation of Section 79 of DAO 2010-21 and other charges in accordance with pertinent provisions of the existing mining and environmental laws, rules and regulations.

Further, you are directed to join the Technical Conference together with the complainant and Provincial Mining Regulatory Board (PMRB) of Cavite to resolve the royalty payments to the land owner. Schedule of the conference is to be announced.

Please be guided accordingly.

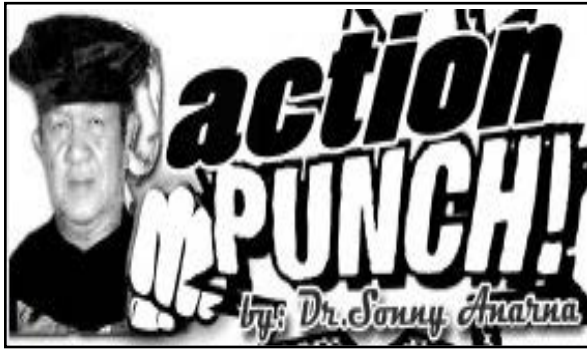

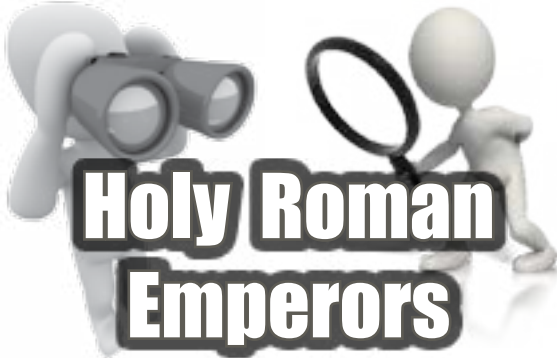

GUN-FOR-HIRE KILLED IN ENCOUNTER WITH POLICE

Camp Vicente Lim, Laguna - A gun-for-hire and a high-value target drug suspect in the province of Laguna was killed in an armed encounter with the police Tuesday morning.

Laguna Provincial Director Sr Supt Rleazar Matta in his report to CALABARZON Regional Director Chief Supt Ed-

ward Carranza identified the suspect as Ali Basher Adiong alias Boss Tan and a resident of Happy Valley in Canlubang, Calamba City.

Matta said with coordination with the Philippine Drug Enforcement Agency (PDEA), the operation was conducted by the drug enforcement unit of Calamba City Police Station at the residence of the suspect.

During the drug

transaction, the suspect sensed that he was transacting with a police officer who posed as poseur-buyer and drew his firearm and shot the police poseur-buyer which caused the latter to fall on the ground.

This prompted other officers to return fire.

The police poseur-buyer and the suspect were brought to Global Hospital for immediate medical atten-

tion; however, Adiong was declared dead on arrival.

On the other hand, PO1 Mark Anthony Burgos did not sustain an injury or gunshot wound due to the bulletproof vest worn during the operation.

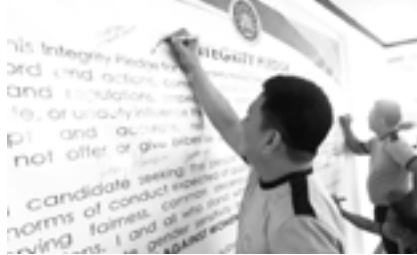
