

search and was among those shortlisted during the desk review on March 19 at the NEDA regional office in Calamba City, Laguna.

Ms. Gied Evangelista of NEDA IV-A provided a brief overview of the 2019 Search for Outstanding Local Project Monitoring Committee in Calabarzon with emphasis on the primary goal of the program to motivate Local Project Monitoring Committees and identify model LP-MCs to provide a benchmark in terms of project monitoring and evaluation mechanisms.

Ms. Rujen A. Polo, OIC-CPMS of DBM-RO IV-A, Engr. Arnel Tolon of DILG-RO-IV-A and Ms. Evangelista carefully reviewed the prepared documents of the Cavite Local Project Monitoring Committee, which include the Executive Order that reorganized PPMC, trainings provided to members, work and financial plan, plus the project monitoring plan and accomplishments in 2018. During the validation, several and areas for improvement were raised which will aid in the future initiatives of the PPMC and can be rolled out to the LPMCs in the different cities and municipalities in Cavite.

The evaluation committee also recognized some commendable accomplishments of the PPMC including the detailed field inspection reports with corresponding photos and project status which manifest the commitment of the members on their work to assess project implementation. The team also lauded the active participation of PPMC members from civic organizations who do not receive any remuneration for their partnership with the local government. On the other hand, Ms. Polo looked for committee reports and recommended that such documents be submitted to the regional project monitoring committee on a quarterly basis for full compliance.

Mr. Barrera took the opportunity to solicit suggestions and some

tips to further improve the work flow and reporting system of the monitoring committee. He also asked on how the province can give incentives to members especially those from the non-government organizations. The PPMC secretariat also took note of how to monitor implementation schedule, with consideration to the targets and program of works, as per Engr. Arnel Tolon.

Over-all, the meeting which was attended by the OIC-Provincial Budget Officer Ms. Ma. Dulce Tangco, Provincial General Services Officer Ferdinand Belamide. Internal Auditor Maribel Bernal, OIC-Provincial Information Officer Evelyn Reyes and other committee members from different offices of the provincial government became a leap forward to further improve the system and efficiently carry out project monitoring tasks to achieve the dream of becoming the Most Outstanding Local Project Monitoring Committee in the region. Assistant to the President and 2019 senatorial candidate Christopher Lawrence "Bong" Go on Friday said a Senate seat should be utilized to help uplift the lives of the Filipino people.

The former SAP made the statement after going around the city in a motorcade where he received enthusiastic welcome from the residents. He also vowed to continue the programs and policies of President Rodrigo Duterte.

"Ipagpapatuloy ko yung pagbabagong sinimulan niya, kampanya laban sa kriminalidad, kampanya laban sa corruption sa gobyerno, kampanya laban sa iligal na droga. Go was also mobbed by adoring supporters when he decided to eat in a carinderia at the Cogon Market here after his motorcade around the city. Chants of "Go! Bong Go! Go! Bong Go!" echoed at the market when the customers realized the former SAP was taking his meal at one of the eateries.

"Salamat po sa mainit na pagsalubong sa amin, kasing init ng panahon ngayon. Nakakawala ng pagod at nakaka-inspire na magserbisyo para sa kapakanan ninyo," Go said.

Go assured that apart from the campaign against illegal drugs, criminality and corruption, he also wants to improve the delivery of health services in the country, particularly through the law that would allow the establishment of Malasakit Center in more provinces and key urban areas of the country.





## PNP TO PROBE MURDER OF MANGYAN LEADER



MIMAROPA Regional Director Brig Gen Tomas Apolinario, Jr stated that the government, the PNP condemned the barbaric act perpetrated by the NPAs against our peace loving and innocent IP brothers.

This is Aplonario's reacrion to the killing of a Hanunuo Mangyan Tribe Leader Jose Barrera, an Ingenious People (IP), and a resident of Sitio Liberty Brgy. Naibuan, San Jose, Occidental Mindoro who was abducted and murdered by members of NPAs on April 12, 2019 at the vicinity of Tumalo River, Brgy Benli, Bulalacao, Oriental Mindoro.

Based on the report by San Jose Police, Barrera was abducted on April 7, 2019, 5 days before the murder happened. His family witnessed the abduction by the NPAs.In-depth inquiry also revealed that Boy Barrera, brother of the victim narrowly escaped the incident and positively identified the perpetrators as NPAs Miguel Magbata alias Ka Mikoy, Lena Gumpad Alias Ka Aira, Tata Malucon, and Mervin Malucon, and 5 other members. He was positive of their identities because he was once a former NPA and a member of MASA.

"It is an obvious and desperate action by the terrorist NPAs to coerce our brother IPs to join their dwindling & hopeless group. They hav been doing this (forcing people to join them) for decades but the people are already tired and know better now than to join them. The NPAs are no different from the terrorist Abu Sayaf & ISIS who resort to kidnapping and murder to force people and communities to join their group.


We wil make sure that this violation of the International Humanitarian Law (IHL), as well as all other past atrocities against innocent civilians wil reach the United Nations Commission on Human Rights (UNCHR) and the true color of NPAs and its founding chairman Jose Maria Sison be exposed", Apolinario said.

Apolinario also immediately directed the Regional Human Rights Office (RHRAO) to assist the family of the slain tribal leader to file a criminal cases in court and a case for violation of Human Rights at the Commission on Human Rights (CHR).

Apolinario also called for the KARAPA-TAN and other human rights groups to investigate this incident. "Our country and people have suffered long enough and its time we put an end to all these".

The Regional Crime Laboratory Office will schedule an exhumation and necropsy report on the body at an opportune time to determine if the victim was also tortured before being killed by his perpetrators.

The tribal community will be holding an Indignation rally against Communist Terrorist Grps to denounce the killing of their IP brother who only choose return to the folds of the law and to live a normal life. **Roselle Aquino**

## Mangyan Leader and a Political Supporter, killed, tortured by NPAs in Mindoro

was found dead at Sitio Liberty, Barangay Naibuan, San Jose, Occidental Mindoro Friday.

The victim was identified as Jose Barera, a former member of Sangay ng Partido sa Lokalidad (SPL), an underground organization of CPP-NPA-NDF.

According to Lt Col Alexander Arbolado, Commander of 4th Infantry Battalion, Barera surrendered to government troops last 10 August 2018 and decided to live normally. He is also one of the 43 former rebels who received benefits from the government's Enhanced Comprehensive Local Integration Program (ECLIP).

The body of the victim was along side of Tumalo River, Barangay Benli, Bulalacao, Oriental Mindoro which was identified by his brother, Boy Barera.

According to his family, Barera was kidnapped at their house by members of the NPA who belongs to Kilusang Larangang Gerilya – Silangan (KLG Silangan) led by Rosita Serrano of the Sub-Regional Military Area – 4D who operates in Southern Mindoro.

It was also found out that Barera is a known supporter of Representative Josephine Sato and Governor Mario Gene Mendiola, who are actively providing support to the Mangyan Community.

According to his brother, the victim was tortured and by the perpetrators due to his defiance to support favored candidates of the NPAs and for the going against the NPA and wanting to live a normal life by availing the ECLIP of the government.

The Hanunuo Tribe and people of San Jose strongly condemned on its strongest terms the fate that Barera suffered on the hands of CPP-NPA Terrorists (CNTs).

It is a clear manifestation of the violation of IPs Human Rights and Comprehensive Agreement on Human Rights and International Humanitarian Law (CAHRI-HL).

Arbolado added that CNTs are very desperate due to their sagging strength. They resorted to kidnapping to force their victims to join on their group. The heinous crime made by that the CNTs shows that they merely a terrorists like Abu Sayaff and ISIS.

Meanwhile, Col Marceliano Teofilo, Commander of 203rd Infantry Brigade, urged the IPs and people of Mindoro to stand against this CPP-NPA Terrorist. The CNTs are targeting the IPs since they are a vulnerable sector of the society and civilians who are not supporting NPAs favored politicians.

It can be recalled that on April 6, Reymundo Malupa, a CAFGU of Mabuhay Patrol Base together with the Barangay Captain of Malo, Bansud and 2 others were also kidnapped by the NPAs. However, the three were already released while Malupa is still on the hand of captors.

Aside from this crime, the NPAs are also liable on the killing of Kennedy Dam-in Aquino of Barangay Manoot, Rizal and Jun-jun Ysog of Panaytayan, Oriental Mindoro. They are also the behind the foiled kidnapping of 4 civilians from Bongabong who managed to escape.

On the other hand, Maj Gen Rhoderick Parayno, Commander of 2nd Infantry Division, extended his deepest condolence to the bereaved family of Jose Barera. He assured that justice will be serve and perpetrators will be put behind bars and face their fate.

## Multi-billion-peso flood control projects underway for Caviteños

he partment of Public Works and Highwavs

(DPWH) Unified Project Management Office now has two (2) ongoing mega flood-control projects costing approximately P8.87 Billion in the Province of Cavite.

In his report to DPWH Secretary Mark Villar, DPWH UP-MO-Flood Control Management Cluster Office Director Patrick Gatan said that the Cavite Industrial Area Flood

Risk Management Project (CIA-FRIMP) costing JPY15.928 Billion or roughly P7.4 Billion recently commenced in the eastern part of Cavite.

"The now ongoing CIA-FRIMP will be implemented within nine (9) municipalities of Cavite namely: Kawit, Noveleta, Rosario, General Trias, Imus City," said Director Gatan.

"We will be working along the 146.8 kilometers of the province's San Juan River Basin and the 4.7 kilometers of Maalimango Drainage Area. Imus City, Noveleta, Rosario, Kawit, and General Trias will be the major beneficiaries of these main components," said Director Gatan.

The project has five (5) structural packages covering upper and lower San Juan Diversion Channel and Maalimango Diversion 1, bridge of diversion road, diversion weir under Package 1; Rio Grande River and Ylang-Ylang River improve-ment under Package 2 and 3 respectively; Maalimango Creek improvement, construction of Maalimango Diversion 2, and sluice gates; and resettlement site development.


Non-structural measures of CIA-FRIMP will involve waterways cleanup, river area and flood control area management, enactment of ordinance for on-site flood regulation pond, and development of flood forecasting and monitoring system for flood warning and evacuation.

Another ongoing flood-control project of

UPMO-FCMC in Cavite involves the construction of two (2) retarding basins in the cities of Bacoor and Imus. The P1.47-Billion project which started August 2016 is now 23 percent completed.

When completed, Imus Retarding Basin will have a 118-meter in length overflow dike, 1.3 kilometer of surrounding dike, 1.1 kilometer of separating dike, standing an average of three (3) meters in height. DPWH will be excavating approximately 2 million cubic meters of soil to unearth seven (7) meters in depth in the a 35-hectare land area.

For Bacoor Retarding Basin, DPWH will excavate 250,000 cubic meters of soil to dig the seven (7) meters in depth within a 9.2

# UNESCO, CPJ 'pleased' wi **PTFoMS work, initiatives**

ANILA The United Nations Educational, Scientific and Cultural Organization (UNESCO) and the Committee to Protect Journalists (CPJ), an international body dedicated to the protection of journalists worldwide, have hailed the initiatives and work being done by the Presidential Task Force on Media Security (PTFoMS).

PTFoMS executive director, Undersecretary Jose Joel Sy Egco recently discussed with representatives of UNESCO and the CPJ the accomplishments registered by the task force in less than three years after its creation.

President Rodrigo Duterte created the PTFoMS soon after he assumed the presidency in 2016 in response to the violent assaults against media workers in the country, many of which have remained unresolved.

In their recent meeting with Egco, CPJ Asia program coordinator Dr. Steven Butler, CPJ board chair Kathleen Carroll, and Queensland University (Australia) Journalism Communications and chair, Prof. Peter Greste who represented UNESCO, have vowed



to keep in touch with the PTFoMS for developments in Philippine journalism.

During their discussions. Egco pointed out that in its 2018 Global Impunity Index (GII) report, the CPJ noted with optimism that while the Philippines remained at its previous No. 5 ranking, it had significantly improved its status in terms of protecting journalists.

Egco also highlighted the fact that the Reporters Without Borders (RSF) has also delisted the Philippines from the top 5 Most Dangerous Countries in the World for Journalists on December 2018.

PTFoMS chief investigator Police Lt. Col. Eder Collantes gave a rundown on the updates on cases of


violence against media practitioners. Of the 58 victims in the Nov. 23, 2009 Maguindanao Massacre, 32 were journalists covering the filing of certificate of candidacy of then town mayor Ismael "Toto" Mangudadatu for Maguindanao governor.

Mangundadatu, whose wife was one of the 58 massacre victims, subsequently ousted

then Gov. Andal "Unsay" Ampatuan Jr. He earlier said press freedom in the country has significantly improved since PTFoMS' creation in 2016.
