1st Filipino hybrid train runs from Calamba to Manila

BA CITY, Laguna The Filifirst pino-made hybrid electric train went on its test run from this city's Philippine National Railway (PNR) station on Wednesday morning, amid concerns about aftershocks in the aftermath of Monday's Magnitude 6.1 earthquake that shook Metro Manila. Central Luzon and Calabarzon Region.

Touted as an efficient solution to the country's traffic woes, it was assembled by the Dept. of Science and Technology's Metal Industry Research Development Center (DOST-MIRDC).

interview In an with the Philippine News Agency (PNA) on Wednesday before its pre-validation test run, DOST-MIRDC Hybrid Electric Train Project Head, Engr. Pablo Acuin said the hybrid electric train is considered the first mass transport vehicle of its kind made in this country.

"For us, we designed this hybrid train with features similar to the PNR train which goes through testing that could withstand intensity or magnitude by train standards. Although we are not vet aware for any PNR standard like during a strong earthquake," Acuin said.


He added that in the event of moderate earthquakes, PNR will suspend train operations and check on the condition of the railroad

He explained that the hybrid train is equipped with automatic stop safety features which will be very helpful should a strong earthquake occur.

According to Acuin, the hybrid train project team conducted their testing last year, running it around 5,000 kilometers, passing the PNR's standards.

The project head engineer said they em-



He said the PNR detected minor problems during the tests, all of which were quickly remedied."We have a generator which consumes less fuel using electricity-generated power source that also emits less carbon into the air and thus it is environment-friendly," he said.

Developed by a pool of 10 Filipino engineers and technicians at the DOST-MIRDC together with industry partners, the train was assembled at the PNR Caloocan de-

He said the train has five coaches, designed by Filipino experts although the actual manufacturing was outsourced.

Around 900 passengers could be accommodated by the hybrid electric train, which is expected to go on its commercial run by May this year. (PNA)

COMES NOW, Petitioner, RHIZA ALFIE G. GUTIER-REZ, through undersigned counsel and unto this Honorable Court, most respectfully alleges:

- 1. Petitioner is of legal age, Filipino Citizen, married, with new residence and postal address at Pulo, Mayor's Blvd. Brgy. Maduya, Carmona, Cavite, where she may be served with judicial processes;
- Respondent is likewise of legal age, Filipino Citizen, married, with residence and with postal address at 1957 Firmeza Street Ext., Sampaloc, Manila where he may be served with summons and other legal processes. However, recent unverified information reached petitioner that respondent is now abroad, hence, if true, his whereabouts is now unknown, so, summons by publication may be resorted to should personal service is unavailing;
- The parties are husband and wife, having been married on July 07, 2007, before Minister Daton A. Palitayan at Central Church of Christ, Roces Avenue, Quezon City, a copy of the marriage contract is hereto attached as Annex "A" and made integral part of this petition. Out of said union, they were NOT blessed with any child;
- That after 3.5 years of living together, the respondent left the conjugal dwelling and did not return since then. Unverified information reached petitioner that he is now living with a mistress in the State of Kuwait with one child;
- The respondent, at the time of the celebration of his marriage with herein petitioner, was psychologically incapacitated to comply with his essential marital obligations of marriage, and such incapacity became manifest only after the solemnization of said marriage;
- That the psychological incapacity of the respondent is such that he cannot carry out the normal duties of marriage or ordinary obligation to the family and is psychologically unfit to assume and perform the essential marital obligation of marriage;
- That the psychological incapacity of the respondent which he manifested during marriage was obviously his having left his wife after 3.5 years of being together, thus construed as he was not ready to take the challenge and responsibility of being a husband to the petitioner. It can also be construed as total absence of mutual love, respect, understanding and support;
- The fact that respondent has already left petitioner since February 2011, the couple had no cohabitation since they parted ways and clearly, petitioner can no longer work out for reconciliation since respondent now has refused to do so and therefore he could no longer maintain a healthy and meaningful alliance with the petitioner;

programs. He likewise encouraged the participants to share their ideas and initiatives that will enhance M&D programs and services to address the needs of OFs and their families.

Levelling off activity was facilitated by Ms.Iennvlvn Iucutan of the National Economic Development Authority (NEDA). NEDA IV-A Regional Director Luis G. Banua led the session on "Migration and Development 101" which focused on understanding the history, patterns and features of international Filipino migration, distinguishing the duality of migration, its social costs and benefits to migrants, their families, communities and country, and appreciating the ways of harnessing the development potential of international migration. Dir. Banua also pointed out that according to the Calabarzon Migration Data, movements of migration growth in the Calabarzon region has increased. Cavite is one of the contributors of the top sending region in terms of migration as reflected by the number of sea farers in the province.

Director also enlightened the attendees on the positive and negative effects of migration on migrants, their families and the community. He also echoed the important LGU roles including the policies, services, multi-stakeholder partnerships and institutional capacity which affected the conditions of migration and development dynamics.

Cavite Governor Jesus Crispin "Boying" appreciated Remulla the efforts initiated by the PSWDO and NEDA to come up with the orientation and seminar/workshop for the awareness of the status of migration and development in the province. The governor emphasized the idea that migration leads to brain drain and said that it is only temporary since the world has now become united by technology through digital infrastructure. He added that the fiber optic project in the province will be fully operational in the coming days and will address the separation of families since the digital infra will bridge the distance and make communication easier. The governor also said that the provincial government works on strengthening its employment services to give more jobs to Cavitenos. Access on basic services has already been implemented to reach the poor communities.

The session on Mainstreaming Migration and Development in Local Development Planning and Governance was led by Ms. Lovely Morres, OIC-Supervising Economic Development Specialist of NEDA IV-A. Her session concentrated on the assistance that they may provide for the LGU's in integrating migration and development into their local planning and provide them with a sample menu of services that can be offered for the migrants and their families. Her lecture also showed the services that may be extended to provide pertinent information on international migration, issues of migrants and the national government agencies involved in migration and development initiatives so the LGus could link up with them. The lecture covered essential steps in building local institutional capacities and working towards a multi- sectoral engagement through the 8-step guide in mainstreaming migration and development.

After the discussion, the planning workshop was facilitated by Ms. Morres and participants were assigned to form groups to identify existing programs if any, the gaps in implementation and future M&D initiatives. Each group presented workshop outputs to the assembly.

hree technologies from the Department of Science and Technology-Industrial Tech-Development nology (DOST-ITDI) Institute were handed over to the Maranao People Development Center, Inc. (MARADECA, Inc.) for the livelihood and development of the Marawi siege victims on April 10-11, 2019 at the Provincial Capitol, Marawi

One of the technologies was the Essential Oil Extractor which extracts essential oils from Citronella Grass and other plant materials that are abundant in Marawi City.

Essential oils are the aroma-giving constituents of aromatic plants. These oils are water-insoluble organic

liquids or solids.

The second was the Charcoal Briquetting Equipment which was made up of ITDI Modified Drum Carbonizer, Crusher, Mixer, and Manual Briquettor.

Briquetting is process of molding or compacting materials such as charcoal fines of biomass or coal, with or without binder under pressure.

The other technol-

ogy was the Tea Bag Processing Equipment. The participants were trained on herbal processing from the collection of plant materials to Herbal Tea and Herbal Capsule production.

The Marawi IDPs were able to processed Moringa Herbal Tea and Turmeric Herbal Tea out of the collected Moringa and Turmeric plant materials.

The three equip-

ment are now available anytime for the use and livelihood of the Marawi IDPs.

Aside from turned-over equipment, DOST-ITDL also trained the Maranaos on Personal and Home Care products wherein the participants were able to produce Dishwashing Liquid, Hand Wash, and different kinds of soap.

The conduct of the activity was in collaboration with DOST. DOST-IT-DI, Task Force Bangon Marawi, NDRRMC, The Ethne Essence Project, LGU-Marawi, and the Province of Lanao del

Together, they expected an impact of improved living quality of Maranaos through sustainable livelihood programs using their natural resources.



other duties and functions as may be prescribed by law or ordinance...
