### LOST A PILLAR, BUT NEVER LOSES HOPE.

**CARD, SAN PABLO CITY, Laguna** -- *Life is full of uncertainties. It is unpredictable and uncontrollable. Just like the story of Rosila Galangga, the woman who lost a pillar but never loses hope.* Last May 2019 began the desolation of Tita Rosila, 55, of Tiaong, Quezon when her late husband was diagnosed with Brain Infarction. In this surprising news, they were not ready of what the outcome of it.

"I was stunned and I don't know what's happening to my husband. I was crying the moment I saw him in stroke condition. Days after that, my husband died," Rosila recollected.

This fresh moment still lingers in her memory. The death of her loved one became the news in their community and it reached the knowledge of their Account Officer and MBA Coordinator as she and her husband are both members of CARD Mutual Benefit Association (CARD MBA). The validation starts processing right after. The MBA Coordinator asked for the needed documents and in no less than 24 hours, she already received the claims payment for the insurance of her husband.

Her lonesome moments made it better by CARD MBA as it gave her hope after they lost their pillar. Part of the claims they received was used for the burial of her husband.

"I am still thankful that the claims we received from CARD MBA give us hope to start our again without him. If I and my husband didn't join and let ourselves be secured by CARD MBA, I don't know what kind of life I have now," said Tita Rosila.

Marwin, their son, also received donation from the Association as he is also a member of the Association. The remaining amount from their claims was used as additional capital for their small business. Tita Rosila engages in direct selling while her son has an animal raising business. Though still small business, they do their best to make it grow.

"Even that there are big changes in the household, it didn't become a hindrance for us to move forward and become stronger. I know my father wouldn't like to see us weeping for his lost for a long time," Marwin stated.

"CARD MBA didn't neglect us, instead they helped us in their uttermost ability. I sincerely thank them for that," he added.

"Don't ever think of quitting. We can't say when will be the end of our lives, but we can count on CARD MBA. For those who are living in the countryside, on the rural places like ours, this opportunity will secure us in whatever uncertainties that may happen. I can assure you that CARD MBA will be our hope," Rosila said with a smile on her face. (Kristine Mae Beredo)

Ayon kay Janairo, maaring sa Dubai pa lamang ay mayroon ng itong meningococemia at naging carrier na. Kahit carrier na ang babae ay hindi agad ito nakitaan ng sintomas ng sakit sapagkat malakas pa ang pangangatawan nito kung kayat ng humina na ang kanyang resistensiya

saka siya kinakitaan ng sintomas na naging sanhi ng kanyang kamatayan.

Maaari lamang maihawa ang sakit sa pamamagitan ng pag-ubo at paghalik at nakukuha rin ito sa bacteria tulad ng sa meningitis.

Napag-alaman na ang meningococemia ay malubhang sakit dulot ng bacteria at ang malalang kaso nito ay nagdudulot ng impeksiyon sa utak, gulugod at dugo na nakamamatay.

andez of the 202 IB of the Philippine Army during the meeting, the AFP recommends to sustain the delivery of basic services, livelihood and development projects especially in critical areas and vulnerable sectors to curtail the infiltration of communist terrorist armed groups and ensure internal security in the province. In addition, they also urge to fast track the Declaration of Persona Non Grata of communist groups in the municipalities down to barangay level in accordance with President Rodrigo Duterte's Executive Order No. 70 stipulating the creation of a National Task Force to End Local Communist Armed Conflict (ELCAC).

Col. Fernandez shared that although there is no terrorist armed group presently operating in the province, the enemy is likely to exploit different issues to further their armed struggle particularly in the labor sector, the youth and students, the urban poor and the transport sector.

DILG OIC Provincial Director Eloisa Rozul lauded the efforts of Maragondon-LGU headed by Mayor Reynaldo Rillo for its proactive stance against attempts of undesirable groups to infiltrate their vulnerable communities in Barangay Patungan and Pinagsanhan through the provision of basic services and other assistance to affected families.

Updates on peace and order situation was reported by Police Maj. Jonathan Asnan showing a notable 37.5% decrease in the crime statistics from January - September 2019 with 980 as compared to the

same period in 2018 with 1,567 recorded crimes.

The alarming case of dengue outbreak was also discussed during the meeting. There were 13,292 cases of dengue reported from January 1 to September 19, 2019 with 51 deaths. Dr. Nelson Soriano, head of the Provincial Epidemiology Surveillance Unit emphasized that the dengue outbreak is public safety concern that must be promptly and rightly dealt with since it has been a recurring problem in the province for years. He called on the LCEs to help the health department in dealing with the issue particularly in terms of legislations that will lay down stricter rules and impose penalty as necessary to mobilize the people to do their share in battling dengue.

Reports on the peace and order and anti-drug abuse programs were delivered by Mr. Jesus Barrera, Provincial Planning and Development Coordinator following the planning workshop conducted on September 17-19 for the formulation of Cavite POPS Plan 2020-2022.

In other updates, Police Lt. Col. Pablito Naganag reported on the security preparations for the upcoming SEA Games to be hosted by the Philippines on November 30 to December 11, 2019 where the CALABARZON, Cavite in particular is among the venue for games and billeting of athletes.

The meeting was presided by Mr. Alvin Mojica, Provincial Administrator for Community affairs on behalf of Governor Jonvic Remulla, chairman of the council. (PICAD)



**PETITION**

COMES NOW, Petitioner for and by herself, and unto this Honorable Court most respectfully alleged:

1. That Petitioner Nimfa D. Lara-Hisugan, is of legal age, married but separated in fact from the Respondent, Filipino, and a resident of #371 Congressional Road, Brgy. Poblacion 5, Gen. Mariano Alvarez (GMA), Cavite, where she could be served with the processes of this Court;

2. That Respondent Ludy Bebit Hisugan, is of legal age, married, Filipino, with last known address at Gonzaga St., Pavia, Iloilo and whose present whereabouts is unknown. He may be served with summons and processes of this Court through his last known address and by publication, with leave of court;

3. That Petitioner and Respondent are married to each other, their marriage having been solemnized on August 25, 1993 in Muntinlupa City, Metro Manila. A copy of their Marriage Contract is hereunto attached as **Annex "A"**;

4. That their marriage begot them the following children, to wit:

a. Patricia April L. Hisugan, born on April 26, 1994, in Silang, Cavite; and

b. Shiela Marie L. Hisugan, born on February 4, 1996, in Silang, Cavite.

Copies of their Certificates of Live Birth are hereto attached as **Annexes "B" and "C"**, respectively.

5. That Petitioner and Respondent met in the year 1992 when they were both working with Trans Builder Resource Development Corp. ("Transbuilder") with office address in Alabang-Zapote Road, Las Piñas City. Petitioner was then the Marketing Head of Transbuilder while Respondent was the Project Engineer in its Trece Martires City construction project;

6. That Respondent was known to the Petitioner, to their friends and to their office, as single;

7. That Respondent courted the Petitioner. After a short courtship and few months of in a relationship, the Petitioner and Respondent decided to get married;

8. That in his Application for Marriage License to contract marriage with the Petitioner, Respondent declared therein his status as "Single". Copy of the Application for Marriage License is hereto attached as **Annex "D"**.

9. That having resigned from Transbuilder, the Petitioner and Respondent then already married, ventured into a General Construction Business and had projects in different areas;

10. That on March 13, 1996, Respondent informed the Petitioner that he would not be coming home that night as he would be attending a wake in Malolos, Bulacan. Respondent no longer came home after said date;

11. That on March 14, 1996 when Respondent failed to come home, Petitioner then tried to get in touch with the Respondent thru the latter's mobile phone. As it was not the Respondent who answered the mobile phone, Petitioner introduced herself to the male person who answered it as the wife of the Respondent. Petitioner was surprised when the man informed her that they did not know that Respondent has a wife;

12. That when Respondent returned the call of the Petitioner, the Petitioner and the Respondent had an argument. Thereafter, Respondent no longer answered or return the calls of the Petitioner.

13. That as several days had passed without the Respondent coming home and as Petitioner could no longer get in touch with the mobile phones of the Respondent and further worried that something wrong might have happened to the Respondent, Petitioner reported the Respondent as a missing person. Likewise, a flash alarm was made on the vehicle driven by the Respondent the last time he was

seen by the Petitioner;

14. That when the April 1996 billing statements for the mobile phones of the Respondent arrived, Petitioner in the hope of locating the Respondent called the several phone numbers indicated therein, especially those frequently called numbers as well as those numbers unfamiliar to her.

15. That Petitioner was able to talk to someone in one of the numbers she called. She then learned from said person that Respondent got married to one Arlina Jasa on March 14, 1996 in Batangas City. She also obtained information about the residence of said Arlina Jasa;

16. That using the information obtained by her, Petitioner immediately went to Batangas City. It did not take her long to locate the address given to her as while circling the areas of Batangas City she spotted the vehicle driven by the Respondent parked in front of a house.

17. That from the documents and information she obtained, Petitioner learned that Respondent and said Arlina Jasa got married on their claim that they were already cohabiting as husband and wife for more than five (5) years. Petitioner then filed criminal charges against the Respondent and Arlina Jasa in the courts of Batangas City;

18. That it was in the course of pursuing the cases she filed against the Respondent and Arlina Jasa that the counsel of the Petitioner advised her to secure from then National Statistics Office (NSO) a Certificate of No Marriage on the Respondent to assure themselves that there are no other marriages entered into by the Respondent;

19. That Petitioner was surprised and shock when she got hold of the CRS Form No. 5-Advisory on Marriage from NSO (now Philippine Statistics Office) and learned that not only the Respondent got married after marrying her, Respondent also had other two (2) marriages prior to his marriage to the Petitioner, one involving Hazel Marie Tigar on November 17, 1983 in Pavia, Iloilo and the other with Agnes Patricio on August 7, 1989 in Bacolod City. Copies of the CRS Form No. 5-Advisory on Marriages and the Marriage Contracts of the previous marriages of Respondent are hereto attached as **Annexes "E", "F" and "G"**.

20. That the previous marriages of the Respondent were still subsisting when he married the herein Petitioner as shown in the copies of the Marriage Contracts obtained by the Petitioner and further confirmed by Hazel Marie Tigar, the first wife of the Respondent, whom Petitioner was able to locate and later on meet in recent years.

21. That it was in the course of gathering and collating the necessary information and evidence relative to the cases the herein Petitioner filed against the Respondent that Petitioner was able to locate and get in touch with Hazel Tigar;

22. That it was from Hazel Tigar that Petitioner got the information about the Respondent and his family. That the Respondent and his family were residents of Pavia, Iloilo and not Jaro, Iloilo as claimed by the Respondent.

23. That the marriage of Respondent with the said Hazel Tigar was still subsisting at the time the Respondent married the Petitioner on August 25, 1993 was supported by the fact that it was only on January 30, 1997 that Hazel Tigar filed a Complaint for Declaration of Nullity against Respondent Ludy Hisugan premised on the latter's psychological incapacity docketed as Civil Case No. 23415 before Regional Trial Court Br. 30, Iloilo City. Copy of the said Complaint is hereto attached as **Annex "H"**,

24. That after the filing of the criminal cases against the Respondent in Batangas City, Petitioner had not seen or heard from the Respondent since then. He left Batangas City after the institution of the cases against him.

25. That Petitioner with her work in insurance and with the assistance of her family, single handedly raised and reared her two (2) daughters who are now both college graduates and of age;

26. The Petitioner and Respondent were not able to acquire any real property during their cohabitation;

27. That with the present condition of her children, Petitioner now has the time and means to address the concerns involving her marriage with the Respondent. Hence, the instant petition.

**EX PARTE MOTION FOR LEAVE OR COURT  
TO SERVE SUMMONS BY PUBLICATION**

28. Petitioner last saw the Respondent in the year 1996. She has not heard any news as to the whereabouts of the Respondent from then on until the present.

29. That from what Respondent relayed to the Petitioner, Respondent was a resident of Jaro, Iloilo prior to his marriage to the Petitioner while his parents who were already of advanced age were residing in GUAM, USA;

30. That it was only after the Petitioner filed cases against the Respondent that Petitioner learned that the Respondent and his



family were residents of Gonzaga St., Pavia, Iloilo;

31. That as more than twenty (20) years had already passed since the Petitioner learned of the residence of the Respondent, she is uncertain if the Respondent could still be found on the said address. She has no knowledge of the present whereabouts of the Respondent.

32. That considering that the whereabouts of the Respondent is unknown and this case affects the status of the marriage of the Petitioner and of the Respondent, Petitioner most respectfully move with leave of court that in addition to the regular mode of service of summons, Respondent likewise be served with summons by publication.

WHEREFORE, foregoing premises considered, it is respectfully prayed that:

a. With leave of court, in addition to the regular mode of service of summons, an order for service of summons by publication on the Respondent be issued.

b. After due notice and hearing, judgment be rendered declaring the marriage between the petitioner and respondent on August 25, 1993, and all its effects under the law, as NULL and VOID from the beginning for being bigamous.



**4. Non-Resident** – a person who lives in this city but not a registered voter, he/she has a relationship to a legitimate resident up to second degree of consanguinity and affinity.

**Section 3. Name of Funeral Homes.**

The Funeral Homes shall be called **FUNERARIA DE MARTIREZ** in commemoration of the thirteen martyrs of Cavite. The funeral service shall be under the management of Trece Martires Memorial Park Office as one of its section.

**Section 4. Guidelines and Requirements.**

1. Voter's ID/certificate of registration or any proof that the deceased is a registered voter of this city of Senior Citizen ID/PWD ID (issued by the CSWD TMC)
2. Photocopy of Death Certificate
3. Official Receipts (from Treasurer as proof of payment)

**Section 5. Non-Resident**

A non-resident may avail the program provided that the family shall pay the corresponding amount of P10,000.00. A non-resident shall not be entitled to avail other program of the City Social Welfare and Development Office.

**Section 6. Payment**

All payments shall be collected by the City Treasurer's Office and the corresponding official receipts shall be issued as proof of payment. In cases where the family of the deceased have no capability to pay, the CSWD may intervene by charging the amount to be paid to one of its program.

**Section 7. Senior Citizen/ Persons with Disability**

No fees shall be collected to the family of Senior Citizens and PWD's provided that they are registered member of such association. The family of the deceased shall comply with the necessary requirements.

**Section 8. Terms and Condition.**

Those who are qualified to avail of the aforesaid services shall be subjected to the terms and conditions stipulated herein and in the Memorandum of Agreement provided by the City Government.

**Section 9. Exemption**



## Member of Maute Group, nabbed in Batangas

**C**amp Vicente Lim, Calamba City - A member of DAWLAH ISLAMIYAH LANA O/MAUTE Group was arrested during the implementation of Search Warrant at his residence in Batangas City by the joint elements of the Regional Intelligence Division, Regional Special Operations Unit 4A, Batangas Provincial Intelligence Team, RMFB4A, EOD Batangas, Batangas City Police Station, PIB Batangas PPO, AIR FORCE 730th Combat Group Friday night.

The suspect identified as @MUHA-

JIR/@ MUHASJIR/ @DIYA later identified as JAFAR DIA ABDUL NAZER was arrested by virtue of Search Warrant Nr 2019-31-CL for Violation of PD 1866 as amended of RA 9516 (Illegal Possession of Explosives).

Accordingly, members of the AFP received information that said suspect is keeping high explosives and hand grenade inside his residence. Upon receiving such information, operatives conducted series of surveillance operation to locate the whereabouts of said suspect.

Investigation revealed that Abdol Nazer is native of La-

nao del Sur hiding his identity while running a cellphone accessories shop in Batangas City Public Market. It was further found out that he is affiliated with ABU DAR and ABU ZACARIA current AMIR of said terrorist group and serves as intelligence officer of a DAWLAH ISLAMIYAH LANA O/MAUTE Group operating in Calanugas-Pagayawan-Malabang Area all of Lanao Del sur.

The suspect was observed to be very evasive since he frequently transfers from one stall into another from his cellphone accessories shop. Upon surveillance near the apartment of the suspect, he was seen carrying a black pouch inadvertently tucked on his waist containing hand grenade leaving the premises riding his black Yamaha Mio Motorcycle.

“C o n s i d e r e d armed and danger-

ous, my men immediately requested for the Search Warrant which was later granted and approved by Hon Dorcas P Ferriols- Perez, RTC Br. 84, Batangas City,” PRO4A Regional Director Brig Gen Edward Carranza said.

The search resulted to the confiscation of One (1) ½ pounds of TNT High Explosives, 1 M67 Fragmentation Hand Grenade and 1 black pouch.

“We shall not remain complacent by the possible terrorist attacks coming from these kinds of people. We shall protect the citizens of this region from any acts of terrorism. I also appeal to the public to remain calm and report suspicious person and actions so that we could earlier avoid the worst incident and go after these suspects,” Carranza further added.

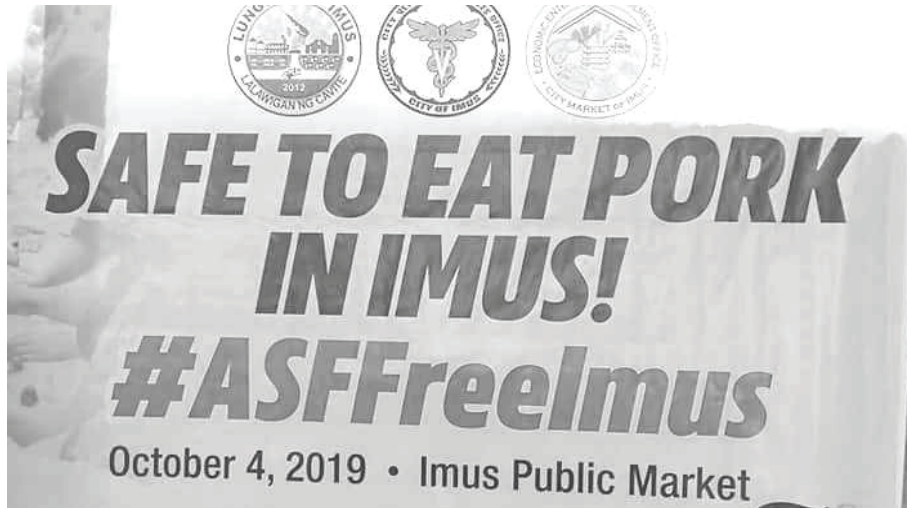
