



ferred with the Seal of Good Local Governance (SGLG) from the Department of the Interior and Local Government (DILG). The award was received by City Mayor Arlene Arcillas, former Mayor and now Representative Danilo Ramon Fernandez of the First District of Laguna, and City Director Melody Barairo during the Awarding Ceremony held on November 5, 2019 at The Manila Ho-

"This is the third consecutive year that the city received the award, and I am really very proud since the Seal recognizes remarkable performance of a local government unit which means that we are doing it right in the City of Santa Rosa," said Arcillas in an interview.

According to the program brief, the SGLG symbolizes integrity and good performance through continuing governance reform and sustained local development. The seven local governance areas under which the local government units (LGUs) were assessed include the following: Financial Administration; Disaster Preparedness: Social Protection; Peace and Order; Business-friendliness and Competitiveness; Environmental Management; and Tourism, Culture and the Arts.

There were a total of 380 LGUs awarded with Seal, of which 17 were provinces, 57 were cities and 306 were municipalities.

The City of Santa Rosa is a recipient of SGLG in years 2017 to 2019. Prior to this, the city also received the Seal of Good Local Governance: Good Financial Housekeeping in 2015; the Seal of Good Housekeeping Silver Grade in 2014; and the Seal of Good Housekeeping Bronze Level in 2011.

Arcillas expressed her thanks to the city government offices and national offices that helped the city secure the award for the third consecutive year. "Like in the recent years, we also accept the challenge that comes with this award and that is to do better to get a higher ranking so we can give a more enhanced public service to our people," Arcillas said.

As an awardee, the city will receive the 2019 SGLG marker; eligibility to the DILG Performance Challenge Fund (PCF) to finance local development projects; and

priority access to other programs and capacity development assistance from the DILG. The City Govern-

ment of Santa Rosa and the DILG also recently recognized barangays through the Seal of Good Local Governance for Barangay (SGLGB) and Functional Assessment Award. The awarding was held on October 28, 2019 during the Monday morning flag raising ceremony at the City Hall Grounds. Regional Director Elias Fernandez, Jr. of DILG IV-A and Mr. Lionel Dalope, DILG Special Assistant to the Regional Director attended the awarding.

According to DILG Memorandum Circular 2018-194 dated November 6, 2018, the SGLGB is an award and incentive program for performing barangay governments in the areas of Peace and Order. Financial Administration, Disaster Preparedness, Social Protection, Business-Friendliness and Competitiveness, and Environmental Management. Its purpose is to institutionalize a system of recognition and incentives for barangay governments and to provide mechanics for possible access to PCF.

Out of the 18 ba-

rangays in the city, 14 barangays passed the assessment for SGLGB and these were barangays Aplaya, Balibago, Caingin, Dila, Dita, Don Jose, Ibaba, Labas, Macabling, Market Area, Pulong Sta. Cruz, Sinalhan, Sto. Domingo and Tagapo.

The six barangays that topped the assessment were awarded with the 2019 SGLGB and received incentives from the city government. These were barangays Labas and Tagapo (Rank 1); Dila, Dita and Sto. Domingo (Rank 2), and Pulong Sta. Cruz (Rank 3). The barangays that ranked first received a P1-million worth of development program and P100,000 cash incentives. The three barangays that ranked second received P75,000 cash incentives and P50,000 for the barangay that ranked third.

For the Function-Assessment Award, Barangays Aplaya, Sto. Domingo and Tagapo were awarded as Best Performing Barangay Development Council; Brgy. Don Jose as Best Performing Barangay Anti-Drug Abuse Council (BADAC); and Brgy. Labas as Best Performing Violence Against Women (VAW) Desk.



"We wanted to give rewards and incentives to barangays as our way of giving thanks to them para sa pagtataas at pagpapatibay ng pamamahala. Pamamahala na kapantay ng uri ng pamamahala ng Lungsod ng Santa Rosa," Mayor Arcillas said during the awarding.

She also encouraged the barangays to excel more in preparation for next year. "Pagtibayin pa natin at gawing mas episyente ang pamamahala dahil magiging mas strikto ang assessment next year dahil naipasa

na ang batas ukol dito." she said.

Arcillas was referring to House Bill 08719 which she authored in Congress and is now known as Republic Act 11292 or the Seal of Good Local Governance Act of 2019. Arcillas served as Representative of the First District of Laguna in years 2016-2019.

"Mahirap ngunit kakayanin sa pamamagitan ng participatory governance na atin pong ipinatutupad noon pa man," Arcillas said.

Tanghalang Pangmamimili is a yearly event and competition designed for high school students which aims to showcase their talents on role-playing and stage plays, adhering to the Consumer Protection Month's theme and tackling the issues on consumerism. It also illustrates the advocacy on consumer responsiveness and the striking features of Republic Act No 7394 otherwise known as the Consumer Act of the Philippines.

On behalf of Governor Jonvic Remulla,

Provincial Cooperative Livelihood and Entrepreneurial Development Office head. Attv. Khervy Reyes, delivered the welcome remarks focusing on the role of the provincial government and DTI in molding the minds of the youth pertaining to the sustainable consumption of goods and considering the impact of costumer's choices in maintaining the safety of the environment. On the other hand, Trece Martires City Councilor Antonio Lontoc, on behalf of Mayor Gemma Lubigan, welcomed all the attendees and encouraged the partakers to join hands and be alert on what can be done to preserve the balance of the ecosystem.

Highlighting the event were the cheering and actual role-playing of contestants which consist of high school students from CALA-BARZON. Maximum of twenty minutes were allocated per participat-

ing school which include setting up of props, cheering performance and play proper. Creativity of each team was exhibited with the comic theatrical piece, dancing and song interpretation in colorful costumes and designs. Lyceum of the Philippines - Batangas bagged the championship award as well as the Recognition for the Best Director and Best Performer, followed by Felix Amante Senior High School of Laguna and Congressional Integrated National High School in Cavite which won the 1st and 2nd runners up, respectively. Best Cheer was awarded to Congressional Integrated National High School in Cavite. Panel of judges consisting of Mr. Oliver Alcid from Jollibee Foods Corporation, Ms. Jonnah Belle Valero of Malayan Colleges-Laguna and Mr. Allein Alvarez of DepEd-Cavite proudly congratulated all the participants who have exerted efforts

to deliver presentations depicting concepts and issues related to consumer awareness.

AMP CAPIN-PIN, Tanay, Rizal — Combined elements of the AFP and PNP recovered two M14 rifles after two former rebels who signified their intention to return to mainstream society guided them to an arms cache during intelligence operations on Tuesday.

The two surrenders are on top of the 63 others from Mindoro Island who have returned to the folds of law and availed government grants since the beginning of the year.

Col Antonio Lastimado. Commander of 203rd Brigade which has operational jurisdiction over the the two Mindoro provinces and Romblon, said that the former rebels were NPA regulars who used to play a key role in the underground movement's terroristic activities in the region.

He added that the Provincial Task Force ELCAC of Occidental Mindoro under Gov Eduardo Gadiano is confident that "we will be able to defeat insurgency in this part of the country through the civilian agencies' consistent delivery of social services to far-flung areas complemented by the military's unrelenting intelligence-driven focused military operations."

He ended his statement by reiterating the soldiers' commitment to serve the Filipino people and ensure their security at all times so that they may enjoy their families' company in peace, particularly this coming holiday season.
