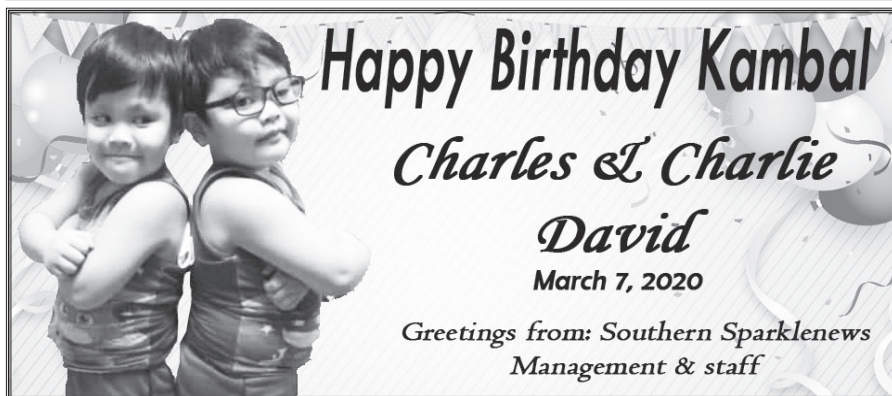
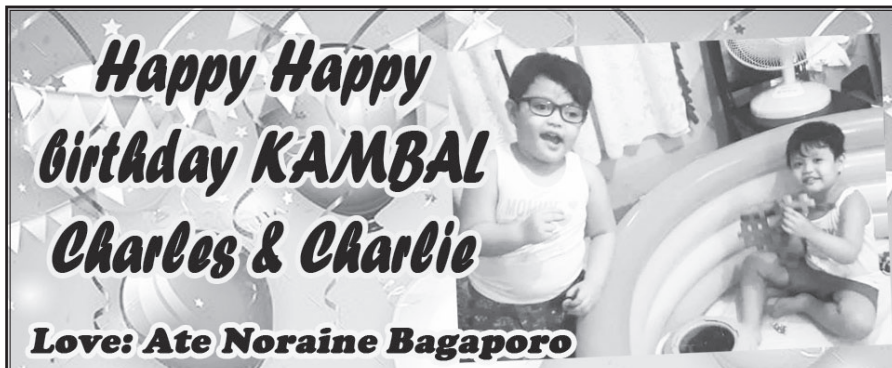

SAN PEDRO CITY, Laguna -- Idinaos ang paglagda sa Memorandum of Agreement ng Alaska Milk Corporation at City Government ng San Pedro para sa programang "ALASKAlikasan-Basura Palit Gatas" para isulong ang tama at responsableng pagtatapon ng mga basura gayundin ang pangangalaga sa kalikasan na ginanap sa Multi-purpose hall.

Nabatid na sa 5 kilong empty sachets, wrapper, pouches or aluminum foil o anumang sachets ay kapalit ng 1 kilong powdered

milk ng alaska. Sa 1 kilong plastic naman ang katumbas ay 165 grams ng Alaska na magaganap sa March 24, April 21 at June 23 sa CENRO.

Sa mensahe ni City Mayor Lourdes S. Cataquiz, malaking pasalamat ang ipinaabot niya sa pamunuaan ng Alaska dahil hindi lang kalusugan ng mga kabataan ang kanilang pinahalalagahan gayundin ang kalikasan.

Ayon naman kay Managing Director Harvey Uong, sa 50 taon ng Alaska ay patuloy ang kanilang pagbibigay ng masustansiyang gatas,

hindi lang pangangalaga sa kalusugan gayundin ang makatulong na magkaroon ng malinis na kalikasan. "Kapag sama-sama ang Alaska at San Pedro wala pa rin tatalo sa lahat", dagdag ni Uong.

Itinakda ng Family Code of the Philippines na ang legal age of marriage ay 18 taong gulang subalit exempted dito o hindi sakop ang mga Muslim minors.

Sa datos ng UN Children's Fund, 15 porsiyento ng mga babaeng Filipino na edad 20 hanggang 24 ay nakapag-asawa na bago pa man sila tumuntong sa edad na 18.

Inisponsoran ni Senator Bong Go ang pagpapasa ng mga panukala na layong maisaayos ang mga lokal na ospital sa bansa upang mapabuti ang access ng mga Filipino sa de-kalidad na serbisyo para sa kanilang kalusugan.

Tinukoy ni Senator Go, Chairman, Senate Committee on Health ang pahayag ng World Health Organization (WHO) ang kahalagahan ng mga ospital sa implementasyon ng universal health care measure.

Mataandaang nilagdaan noon ni Pres-

idente Duterte ang Republic Act 11223 o "Universal Health Care Act". Binibigyan diin ng batas ang patuloy at maayos na pagbibigay ng serbisyo ng gobyerno para sa kalusugan ng mga Filipino. Sa ilalim ng batas, ang bawat Filipino ay awtomatikong kasama sa National Health Insurance Program (NHIP). Nangangahulugan, makakatanggap pa ang bawat isang Filipino ng primary health care services kahit walang Philhealth Identification card.

Sa datos ng DOH noong 2018, halos 65

percent ng mga pam-publikong ospital ay "over-crowded". Sa kasalukuyan, ang Pilipinas ay nasa one-to-1,083 bed-to-population ratio, malayong-malayo sa recommended target ratio na one-to-1,000.

Binanggit din ni Go na ang banta ng COVID 19 ay isang crucial na dahilan kung kaya't kinakailangan maisaayos ang serbisyo ng mga ospital.

Hinimok ni Go ang mga kapwa mambabatas na suportahan ang mga isinusulong niyang mga isinusulong niyang mga government hospital sa bansa.

DepEd bats for more non-teaching staff.. from p. 1

Q U E Z O N CITY, February 28, 2020 — Keen to further reduce teachers' load in school duties, the Department of Education (DepEd) is in continuous talks with the concerned national agencies to grant the needs for more non-teaching staff and guidance counselors.

Education Secretary Leonor Magtolis Briones on Thursday reported on a meeting of the House of Representative Committee of Basic Education and Culture that the Department of Budget and Management (DBM) is favorably considering the request of DepEd for the adding of non-teaching items to its

overall budget.

For this year, DepEd was granted additional 5,000 non-teaching items but Briones hopes more slots for administrative or technical jobs will be given to the thousands of schools that the Department is managing.

"It is not enough for our 47,000 public schools but it is already, I believe, a step in the right direction," Secretary Briones said.

DepEd has also reduced the number of school forms needed to be filled out by teachers to 10 from the previous 36 forms after implementing simplified school forms, standardization of format, and updating and reduction

of data needed in existing forms.

Solving the guidance counselors' supply problem

The DepEd chief also said that discussion with the DBM and Civil Service Commission (CSC) is ongoing to ease up minimum requirements to attract more guidance counselors in the public school system.

"At this time with Generation Z and the challenges which our learners our facing from society and global developments, kailangan talaga ng guidance counselors," Briones noted.

Briones explained that a public school guidance counselor has

a very stringent minimum requirement, needing a master's degree holder, but the government does not offer a competitive salary for practitioners, thus creating a 'problem of supply'.

"We don't have enough graduates that specializes in guidance counselling, and if they are, they are usually in the private sector because the compensation is more attractive," she said.

The Department is working on finding ways with DBM and CSC in solving the disparity in the qualification standards and the salary grade for entry level for guidance counselors as provided by law.###
