

providers with the much needed liquidity to adequately respond to the pandemic.

PhilHealth said that the amount is equivalent to three months' worth of claims based on historical data, which will be charged to theirfuture claims. Hospitals will be asked to submit a letter of intent to avail of the mechanism. This will include including those facing sanctions for various violations of their contracts with the national health insurer.


The arrangement is also part of PhilHealth's efforts to reduce return-to-hospital payables filed in 2019 and earlier, and to further increase payments to hospitals.

"PhilHealth rests on solid ground and with sufficient liquidity to support Government's efforts to fight the CoVid-19 threat. These are extraordinary times that require extraordinary measures, and this arrangement will surely be of help in President Rodrigo Duterte's resolve to avert the spread of the virus."PhilHealth President and CEO Ricardo C. Morales said.

Further, the state

health insurer will also provide its members and service partners with additional relief in view of the recent declaration of a state of public health emergency in the country by extending the deadline of payment of contributions for its self-paying direct contributors. They can now pay their first quarter contributions on or before April 30, 2020 instead of March 31, 2020 without interest.

Moreover, its policy on single period of confinement and 45days coverage are also waived in favor of the member, while the filing period for claims is also extended from the usual 60 days to at least 120 days in favor of the health care providers.



"The same cash assistance should also be immediately disbursed to poor households within the Department of Social Welfare and Development's [DSWD] household targeting system," she added.

Hontiveros explained that companies laying off work-ers and COVID-19's adverse effects on the informal economy will place households more at risk in terms of their food security and health. The Senator urged DSWD and the Department of Labor and Employment [DOLE] to craft implement and а comprehensive safety net for the poor and near-poor who will be adversely-affected by

"This cash aid will keep Filipinos in poverty and near-poverty afloat during this COVID-19 crisis. It will help them cope with the expected inflation in goods due to the lockdown. In times of crisis, cashflow is crucial especially for poor Filipino families who need money for essential items like food, shelter, water, and medicine," Hontiveros explained.

According to Hontiveros, a family's loss of income will worsen their health status and will make them more at risk for COVID-19. "Sa mga manggagawa at mahihirap, mahirap gawin ang social distancing: dikit-dikit ang mga bahay at nagko-commute araw-araw. We need to help them minimize their risks through proper safety nets for their health and social protec-tion," she pointed pointed out.

Hontiveros said that DSWD, DOLE and local government units [LGUs] can access the calamity fund once a state of calamity is declared, either by the national government or the LGU. "In order to free up funds for this cash assistance, the national government or the respective local government units can declare a state of calamity. The COVID pandemic, without question, is a calamity," the senator advised.


