

Distribution of Financial and **Burial Assistance**

Covid 19 pandemic, the provincial government led by Governor Jonvic Remulla never cease to find ways to deliver its services to the people of Cavite, particularly the distribution of financial assistance which was temporarily suspended due to the outbreak. Prioritizing the safety of its constituents, mass distribution which will gather a huge crowd was disallowed prompting the Office of the Governor to spearhead the house-to-house distribution of aid to beneficiaries.

Aside from the Botika on wheels which caters to the medical needs of the locals, the team from the Office of the Governor and the Provincial Social Welfare and Development Office went down to barangays to dispense financial and burial assistance which were already processed in the previous months and awaiting release.

On July 21- 23, a total of 116 beneficiaries were given assistance including those from the municipality of Mendez with 33 recipients, 40 from Tagaytay City and 43 citizens from General Emilio Aguinaldo.

Another batch composed of 408 recipients were granted assistance on July 28-31 with 114 beneficiaries from Ternate, 53 residents from Alfonso, 104

from Magallanes and 137 beneficiaries from Amadeo.

Owing to huge impact of the pandemic to the health and livelihood of Caviteños, the provincial government's response actions focus not only in stopping the further spread of the virus through policies and guidelines, education and information, treatment, testing ang contact tracing but also in providing the needed assistance like financial aids, food and non-food commodities, and ways to move forward like business continuity for the economic sector, tourism and education sector support, and many more. 



Cavite na makapagsagawa ng aabot sa 10,000 COVID-19 tests kada araw sa nalalapit na pagbubukas ng isang testing laboratory na kayang mangasiwa ng 3,000 tests araw-araw. Ito ang pahayag ni Governor Jonvic Remulla nitong Huwebes, July 30.

"In Cavite, we are doing our best: The biggest testing laboratory in the country is about to open at DLSU (Dela Salle University) Dasmariñas: 3,000 tests a day, 7 days a week," pahayag ni Gov. Remulla sa kaniyang Facebook post.

Sakaling magbukas na ang laboratoryo sa unibersidad para sa publiko, magiging posible na makapagsagawa ang Cavite ng 10,000 tests kada araw. Ito ang sinabi ng gobernador sa isang panayam.

Ayon kay Gov. Remulla, nagtatayo ang Cavite ng dalawa pang karagdagang mga laboratoryo para sa COVID-19 testing.

Nang hingan ng kumpirmasyon kung ang laboratoryo sa Cavite nga ba ang magiging pinakamalaking laboratoryo kung kapasidad ang pag-uusapan, sinabi ni Health Undersecretary Maria Rosario Vergeire sa isang panayam na ang mga laboratoryo sa Philippine Red Cross ay kayang magproseso ng nasa 5,000 tests kada araw.

Sa kaniyang Face-book post, ikinalungkot ni Remulla ang ayon sa kaniya'y nakalilitong mga patakaran ng gobyerno sa pagtugon sa pandemya.

"Maraming magulo at walang kabuluhan na patakaran (backride parachute). Parami nang parami ang napipikon habang ang iba naman ay patuloy na umaasa at naghihintay sa susunod na ayuda," he said.

Maliban sa pagdaragdag ng testing capacity ng Cavite, sinabi rin ni Remulla na ang pamahalaang panlalawigan ay maglulunsad ng isang educational plan upang matulungan ang kaniyang mga nasasakupan na lumipat sa blended learning bilang pagsunod sa direktiba ng Department of Education.

"We are launching an educational plan in 10 days. Clue: #Free-WiFiForCavite," ani Remulla.

Ibinunyag din ng gobernador na ang Cavite ay mag-iimplementa ng isang provincial identification system para sa epektibong administrasyon ng COVID-19 vaccine sakaling magkaroon na nito.

Sinabi ni Remulla na ang pamahalaan ay dapat na maging handa sa pagtugon para sa mga tiyak na hinaing sakaling ang bakuna ay maaaring nang gamitin.

"How do we administer 220,000,000 doses (2 shots per person x 110 million Filipinos)?

How do we do it without creating the least amount of panic and hysteria? Who gets it FIRST and how do people get it quickly enough?" tanong ng gobernador.

"How do we apply the lessons learned from the challenges we encountered during the SAP distribution and avoid the same mistakes when it comes to the availment and administration of the vaccine?" dagdag pa nito.

Pahayag ng gobernador, "if our minds are full in the containment strategy, then our best minds should have the foresight and prepare for the arrival of the vaccine."

"The good news is we are now crafting a proactive and viable plan for Cavite," dagdag pa nito.


