

was looking forward to working with the 46th President of the US.

"We look forward to working closely with the new administration of President-elect Biden anchored on mutual respect, mutual benefit, and shared commitment to democracy, freedom and the rule of law," he added.

Roque expressed confidence that "long-standing" bilateral relations between the Philippines and US would continue under Biden's term.

Philippines "The and the United States have long-standing bilateral relations and we are committed to further enhancing the relations with the United States under the Biden administration. Congratulations and we wish him all the best," he said.

Roque said he expects no major changes in bilateral relations between the Philippines and the US regardless of who wins the race for the White House.

"You see the (US) State Department ensures continuity as far as US foreign policy is concerned. So we don't expect any major changes in bilateral relations between the Philippines and the United States," Roque said in an interview over CNN Philippines' The Source.

He acknowledged the "personal relationship" between Duterte and former US President Donald Trump but noted that he could also establish rapport with Biden.

"Of course, there is an issue of personal relations but I think given time the President can establish equally warm personal relations with whoever wins this election even it's not President Trump," he said.

Trump refused to concede and threatened unspecified legal challenges regarding the vote counting process.

gas, Rizal, Quezon) today inaugurated the fourth Botika ng Bayan (BnB) in the region located at the City of Trece Martires, Cavite.

"Sa tulong ng ating lokal na pamahalaan ay pananatilihin natin ito at bibigyan ng wastong pangangalaga upang hindi mapabayaan at ito ay ating palalakasin sa pamamagitan ng pakikipag-ugnayan sa mga pribadong pharmaceutical companies upang sila ay makapaglagay ng mga gamot na dito sa BNB upang ang mga pasyente ay hindi na maghanap kung-saan-saan pa para sa kailangan nilang gamot at ito rin ay makukuha ng libre," Regional Director Eduardo C. He added that the collaboration with private multinational companies will provide the needed essential medicines and will ensure an adequate supply for all BnB outlets.

Among the essential medicines that are available includes paracetamol, antibiotics, topical ointments, anti-thrombotic, anti-inflammatory, antihyperlipidemic, anthelmintic, oral hypoglycemic, vitamins, micronutrients, antacids and other essential drugs for asthma, hypertension, diabetes and dyslipidemia even for family planning.

The Trece Martires BnB was made possible through the effort and cooperation of the city government. The outlet will provide quality outpatient pharmacy services to the residents of the city, especially the

underprivileged patients. The three other BNBs are located in Sta. Maria, Laguna, Mauban, Quezon and in Magallanes, Cavite.



## **TWO GUN-FOR-HIRE SUSPECTS KILLED IN** SHOOT OUT WITH **POLICE IN LAGUNA**

Lim, Calamba City - Two suspected gun-for-hire were

killed by the combined forces of Highway Patrol Group's Special Operations Division Task Force "Limbas" Division (SOD/TF Limbas), Regional Highway Patrol Unit 4a (RHPU4a), and Biñan City Police in a shootout.

Acting on an intelligence information about a planned assassination of a Biñan City local official, SOD/TF Limbas Officer-in-Charge Lt Col Ioel Ana immediately sent out SOD/TF Limbas plainclothes operatives, motorcycle, and mobile teams in coordination with the Biñan City Police Chief Lt Col Giovanni Martinez and RHPU4A Chief Lt Col Samson Belmonte.

The suspects, who were aboard a blue Ford Fiesta sporting a "MAYOR" front plate and TFF04 at the rear, were spotted near a gas station along the Manila South Road in Barangay San Antonio, Biñan City and was immediately flagged down.

The suspects immediately fired at the enforcers and sped off towards the Pavilion Mall's direction, counterflowing a one-way street along Greenfield Parkway Avenue and then going towards the Mamplasan SLEX Toll.

Mobile teams were able to set a roadblock while pursuing opera-

the suspects, causing them to lose control and crashed their vehicle at the elevated curb.

The two suspects continue to fire despite the operating teams' repeated warning orders, forcing the police to engage them in a brief firefight that killed both suspects.

The two suspects were later identified as ex-convicts and members of a gun-for-hire group operating in Southern Luzon area. Recovered from the scene were one .45-caliber pistol and .38 revolver, both with ammunition, spent shells, numerous fake IDs, and fake plate numbers.

"Let this be a reminder to all crooks out there that justice does not sleep," HPG Director Brig Gen Alexander Tagum stated.

"This is the result of teamwork between the HPG, the local police & the community. Hence, I encourage the public to continue to coordinate with our law enforcers so we could capture these criminals the soonest possible time. We assure everyone that we will continue to intensify our presence on thoroughfares and in communities to ensure that crime will not gain a foothold. Working as one, we will ensure our communities remains safe especially for our children to enjoy," he concluded.


