





The BHWs will be the one to conduct house-tohouse distribution and promotion of the BIDA campaign to 41 barangays covering 53,692 households in Tanza, Cavite.


According to the De-cember 22, 2020 DOH-AL-ABARZON Covid-19 tracker, there are 78 cases recorded in Barangay Bagtas, Tanza with 26 active case and 1 death.

WANTED GANG MEMBER FALLS IN LAGUNA

amp Vicente Lim - Laguna An intelligence-driven operation has led a police composite team to capture and neutralize a wanted per-

son who has been evading the law since 2017 for various crimes. PRO4A Regional Di-

rector Brig Gen Felipe Natividad said the successful operation of Laguna Police Provincial Intelligence Unit and San Pedro City Police Station has neutralized James Elomina in Aplaya Purok 4, Barangay Cuyab, San Pedro City, Laguna.

Elomina was the subject of a Warrant of Arrest for the crime of Homicide issued by Hon. Francisco Dizon Pano, Presiding Judge of the RTC Branch 93 of San Pedro City last August 24, 2017.

According to Natividad, the police operating teams approached the suspect to serve arrest warrant but he chose to run toward Aplaya area and engaged the lawmen in a gunfight.

Elomina sustained gunshot wounds and was immediately brought to Jose Amante Hospital in Barangay Sto. Nino but was declared dead on arrival by the attending physician. Intelligence reports noted that since 2016, the suspect was an active member of Ireneo Fajardo Criminal Group, a notorious gang involved in gun-for-hire activities and illegal drug trade and operating in south districts of Laguna Province and Muntinlupa City

Natividad also confirmed that the suspect was one of the high value individuals of the province involved in illegal drug activities and the killing of street-level drug couriers who failed to pay him on time after their illegal transactions.

The SOCO team recovered from the crime scene one caliber.45 of the suspect, two fire cartridge cases, 25 sachets of suspected Shabu, and cash bills amounting to P1,440.

The cadaver of the suspect was brought to a funeral parlor in Barangay Nueva for autopsy examination.

"ARTA shall be conducting a series of on-the-spot surprise starting inspections 1st working week of January, especially to NCR (National Capital Region) Cities and other Highly Urbanized Cities," ARTA Director General Jeremiah Belgica said in a statement on Friday.

He said the LGUs compliance will be audited based on the requirements of Republic Act 11032 or the or the Ease of Doing Business and Efficient Government Service Delivery Act of 2018 and other existing policies of ARTA, Department of the Interior and Local (DILG), Government Department of Trade and Industry (DTI), and Department of Information and Communication Technology (DICT) on BOSS.

Some of the important requirements and features that are expected from the BOSS of LGUs are the following: --A single window for submission of all requirements.

--A Unified Application Form containing all required questions by all the offices involved in permits process.

--Three Simple Step process of Submission, Assessment/Payment and Release. --Presence of a

clear and complete citizen's charter.

--Integration of Barangay Clearance in the BOSS

--Integration of Fire Safety Inspection/Evaluation Clearance in the BOSS.

--A processing of application of not more than 3 days.

He said deficient LGUs shall receive Notice of Deficiencies and may be subjected to a formal investigation which may result to an administrative case.

"We are likewise reminding all LGUs that the statutory deadline for the creation of their Electronic Business One Stop Shops (E-BOSS) is only until June 17, 2021 which is three years from the effectivity of RA 11032.

LGUs who have no Electronic BOSS yet may already use the DICT developed Electronic Business Permitting and Licensing System (EBPLS) which is already available for free.

"This is in line with the President's directive to bring government transactions and services online," Belgica said.

The Philippines is currently 95th out of 190 economies in the Ease of Doing Business Survey of the World Bank. Under the Ease of Doing Business Law, all LGUs are required to set up their business permit and licensing systems or E-BOSS by June 2021.

For LGUs to be able to comply with said provision of the law, ARTA recommends the adoption of the DICT's Electronic Business Permits and Licensing System (eBPLS) and Integrated Business Permits and Licensing System Software (iBPLS).

The eBPLS software involves permitting system for securing Business Permits and soon, Barangay Clearance as well, while the iBPLS allows for the electronic processing of applications for Building Permits and Occupancy Permits. (**PNA**)
