IMUS CITY, Cavite Local Bureau of Jail Management and Penology (BJMP) personnel were inoculated against coronavirus disease (COVID-19) on Wednesday, March 24, in a bus customized as a mobile vaccine clinic.

In a Facebook post, Mayor Emmanuel L. Maliksi shared photos of the mobile clinic rolled out by the local government unit (LGU) in coordination with the Philippine Red Cross and UBE Express.

- 1. Below 18 and above 65 are strictly not allowed outside of their homes unless the reason is essen-
- 2. 10PM to 5AM curfew remains in effect;
- 3. Ang mga kasal, binyag, at libing ay puede hanggang 10 katao lang;
- 4. Religious gatherings will be restricted. Bawal na muna ang pag-attend ng misa sa simbahan hanggang matapos ang Easter Sunday;
- 5. Ang "staycation" sa mga hotel ay kailangan ng proof of booking and negative COVID test results para palusutin sa mga checkpoint;
- 6. Ang mga dine-in sa mall restaurants, kasama ang corridors ay bawal na sa Cavite. Take out & deliveries are allowed;
- 7. Factories are restricted to 50% capacity;
- 8. Exempted po sa curfew ang mga essential workers;
- 9. Bawal ang mga party at celebrations. Bawal rin po ang mga reunion and face to face meetings. Mag-ingat rin po ang mga hindi marunong gumamit ng zoom (ayan nanaman);
- 10. Sarado muna ang mga sabungan;
- 11. Wala pong Liquor Ban ngunit bawal na po ang inuman kasama ang barkada. KTV curfews are also in effect;
- 12. Beach resorts may only accommodate pre-existing or advanced bookings;
- 13. Golf courses are open to those from NCR, Laguna, Rizal, at Bulacan. Magpakita lang ng ID at course booking sa checkpoint;
- 14. Ang kailangan pumunta sa kanilang mga doctor's appointment ay kailangan magpakita ng confirmation slip sa checkpoint;
- 15. Public swimming and leisure day trips are not allowed.





No increase in Covid-19 deaths...

go down, a health expert said on Wednesday.

buwan "Ngayong ng Marso, hindi pa tayo nakakakita ng pagtaas ng deaths, nakaka-10 deaths po tayo (This month of March, we haven't seen an increase in deaths, we have deaths [average of 10 per day], that is one of the lowest since the start of the pandemic," said Dr. Guzman, Alethea de Department of Health (DOH) Epidemiology Bureau director during an online media forum.

Based on the latest DOH data, the highest average death per day due to Covid-19 is 67 which happened last August 2020.

"Pero binabantayan natin siya dahil sa mortality curve na ito nakita naming na kung nagpeak tayo ng first week of August, 'yung peak ng deaths natin, nakita natin (But we're monitoring this because we see in our mortality curve when [cases] peak by the first week of August, the deaths peak) either that same week or the following week," de Guzman said.

Part of the government's pandemic response efforts is to prevent deaths due to Covid-19.

Hence, it monitors the healthcare utilization rate (HCUR) of hospital beds -- intensive care unit beds, isolation beds, and ward beds -reserved for moderate, severe, and critical cases.

"Regionally, lahat naka-safe zone, walang umaabot ng 60 percent, subalit nakikita natin while they are all in the safe zone, may pagtaas talaga sa paglaki ng (all are in safe zone, no region has reached 60 percent, we also see while they are all in the safe zone there is an increase in the) healthcare utilization rate," de Guzman said. She noted the National Capital Region's HCUR increased by 21 percent in a week while Calabarzon increased by 19 percent.

"So, this is aligned, consistent with the increase of cases in these places. We're monitoring each region, their increase in HCUR or ICU rate, we study how to lower it," she said.

In connection, de Guzman stressed the importance of triage in hospitals and the referral of patients who are either asymptomatic or with mild Covid-19 symptoms to community quarantine facilities. (PNA)




