The said program aims to assure the consumers and the general public of the establishments’ compliance with the minimum public health standards set by the government.

## PhilHealth, Ipatutupad ang Debit-Credit Payment Method (DCPM)

Ipinatupad ng PhilHealth ang alternatibong paraan ng pagbabayad ng claims bilang tugon sa direktiba ng Pangulong Rodrigo Duterte na pabilisin ang pagbabayad sa mga pasilidad sa gitna ng pandemya. Inilabas kamakailan ang PhilHealth Circular 2021-004 kung saan nakasaad ang polisiya patungkol sa Debit-Credit Payment Method (DCPM) na layuning mapabilis ang pagbabayad ng mga claims ng pasilidad.

Sa ilalim ng DPCM, babayaran ng PhilHealth ang 60% ng kabuuang halaga ng sakop ng Health Care Facility (HCF) receivables kung saan ito ay may 2% na bawas base sa expanded withholding tax para sa mga kwalipikadong HCF. Ang natitirang 40% sa kabuuang halaga ay magkakaroon pa din ng 2% na bawas, ngunit kinakailangang makumpleto ng pasilidad ang mga compliance sa mga claims processing requirement at procedures at gayundin ang full reconciliation ng naunang 60% na halaga. Sakop nito ang mga naipasang claims

ng mga pasilidad sa PhilHealth simula Marso 8, 2020 hanggang Abril 7, 2021.

Upang maka-avail ng DCPM, kinakailangan ang pasilidad ay nasa mga lugar ng National Capital Region, mga probinsya ng Batangas, Bulacan, Cavite, Laguna, Pampanga at Rizal batay sa identipikasyon ng Inter-Agency Task Force for the Emerging Infectious Diseases (IATF-EID).

Gayundin, pinayagan na rin ng IATF ang expansion ng DCPM base sa Resolution No. 111 na na-isyu noong Abril 22. Sa ilalim ng nasabing resolusyon, kasama na sa mabibigyan ng DCPM ang mga pasilidad na nasa high at critical risk areas batay sa two-week growth rate, average daily attack rate at health care utilization rate.

Kaugnay nito, ang mga interesadong pasilidad ay kailangang:

- Walang balanse sa record ng Interim Reimbursement Mechanism (IRM)
- May claims para sa PhilHealth Covid-19 packages
- Hindi suspendido ang akreditasyon mula sa

applicable period para maka-avail ng DCPM

Ang DCPM ay applicable lamang sa in-process claims na natanggap mula Marso 8, 2020 hanggang Abril 7, 2021. Hindi dito kasama ang Return-to-Hospital (RTH), denied claims, claims na naka-refer sa Legal Office ng PhilHealth para sa imbestigasyon at claims na approved for payment ng Abril 7, 2021.

Sa 90 na pasilidad na nasa listahan ng Region 4A, mayroong 18 pasilidad na hindi interesado at isang hindi PhilHealth accredited. Ayon sa pinaka huling datos, may 48 na pasilidad na ang nabigyan ng DCPM at may 15 pang pasilidad na hinihintay ang aplikasyon.

Ang mga interesadong pasilidad, kinakailangan magsumite ng letter of intent na nilagdaan ng may ari ng pasilidad o Medical/Hospital Director. 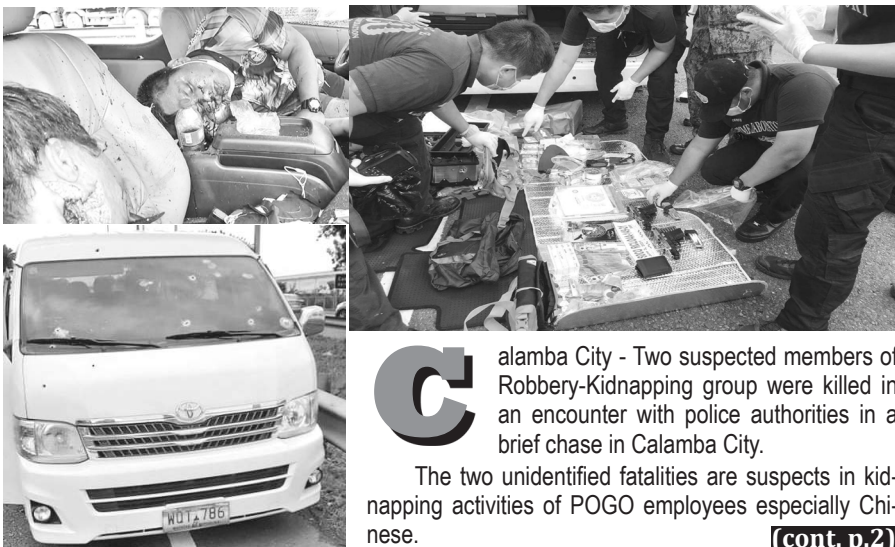

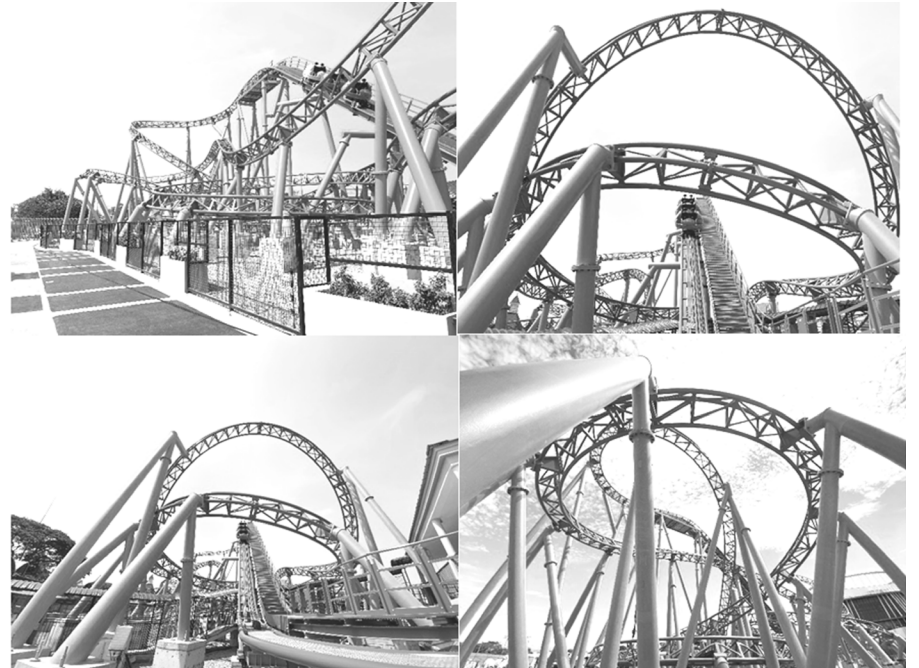
