

Kabilang dito ang maigting na pagpapatupad ng contact tracing na itinuturing ng pamahalaang lungsod na isa sa mga pinaka-epektibong hakbang kontra Covid-19.

Sa panayam sa programang Sulong Calinilahad ni abarzon, Arcillas na malaki ang naitutulong ng contact tracing upang tugunan ang tumataas na kaso ng Covid-19 sa lungsod.

" N a p a p a b a b a naman natin with all of our guidelines pero we just have to check what else we can do para ma-control. And, the best possible way is to check yung mga nagkakasakit at mapangalaagaan sila," pahayag ng alkalde.

Bukod sa pagtukoy sa posibleng nahawaan ng Covid-19 ay nakatutulong din ang aniya ito upang mabantayan at maalagaan ang mga residenteng nakasailalim sa quarantine.

"Sa pamamagitan ng contact tracing, nalalaman nating 'yung mga positive pati 'yung mga close contact nila at nache-check din natin kung anong mga pangangailangan ng pamilya na naka-quarantine," pahayag ni Arcillas.

Ayon sa alkalde, bawat pamilya ng mga nagpopositibong kaso ay binibigyan nila ng 'home care kit' na naglalaman ng mga bagay na kinakailangan sa pag-monitor ng kundi-

syon ng mga pasyenteng tinamaan ng Covid-19.

Sa tulong ng mga contact tracing teams ay nagbibigay din aniya sila ng mga relief packages para sa mga pamilyang naka-quarantine. Kaya naman, nag-

pasalamat si Arcillas sa Department of the Interior and Local Government sa paglalaan nito ng mga contact tracers sa lungsod.

Bagaman natapos na ang kontrata ng mga ito sa DILG ay minarapat aniya na ipagpatuloy ang trabaho ng mga contact tracers sa ilalim ng pangangasiwa ng pamahalaang lungsod.

Rosa Bukod sa contact tracing ay isa rin sa maituturing na epekti-

bong hakbang kontra Covid-19 ay ang tuloy tuloy na pagbabakuna sa mga residente.

Ayon kay Arcillas, umabot na sa 76,000 ang kabuuang bilang ng mga nabakunahan kung saan 26,000 sa mga ito ang fully vaccinated na o nakatanggap na ng kumpletong dose ng bakuna.

Dagdag pa ng alkalde, mas maraming residente pa ang inaasahang mababakunahan sa mga susunod na araw sa unti-unting pagdating ng 300,000 doses ng bakunang AstraZeneca na binili ng pamahalaang lungsod.

Ayon kay Arcillas, may 200,000 residente ang nagparehsitro para sa vaccination program ng pamahalaang lungsod.

Target aniva nila na mabakunahan ang 250,000 indibidwal kasama na ang mga empleyado ng pribadong kumpanya sa lungsod.

'We are doing our best na ma-inoculate ang mas maraming tao as fast as possible at madagdagan ang mga vaccination sites dahil ayaw naman nating nagkakagulo ang pagbabakuna," pahayag ni Arcillas.

Nagpaabot naman ng pasasalamat si Arcillas sa mga pribadong ospital sa lungsod na katuwang nito sa pagsasagawa ng vaccination program.

## ENR Seeks Aid from KRA-5 on Cavite Fishing Structures Issue




and Natural Resources (DENR) CALABARZON sought the assistance of the Key Result Area (KRA) 5 of the Manila Bay Inter-Agency Task Force (MBIATF) in addressing the issues on the illegal fish traps, fish cages, and other aquaculture structures in Cavite.

During the meeting of the MBIATF-KRA 5 on August 10, 2021, DENR CALABARZON Assistant Regional Director for Management Services, Nelson V. Gorospe presented the Regional Department's action plan for bamboo fish cages, fish traps, and tahungan operations in Cavite, that include updating of the master list of fish cages, fish traps, and tahungan operators; issuance of notice to self-demolish for non-permittees; demolition of the remaining illegal fish cages, fish traps, and tahungan operations for non-permittees who failed to self-demolish their structures; requiring tahungan operators with permits to shift to long-line method of shellfish propagation as prescribed by the Bureau of Fisheries and Aquatic Resources; and declaration of temporary suspension of the issuance of permits for the transport of bamboos to Cavite for aquaculture purposes.

ro ng isang jeep matapos umano nitong makasalpukan ang isang truck sa kahabaan ng Maharlika Highway, Brgy. San Nicolas, San Pablo, Laguna dulot ng hindi maayos na pagparada ng jeep upang magsakay ng pasahero, Agosto 12.

Kita sa CCTV ang paghinto ng jeep sa pedestrian lane at hindi umano nakatabi sa kalsada upang magsakay ng pasahero, kung saan dalawang magkasunod na truck na ang muntikang makahagip sa jeep ngunit nagawa namang makaiwas.

Subalit sa ikatlong truck na dumating, tuluyan nang sumalpok ito ng jeep, kung saan bigo naman itong nakaiwas dahil sa kasabayan nitong truck sa daan.

Agaran namang nakapreno ang truck ngunit sa lakas ng epekto ng pagkakasalpok nito sa jeep ay nagdiresto pa ang jeep at sumalpok sa poste.

Bukod sa tinamong sugat, tumilapon rin ang isang pasahero ng jeep na nasa estribo, ngunit nagawa pa ring makagapang papunta sa gilid ng kalsada. Bagamat nagtamo ng sugat ang 12 katao ay idineklara naman ang mga ito na ligtas.

Kaugnay sa pagpapagamot sa mga ito, sinagot naman ng mayari ng truck ang mga gastusin ng mga nasaktan sa nasabing insidente.

Sa kabilang banda, ipinaalala naman ni Dong Fullo ng San Pablo Public Forum na hindi raw dapat sumakay ang mga pasahero sa jeep kung nasa gitna ito ng daan dahil ito ay maaaring magresulta ng kanilang kapahamakan.

from the concerned local government units (LGU), Bacoor City has 351 tahungan operators with permits on-hold per Mayor's order as the said operators failed to pay annual registration fee due to the issue on the proposed Bacoor reclamation projects. On the other hand, no permit was issued to the 23 pond-type operators in Kawit, Cavite and 26 bamboo fish traps in Cavite City. In the same way, no permit or fishing license was issued to any fish pen tahungan. and sapra operators in Noveleta, Cavite as certified by the Municipal Agriculturist.

Considering the urgency of the directive of the Secretary, DENR Legal Affairs Service Director, Atty. Norlito A. Eneran said the demolition of the structures which totally have no corresponding permits should be prioritized. However, the economic effect of the said action to the affected fisherfolk should be taken into consideration, he emphasized.

In response to the request of the DENR

CALABARZON for advice and assistance regarding the plan presented, the KRA 5, led by Department of Justice Assistant Secretary Margaret V. Castillo-Padilla, advised the regional department to coordinate with the Department of Social Welfare Development and Bureau of Fisheries and Aquatic Resources with regard to the assistance which may be provided to the affected fisherfolk, and with the concerned LGUs and the Department of the Interior and Local Government (DILG) regarding the dismantling operations.

Gorospe said they will officially request DILG Secretary Eduardo Ano to direct the concerned LGUs to demolish those structures without permit and to provide security during the demolition. A special KRA 5 meeting will be held on August 17, 2021 for DENR CALA-BARZON to present its concrete plan and timeline for demolition. The said meeting shall also be attended by the concerned LGUs.

ordinating and Management Office-4 Deputy Site Coordinator, Cynthia N. Rozaldo said they should be able to address the issues on the fish cages, fish traps, and tahungan operations in Cavite by August 30, 2021 as per directive of the Secretary.

Early in July 2021, Environment Secretary Roy A. Cimatu ordered DENR CALABARZON Regional Executive Director Nilo B. Tamoria to conduct an immediate and complete inventory of all fish pens, fish cages, baklads, and sapras in Cavite, and to identify those with permits to operate. Cimatu said "legitimate operators will be required to repair their damaged fish pens and cages while those without permits shall be ordered to immediately self-demolish". The said instruction was in view of the huge amount of bamboo poles from fish pens, fish cages, and baklads/sapras, which washed from were Cavite waters into the shore of Manila Bay due to the recent southwest monsoon.###





ANILA The Duterte admin-

istration will look into an option of fulfilling the failed incentives promised to retired boxer and Olympic silver medalist Mansueto "Onyok" Velasco, as well as other cash reward after winning a silver medal during the 1996 Atlanta Olympics.

Presidential Spokesperson Harry Roque said he would relay Velasco's plight to President Rodrigo Duterte, recognizing the neglect

on the part of the past administration to meet the avowed rewards for the actor-turned boxer.

"Ipagbibigay-alam ko po ito kay Presidente. Kung si Onyok Velasco nananalo noong silver sa ibang administrasyon ay hindi nakakuha po ng kaniyang pabuya, ipakiusap po natin kay Presidente ito, baka naman mabigyan siya ng pabuyang ayon. Kapabayaan po iyan ng gobyerno na hindi nagbigay sa kaniya ng pabuya," Roque said during his press briefing in Malacañang.

"Napakahirap kasi

mangako doon sa mga bigong pangako ng nakalipas na administrasyon. Pero unang-una po, iti-trace po natin kalian iyong effectivity ng law na nagbibigay ng P10 million, Roque said, referring to the Year 2001 law giving cash incentives for athletes and coaches if could still be applied to Velasco's case.

Under Republic Act (RA) 10699 or the National Athletes and Coaches Benefits and Incentives Act, Olympic gold, silver, and bronze medalists are entitled to P10 million, P5 million,

and P2 million rewards, respectively.

Tokyo Olympic 2020 weightlifter gold medalist Hidilyn Diaz was also promised with cash rewards and other incentives worth millions of pesos, including a house and lot, condominium and vehicles, among others.

Velasco wished that Diaz would not suffer the same fate with him who just received a one-time cash incentive amounting to P750,000.

On top of the onetime cash gift, the 47-year-old former

also hoxer admitted that he had received an additional P1.2 million under Republic Act No. 9064 or the Sports Benefits and Incentives Act during the time of former President Gloria Macapagal Arroyo. Velasco

However,

is also lamenting about the failed pledge of P2.5 million reward by the members of the House of Representatives in 1996, including the house and lot given to him but its title has not been transferred to his name until this date.
