



DPWH Reservoir Projects to Play Pivotal Role in Mitigating Floods in Imus and Bacoor



u b l i c Works and Highways Secretary Mark A. Villar on Thursday, September 23, 2021 led the inauguration ceremony of Cavite's two (2) floodwater reservoir projects in Barangay Buhay na Tubig, Imus City.

Secretary Villar was joined by Japanese Ambassador to the Philippines Kazuhiko Koshikawa; DPWH Undersecretary for Unified Project Management Office (UPMO) Operations Emil K. Sadain; Cavite Governor Juanito Victor C. Remulla; Japan International Cooperation Agency (JICA) Chief Representative Eigo Azukizawa, Cavite 2nd District Representative Strike Revilla; and Cavite 3rd District Representative Alex L. Advincula.

The event was also attended by DPWH UPMO Flood Control Management Cluster (FCMC) Project Director Ramon A. Ariola III; **UPMO** Project Directors Benjamin A. Bautista and Rodrigo I. Delos Reyes; and Project Manager Aurelio C. Mendoza.

Secretary Villar said that the Imus and Bacoor retarding basins implemented by DPWH UPMO-FCMC are expected to help manage or mitigate the challenges of rainy season for Imus and Bacoor that are highly susceptible to rain-induced flash flooding.

project will The help address flooding woes in low-lying areas affected by the confluence of Imus River and Bacoor River, added Secretary Villar.

According to Undersecretary Emil K. Sadain, the design of two (2) retarding basins are based on a comprehensive flood management master plan prepared by JICA.

These constructed retarding basins will temporarily store most, if not all, of the rainwater run-off during very high rainfall to reduce the peak volume of flood flow and later release at regulated rate, said Undersecretary Sadain.

The reservoirs that will also reduce the floodwater going downstream were built under financing of JICA's Official Development Assistance (ODA).

When water level increases during flooding, the floodwater overflows into the retarding basins and will be discharge once the water

level in Imus and Bacoor River subsides or at normal rate.

The Imus retarding basin at Barangay Anabu has a water detention area of about 35 hectares with 2 meters by 2 meters one (1) barrel drainage sluice and 84 meters overflow dike.

On the otherhand, Bacoor retarding basin located in Barangay Buhay na Tubig has two (2) basin connected by a 2.7 meters by 2.7 meters one (1) barrel sluiceway for a total pond area of 9 hectares with overand 1 meter by 1 meter

flow dike of 42 meters one (1) barrel drainage sluice. (DPWHPIO)



Marking of illegal fishery structures for demolition in Cavite commences



ed by the Department of Environment and Natural Resources (DENR) CALABARZON and the Provincial Environment and Natural Resources Office (PEN-RO) of Cavite, the marking of the illegal fish cages, fish pens, baklads, sapras, and tahungan within Cavite City, Kawit and Noveleta, Cavite for demolition commenced on September 15, 2021.

Divided into three sub-teams, the marking team is composed of selected personnel from DENR CALABARZON Enforcement Division, Regional and Provincial Manila Bay Site Coordinating and Management Offices (MBSCMO), Municipal/City and Barangay Government Units,

Philippine National Police (PNP), PNP-Maritime Group, and Philippine Coast Guard.

Per data given by the respective local government units prior to the actual marking, there are a total of 370 illegal aquaculture structures in Cavite waters: 271 in Cavite City, 97 in Kawit, and 2 in Noveleta. However, per actual marking conducted from September 15-17, 2021, 492 structures had been marked: 333 in Cavite City, and 159 total in Kawit and Noveleta. Also, a team member said they are not yet done with the marking.

One of the members of the marking team said there could possibly be errors in the marking considering

that it was difficult to determine the borders of each structure due to the waterbody. Another member added that they have no baseline information to rely on as the said structures neither have permits nor record with the concerned local government units.

The marking team will resume their activities on September 20, 2021. The actual demolition, which was earlier scheduled on the said date, will be conducted soon after marking is completed.

DENR CALABAR-ZON Regional Executive Director and MBSCMO-4 Regional Coordinator, Nilo B. Tamoria emphasized that the planned demolition of illegal aquaculture structures is for the sake of the marginalized fisherfolk.



This return shall be filed in triplicate by the executor/administrator/authorized representative of estates availing of the Estate Tax Amnesty under Republic Act (R.A.) No. 11213, otherwise known as the "Tax Amnesty Act", as amended by R.A. No. 11569.

When and Where to File and Pay

This return together with complete documentary requirements, shall be filed not later than June 14, 2023, to the Revenue District Office (RDO) having jurisdiction over the last residence of the decedent at the time of his death.

In case of a non-resident decedent with executor or administrator in the Philippines, the return shall be filed with the RDO where such executor/administrator is registered or if not yet registered with the BIR, at the executor/administrator's legal residence. If the decedent has no legal residence in the Philippines, the return shall be filed with RDO No. 39, South Quezon City.

The tax ammesty due shall be paid using the Estate Tax Acceptance Payment Form (BIR Form No. 0621-EA) to the Authorized Agent Bank (AAB) or Revenue Collection Officer (RCO) of the RDO.

Tax Rates and Basis of Tax

There shall be imposed a rate of six percent (6%) based on the decedent's NE

TAXABLE ESTATE determined as of the time of death of decedent composed of
