


# INCREASE DSWD BUDG MAKE IT A PANDEMIC RECOVERY BUDGET

Three-term Senator Loren Legarda today renewed her call for a national budget that ensures the integration of human capital development and climate resilience in government policies and programs.

Legarda, former Chairperson of the Senate Committee on Finance, made the statement during the budget deliberation of the Department of Social Welfare and Development (DSWD) in the House of Representatives stressing that the proposed Php 191.4 billion budget

for the agency under the 2022 National Expenditure Program (NEP) should be augmented to provide better socio-economic services to the marginalized and vulnerable sectors.



sugan kundi pati na rin sa pangkabuhayan. We have an estimated 20 million poor Filipinos, which include more than 4 million active beneficiaries registered under the Pantawid Pamilyang Pilipino Program (4Ps) who depend on government programs like the Department's Sustainable Livelihood Program (SLP), Assistance to Individuals in Crisis Situation (AICS), and Cashfor-Work Risk Resiliency Program to cope with socio-economic challenges, especially amid the pandemic and the continuing climate crisis," Legarda said.

Legarda has called for the Congress' support in amending the budget of DSWD to include additional funding for the SLP. Legarda noted that under the NEP, only Php 4.864 billion is allocated for SLP, a livelihood program that supports 4Ps families and individuals to eventually gain financial independence. It offers two tracks—microen-

terprise development, which provides a maximum of Php 15,000 seed capital fund as capital for small businesses such as sari-sari store, shoe repair, poultry raising, among others; and employment facilitation, providing maximum of Php 5,000 per individual as assistance for processing of employment documents and to augment expenses for the first fifteen days of employment.

"We have to consider the statistics of our beneficiaries in allocating our budget and ensure that a majority, if not all, will be able to improve their level of well-being and economic status. With the current proposed allocation for SLP, only around 8% of the 4 million 4Ps beneficiaries will be accommodated under the microenterprise development track. For us to reduce chronic poverty and promote human capital development in the country, we have to augment DSWD's bud-

get especially for the allocation of these programs," Legarda said.

As the principal author of the Magna Carta of the poor, Legarda lamented that the proposed budget of DSWD does not seem to be reflective of a pandemic recovery budget that gives priority to the poorest of the poor, neither is it a resilient budget that prepares and addresses the needs of vulnerable communities to the impacts of climate change through implementation of temporary employment with activities that include planting of indigenous trees, organic gardening, waterways dredging, community clean-ups, rehabilitation of river banks, among others considering that the Philippines is a vulnerable nation often visited by typhoons.

According to Legarda, it is not enough that we plan just to recover from this pandemic, the three-term Senator committed that she will actively push and intro-

duce amendments to the DSWD budget to ensure that it is aligned with the pandemic recovery and climate justice, as well as in compliance with the provisions of the Magna Carta of the Poor.

"As public servants, we have to take care of the human capital so that our economic gains also address the needs of the people. We have to provide our people with programs and services that would usher in personal growth, community development and national progress. As long as there is zero-tolerance for corruption in the implementation of

these programs that invest in the human capital and the marginalized sector, we will be able to overcome this pandemic

and tread the path towards an inclusive, sustainable and resilient recovery," Legarda con-cluded.\*\*\*





#### MARCOS URGES COMELEC TO ALLOW LGUS TO AID FAMILIES UNDER LOCKDOWN

eeing the pandemic COVID-19 endgame is not here yet, former Senator Ferdinand 'Bongbong' Marcos Ir. asked the Commission on Elections (Comelec) to allow families under granular lockdowns to continue receiving relief packs from their local government units.

Citing the poll body Resolution No. 10695 which set the calendar of activities for the May 9, 2022 presidential particularly elections. the prohibition on giving donations or gifts, in cash or in-kind, from the start of the campaign period for national positions to election day, Marcos requested the COMELEC to issue an exemption order.

Under the said resolution, giving donations or gifts, in cash or inkind, is prohibited from the period of Feb. 8 to May 9, 2022. "Sa tingin ko hindi pa rin naman matatapos ang pandemiya by that time kaya hindi pa rin mawawala ang mga lugar na malalagay sa granular lockdown. Inisip ko ang mga taong maapektuhan ng campaign period kaysa mga kandidatong gaya ko. Paano na 'yung mga pamilyang nasa lugar na may granular lockdown?" he said.

Unless the Comelec issues an exemption order, residents of areas under granular lockdown, who are barred from leaving their homes, may not be able to get aid, in the form of relief goods, from their LGUS, he said.

"Parang may tali ang kamay ng mga taga-LGUs. Pero ang mas kawawa ay ang mga pamilyang hindi mahahatiran ng ayuda na hindi pa pwedeng lumabas sa kanilang mga tahanan," he added. **(BENJIE J. MURILLO)**

he Department of Health (DOH) CALABAR-(Cavite. 70N Batangas, Rizal, Laguna. Quezon) today presented its accomplishments as it joined the launching of the Duterte Legacy Campaign with the theme. "Barangayanihan Caravan Towards National Recovery" at the Batangas Police Provincial Office located at President Jose P. Laurel Highway, Camp Malvar, Batangas.

The campaign showcased the successful implementation of various programs, policies and projects by government agencies that provided better services and directly benefitted the people including those in Geographically Isolated and Disadvantaged Areas (GIDAs).

Assistant Regional Director Paula Paz M. Sydiongco, who represented Regional Director Eduardo C. Janairo, showcased the significant accomplishments of DOH-CALABARZON under the Duterte Administration which includes the establishment, upgrading of services and renovation of health facilities including 43 hospitals, 33 rural health units and 74 barangay health stations together with the installation and provision of 113 various equipment in the hospitals, 184 in rural health units and 193 in barangay health stations.

"We have provided 7 sea ambulance, 158 land ambulance and 100 bicycles for barangay health workers," Sydiongco shared in her presentation.

The regional office also upgraded the services, facilities and equipment of its apex hospitals namely the Batangas Medical Center in Batangas City, the Maria L. Eleazar District Hospital in Tagkawayan, Quezon, the Southern Tagalog Regional Hospital in Bacoor City and the Northern Tagalog Regional Hospital in Rodriguez, Rizal will start construction this year.

A JICA project with 500 bed rehabilitation facility is currently on-going construction in Trece Martires, Cavite.

"For Covid-19 response, critical care capabilities of intensive care units (ICUs) of five key Covid referral facilities were enhanced and improved including the installation of six ICUs and 11 ward tents to augment hospital capacities."

"Dialysis centers were established in Cabuyao City Hospital and San Pablo City District Hospital (SPCDH) for Covid patients."

"To provide access to specialized health care services, particularly in remote areas, the regional office established telemedicine services including the Kapit-Bisig Helpline for mental health, O-HI Doc for tele-dentistry and the KonsultaMD for primary healthcare services," she narrated.

The first Traditional Complementary and Alternative Medicine (TCAM) Center located at the Batangas Medical Center and Pagsanjan Rural Health Unit were inaugurated to highlight and put into mainstream the accepted forms of oriental therapy, such as acupuncture, home-

DOH-CALABARZON also facilitated the establishment and licensing amd provided technical support for the 25 molecular laboratories in the region, located in Cavite (5), Rizal (3), Laguna (8), Batangas (7) and Quezon (2). A total of six extensive Temporary Treatment Monitoring Facilities (TTMF) were also established.

### Fraud in Lipa 2019 By BENJIE J. MURILLO mayoral race uncovered

#### Sabili counsel filed motion to withdraw as true winner can now be ascertained

A massive fraud was discovered by the Commission on Elections (COMELEC) in the 2019 mayoral race in the City of Lipa, Batangas Province.

A number of combined signatures and thumb marks were discovered to be not matching with the number of 15,728 registered voters, the number almost equivalent to the 16.920 found identical based on results of technical examination, the 198-page order penned by poll body's Second Division Presiding Commissioner Socorro Inting revealed.

The examination discovered that irregularities has existed in the huge discrepancies in the signatures of the supposed voters. The COMELEC

sought to determine the true result of the election and ruled that "all technicalities and procedural barriers should not be allowed to stand if they constitute an obstacle to the determination of the true will of the electorate in the choice of their elective officials."

Protestant Bernadette P. Sabili filed an election protest, docketed EPC 2019-003 by the poll body, against protestee Eric Africa, who got 78,109 votes against the former's 76,511 votes, or a margin of 1,598 votes.


Sabili's counsel George Garcia filed a



motion to withdraw, requesting the Comelec Second Division to stop the review of the remaining protested precincts, citing the findings on the 49 pilot precincts where the Comelec established there were irregularities.

"The protestant humbly submits that the continuation of the revision and technical examination proceedings for the remaining 196 protested cluster precincts is no longer necessary considering that the legitimate and true winner for the position of mayor in the city of Lipa during the 2019 elections can now be ascertained; and such continuation will only waste the valuable time and energy of the honorable commission," the motion cited.

"And after completion of the proceedings, declare the protestant (Sabili) as the true and legitimate winner for the position of mayor in the city of Lipa during the May 2019 national



and local elections," the motion added.

The Comelec wanted to know whether Africa was the real winner or if Sabili was the legitimate elected mayor.

Garcia claimed that Sabili would have 69,715 votes as against Africa's 69,584 if the results from the 49 contested pilot precincts that the poll body found signatures irregularities will be nullified.

The 196 precincts that still remain to be reviewed by the poll body are now the subjects of Garcia's motion to withdraw.

Citing the findings of Comelec technical experts that a total of 15,724 signatures of voters in the reviewed ballots were found to have been different from the signatures of the same names when compared to their voters' registration form, Garcia claimed that Sabili's camp has by now proven its assertion of electoral fraud in the 2019 mayoral race.

Comelec Commissioner Antonio Kho Jr. agreed with the Second Division Order, in that way issued his separate concurring opinion.
