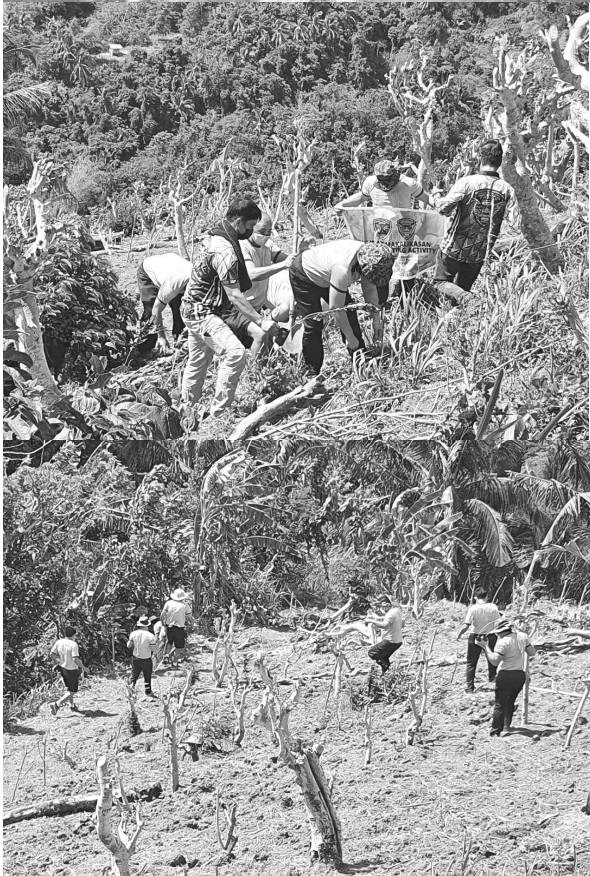

BARZON said violators of facemask ordinance will not be jailed but will be booked and investigated.

Violators can be held for a maximum of 12 hours while undergoing investigation and booking procedure, during such time, we will provide them face masks to protect our own investigators, and their

fellow violators, Eleazar explained.

Violators will undergo records check to determine previous arrest record for similar offense for which appropriate penalty for repeat offenders will apply. Those found with outstanding Warrants of Arrest will undergo further appro-

priate police action in coordination with judicial authorities.

During his "Talk to Men", he emphasized cleanliness in all police offices, intensify campaign against street crimes, equal treatment to others and continue to implement community mobilization program.

DOH-CALABARZON REMINDS COVID VACCINE RECIPIENTS TO TAKE SECOND DOSE



DOH-CALABARZON Regional Director Eduardo C. Janairo reminded Covid vaccine recipients to take their second dose to get the full protection against severe Covid-19 symptoms.

Laguna - The Department of Health (DOH) - CALABARZON (Cavite, Laguna, Batangas, Rizal, Quezon) reminded Covid-19 vaccine recipients not to forget to take their second dose of the vaccine to get their full protection as cases in the region continue to rise.

Regional Director Eduardo C. Janairo emphasized that the body's immune system takes time to build protection against the virus.

"Kahit nabakunahan na kayo ay hindi ibig sabihin nito na hindi na kayo tatanaan Covid dahil ang katawan natin ay kailangan munang makabuo ng antibodies pan-

laban sa virus para hindi magkaroon ng severe form ng Covid-19."

"Tandaan natin na nagkaroon na ng maraming variant ang virus kaya napakaimportanteng makumpleto natin ang bakuna natin upang masiguro na ang katawan natin ay may completing panlaban sa Covid-19," he stated.

The DOH has been providing two types of vaccine to priority groups, Sinovac CoronaVac and Oxford-AstraZeneca which are being given in two doses.

"If you received the AstraZeneca vaccine, you have 12 weeks to get the second dose. For the Sinovac recipients, you have 28 days or 4

weeks to get your second shot."

"Only upon receiving the second dose of Covid vaccine can you get the full protection against the virus. Huwag po natin itong ipagwalang bahala dahil mahirap po ang magkasakit dahil sa covid. Mahirap ma-hospital at hindi rin madaling gumaling dahil dito," Janairo stressed.

As of May 4, 2021, there are 132,180 doses of Covid-19 vaccines administered in CALABARZON. From this figure 154,347 (93.8%) have received their first dose and 10,154 (5.2%) were given their second shot.

"Continue following the minimum health protocols like wearing face mask, social distancing and handwashing. Even if you were already vaccinated you may still get the virus and infect others."

"Let us be vigilant as we continue to fight the current pandemic. Let us ensure our own safety, that of our family and the people around us so that we may not spread the virus in our community," Janairo underlined. (GLEN RAMOS)

NCR Plus placed under GCQ... from p. 1

Quarantine (GCQ) with heightened restrictions from May 15 to 31, 2021.

Also under GCQ status from May 15 to 31, 2021, are areas under the Cordillera Administrative Region, such as Apayao, Baguio City, Benguet, Kalinga, Mountain Province and Abra; Cagayan, Isabela, Nueva Vizcaya in Region 2; Batangas and Quezon in Region 4-A; Puerto Princesa in Region 4-B; Iligan City in Region 10; Davao City in Region 11; and Lanao del Sur in the Bangsamoro Autonomous Region in Muslim Mindanao.

The City of Santiago and Quirino Province in Region 2; Ifugao in the Cordillera Administrative Region; and Zamboanga City in Region 9 shall be placed under Modified Enhanced Community Quarantine (MECQ) from May 15 to 31, 2021.

All other areas shall be placed under Modified General Community Quarantine (MGCQ) until month's end.

On the heightened restrictions in the NCR Plus, only essential travel into and out of

the NCR Plus shall be allowed. Public transportation shall remain operational at such capacities and protocols in accordance with the Department of Transportation guidelines while the use of active transportation shall be promoted.

Also, indoor dine-in services in NCR Plus shall be at 20% venue or seating capacity while outdoor or al fresco dining shall be at 50% venue or seating capacity.

Outdoor tourist attractions in the NCR Plus, on the other hand, may be opened at 30% with strict adherence to minimum public health standards.

Further allowed in the NCR Plus are specialized markets of the Department of Tourism (DOT) following the minimum public health standards and implementation of protocols and restrictions as set by the DOT.

Religious gatherings and gatherings for necrological services, wakes, inurnment and funerals for those who died of causes other than COVID-19 in NCR Plus shall be allowed up to 10% of the venue ca-

capacity.

Also continued to be allowed in GCQ areas with heightened restrictions are non-contact sports, games, scrimmages held outdoors; and personal care services that allow for services not requiring mask removal, such as salons, parlors, beauty clinics, etc at 30% capacity.

Individuals, 18-65 years of age, can leave their places of residence in GCQ areas with heightened restrictions.

Meanwhile, entertainment venues, such as bars, concert halls, theaters, etc; recreational venues, such as internet cafes, billiards halls, arcades, etc; amusement parks, fairs, playgrounds, kiddie rides; indoor sports courts and venues and indoor tourist attractions; venues for meetings, conferences, exhibitions shall not be allowed in GCQ areas with heightened restrictions.

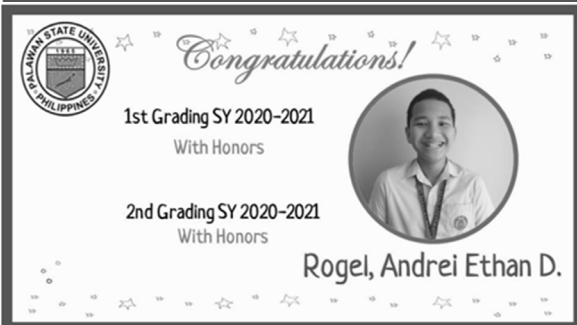
Interzonal travel from NCR Plus areas, except those conducted by Authorized Persons Outside Residence (APORs), shall remain prohibited in GCQ areas with heightened restrictions. (PNA)

ELEAZAR PRESIDES TURN-OVER OF COMMAND CEREMONY AT PRO CALABARZON

Camp Vicente Lim, Calamba City - The Chief, Philippine National Police, Police General Guillermo Lorenzo Eleazar paid a visit to the members of Police Regional Office CALABARZON after his installment as the 26th Chief, PNP earlier this Friday and presided the turn-over of command ceremony for PRO CALABARZON.

The Chief witnessed the passing of command between the outgoing Regional Director, Brig Gen Felipe Natividad, and the incoming Regional Director Brig Gen Eliseo DC Cruz. Cruz in his assumption speech sought the support of the members of PRO CALABARZON to perform their duties and responsibilities aligned with the thrusts of the Chief, PNP.

Setting his policies, he reiterated to everyone to strictly adhere to the directives of the Chief, PNP, and support his newly launched program which is the Intensified Cleanliness Policy in the PNP to raise the standard of public service to the Filipino people particularly to the communities in CALABARZON.

"I enjoin all Provincial Directors and unit commanders to strictly implement this policy. Hinahamon ko ang bawat isa sa inyo na gawin ang inyong



tungkulin ng may mabilis na aksyon upang maresolba agad ang anumang mga problema bago pa ito lumala," he said. The ICP or the Intensified Cleanliness Policy is divided into 3 essential parts which are Cleanliness in the Offices, Cleanliness in the Ranks, and Cleanliness in the Community as earlier stated by the Chief PNP during his assumption of office.

On cleanliness in the Offices, Cruz said that all PNP precincts, stations, and offices must be clean and presentable at all times. He will be implementing the Oplan Brigada Presinto wherein all precincts shall be repainted to make them look new.

Following is the In-

tensified Cleanliness on ranks where he would be focusing not only on internal cleansing but also on reform programs that would shield the PNP from erring cops and bust the culture of wrongdoings among policemen. He also emphasized the effective supervision of all unit commanders to their subordinates.

"We will strictly follow the policy of the different levels of our internal cleansing- the preventive, punitive, and reformative action plans. Hindi natin kukunsintihin ang mga police scalawags, mga kotong cops, at mga abusadong pulis sa ating hanay," he further said.

Finally, the Regional Director said that the Intensified Cleanliness in the Community shall be implemented focus-

ing on peace and order problems in the community by stepping up the campaign in enforcing ordinances and other related laws in violation or against all forms of criminality as part of the crime prevention measures. "We will strengthen and increase our police visibility in the streets to reduce street crimes and improve our crime solution efficiency," Cruz said.

Cruz's additional directives focused on his campaign against Wanted Persons, Loose Firearms, reinforcing Investigation efforts, improving infrastructure and facilities. "Join me in my desire as we put our best foot forward to consistently deliver public service to the highest standard. I want this Police Regional Office on top," he concluded.

Meanwhile, Eleazar congratulated both the officers on their new assignments. He recognized the stint of the outgoing Director mentioning that his transfer is for greater responsibility as the director of Special Action Force. "Marami kang trabahong gagawin Malaki ang role mong gagampanan," he said. He also acknowledged the commitment of the incoming Director with his reiteration of the top command's program thrusts.

"You just have to internalize what this concept is all about. Kailangan lang natin tutukan, palakasin at siguraduhing maayos itong maipatupad. Hangad ko ang tagumapy ng bawat isa sa atin," he said.

Natividad, the outgoing Director, a short

but accomplished stint in PRO CALABARZON left a significant mark especially on the fight against insurgency and terrorism in the region with the Project SIKAP or Sitio Kapayapaan and SIKHAY or Sikap Buhay for Former Rebels. "With all of these achievements, hindi ko maipagkakaila na maswerte ang aking pagiging Regional Director dito sa rehiyon dahil mayroon akong mga tauhan na disiplinado, magagaling, at masisipag. Even when we had to face unusual challenges, hindi parin kayo bumibitaw at nananatiling tapat sa inyong serbisyo," he said during his farewell speech while thanking the men and women of PRO CALABARZON for their cooperation during his administration. Natividad is set to lead the Special Action Force replacing Maj Gen Bernabe Balba.

DPWH INSPECTS CALAX PROGRESS



Biñan City - The Department of Public Works and Highways Sec Mark Villar along with executives from MPCALA Holdings Inc. (MCHI) inspects the progress of CALAX Subsection 5, which is slated to be opened to motorists this third quarter of 2021.

CALAX Subsection

5 is a 7.2km, 2x2 lane expressway that will link Sta. Rosa-Tagaytay Road to Silang, Cavite. Once operational, this section of CALAX is expected to serve 5000 vehicles daily, helping decongest traffic along Governor's Drive, Aguinaldo Highway, and Sta. Rosa-Tagaytay Road.

Seen during the drive-through inspection are toll structures of the upcoming Silang East interchange, and other miscellaneous works being conducted to ensure road quality and safety of motorists in the expressway.

"I am very pleased that despite the mobil-

ity challenges brought about by the pandemic, construction for CALAX Subsection 5 remains on track and would soon be made available to motorists in the third quarter of 2021. It is a vital portion of CALAX that would help accelerate economic progress of Region IV-A, as it links

the two provinces of Cavite and Laguna," stated DPWH Villar.

MPCALA President and General Manager, Robert Bontia further shared that as of date, CALAX Subsection 5 is already 94% completed. Like DPWH, they look forward on the segment helping spur growth to the community and the Region.

Simultaneously, MPCALA and DPWH have started and have reached 18.3% construction progress of the next 2.8km CALAX Subsection 4 which will link Aguinaldo Highway to the upcoming Silang East interchange and this segment is set to be completed by 2022.

"DPWH continues to exert full effort in the acquisition of right-of-way for all the remaining segments to be able to deliver the project by the end of 2022", added Villar.

The currently operational segments of

CALAX run from Mampalasan to Sta. Rosa, Laguna and serves around 10,000 vehicles daily.

Upon completion, CALAX will span 45-kilometers with eight (8) interchanges at the following locations: Kawit, Governor's Drive, Open Canal, Silang (Aguinaldo) Highway, Silang East, Santa Rosa-Tagaytay, Laguna Boulevard, and Laguna Technopark. It shall serve about 45,000 vehicles while cutting travel time between Cavite and Laguna from 2 hours to under an hour.

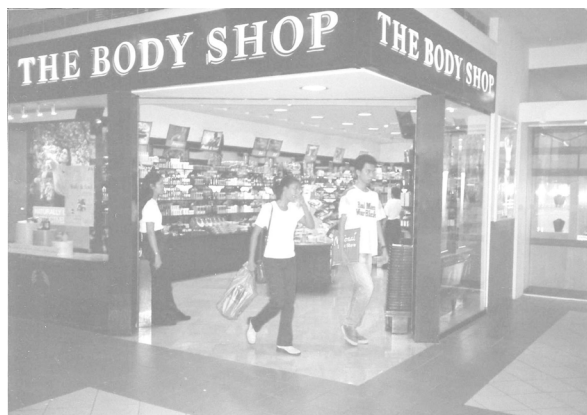

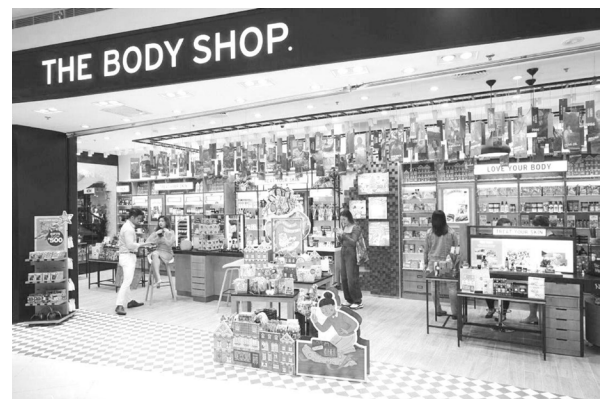
