As of September 16, 2021, the Regional Epidemiology and Surveillance Unit recorded 406 Delta Variants with Laguna having the highest number of cases at 112 followed by Cavite with 99 cases, Rizal with 83, Batangas - 65, Quezon - 33 and Lucena City with

14 cases.

Most source of Delta infection comes from local transmission with 355 cases with the largest number also from Laguna with 102 cases followed by Cavite with 82 cases, Rizal - 78, Batangas - 52, Quezon - 28 and Lucena City with 13 cases.

A total of 51 Delta cases came from Returning Overseas Workers (ROF) with Cavite topping the list with 17 cases followed by Batangas with 13, Rizal and Quezon with 5 cases each and Lucena City has one case.




