

## CALABARZON GENERALLY PEACEFUL IN THE PAST 6 MONTHS

Lim, Calamba City -Region-Calabarzon al Director Brig Gen Eliseo DC Cruz lauded the men and women of Police Regional Office CALABARZON for all the efforts and hard work in making the region generally peaceful for the past six months since he assumed as the top cop of CALABARZON on May 10, 2021.

"The past months have been tremendously hard and challenging for all of us. But as we look back, I must say that everyone deserves a tap on their back for being resilient and optimistic amid all the trials. Cruz said the police force of PRO CAL-ABARZON along with the other government agencies, stakeholders and the community had been working hand-in-hand to ensure peace and order in the region.

"Malaking bahagi ng kaayusan at katahimikan ng rehiyon ay dahil sa tulong ng ibang ahensya ng gobyerno, stakeholders, lalong-lalo na ang mamamayan ng CAL-ABARZON na patuloy nakikpagtulungan sa pagsugpo ng kriminalidad sa ating bayan," he said.

For the past 6 months, the Regional Investigation and Detective Management Division has documented 25, 372 total crime incidents.

There is a decrease in the crime incident by 1.17 % or 300 incidents compared to July - December 2020 with 25, 672 crime incidents.

More so, based on the report, a total of 14, 850 or 96.15% of cases were cleared and 12, 735 or 82.45% were solved for the last 6 months this year.

"I always see to it that cases should be solved with utmost dedication because that is what a law enforcer should do. We give justice to the family of victims and put behind bars the criminals," Cruz added.

Cruz highlights the successful solution of the death of Lorena Presbitero De Jesus, Chairman Barangay of Brgy. Kanluran, Sta Rosa City, Laguna that happened last November 22, 2021 inside Pares Mami Store, beside Brgy. Kanluran Health Center and Barangay Hall of Brgy.

According Cruz, he has been on top of the case and ordered the authority to conduct in-depth investigation. As a result, in the CCTV footages, suspects' description was captured, victim's daughwho witnessed the incident identified the suspects as: (1) Darby Gonzales Bernilla a.k.a Brad, a resident of No. 46 National Highway, Brgy. Tagapo, Sta Rosa City, Laguna and Rustom Bryle Yambao Maramba a.k.a Teban/Utum, a resident at Maramba Compound, Añonuevo St., Brgy. Kanluran, Sta Rosa City, Laguna.

Through the concerted efforts of the Sta Rosa City Police Station, on December 15, 2021, the daughter of the victim filed a case to suspects for Violation of Article 248 of Revised Penal Code or Murder for conspiring to kill the late Barangay Chairman Lorena Presbitero De Jesus. The case was filed at the Office of the City Prosecutor of Sta Rosa, Sta Rosa City, Laguna docketed under IS No. IV-19-INV-21L-00588 duly received by Assistant City Prosecutor James E. Villanueva.

On the report dated May 10 - December 26, 2021, there is a total of 1,776 recorded Arrested Most Wanted Persons and 4,393 for the other Most Wanted Persons.

Cruz also said that he put the police force on alert during Christmas and New Year to ensure peaceful and safe celebration



### PETITION

PETITIONER, thru the Undersigned Counsel, unto this Honorable Court most respectfully stated that:

- 1. PETITIONER is single, Filipino, of legal age and a resident of Unit 609 Vivant Flats, Filinvest, Muntinlupa City. RE-SPONDENT SPS. ISIDRO FAUSTINO & MAURA DAVID FAUSTINO are both, of legal age, Filipinos and with postal address at 12 Gen. Segundo, Quezon City where they may be served with summons and other processes of this Court. RESPONDENT Registry of Deeds is impleaded as the public official tasked with the issuance and recording of certificates of title over real properties found in his territorial jurisdiction. He may be served with summons and other processes of this Court at the Office of the Registry of Deeds, Capitol Compound, Trece Martires City,
- Respondent SPS. ISIDRO FAUSTINO & MAURA DAVID FAUSTINO are the registered owners of a parcel of land located in D.S Realty Inc, Brgy. Sampaloc 4, City of Dasmariñas, Cavite consisting of One Thousand Eighty Nine (1,089 sq.m), covered by Transfer Certificate Of Title No.5627251 issued by the Register of Deeds for the Province of Cavite. The property has been registered for real taxation purposes in their names.2
- 3. For failure of the respondent to pay the real property tax on the property, the City Government of the City of Dasmariñas, Cavite levied on the property 3 and sold the same at a public auction conducted on April 6, 2018 at the Audio Visual Room 3rd Floor, Pagamutan ng Dasmariñas, City of Dasmariñas, Cavite.
- 4. PETITIONER, being the highest bidder, acquired the propertv. 4 The Certificate of sale of Delinquent Property was registered and annotated on page 5 of the title as Entry No. 2018052854 on August 8, 2018.5
- 5. The one-year redemption period lapsed on August 8, 2019 without the respondent SPS. ISIDRO FAUSTINO & MAURA DAVID FAUSTINO their right of redemption as a consequence of which the City Treasurer of the City of Dasmariñas, Cavite issued a Final Deed of Conveyance.<sup>6</sup>
  6. On August 28, 2019, the PETITIONER consolidated ownership
- of the property in her favor thru an Affidavit of Consolidation of ownership.
- 7. The original copy of Transfer Certificate of Title No. T-562725 is existing and intact in the files of the Register of Deeds of Province of Cavite.8

8. In view of the sale of the property to the PETITIONER by the City Government of Dasmariñas, Cavite and the failure of the private respondent redeem the same within the one-year reglementary period and the consequent consolidation of ownership over the property in his favor, the Transfer Certificate of Title No. T-562725 should be cancelled and a new one issued in the name of herein PETITIONER, CINDERELLA C. JAVIER, single, Filipino, of legal age.

9. Section 78 of Act No. 496 and Section 75 of PD No. 1529 provide that:

Section 78 of Act 496 reads:

Sec.78. Upon the expiration of the time, if any allowed by law for redemption after registered land has been sold on any execution, or taken or sold for the enforcement of any lien of any description, the person claiming under the execution or under any deed or other instrument made in the course of the proceedings to levy such execution or enforce any lien, may petition the court for the entry of a new certificate to him, and the application may be granted: Provided, however, That every new certificate entered under this section shall contain a memorandum of the nature of the proceeding on which it is based: Provided, further, That at any time prior to the entry of a new certificate the registered owner may pursue all his lawful remedies to impeach or annul proceedings under execution or to enforce liens of any description.

Section 75 of PD 1529 provides:

- Sec.75. Application for new certificate upon expiration of redemption period. 'Upon the expiration of the time, if any, allowed by law for redemption after the registered land has been sold on execution, or taken or sold for the enforcement of a lien of any description, except a mortgage lien, the purchaser at such sale or anyone claiming under him may petition the court for the entry of a new certificate to him.
- 10. The owner's copy is in the possession of the registered owner, private respondent SPS. GILBERT C. GAW & BEE CHU GAW. Since they have lost all their rights over the property, they should be ordered to surrender the same for its cancellation.
- 11. Section 107 of Presidential Decree (P.D.) No. 1529 provides

SECTION 107. Surrender of withheld duplicate certificates. Where it is necessary to issue a new certificate of title pursuant to any involuntary instrument which divest the title of the registered owner against his consent or where a voluntary instrument cannot be registered by reason of the refusal or failure of the holder to surrender the owner's duplicate certificate of title, the party in interest may file a petition in court to compel surrender of the same to the Register of Deeds. The Court, after hearing, may order the register owner or any person withholding the duplicate certificate to surrender the same, and direct the entry of a new certificate or memorandum upon such surrender. If the person withholding the duplicate certificate is not amenable to the process of the court, or if [for] any reason the outstanding owner's duplicate certificate cannot be delivered, the court may order the annulment of the same as well as the issuance of a new certificate of title in lieu thereof. 



## Construction of New Iconic Bridge in Manila Now 88% Complete

he Department of Public W or k s and Highways (DPWH) has started with the massive installation of prefabricated girders for abutments and ramps of the iconic Binondo - Intramuros Bridge Project in Manila.

In his report to DPWH Acting Secretary Roger G. Mercado, Undersecretary and Build Build Build (BBB) Chief Implementer Emil K. Sadain said that already lifted on piers were steel box girder components for the up-ramp at Intramuros side with a total length of 191 meters and between pier 5 to near pier 8 for the viaduct structure over Estero de Binondo and corresponding ramp at Binondo side.

Undersecretary
Sadain, in-charge of
DPWH Unified Project
Management Office
(UPMO) Operations,
said that the overall
progress of the bridge
project implemented
by UPMO - Roads Management Cluster 1 (UP-

MO-RMC 1) is now at 88.63 percent.

Simultaneously, manpower and equipment resources are also doing the lifting of pre-fab girders for the 298 meters up-ramp at Muelle dela Industria side.

"We are expecting a lot of dramatic changes for this project, with all the needed materials and high-performance launching equipment available on the construction site", Undersecretary Sadain told contractor China Road and Bridge Cor-

poration following his inspection with UPMO RMC 1 Project Director Benjamin A. Bautista, Project Manager Melchor Kabiling, and Project Engineer Joey Doria.

The Binondo-Intramuros Bridge Project involves the construction of 680 linear meter bridge connecting historic district of Intramuros at Solana Street and Riverside Drive with the bustling district of Binondo at Rentas Street/Plaza del Conde Street and Muelle dela Industria.

With an already completed basket-handle tied steel arch main bridge over Pasig River, DPWH is targetting to finish the project by the first half of 2022.

Initially, the new bridge would be completed by end of 2021.

However, DPWH had to push back the project timeframe to relocate public and private services and utilities in the area as well as to wait on the pre-fabricated steel materials to come in from China. The project was also affected

The ₱3.39-Billion bridge project is financed by a grant aid rom the People's Republic of China.

Considered one (1) of the flagship infrastructure projects of DPWH under the Build, Build, Build Program, the bridge project is expected to not only cut travel time between the two busy districts of Intramuros and Binondo in Manila but also benefit approximately 30,000 vehicles daily.

## CALABARZON STARTS COVID-19 BOOSTER ROLL-OUT

C

alamba City - De-

partment of Health (DOH) Secretary Francisco Duque III led the booster ceremonial vaccination for senior citizens and immunocompromised individuals of CALABARZON (Cavite, Laguna, Batangas, Rizal, Quezon) held at DREAM Zone, Capitol Compound, Batangas City, which is also the designated vaccination site of the province.

"This third shot of Covid-19 vaccine will provide the optimum protection from the virus. It is essential to strengthen the efficacy of the two doses of vaccines received," Duque reiterated.

The Covid-19 booster campaign for senior citizens and individuals with comorbidities and immunocompromised started on Monday, November 22, 2021. "This is to enable our elderly population to have an extra vax, and for them to become fully vaccinated and protected against the virus," Duque emphasized.

He also pointed out that individuals who have received two vaccines can choose which booster shot they prefer depending

on the availability of vaccine brands at the vaccination site.

Vaccines from Moderna, Gamaleya Sputnik, Pfizer and AstraZeneca have been approved by the Food and Drug Administration (FDA) to be used as a third dose.

Person with comorbidities and immunocompromised individuals who are eligible to receive the booster shot includes those with immunodeficiency state, people living with HIV, active or malignant cancer, transplant patients and patients under immunosuppressive treatments.

DOH-CALABAR-ZON Regional Director Ariel Valencia added that individuals who are eligible for booster doses can have their shot at any vaccination site by presenting their vaccination card and a valid ID.

A total of 3 million individuals are targeted for booster shots in the region.

As of November 22, 2021, the regional office recorded

BARZON (Cavite, Laguna, Batangas, Rizal, Quezon) again obtained the highest number of vaccinated individuals during the second day of the 30-day national vaccination days being conducted by the national government with a total of 360,444 jabs administered for day 2.

CALABARZON was followed by Central Visayas (Region VII) with 197,442, Western Visayas (Region VI) – 174,782 and Bicol Region (Region V) – 158,579.

The total jabs administered during day

884,737 or 79% of senior citizens (priority group A2) are now fully vaccinated from the 1,117,555-target population while a total of 922,318 or 56% of persons with comorbidities received full vaccination from the 1,636,173-target population for priority group A3.

For the whole of CALABARZON, a total of 70% of the eligible population or 11,452,775 individuals need to be vaccinated. There are 7,060,956 individuals who received their first dose and a total of 5,190,892 are now fully vaccinated

1 was 384,452 plus 360,444 for day 2 for a total of 744,896 or 63.9% accomplishment for the 1 million jabs target for the national vaccination days (NVD).

The province with the highest number of administered Covid vaccine for day 1 and 2 is Laguna with 175,784 doses followed by Cavite with 173,683 doses, Batangas – 168,389, Rizal – 116,578, Quezon – 95,079 and Lucena City with 15,383 doses.

The National Task Force Against Covid-19 (NTF) and the National Vaccination Operations Center (NVOC) has recently lowered the target of 15 million doses to be administered during the 3-day "Bayanihan Bakunahan" to 9 million jabs due to the global shortage in syringes specifically intended for the Pfizer-BioNTech vaccines including the delay in the scheduled shipment of the procured supplies made through the Unicef (United Nations Children's Fund).

The NTF and NVOC are now expecting to administer Covid shots to at least 3 million people as its new target.


For CALABARZON, the new target set is at 1 million doses for the 3-day NVD.

Regional Direc-

tor Ariel Valancia has already addressed issues regarding booster shots for the A3 priority groups. "We have already accommodated senior citizens and immunocompromised individual prioritized their jabs especially when they are already at the vaccination sites."



The order also prohibits the illegal manufacture, use and sale of the Super Lolo, Atomic Big, Triangulo, Mother Rockets, Lolo Thunder, Five Star, Og, Pla-Pla, Pillbox, Watusi, Piccolo, Giant Whistle Bomb, Big Judah's Belt, Large Bawang, Bosa, Goodbye Philippines, Goodbye Earth, Bin Laden, Coke in Can, Kabasi, including overweight firecrackers with more than 0.2 grams or 1/3 teaspoon of explosives, as well as those with short fuses or those that detonate in less than three seconds but no more than six seconds.

Likewise, firecrackers without labels and those which contain sulfur or phosphorous combined with chlorates are also prohibit-


ed.

"We have been promoting "only fireworks community displays", provided of course they have authorization of their local government unit." Valencia added.

He also reiterated the health department's directive discouraging the use of horns and whistles, especially by kids, to prevent the spread of the corona virus which is through airborne or respiratory droplets. CALABARZON recorded a total of 5 cases of fireworks-related injury last year.
