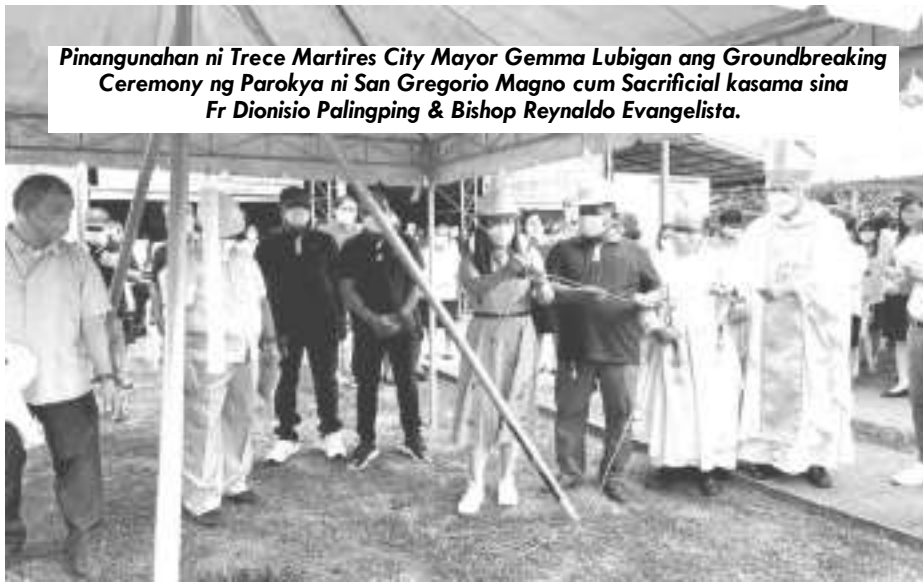

Lumabas sa pag-aaral ng ilang mga eksperto mula sa bansang Denmark na higit umanong mas nakakahawa ang BA.2 subvariant o mas kilala sa tawag na 'Stealth Omicron' kaysa

sa orihinal nitong strain.

Ang nasabing pag-aaral ay isinagawang nitong Disyembre 2021 hanggang Enero sa kasalukuyang taon kung saan napag-alamang nasa 39% ang tyansa na mahawa ang

isang indibidwal na na-expose sa BA.2 positive na pasyente sa loob ng 7 araw habang 29% naman sa BA.1 subvariant.

Ayon din sa mga eksperto, mas mabilis kumalat ang BA.2 subvariant sa mga 'unvaccinat-

ed' o 'di pa bakunadong indibidwal.

Matatandaang nito lamang Enero 26, kinumpirma ng Department of Health (DOH) na mayroon nang kaso ng BA.1 at BA.2 sublineages sa bansa.

Sa isang pahay-

ag, sinabi ni Health Undersecretary Maria Rosario Vergere na karamihan sa mga balikbayang Pinoy ang nakakita ng BA.1 subvariant habang ang BA.2 naman ay karaniwang makikita sa mga lokal na kaso sa lahat ng re-

hiyon sa bansa.

Ayon naman sa ulat ng Philippine Star, tinawag na 'Stealth Omicron' ang nasabing subvariant dahil sa katangian nito na mas mahirap matukoy kahit gumamit ng 'gold standard' na RT-PCR testing kits.

CALABARZON HAS A NEW POLICE REGIONAL DIRECTOR

Camp Vicente Lim, Calamba City - Brig Gen Antonio Yarra took the helm of leadership as the newly installed Regional Director of Police Regional Office CALABARZON in a simple turn-over ceremony held this camp.

Presided over the Deputy Chief, PNP for Operations, Lt Gen Israel Ephraim Dickson, the office symbol, property, equipment inventory book, unit saber, unit color, and property book were turned-over by the outgoing Regional Director, Brig Gen Eliseo Cruz accepted by the incoming director.

Delivering his message, Yarra acknowledged the achievements of his predecessors and

the previous regional directors of PRO CALABARZON who have done the most of the thinking and instituted into the PNP system. "We don't have to reinvent the wheel. What we should do is to improve on the actions they took to have better results," he said.

Yarra briefly presented his 4A's ideals to PRO CALABARZON personnel. "As we work together starting today, let us embody the ideals of the PNP. We will do that by developing Aptitude, by taking Action, by having the right Attitude, and by facing Accountability. Encourage the local government officials and the communities you serve to join us in our quest to having a safer CAL-



ABARZON through the 4A's," he explained.

Prior to his designation as the Regional Director, he spent almost one third of his police career in PRO CALABARZON. Yarra served as Chief Comptrollership in 2014, Quezon

Police Provincial Director in 2016 and Deputy Regional Director for Administration in 2020. After his stint in PRO CALABARZON, he was assigned at NCRPO as Deputy Regional Director for Operations and Administration respec-



tively. In April of 2021 he was designated as the District Director of Quezon City Police District.

In his closing message, he asked the entire CALABARZON police force to join him in the journey guided by the 4A's while building the culture of service, honor, and justice. "As professional police officers, I believe that we all

know what we ought to do. We should have the moral courage to stand for what is right and to uphold the rule of law," he concluded.

Yarra is a member of PMA Class "Sambisig" of 1991. He replaced Cruz who is set to lead the Area Police Command, in Visayas as the Acting Deputy Commander. (ROSELLE AQUINO)

ONE (1) DIED, 309 ARRESTED IN CAVITE'S THREE-DAY SIMULTANEOUS ANTI-CRIMINALITY LAW ENFORCEMENT OPERATION (SACLEO)

Cavite Police Provincial Director, Police Colonel **ARNOLD E ABAD** reported to **CALABARZON Regional Director, Police Brigadier General ELISEO DC CRUZ** on the arrest of 309 personalities and one (1) reportedly neutralized out of 192 operations in Cavite Police Simultaneous Anti-Criminality Law Enforcement Operation (SACLEO) drive conducted from January 26-28, 2022.

This aims to intensify the reduction of crimes in hotspot areas and notorious criminals by focusing in the service of Warrant of Arrest, operation on Illegal Drugs, Gambling and Illegal Possession of firearms.

A certain **Diego Flores y Senupe**, male, 39 years old, native of Ilo-Ilo was neutralized in an armed encounter during buy bust operation conducted by elements of Naic PNP on January 28, 2022 in Brgy Timalan

Concepcion, Naic, Cavite. The suspect was neutralized after trading shots with the operatives.

Cavite Police conducted 116 anti-illegal drugs operations which resulted in the arrest of 193 illegal drug personalities (13 users and 180 pushers) and confiscation of 393 pieces of small size heat-sealed transparent plastic sachets containing white crystalline substance suspected as shabu, three (3) pieces of small HSTPS of dried leaves suspected as marijuana and other drug paraphernalia.

On warrant of arrest, a total of 56 persons were arrested which include the arrest of 23 Most Wanted Persons in the Regional, Provincial and City/Municipal Manhunt Charlie List.

A total of 21 firearms were deposited to the police for safekeeping while their licenses are being processed.

Moreover, operations against loose firearms re-

sulted in the arrest of four (4) personalities and confiscation of four (4) units of cal.38 revolver and ammunition while another unit of caliber.38 revolver was recovered from the drug suspect neutralized in Naic, Cavite.

Whereas, out of 16 operations conducted against illegal gambling, 56 individuals were arrested and confiscated cash money amounting to Php 8,089.00 and several gambling paraphernalia.

Arrested suspects and pieces of evidence were brought to Cavite Provincial Crime Laboratory Office (SOCO) for laboratory examination

while Criminal Complaints for Violation of RA 9165 otherwise known as "Comprehensive Dangerous Drug Act of 2002" and Violation of RA 10591 and Violation of PD 1602 are being prepared for filing before the Prosecutor's Office while all wanted persons were turned over to the court of origin to face criminal charges.

Cavite Police Provincial Office, simultaneous police operation seemingly gained a positive result which is projected to favorably contribute to the decline of crimes within the Area of Responsibility of Cavite. **(CAV-PIO/ Margie Bautista)**

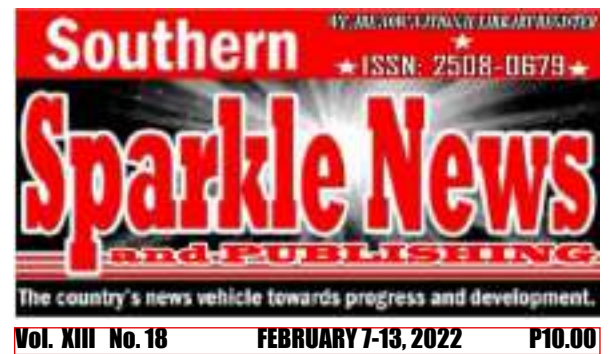
