## CALABARZON's Crime Rate Drops on First Quarter of the Year

ABARZON's Crime Incidents have decreased by 8.16% or 1,142 incidents on the 1st Ouarter 2022 as compared to the 4th Ouarter 2021 according to the data gathered from the Regional Investigation and Detection Management Division.

CALABARZON's Average Monthly Crime rate for the first quarter of year 2022 recorded an average of 16.86, which is 0.85% lower from the 17.01 Average Monthly Crime Rate that was recorded in the last quarter of year 2021. The crime against person specially Rape has decreased by 58, Murder by 26 and Physical Injury by 12. Crimes along the streets have decreased by 37 from 165 to 128 while crimes incidents in residential areas have decreased by 44 from 330 to 286.

This drop in crime rate can be attributed as an incidental effect of the relentless collabora-

tive efforts in the grassroots level up to the topmost level of the PNP in order to maintain peace and order ,especially this election period. The strong and sincere desire of the PNP Command led by the Chief PNP Gen Dionardo Carlos to have a peaceful community and fair election is manifested by intensified police efforts such as but not limited to the strategic conduct of Checkpoints, patrolling, police visibility and investigation among others.

"We would exert more attention on these areas and I already instructed the station commanders as well as the Provincial Directors to focus on doubling police visibility and intensify their safety awareness campaign to


address these concerns," said Brig Gen Antonio Yarra, the Regional Director of Police Regional Office 4A.

With this drop of crime rate this first quarter of 2022 as compared to the last quarter of 2021. PRO CALABAR-ZON will not settle and instead will continue to adopt means and measures to further improve in order to perform its mandate focusing on the maintenance of peace and order.

## **BFPNCR CITES GAINS IN FIRE PREVENTION MONTH 2022 DRI**



he cost of damage due to fire incidents in the month of March this year has significantly decreased by 62.18 percent compared to the amount of damage in the same period last year, according to the records of the Bureau of Fire Protection National Capital Region Office (BFPNCR)

The record shows total amount of P27,576,035.00 estimated worth of properties went up in smoke from March 1-31 during the Fire Prevention Month observance, compared P72,904,800.00 worth of damages posted in last year's period.

The top causes of fires are: electrical ignition caused by arcing, 17.9 percent; smoking, 16.4 percent, electrical ignition caused by overloading, 9.9 percent; and, electrical ignition caused by loosened connection, 7.7 percent.

The decrease was attributed to the vigilance of BFPNCR firefighters in the implementation of various calculated fire safety plans and programs initiated by the command that include: Metro-wide Kickoff Motorcade by BFP and volunteer firefighters and other stakeholders on March 1; display of fire prevention month infomercial on light emitting diodes (LED) advertising billboards in shopping malls and other LED billboard advertis-

BFPNCR five district commands' online streaming broadcast through Facebook Live that intensify further the month-long campaign which has reached around 320,568 views, so far, aside from television and radio interviews, and press conferences.

The Fire Prevention Symposium on various fire safety topics simulcast on Facebook Live was also held with the participation of 249 volunteer groups and other stakeholders.

During the formal culminating activity held on April 4 at BF-Headquarters in Cubao, Quezon City,

Regional Director Chief Superintendent Gilbert D. Dolot acknowledged the concerted efforts of all his command's firefighters and personnel, the BFP hierarchy, and other stakeholders in the success of this year's fire prevention month advocacy.

The event guest of honor and speaker Land Transportation Office Law Enforcement Service Acting Director lawyer Clarence V. Guinto, also commended the entire BFP NCR Command for launching the series of efficient and massive fire prevention activities that resulted to the significant decrease in property loss due to fire.

Certificates of recognition were also hand-

ed over to distinguished personalities while the winners of Advocacinema contest, Skills Olympics 2022 events and overall champion, and the much-awaited Miss Skills Olympics 2022 also awarded were during the final culmination rites.

Various fire stations were also awarded, such as: Navotas City Fire Station for having zero structural fires in the whole month of February this year; Marikina City Fire Station for zero structural fire from January to March this year and for having 69.07 percent decrease in fire Incidents.

San Juan City Fire Station for zero structural fire from January to February 2022; Pasig City Fire Station for posting a huge 572.19 percent increase in the Fire Code Fees collection; and, Quezon City Fire District for achieving a 100.27 percent increase in establishment inspection target.

UEZON CITY - The newly constructed Quezon City Jail (QCJ) situated in the 2.4 hectares property in Barangay Payatas, Bagong Silangan is seen as the opportune solution to address the congestion problem that beset the old QC Jail located at EDSA corner Kamuning Road in this city for a very long time.

The facility which is considered as the most modern and most spacious jail facility today adheres to international minimum standard for humane safekeeping and development of persons deprived of liberty (PDL).

posed of three buildings comprising 440 cells with 47 square meter jail cell size per 10 PDLs occupant. Each cell is provided with adequate water, entry of light and air adhering to the standard requirement of the **International Committee** 

Also included in the amenities are non-contact visitation area, laundry section, livelihood training space, sports and recreational areas, and medical infirmary. It is also equipped with closed-circuit television, elevator and automatic sprinkler system.

The administrative

building and billeting for personnel were also integrated in the facility.

The new jail has an ideal capacity of 4,400 PDL with a total cell area of 20,880 square meters, which is adopted to the United Nations Minimum Standard of an ideal living area of 4.7 square meter per PDL.

The construction of the new QCI facility started in four years ago under the Deed of Usufruct signed by and between the City Government and the BJMP for the latter's 25-years use, renewable for another 25 years.

The project total

cost is P1.397 billion, with a separate budget of P39 million from OC government for the construction of Phase 1 perimeter fence construction. Mayor Belmonte announced that another P100 million was allocated for the construction of the final Phase 2 perimeter fence.

After the Phase 2 fence is erected, then that is only the time for the QC Jail to finally transfer to the new facility from its old 2,790 square meters property in Kamuning Road, which is currently congested at 1,247 percent. (Benjie Murillo)

## PRO CALABARZON **Identifies Possible** Election Hot Spots in the Region

cente Lim. Calamba City - PRO CALABARZON under the leadership of the Regional Director, Brig Gen Antonio Yarra identified the different possible election hot spots in the area of CALABARZON categorized under Yellow and Orange Category.

The election hotspot list has three categories which include Yellow, Orange, and Red.

Election hotspots are classified according to the presence of intense political rivalry, presence of armed group and if threat of insurgency is eminent. Presence of one factor in the city or municipality falls under Yellow Category, presence of two falls under Orange Category or immediate concern and presence of all three factors falls under Red Category or grave concern,

that may warrant the motu proprio declaration of COMELEC control. History of election-related incidents in the last two elections are one of the considerations taken in identifying election hotspots, aside from the result of current continuous information gathering being undertaken.

Under yellow category, 5 were identified in the Province of Cavite, 2 in Laguna, 12 in Batangas, 1 in Rizal, and 2 in Quezon Province. On the orange cat-





COMES NOW, petitioner through the undersigned counsel unto this Honorable Court respectfully avers THAT:

### THE PARTIES

- 1. Petitioner, Flora Mae A. Rulona, is legal age, Filipino, married and a resident of no.46 Apitong, St., Brgy. San Jose, Wood Estate Village, Dasmarinas City, Cavite, where she may be served with Summons, Notices and Resolutions of this Honorable Court. (Copy of Contract of Lease, PLDT Billings, Brgy, Certificate and Attestation/Verification are hereto attached as Annexes "A" to "D" respectively.
- 2. Respondent, Melcicedick M. Deliman, is of legal age, Filipino, married and previously a resident of Cabacnitan, Batuan, Bohol (present address unknown), where he may be served with Summons, Notices and Resolutions of this Honorable Court.

#### THE FACTS

- 3. Petitioner's parents are engaged in the business of selling or supplying seafoods in BQ Mall and other restaurants in Bohol.
- 4. In 2006, petitioner who always accompanied her parents' de-

livery staff in almost all customers, met the respondent at BQ Mall, Bohol who was then working there as promodizer. As promodizer he would assist the receipt of delivery items or supplies in the said mall. At that moment, respondent took the cellphone number of the petitioner and started texting and calling.

- 5. After three (3) months of courtship, petitioner answered the respondent who initially showed kindness and gentlemanly character. Later, after few months of their relationship the petitioner got pregnant.
- 6. On August 25,2007, the petitioner, Flora Mae A. Rulona and respondent, Melcicedick M. Deliman got married at Roman Catholic Church, Calape, Bohol. Thereafter, they lived in petitioner's parent's home in Bentig, Calape, Bohol. At that time of their marriage ceremony respondent was 26 years old while the petitioner was 21 years of age.(Copy of the Marriage Certificates, Birth Certificates of petitioner and respondent are hereto attached as *Annexes "E" to "G"*)
- 7. On December 16,2007, Flora Mae Rulona gave birth to Josh Deliman in a certain hospital in Bohol. Respondent visited her at the hospital and signed the birth certificate and then left without the word. She noticed that her husband was not happy and neither showed care towards the child. Respondent hurriedly went out to meet his drinking buddies. (Copy of the Birth Certificate of Josh Deliman is hereto attached as Annex "H")
- 8. After few days of their marriage, respondent left his job in BQ Mall. He completely depended on the income generated by his wife. He is lazy and refused to find work to support the family. Respondent was almost always drunk and even showed violent behavior towards her and to others. In one instance, when her husband was drunk, she touched his arm, but her husband twisted her arm for no reason which almost broke her arm. Petitioner was shocked at the incident. Respondent also threw stones to their neighbor houses when he is drunk and stole chickens. They would always quarrel every time they met and under the same roof. The only instance that their quarrel ceased is when petitioner was away for a job or business.Respondent would usually asked money from the petitioner to buy alcoholic beverages.
- 9. Further, Flora Mae was informed that her husband was taking marijuana, a prohibited drug. Respondent would always put a bolo under his pillow when he is sleeping because according to her husband, there was somebody trying to kill him. This is a clear indication of hallucination possibly caused by illegal drugs. Petitioner has no choice but to sleep despite fear on her life.
- After several months without a work, respondent applied for work in a certain restaurant, but resigned few weeks after. Respondent is satisfied with his life. He is totally depended on the income of his wife. He has no ambition or plan for the future of their family.
- 11. Petitioners's parents helped her husband by hiring him to assist her parents in the delivery of seafood to various customers, but after few weeks, her husband left their abode without notifying them. Then he returned after few months.
- 12. Later, respondent insisted that they should live at her husband's parents. To avoid discussion, petitioner acceded.
- 13. Every two (2) weeks petitioner would return to her ancestral home, bringing with her various fruits and other agricultural products to be sold. She tirelessly worked to support their family even without the financial and moral support from her husband.
- 14. Respondent would usually curse her and got mad without apparent reason. While she was away selling various fruits, her husband would always drink alcohol with his buddies without thinking if their child, Josh Rulona Deliman was hungry or not. Her husband would always act as if he was single.
- 15. In 2009, petitioner left Bohol and went in Quezon City where she worked in Esguerra St., in the same city. Later, he resigned and underwent call center training in Makati City. While she was in Quezon City she left their child in the custody and care of respondent. But, respondent was irresponsible who could not care and support their only child, so he surrendered the custody of the child to the parents of petitioner. Not long after, she went home in Bohol and tired to live with respondent. She was hoping that her husband would become
- 16. In January 2010, petitioner returned in Bohol and lived again with respondent. But after few weeks, they again separated. She also worked there in a call center company.
- 17. In 2011, petitioner departed Bohol and went to Cebu and worked again in a call center company which offered a higher salary. Later, she applied and worked in online call center as agent. Even if respondent and petitioner went separate ways, the former continued to ask money from the parents of the latter for his personal needs and for expenses in his application for work. The respondent always asked money from petitioner's parent since they were married until present. Sometimes, her husband would send money for the child, but after few days, he would ask twice the amount from petitioner's parents.
- 18. In 2014, petitioner left Cebu and came here in Metro Manila and went on to reside in Brgy. San Jose, Dasmarinas, Cavite. She is currently working as online business to support herself and their child in Bohol. Twice a year she would visit their child who is in custody
- 19. In 2010, respondent also left in Bohol and according to her relatives, he came here somewhere in Metro Manila, but the exact address is unknown. Since their separation in 2010, they have no more communication.

- 20. During their living together as husband and wife, they did not
- 21. Thereafter, petitioner sought the services of clinical psychologist, Dr. Lara A. Maguad who found that petitioner suffers general personality disorder while respondent suffers antisocial personality disorder making them both psychologically incapacitated to perform the essential marital obligations. Their defect is incurable, grave and exists even prior to their marriage, but manifests only after their marriage.
- 22. Part of the Comprehensive Personality & Behavioral Assessment issued by clinical psychologist Dr. Lara A. Maguad provides:

#### "RECOMMENDATIONS"

The mentioned behavioral and personality manifestations of the petitioner, Flora Mae Rulona-Deliman is similar to the behaviors manifested by an individual suffering from **General Personality Disorder** (DSM-5, 2013). On the other hand, the respondent Melcicedick manifests behavioral and personality manifestations similar to an individual suffering from **Antisocial Personality Disorder** (DSM-5,2013).

The general personality disorder of the petitioner, Flora Mae Rulona-Deliman suggest a psychological incapacity on her part to perform the essential marital obligations due to developing a different perception of herself, other people, and events as well as how easily she could get affected by the actions of other people. These manifestations lead to her being tolerant and afraid, but still trust her husband. The petitioner was easily swayed by the respondent's quiet and gentlemanly nature. Such pathological behavior caused feeling of helpless, being trusting, easily being affected by the reaction and actions of the people around her, limited adaptive skills, and being inadequate thus making her not capable to perform her role as a wife to the respondent and caused a failure to render mutual and appropriate respect and support to the respondent, Melcicedick Deliman.

The antisocial personality disorder of the respondent, Melcicedick Deliman. Suggest a psychological incapacity on his part to perform the essential marital obligation due to pervasive pattern of disregard for and violation of the rights of his wife, the petitioner and their son. These manifestations lead to his lack of remorse, violation of laws and respect, and emotionally and verbally abusing his wife. Thus, making him incapable of performing his role as a husband to the petitioner and caused a failure to render mutual and appropriate respect and support to the petitioner, Flora Mae Rulona-Deliman.

Since the above personality disorders incapacitate the petitioner and respondent to perform their essential marital obligations to each other, reconciliation is impossible and totally not healthy as this will only cause continuous suffering to petitioner,respondent and their son. It is therefore recommended that the marriage be nullified." (Copy of the Comprehensive Personality & Behavioral Assessment is hereto attached as Annex "1")

23. Art. 36 of the Family Code provides:

- "Art. 36. A marriage contracted by any party who, at the time of the celebration, was psychologically incapacitated to comply with the essential marital obligations of marriage, shall likewise be void even if such incapacity becomes manifest only after its solemnization. (As amended by Executive Order 227"
- 24. Pursuant to the above-cited law, the marriage between petitioner and respondent is null and void from the beginning. It was established that their personality problem is grave and incurable as both cannot carry out to perform their marital obligations. The defect of their personality has juridical antecedence as it rooted from their childhood.

## Metro Pacific Tollways' "Safe Trip Mo Sagot Ko" rolls out anew for Lent





iñan City -Holy Week 2022 and many reli-

gious pilgrims and vacation travelers will be leaving Metro Manila to head to their destinations using Luzon's expressways.

If the noticeable influx of motorists due to the downgrade of COVID-19 alert levels isn't enough, traffic data shows that traffic volume rises during Holy Week by anywhere from 10% to 15%.

For a smoother and safer drive, Metro Pacific Tollways Corporation (MPTC), the Philippines' biggest builder and operator of North Luzon Expressway (NLEX), Subic-Clark-Tarlac Expressway (SCTEX), Manila-Cavite (CAVITEX), CAVITEX C5 Link, and Cavite-Laguna Expressway (CALAX), is again

implementing the "Safe Trip Mo Sagot Ko" (SMSK) from April 8 to April 18, 2022.

SMSK, now on its 13th year, is MPTC's motorist assistance program that is aimed at providing motorists with a safer and more convenient journey during the peak season.

Included in this program are the increased deployment of patrol crews, traffic marshals, security teams, and toll plaza personnel to ensure safety, and provide immediate assistance to motorists. As in the past, emergency medical services and incident response teams will also be augmented and will be stationed at strategic areas of the expressways.

Lane closures and mainline road works will also be suspended from April 8 to 18 unless safety repairs are necessary. Safety and directional signages are put in place to ensure unimpeded travel.

Updated traffic information will continually be posted on each of the expressways' social media accounts, while the MPTC Hotline (1-35000) will be fully manned 24/7 to address immediate customer concerns.

This year's SMSK will also provide free towing to the nearest exit for Class 1 vehicles, from 6:00am of April 13 up to 6:00am of April 18.

"With the easing of travel restrictions, there's a lot more outdoor activity from the general public. As we return to some normalcy as compared to recent years, we have anticipated this increase in volume by fielding additional personnel and

offering special roadside services," said MPTC President and CEO Rodrigo Franco.

For more convenient travel, motorists are encouraged to use RFID for faster and safer transactions. Those who have no RFID sticker yet may have it installed for free in any of the Easytrip installation sites, and pay the initial load.

Existing RFID users are advised to ensure that they have enough load prior to their travel. For the complete list of installation sites and reloading options, motorists may visit the Easytrip website www. easytrip.ph or download the MPT DriveHub app.

MPT DriveHub is an all-in-one travel app available for free from the Apple App Store and Google Play. Drive Hub integrates three key functions in one: RFID transactions, trip planning, and emergency roadside assistance.

Motorists can check their RFID balance and reload their accounts within MPT DriveHub before they travel on NLEX, SCTEX, CAVITEX or CALAX. A toll fee calculator is also in the app to help users calculate how much load they need in their RFID accounts.




