

Ang naturang pagdinig ay isinagawa sa pangunguna ng Regional Tripartite Wages and Productivity Board sa Building Legislative Sangguniang Panlalawigan ng Cavite.

Dumalo sa nasabing public hearing ang Chairman ng RTWPB DOLE IV-A IV-A at Regional Director. Director Ezekiel Ronie de Guzman, Cavite Vice Governor Jolo Revilla, mga kinatawan ng Labor Groups and Laborers, mga manggagawa at Management Group mula sa lalawigan.

Noong nakaraang taon ay matatandaan na naghain ng Provincial Resolution ang lalawigan ng Cavite sa pangunguna ni Revilla upang maisakatuparan ang hiling na pagtataas ng sahod sa probinsya at nito lamang Abril ay naging matagumpay ang public consultation.


for Class 1, P50 for Class 2 through a rebate program.

The toll reprieve program is system driven via the RFID, so all the PUVs operators and drivers have to do is enroll their account to the program in coordination with their different transport organizations. The program will run for 90 days starting on Day 1 of the implementation of the new toll rates.

Toll Regulatory Board expressed gratitude to CIC and its JV partner PRA for their cooperation and support to the mass transport groups. Target enrollees to the program are all drivers and operators of the 1,420 public utility vehicles that ply through CAVITEX.

The new rates are inclusive of the 2011 and 2014 periodic toll petitions, and add-on toll petition for enhancement works done in the expressway, which includes bridge lane widening works. Thus, starting May 22, motorists plying through CAVITEX R-1 segment (Cavitex Longos Bacoor to MIA Exit v.v.) will be charged the following VAT-Inclusive amounts: Php 33.00 Class1 vehicles, Php 67.00 for Class 2, and Php 100.00 for

SUMMONS (BY PUBLICATION)

Petitioner **ALFREDO C. TOMELDEN, JR.**, by and through the undersigned counsel, unto this Honorable Court, respectfully avers and states that:

THE PARTIES

- Petitioner ALFREDO C. TOMELDEN, JR. is of legal age, Filipino, married to the Respondent, and with address at Block 21 Lot 6 Phase 3 Citta Italia, Molino 3, Bacoor City, Cavite. He may be served orders and notices from the Honorable Court through our law office at the address indicated in this Petition.
- Respondent AEGEAN R. BERLANDINO-TOMELDEN is of legal age, Filipino, married to Petitioner, and with address at Block 11 Lot 61 Brighton Phase 4, Barangay Pasong Camachile, General Trias, Cavite, where she may be served summons, notices and other court processes.

NATURE OF THE PETITION

- 3. This is a Petition for the declaration of nullity of the Parties' marriage pursuant to *Article 36* of the *Family Code of the Philippines*, which provides that;
- "Article 36. A marriage contracted by any party who, at the time of the celebration was psychologically incapacitated to comply with the essential marital obligations of marriage, shall likewise be void even if such incapacity becomes manifest only after its solemnization.
- 4. This Petition is anchored on Respondent's psychological incapacity, which is grave, antecedent and incurable. The Petitioner shall present the factual bases to merit the issuance of a decree of absolute nullity of their marriage to free them from a marriage that exists in name only.
- It shall be shown that Respondent is totally unable, completely unwilling, and wholly incapable of complying with the essential marital obligations as ordained under Article 68 and Article 72 of the Family Code, to wit:
- "Article 68. The husband and wife are obliged to live together, observe mutual love, respect and fidelity, and render mutual help and support.
- Art. 72. When one of the spouses neglects his or her duties to the conjugal union or commits acts which tend to bring danger, dishonor or injury to the other or to the family, the aggrieved party may apply to the court for relief."

JURISDICTIONAL FACTS

6. Petitioner is a resident of Block 21 Lot 6 Phase 3 Citta Italia, Molino 3, Bacoor City, Cavite as evidenced by his Barangay Certificate. 4 This is also evidenced by Petitioner's Non-Professional Driver's License 4 Professional Identification Card, 4 Philhealth Identification Card 3 and utility bills which all indicate the same address.

7. The Petitioner and the Respondent married each other on 15 April 2011 in

Manila City Hall, Malate, Manila,

- 8. During the Parties' marriage, Respondent had a child named Dylan Elijah B. Tomelden born on 04 October 2011. $\!\!\!\!\!^{7}$
- 9. The property regime governing the marriage of the Parties' is "Absolute Community of Property" there being no pre-nuptial agreement between them.
- 10. The Parties have one (1) community property a house and a lot at Verona Di Citta Italia Subdivision* which is Petitioner's stated address herein. The property has an assessed value of Two Hundred Ninety Thousand One Hundred Pesos PhP290,100.00, as evidenced by the Official Real Property Tax Receipt obtained and paid on November 12, 2018.9

NARRATION FACTS

I. The Parties Prior to the Marriage

- 11. The Petitioner is the second child among four siblings. He was not born rich, but his parents worked hard to provide for their needs. He grew up in a family that values faith in God, education, relationships, hard work, and respect to others.
- 12. Petitioner's parents were good role models to him. His father took good care of them while his mother worked in Hong Kong. He always sees to it that he sends and fetches Petitioner and his siblings to school every day. Petitioner was particularly close to his mother. He even considers himself a "Mama's boy." His mother taught them to be contented with what they have. She was a disciplinarian who taught her children how to be responsible wherever they may be. At home, the children were taught household chores and all the necessary skills needed if they were to live away from home. In school, Petitioner and his siblings excelled academically.
- 13. On the other hand, Respondent was the youngest child of her parents. Respondent lived with her parents in a small, wooden house in a squatter's area for many decades. They were not well-off. Respondent's father was described as a kind and responsible man. Despite this, Respondent was not close to her father because of his violent tendencies which she witness as she was growing up. Respondent rarely received love or concern from him. Respondent's father was not the type who would give Respondent pieces of advice and reminders.
- 14. Respondent's mother, on the other hand, was very strict, close-minded, irresponsible, and ill-mannered. She was a nagger who cannot control her words and actions. She would shout and curse whenever she was irritated. She was described as asalkalye and palengkera. She did not allow Respondent to go home late than her usual arrivals at home nor play or socialize with other children outside their house. Otherwise, she would have to receive a mouthful from her mother.
- 15. Respondent also had a distant relationship with her only sibling, Jennel. Her sister lived with her aunt because their parents did not have the means to look after her. The siblings only reunited when Respondent was six and her sister was nine. They had their fair share of sibling rivalry while growing up. Often times, they were not in speaking terms. Petitioner's sister eloped and got pregnant. The father of the baby did not own up to his responsibility over the child.
- 16. The Petitioner met the Respondent in June 2002 while both were first year college students at Technological University of the Philippines (TUP) in Manila. Petitioner was 17 years old while Respondent was a year younger. They took up Bachelor of Science in Architecture and belonged to the same class. Their simple acquaintance soon developed into friendship.
- 17. Unknown to Respondent, Petitioner immediately developed a huge crush on her the first time he saw her. For Petitioner, Respondent was easy to get along with, funny, simple, and sexy in her own way. Petitioner thought Respondent was the most beautiful girl in their class. After a month of consistently texting each other, the Parties officially became boyfriend-girlfriend sometime in 2005.
- 18. Their relationship lasted for six (6) years. In 2010, Petitioner noticed that there were changes in Respondent's behavior towards him. By December of the same year, Petitioner was heartbroken when Respondent told him that she wanted to end their relationship. When pressed by Petitioner for reasons, Respondent answered that she hated the "routine" that they were in. She felt burnt out of the relationship already. Despite the sadness he was feeling, Petitioner accepted Respondent's decision.
- 19. However, early in 2011, Respondent informed Petitioner that she was pregnant with his child. Petitioner was surprised. He became very emotional. The Parties thereafter informed their parents about Respondent's pregnancy and their plans of marriage. It was the first time that Respondent introduced Petitioner to her parents.
- 20. Talks of marriage came to fruition when the Parties wed on 15 April 2011 at Room 236, 2nd Floor, Manila City Hall. Petitioner was, at that time, 26 years old and the Respondent 25. The parties' families and relatives were present during the ceremony.

II. The Parties After the Wedding

- 21. After their wedding, the Parties rented an apartment in Pasig City. They experienced their fair share of difficulties in adjusting to married life. Petitioner took it upon himself to pay for their monthly bills and Respondent's needs and regular check-ups.
- 22. Although Respondent's pregnancy was not delicate, she insisted to be served and assisted by Petitioner. Petitioner had to take on the responsibilities of cleaning the house, cooking, and doing the laundry because Respondent was too lazy to do any household chore. Petitioner thought that Respondent would change her ways and help him at home once the baby is born. However, this did not happen.
- 23. On 04 October 2011, **Dylan Elijah Tomelden** ("Dylan") was born. After giving birth, the parties moved into an apartment which was near the house of Petitioner's parents in Cavite. Initially, Petitioner wanted his retired father to help them at home so Respondent could go back to work. However, Respondent wanted her parents to be the ones to stay at their home. Petitioner knew that Respondent would not back down with what she wanted so he relented.
- 24. From 2011 to 2013, Respondent's parents lived with the Parties' in Cavite. Petitioner found it difficult to live with them. Respondent's father wanted authority and control over everything inside their house. Worse, Respondent would always side with her father. Respondent's mother was also not easy to get along with and was not hygienic. She hated cleaning. She did not mind mixing their dirty clothes with the clean ones, for example. This did not sit well with Petitioner as he grew up in a household that was organized and clean.
- 25. One day, Respondent opened up to Petitioner that she noticed his cold treatment to her parents and how he rarely talked to them. Petitioner explained his side, but Respondent was close-minded the entire time. The Parties did not talk for days.
- 26. By the start of 2013, the Parties decided to apply for work abroad so they could save up and buy a house and lot. Thus, Petitioner tried to resign from his work. Instead of approving his resignation, the company offered a house and lot company loan, which Petitioner gratefully accepted. Despite his persuasions and objections, Respondent left for Dubai for a two-year contract around May 2013.
- 27. One month after, the Respondent was able to acquire the house and lot which was officially turned over to him by August 2014. The address of the property is the same as the Petitioner's address stated herein.
- 28. After a few months in Dubai, Respondent became very cold and distant to Petitioner. Whenever the Parties talk, Respondent became verbally and emotionally abusive to Petitioner. Because of this, Petitioner just asked Respondent to come home even before the end of her two-year employment contract, but Respondent refused.
- 29. By December 2014, Respondent informed Petitioner that she would not be spending her Christmas break in the Philippines. Coincidentally, Respondent's mother borrowed their son Dylan for a week. Thus, on 21 December 2014, Petitioner was shocked when Respondent sent her a text message using a local number to ask for the password of Dylan's pocket wift. When Petitioner confronted Respondent about this, she then told him that she has been staying in her parent's house for almost a week already.
- 30. Upon arriving at Respondent's house, she did not hug or kiss Petitioner like she used to. Petitioner instantly felt that Respondent was avoiding any physical contact with him. Then, Respondent told him that she wanted to end their marriage. Petitioner begged Respondent to stay but to no avail.

- 31. Without any sign of remorse, Respondent also revealed to Petitioner that he was not the father of Dylan. Petitioner could not believe and accept what Respondent just told him. It was as if everything was a lie from the very beginning. All along, he thought that Dylan was his child and he had always treated him as his own. At that instance, Respondent's mother cried and asked Petitioner to leave Dylan with them. Betrayed and heartbroken, he brought Dylan home.
- 32. Petitioner and Dylan then undertook a DNA Paternity Test. The results showed that there was 0% probability that Petitioner was Dylan's father. Despite this, Petitioner still accepted Respondent and her son Dylan. He was willing to put the past behind him for the sake of Dylan.
- 33. Respondent again left for Dubai. On the day of her departure, Petitioner's curiosity got the best of him when he noticed in Dylan's tablet that Respondent's Facebook and Google Mail accounts were still logged in. Unknown to her sister Jennel, the exchange of emails she had with Respondent proved that the latter had planned to end the marriage months before she went home from Dubai.
- 34. Respondent even made a separate Facebook account with no marital status or pictures of him and Dylan. When he gained access to it, he decided to upload photos of their family in Respondent's account. All of a sudden, a group chat named "Kilabotsen-kembots" popped up. To know more about Respondent's adulterous affair, Petitioner replied and pretended to be his wife, to wit:¹¹

"kung akoyatasiBenj di nakitasasagutinpagnakitako upload photos mo eh hahahaha

bakit d b kminibenj? D b halata? Hahaha

xxx

Db sabiikomejomallabonakmi ng husband ko

Yes

Prang nawala n ung feelings e. Anjanna kc c Benjaaayyyiii

xx.

Not in good terms pala no Hehehe Hoy sinabi mu kaya saaminHehehe So benjwalana?"

- 35. When Respondent arrived in Dubai, she immediately announced to her friends that her email and Facebook accounts were hacked. Soon, Petitioner noticed that the members of the said group left the chat. Upon scrolling the messages, Petitioner discovered that Respondent was being teased by her officemates to a certain "Benj." Worse, Respondent impliedly confirmed their relationship. For all to witness, she paraded her feelings for this man.
- 36. Apart from this, Petitioner checked the accounts of Respondent's *Facebook* friends to dig more information about Respondent's paramour. Thereafter, Petitioner browsed through the messages Respondent had with this Benj, he found out that his real name was Benjie Arevalo. He began reading lewd messages from Benj to Respondent like "bilatnimo lame," which if translated in English means "your vagina is delicious." Worse, the messages confirmed their relationship, to wit: 12

"mahalnamahalkita Magpakailan man

hehehe..

mahalnamahal din kitanaunbukas at magpakailan

xxx

mahalkitasagad gang matress

hahahaha.. kala kosagad gang pwet..

xxx

Nagsearchka nan g tour package?? Oi hindi saying peramo d2..."

- 37. Petitioner could not go to work in the succeeding weeks. After everything that Respondent put him through, Petitioner was on the verge of losing it. Petitioner sent Respondent messages with hopes of saving their marriage, but she never responded.
- 38. Alarmed by what Petitioner might do to himself, Petitioner's sister Frednalyn Tomelden Peck ("Frednalyn"), on 30 January 2015, reported via email¹³ to Respondent's company her adultery, betrayal, and lies. Motivated to take legal action, Frednalyn asked for information regarding Respondent and her paramour's current whereabouts and contact details. However, the company never replied.
- 39. On 03 February 2015, an anonymous informant sent emails¹⁴ to Frednalyn confirming that Respondent's adulterous relationship with this Benjie Arevalo was known to all in Dubai, and giving Respondent and her paramour's whereabouts and contact details, to wit:

"Karama, beside sunrise supermarket building. 3rd floor flat 5. Above pharmacy. Doonsilanakatira.

Mid of 2013 started.

40. Then, on 14 February 2015, a certain **Ortalessa Ovaldi**, a co-employee of Respondent and her paramour in Dubai, sent emails¹⁵ to Frednalyn further confirming Respondent's adulterous relationship, to wit:

"I have read ur email regarding adulterer wife & partner and definitely agree of everything you have said.xxx I have tried to do something to stop the disgusting activity the two had been doing eversince. I sent a message thru FB early last year to the girl and telling her to stop their extramarital affairs with the boy or else I will tell her husband. But i guess she wasn't able to see that message since we aren't friends in FB.

xxx the last time I know before this recent discovery of the two was they are both living together in Sunrise super market bldg. Al karamast.dubai. Aegean at first is coming to visit or sleep over for twice a week or so..some times she will sleep at the sofa and/or some lady friends would offer her a bed to sleep in their room. Then apparently she moved into with benjie."

- 41. When Petitioner and Respondent's common friends learned about what had happened to the Parties, they started to open up to Petitioner that Respondent had affairs with other men even when they were still boyfriend-girlfriend.
- a. The Parties' common friend Marjoric Cariaso-Ortaleza, who was their classmate in college and Respondent's officemate in Dubai, confessed to Petitioner that their friend "Nikki" is Dylan's father, that Respondent had so many affairs with their friends, including a certain Jesus de Guzman ("Tonton") sometime in 2007-2008, to wit:¹⁶

b. The Parties' common friend **Jay Suarez Acevedo**, who was their classmate in college confessed to the Petitioner that Respondent dated a certain Mart Jon "Majo' Calugtong sometime in 2010-2011, to wit: ¹⁷

xxx

Di konaitatanggiah..Yup..Meron Nung da goldipalang..

rrr

MajoCalugtong

- c. Respondent's best friend **Melanie Mendez** further confirmed Respondent's affàir to this Majo and Tonton. ¹⁸
- d. The Parties' common friend Cecille Kristine Padrones did not deny Respondent's affair with this Majo: 19

42. For the sake of Dylan, Petitioner tried to contact Benjie Arevalo to clarify

"sana man langtinanongmoasawamo sinobadahilanbakit ng yayariito...

unasalahatsabi ng asawamopapelnalangang meronkau..at paguwinyalilinawinnyonalang... ilang beseskopina-alis

beseskopina-atıs at iwasanangasawamo..peroanuginawanya... xxx

sakanyanawagnaxangbuma likditopag d nyamaayos ng anglahatdahilmalakinggulonhmangyayari... perubumalikparinsya...pinalayaskonasyangbahay at lahatperuakuparinsinisisimo??? sirangsiranangapangalankoreputasyon at lahat...andaminginocentengtaonadamay at nagulosa ngyayari... dahilsa drama nyong asawaakoparinsinisisimo??? kung ayawbumalik ng asawaakoparinsinisisimo??? kung ayawbumalik ng asawaamodikonakasalananyun. Hindi ko yon tinali o sinulsulan para malamanmo... pinapauwikopangayun eh para matigilkanadyan... kung d mopa dii mapauwiasawamo... choice nya nay un... walanaaku don... itanongmosakanyayan!!!"

43. It then dawned on Petitioner that Respondent lied to him from the start. He

was taken advantaged of by Respondent just to save face for having a child out of wed-lock. For Respondent to be able to do this to him, Petitioner realized that Respondent did not have any love for him at all. She just used him.

DISCUSSION

Respondent's Psychological Incapacity

44. As can be gleaned from the above narration of facts, Respondent manifested symptoms of psychological incapacity that rendered her incapable of comprehending and complying with the essential marital obligations. In line with this, the Supreme Court held in the case of *Santos v. Court of Appeals*²² that:

""Psychological incapacity" should refer to no less than a mental (not physical) incapacity that causes a party to be truly incognitive of the basic marital covenants that concomitantly must be assumed and discharged by the parties to the marriage which, as so expressed by Article 68 of the Family Code, include their mutual obligations to live together, observe love, respect and fidelity and render help and support. There is hardly any doubt that the intended "Insychological incapacity" confine the meaning of "Insychological incapacity". doubt that the interdament of the law has been to confine the meaning of "psychological incapacity to the most serious cases of personality, disorders clearly demonstrative of an utter insensitivity or inability to give meaning and significance to the marriage. This psychological condition must exist at the time the marriage is celebrated."

- 45. The above jurisprudence finds application to the instant case as Respondent's psychological incapacity is characterized by SERIOUSNESS, FACTUAL ANTECED-ENCE and GRAVITY.
- 46. Respondent's condition is INCURABLE and PERMANENT. She is totally oblivious of the fact that her acts had detrimental effects on their marriage. Respondent's actions caused severe psychological and emotional pain to her husband. Worse, Respondent repeatedly cheated on the Petitioner without any remorse whatsoever.
- 47. On the basis of the foregoing, it is apparent that Respondent's behavior caused the breakdown of her marriage. Thus, the dissolution of such marriage is not only proper but likewise necessary to forestall the continuing suffering of the Petitioner and the mockery of marriage as a revered social institution.

THE PSYCHOLOGICAL EVALUATION

48. In the Psychological Evaluation Report, ²²Clinical Psychologist Shiela Marie O. Montefalcon found the Respondent to be inflicted with 301.81 (F60.82) NAR-CISSISTIC PERSONALITY DISORDER. The aforesaid disorder renders the Respondent psychologically incapacitated to perform the duties attendant to marriage, to wit:

"People suffering from this condition are known to have a pervasive pattern of grandiosity, unhealthy need for admiration, and lack of empathy, beginning by early adulthood and present in a variety of contexts, as indicated by five (or more) of the following: (Below are the specific manifestations of the clinical features Respondent had exhibited.)

- 1. Grandiose sense of self-importance. She only thought of herself and preferred things to happen the way in favor of her. She took advantage of Petitioner's tolerance and kindness to sustain her excessive need for admiration and sense of superiority. Whenever having disagreements, she would not ask or consider his opinions since she believed in her own justifications. She did things that were only pleasing to her. She was always complaining because she expected to be treated like a princess afar from what was expected of her as a wife and a mother.
- 2. Preoccupied with fantasies of unlimited success, power, brilliance and love. She had shown preoccupation to power and success by focusing on her own ways to achieve her means neglecting the much more important responsibilities of a wife. Her intense desire of unlimited brilliance was evident on her dissatisfaction for what was given to her, such as consistently grumbling to completely take over Petitioner's life.
- 3. Believes that he or she is special; She would always want everyone to adjust and give in to be able to fit in with her attitude and her distorted way of thinking and feeling. She was always expecting special treatment from the people around her and she wanted to be treated extraordinarily. This was the reason why she found it hard to blend in or adjust to the demands of married life.
- 4. Requires excessive admiration. Because of her unhealthy need to always be listened, favored, and be considered as special, she gratified such need by requiring Petitioner's time and attention and attention solely given to her. She had no care of Petitioner's feelings as long as she could receive his continuous admiration and submission. It can also be noted that the cause of her persistent engagement in illicit affairs is her excessive need for admiration.
- 5. Has a sense of entitlement. She believed that she deserved special privileges in life such as extreme love and submission of her husband, and attention from other men. She also had the thinking that she was always right so when things get rough and tough, she had the tendency to blame it to Petitioner instead of seeing her shortcomings and misbehavior.
- 6. Interpersonally exploitative. This speaks of the verbal and emotional abuse she did to her husband. The emotional discomfort she brought to him by speaking and even shouting negative words at his face caused Petitioner to feel inadequate. She also took advantage of his kindness and love towards her for her personal advancement. She exploited him in many ways, such as when he made him believe that he was the father of her son just to protect her image.
- 7. Lacks empathy. She was unwilling to recognize or identify with feelings and needs of Petitioner as she was just up to her own needs and wants. She didn't think of the consequences of her actions to the people around her especially her husband. Petitioner, whom she supposed to treat with utmost care, lover and submission, was emotionally tortured because of the recurring rejection from her in favor of her selfish pursuits.
- 8.Is often envious of others or believes that others are envious of him or her. Respondent's goal in succeeding in life was to be envied by the people around her. As a Narcissist, she would always want to be on the limelight receiving awe and adoration from others.
- 9. Shows arrogant, haughty behaviors or attitudes. She was always proud and conceited by not accepting her mistakes and shortcomings. Respondent showed arrogant behaviors in dealing with Petitioner. She was easily irritated and infuriated when confronted and reminded to behave properly because it was an insult to her distorted and boastful ego."
- 49. According to the Psychologist, the disorder of the Respondent stemmed from her early years of development, with an enduring pattern and behavior that deviates from the expectations of the individual's culture to wit:

"RESPONDENT'S personality disorder speaks of ANTECEDENCE as it has an early onset, with an enduring pattern and behavior that deviates markedly enduring pattern and behavior that deviates mari from the expectations of the individual's culture. Upbringing, family relationship, and childhood experiences are the contributory factors in person development."

- 50. Based on the **Psychological Report**, the Respondent's psychological condition is deeply rooted in her person and had juridical antecedence as it existed long before she married the Petitioner, to wit:
- "According to the Self-Theory of Dr. Heinz Kohut, children need to be mir-rored, that is, to have their talk and their accomplishments acknowledged, accepted and praised. Little children believe that they are omnipotent and they also idealize their parents. Such idealization enables them to develop goals and in part, this learn-ing depends on parents responding positively to their children's unique, lovable, and commendable characteristics. If parents fail to respond in appropriate ways, children

may be unable to develop a good sense of self-worth and may spend the rest of their lives looking without success for such acceptance. In those experiences conceived the Narcissistic feelings which are the aspects of personality that gradually unfolds, permeates the entire life span, and leads to a distorted sense of self. Dr. Kohut believed that disorders of the self arise from a failure in parental empathy and mirroring. A permissive or authoritarian parenting style is more likely to foster narcissistic maladjustment.

In the same way, Respondent Aegean failed to receive adequate love are guidance from her parents. She was taken for granted by them that establish her belief that she should do everything to receive praises and acceptance of oth people. Being strong and domineering was the character that she built for herse because she feared to be maltreated and looked down again by the people clo to her. Lacking of proper parental upbringing, Respondent failed to learn how adapt to the changing environment. Her guardians did not provide appropria and necessary discipline to her resulting in failure to train her character and ne ative pattern of behaviors."

51. The Psychologist added that Respondent's psychological condition is

"Her psychological incapacity speaks of GRAVITY as she was not able to carry out the normative and ordinary duties of marriage and family, shouldered by any married woman, existing in ordinary circumstances. Her personality disorder is <u>permanent</u>, <u>chronic and pervasive</u> affecting many aspects of her life such as social functioning and close relationships including marriage. Respondent was unable to assume her marital duties and responsibilities to her family. She failed to render mutual love, respect, help, support, and fidelity (Article 68, FC).

- 52. The Psychologist further stated that the psychological incapacity of the Respondent is permanent and incurable, to wit:
- "Additionally, it also speaks of INCURABILITY as Respondent has no psychological insight that she has a character problem. She would not acknowledge the pain she'd caused to people around her. There are no medications and laboratory examinations available for such kind of condition, Narcissistic Personality Disorder. Also, no amount of therapy deeply ingrained in her personality extractive."
- 53. In view of her findings, the Psychologist recommended the dissolution of the Parties' marriage, to wit:
- "With due consideration to the above findings and since reconciliation would only cause mental and emotional distress on both parties, it is then recommended that the marriage between Petitioner and Respondent be declared null and void on the amount of Respondent's psychological incapacity pursuant to Article 36 of the Family Code that is grave, severe, permanent and incurable, as well as deeply ingrained in her personality structure."

WHEREFORE, premises considered, it is most respectfully prayed that judg-

- 1) Declaring the marriage between the Parties $void\ ab\ initio$ on the basis of the psychological incapacity of the Respondent;
- Ordering the Local Civil Registrars concerned and the Philippine Star Authority to annotate the declaration of the nullity of the Parties' marriage in Marriage Certificate and their records;
- 3) Awarding sole custody of the child Dylan Elijah B. Tomelden to his mother Respondent AEGEAN R. BERLANDINO; and
- 4) Declaring the community property of the Parties at Di Citta Italia Subdivision dissolved with the share of the Respondent in the said house and lot forfeited in favor of the Petitioner.
- Other measures of relief just and equitable under the premises are likewise
