

MANAGEMENT - The Bureau of Jail Management and Penology National Capital Region (BJMPNCR) got a score of 100 percent in the four areas of PRIME-HRM during the virtual assessment evaluation conducted by the Civil Service Commission - National Capital Region held on May 24-27, 2022. The perfect scores were the result of the evidentiary requirements and data gathered during the random interviews conducted on BJMPNCR personnel who had met all the indicators under the PRIME -HRM Maturity Level II. Seasoned firefighter-drug buster is set to put his badge to rest

On June 11, 2022. Bureau of Fire Protection (BFP) veteran firefighter Senior Inspector Von Ferdinand Sangalang Nicasio is set to retire his badge reaching the compulsory retirement age of 56-years-old set for the members of the uniformed service in the country.

An Electrical Engineer by profession, Nicasio entered the Fire Service on October 25, 1993 where he was assigned at the Office of the Batangas Provincial Fire Marshal. During his fresh years in the service, he involved himself in schooling and training to hone his skills and equip himself with the essential knowledge and capability to become both an efficient firefighter and skilled fire safety inspector.

He also through some learning and development trainings on competence in inspection, safety and preventive maintenance and electro-mechanical motor control in his early years.

A few years later, he was included in the team of fire safety inspectors assigned to check vital facilities like power plants and mixed occuestablishment, ergo, he saw the need to diligently study the Fire Code of the Philippines, as well as the Electrical Code and the volumes of NFPA Codes and Standards for the elimination of death, injury, property and economic loss due to fire, electrical and related hazards.

His yearning learn and be updated on the latest fire safety codes and standards has earned him the respect of his peers of being considered as one of the so-called 'Fire Code experts.

The soft spoken and

intelligent fire officer's gallantry was put to test during the election-related fire incident that marred the Year 2017 Election in the town of Taysan in Batangas Province, some 70 kilometers south of Manila that killed a teacher-election inspector and poll watcher.

Nicasio, who was then the provincial operation officer rushed to the scene with his six-man crew upon receiving the alarm. Their swift arrival caused the armed mask perpetrators who set the Bayanan Elementary School ablaze to flee, as a result saving the other polling precincts and crucial election paraphernalia from the mayhem. Crime evidence also preserved were while injured victims rushed to the nearest hospitals for treatment.

During his term as fire marshal of Lipa City, Nicasio also led his team of firefighters in responding to a call for assistance from Lipa City Police Office to support the Philippine Air Force soldiers having some difficulty in unearthing an incendiary vintage bomb discovered from the excavation on the construction site in Barangay-2.

Nicasio's vast experience in emergency and rescue operations, including his training in explosive ordnance disposal (EOD) had become a big help for PAF EOD team at the site in identifying and safe retrieval of the 1,000 pounds 1.5-meters long and 1.5-foot diameter World War-2 chemical bomb with fuses on both tip and tail.

After four gripping hours of the operation, the shell was carefully salvaged and brought by the combined BFP and PAF teams to San Fernando Air Base in the city for proper disposal.

On January 12, 2020, Nicasio's valor was again tested when one of the country's most active volcano erupted - Taal Volcano.

At that period, he happens to be the fire marshal of the Municipality of Lemery, one of the towns in the 7-kilometer danger zone badly damaged by the tragedy.

He and his team worked 24/7 combing the town's 46 barangays (villages) evacuating thousands of affected inhabitants to temporary relocation centers. In the extent of volcanic activity spewing huge plume of hazardous ash and tremors causing major fissures on the roads and damage to properties, Nicasio led his command in the daily patrolling of streets to ensure evacuees' belongings and houses are safe from looters.

In his stint as Lipa City Fire Marshal, Nicasio, a practical shooter and member of the Philippine Practical Shooting Team got the greatest challenge in his career when he was named by then Lipa City Mayor Meynard A. Sabili as Executive Officer of the Task Force Kontra Droga of the City Anti-Illegal Drug Abuse Council in response to the anti-drug war of President Rodrigo R. Duterte, making him the only fireman-drug buster in the country.

Nicasio and his Task

illegal drug operations and confiscated drug paraphernalia, guns and ammo, and substantial amounts of illegal drugs. The arrested suspects were also brought to the court of law in violation of R.A. 9165, known as the Comprehensive Dangerous Drugs Act.

His involvement in the city's anti-drug war had immensely contributed to the massive decrease of illegal drug trade and use, and the surrender of more than 5,000 drug users for re-
