

Governor Jonvic Remulla and former Senator Orly Mercado formally cut the ribbon during the opening ceremony of the non-profit environmental assistance center, the Community Legal Help and Public Interest Centre (C-Help), June 7, 2022. C-Help was founded

C-Help was founded before the pandemic but its founders are known for many years of environmental advocacy. It is headed by Mercado, who championed the log ban and authored the generics law in the 1990s, crop scientist and retired University of the Philippines professor Ted Mendoza, environmental lawyer Zelda D.T. Soriano, permaculturist Beau Baconguis, digital activism advocate Chuck Baclagon; and social justice and grassroots community leader Derek Cabe. C-Help gives legal assistance to marginalized communities affected by environmental problems.

TRB Inspects Soon to Open CAVITEX C5 Link Flyover Extension



ecutive Director Atty Alvin Carullo together with the TRB technical team, the grantor of the Manila-Cavite Toll Expressway Project (MCTEP), inspected the ongoing construc-tion of the CAVITEX C5 Link Flyover extension (Segment 3A2: Merville to E. Rodriguez Ave.) of Cavitex Infrastructure Corporation (CIC) and its joint venture partner, Philippine Reclamation Authority (PRA).

Early this week, the TRB's inspection team together with CIC representatives checked on the progress of the 1.6km flyover extension

that will soon connect to the operational 2.2km Cavitex C5 Link flyover. providing convenient access for motorists bound to SLEX/C5 from Merville and vice versa. As of today, the segment has reached more than 95% completion. Also

discussed during the inspection is the traffic management plan for the area once the extension opens. This entails transferring of the Merville entry and exit ramp to in front of Shell C5 Southlink for better traffic flow. Traffic signalization and signages will be installed in coordination with the local authorities to help manage traffic for motorists bound to the ex-(cont. p.5)

n partnership with HIV & AIDS Support House (HASH) and SAIL Clinics, Cavite Provincial Health Office joined in the annual celebration of Philippine International AIDS Candlelight Memorial with the theme "Keeping the light, honoring our rights, radiating pride" on May 27, 2022 at the Collaboration Cavite Center for Public Health Building in Trece Martires City, Cavite which was attended by 52 participants.

The short program started with an opening message from Dr. Nelson Soriano saying that people should stop HIV together through HIV testing and prevention and educate others about it to make a positive change. Afterwards, Mr. Earl Patrick Penabella, SAIL Clinic Operations Manager, imparted that in keeping the light on HIV and AIDS, the need to talk about the virus should be maintained. He added that there should be human rights-based approach to create an enabling environment that will be helpful and essential in ending HIV threat. Lastly, in radiating pride, a healthy equity and social justice should be achieved to end the disease.

The risk and cases of HIV and AIDS are continuously increasing and the stigma and discrimination to the infected ones continuously are circulating. Human Immunodeficiency Virus is an infection that has no cure and can lead to the condition of AIDS or acquired immunodeficiency syndrome. Acquiring this can be a threat to one's life hence spreading awareness about the virus can save lives.

HIV affects As proportion of LGBTQIA community, stigma and discrimination developing and are growing which leads to



the vulnerability of the group. This is one of the reasons why most of the infected individuals, not just from LGBTQIA community, are having a hard time seeking help and accessing services for HIV and AIDS. Mr. Penabella mentioned "undetectable equals untransmittable" which means that if a person living with HIV is on a regular treatment and therapy and has reached the undetectable levels, HIV cannot be transmitted to their partners. Therefore, HIV patient every HIV patient should be encouraged and supported in getting HIV treatments, care, and services.

This year's theme is not only about remembering the people who have lost their battle against HIV and AIDS but also honoring those who committed their lives to help the people affected by the disease and giving awareness to the public about it to create an intricate response and have a non-discriminatory environment.

Dr. Ana Maureen Villamar, HIV/AIDS Core Team (HACT) Physician said, "Aside from commemorating our loved ones, friend or someone who are

acquainted to us who died because of HIV and AIDS, the ones who are survivors should also keep the light and guide other Filipinos that they would be able to survive

AIDS and HIV as well. We should honor our rights because it is our right to live healthy and always radiate with pride, that we are always proud of ourselves, we keep our


values and practice our responsibility as citizens and HIV advocates and enlighten everybody with the disease".

Mr. Terrenze Angam, Case Manager of SAIL Clinic, pointed out the preventions and treatments for HIV and AIDS including abstinence or no intercourse, being faithful to your partner, using condoms, avoidance, enough knowledge about the disease, and the preexposure prophylaxis. 
