



Drug rehab center opens in Cavite under DOH-JICA program



ANILA – The Department of Health-Center for Health Development (DOH-CHD) in Calabarzon (Cavite, Laguna, Batangas, Rizal, Quezon)

region, in partnership with Japan International Cooperation Agency (JICA) and the City Government of Trece Martires, has put up a Drug Abuse Treatment and Rehabilitation Center (DATRC) in Barangay Osorio.

The construction of the DOH-DATRC is a component of a JPY1.85-billion (PHP734 million) undertaking called "Consolidated Rehabilitation of Illegal Drug Users" (CARE), a bilateral project in line with the Japan-Philippines Joint Statement on Bilateral Cooperation to combat illegal drugs, as part of the efforts to uphold public safety.

According to DOH officer-in-charge Undersecretary Leopoldo Vega, DATRC will be the apex or an end-referral of all rehabilitation centers in the country.

"The DOH shares a vision of a healthy Pilipinas through health promotion activities of substance use and abuse. The DOH believes that substance use and abuse is a chronic but treatable medical condition. This requires a holistic approach to the whole of government, whole of society, and whole of system approach. We need to ensure that individuals suffering from this condition receive sufficient support so they can rebuild their lives and reintegrate into society. Today's ceremony represents a valuable step ensuring the development of our health systems and realizing the goals of Universal Health Care in our country," Vega said in a statement on Wednesday.

In his keynote speech during the center's inauguration on Tuesday, Interior and Local Government Secretary Eduardo Año said: "We are fortunate to have a president whose mission in life is to save our children from the clutches of illegal drugs. He pushed all gears and mechanisms vs. illegal drugs into action."

For his part, Sakamoto Takema, JICA Chief Representative in the Philippines, said, "JICA is deeply committed to the Human Security aspect of its development assistance which aims to protect every individual's life, livelihood, and dignity. JICA's continuing partnership with the DOH and other agencies is a testament to this commitment, and

its vow to promote the Philippines' inclusive and sustainable development as its closest and most reliable partner."


The DATRC has complete amenities and facilities such as a processing building, medical, and administration building, family waiting area, nurse's station, observation room, conference room, garden, prayer hall, separate dormitories for male and female patients, and activity center.

It is built on the five-hectare land donated by the province of Cavite.

Once operating, the facility will cater to illegal drug users mainly from South and Central Luzon and will be free of charge. To be managed by the DOH, its dormitories can accommodate a total of 400 male and 80 female drug dependents.

The rehabilitation center aims to provide accessible and immediate interventions for drug dependents. It will be a fundamental part of the referral system with the DOH's Formula One Plus strategic pillar in the health service delivery network. (PNA)

rules," he said.

Asked on the possible penalty for a violation of the contractual obligations, he said, "Under the Government Procurement Reform Act the Performance Security may be forfeited, in case they did not comply (with) contractual obligations.

"You can also claim warranty security (this is the percentage retention on each payment while the warranty exists on all warrantable deliverables). There is still blacklisting, the grounds and procedures of which are also in the IRR (Implementing Rules and Regulations) of RA 9184," Laudiangco added.

In its Investigation Report to Commissioner Aimee Ferolino, the PSC said there is no cause for alarm as to the materials found in the area.

"Per investigation/ inspection of the Packing and Shipping Committee (PS), it was found that the said election materials inside the black boxes were used items such as indelible ink, stamp pads, bond papers, as well as, used/excess non-accountable forms,

ballot secrecy folders, and envelopes," said the report submitted on June 9.

It added that none of the items were considered "cause for alarm or used for fraud or similar activities as may have been alleged in the FB (Facebook) post."

"Notarized affidavits of members of the Electoral Boards assigned in JP Rizal Elementary School, Pingkian, 1st District of Manila, where the said items came from reinforced the PSC findings," it add-

The report was approved by the commission in its regular en banc meeting on June

During the deliberation on the report, Ferolino stated the inclusion of said election materials in the reverse logistics in JP Rizal Elementary School was on account of inadvertence, with the school's clerk custodian giving instructions to F2 personnel to take everything, wherein the latter is of the impression to retrieve the subject items together with the vote-counting machines.

During transit and

upon realizing that the subject election materials are not included in the items subject of the reverse logistics, the concerned F2 Logistics Personnel temporarily unloaded such in their parking area in Amadeo, Cavite while seeking clarification as to where to deliver these materi-

It was also found out that after the clarification and realizing their inadvertence and miscommunication with the clerk of the school, F2 personnel immediately recovered such election materials and brought the same to the F2 Logistics Headquarters in Parañaque City, where it has been stored for safekeeping and that the area where the election materials were found is, in fact, a parking area of F2 Logistics vehicles, and that the subject items were all accounted for as having been presented to and inspected by the PS investigators.

Last month, pictures and video photos of purported election materials seen in an open area somewhere in Amadeo, went viral when it was posted on social media. (PNA)

A Legacy of Timeless Reverence

With the nation preparing for the celebration of the 161th birth anniversary of national hero Dr. Jose P. Rizal on June 19, the memory of that most poignant moment eleven years ago when the tallest Rizal monument was unveiled at The Plaza as the Calambanos' tribute to our greatest townmate on his sesquicentennial anniversary, comes back to mind. Let me share the story.

The Story

What would I give someone who already has everything as he celebrates a milestone birthday?

What will be a fitting tribute to a great man who sacrificed all for his country — a man who is not only revered in his hometown but in different places around the globe?

It actually started as a dream as we were preparing for the celebration of Dr. Jose Rizal's 150th birth anniversary in 2011.

Several monthly activities were lined up for the yearlong celebration, all in commemoration of the hero's venerable life and remarkable works but there seemed to be something missing. I envisioned something more tangible, something befitting Rizal's stature as our national Hero and last Renaissance man to walk this earth. It should be something that our future generations would see as a testament of their elders' reverence to our greatest contribution to Philippine history.

These thoughts kept playing over and over in my head, caused some sleepless nights and led me to ask the opinion of several trusted friends. Then seemingly out of nowhere, like an unexpected bolt of lightning, it came...... why not build a monument of Rizal and make it the tallest in the world?

The Construction

With barely three months before the targeted unveiling date of June 19, Sculptor Jonas Roces began work on the 16.4 ft. monument. In the middle of March, I thought all our plans were going to be for naught when I heard that the Nueva Viscaya monument topped ours by at least 2½ feet. Undeterred, I challenged the Executive Committee to increase the new monument's height to 22 feet. The conference room's wall shook to the resounding chorus "Yes!" The additional height also meant additional costs, leading me to approach close friends and associates who thankfully did not hesitate to contribute to the construction.

To ensure the correctness of the statue's features and its strict conformity to the guidelines on statues and monuments set by the National Historical Commission of the Philippines (NHCP), I requested NHCP Executive Director Ludovico Baduy to assist us in monitoring the statue's construction. With Arch. Reynaldo Lita of NHCP and the executive committee in tow, we visited Roces in his Marikina workshop to check the progress of the statue. Comments and suggestion

flew from all sides as we debated and brainstormed on how close the statue's features were to the famous portrait of the hero. Even his clothes and shoes did not escape the scrutiny of Arch. Lita and the committee members as we wanted the statue to be close as possible to real Jose Rizal's likeness.

The unveiling of a new tourist attraction

Exactly one and half months before June 19, Roces delivered the 22 ft. statue and placed it on its pedestal in a newly acquired 6.7 hectare property in front of our City Hall. The granite pedestal added 7.87 feet to the total height of the monument while the 15 step circular base added another 13.12 feet, bringing the monument's total height to an imposing 43 feet with an approximate weight of 2 tons.

June 19 dawned with the soft drizzle of rain. This was the day I have anticipated, the day in which I will lead the entire city in honoring our most important contribution to Philippine history. With a hush of anticipation and to the soft strain of Calamba hymn, then President Benigno S. Aquino III tugged at the ropes which parted the green curtains and unveiled our humble tribute to our greatest kababayan. The new Rizal monument became the newest tourist and historical landmark not only in the city but in

the entire country. It may very well be the pilgrimage site for people around the globe who have been inspired and enlightened by our hero's ideals and writings.

The Gift

Having turned over the reins of government of Mayor Justin Marc SB. Chipeco and Vice Mayor Roseller H. Rizal, I now gaze upon Dr. Rizal's new statue with its serene and contemplative expression seemingly looking out for the City and I remember his admonition to us all through the character of Elias in his novel, Noli Me Tangere, "I die without seeing the dawn brighten over my native land. You who have it to see, welcome it and forget not those who have fallen during the night" The monument that we envisioned and built is not in itself our greatest achievement and contribution. The greatest accomplishment that I pray we have

achieved is the continued enlightenment of our countrymen through the life and works of the hero that we paid homage to, the hero who yearned to see the dawn of freedom and had fallen in the night. The greatness of his monument is equaled only by the dept of each Calambeños' commitment to perpetuate the legacy of our greatest kababayan..... for the whole world to see and future generations to treasure.
