

MANILA - President Ferdinand "Bongbong" Marcos Jr. on Thursday instructed the Department of Public Works and Highways (DPWH) to prioritize the inspection of hospitals and health care facilities in Abra following the magnitude 7 earthquake that jolted the province.

"Do the inspections first of the public buildings. I think your priority will be quite right is the hospital,

In his visit to the province, the chief executive personally checked the condition of the Abra Provincial Hospital and its patients.

# Former Health Secretaries renew calls to veto the Vape bill



alam ba City Former Health

Secretaries Dr. Jaime Galvez Tan and Dr. Esperanza Cabral appealed to President Ferdinand Marcos Jr. to veto the Vape Regulation Bill (SB 2239) and fully implement existing regulatory provisions on such products contained in Republic Act Nos. 11346 and 11467 that were passed in 2019 and 2020 respectively. The call is in light of the recent ruling of the Supreme Court (SC) affirming the authority of the Food and Drug Administration (FDA) over tobacco products.

The Vape Regulation Bill is one of the bills that were submitted late in the former Administration that was then inherited by President Ferdinand Marcos Jr.

The SC, in the case filed by the Philippine Tobacco Institute to question the authority of the FDA over tobacco products, ruled that Section 25 of Republic Act No. 9711 clearly establishes that the law shall cover all health products, except for acts covered by special laws. Hence, matters not covered

by special laws remain under the FDA's broad regulatory authority.

Cabral underscored that for the longest time that the public health community continues to assert that DOH and the FDA have jurisdiction over tobacco and similar products such as vape products or e-cigarettes. "The FDA and the DOH should have the final say on any and all products that impact people's health," Cabral said.

For his part, former Health Secretary Jaime Galvez Tan said that this decision ultimately tells the public that the health experts in this country are the DOH and the FDA. "Policy-makers and the public should listen to FDA and DOH instead of industry-backed groups claiming to be health experts but are actually peddling vapes."

Prior to stepping down as Secretary of Health, Dr. Francisco Duque III also reiterated the agency's position against the Vape Bill and categorically stated that their 'end goal' is that the Vape bill will not be enacted into law.

In an earlier statement, Former Secretary Duque also referred to the vape bill as a 'Trojan horse' to the former administration. He explains that "The bill will achieve the opposite of its intended purpose of strengthening tobacco industry regulation as it relaxes the restrictions on the minimum age of access, flavorings, regulation, distribution, advertising, promotion, sale, and use of these products." Atty. Alexander

Padilla, former Undersecretary of Health, is of the view that this is an opportunity for the DOH and FDA to assert its mandate over tobacco products and vapes. "The broad powers of the FDA as affirmed by the Supreme Court should be used by the agency to consolidate the regulations for vapes and tobacco to ensure effective enforcement for the protection of public health."

Former Civil Ser-Commissioner Mary Ann Z. Fernandez-Mendoza highlights the acknowledgement of Supreme Court on the competence and mandate of the FDA 'to ensure safety, efficacy, purity, and quality' health products which includes tobacco products because it negatively impacts health. "This decision is important to improving good governance in our country as it rationalizes the functions of government agencies. To divide jurisdiction over tobacco and vapes that are harmful to health would mean that protection of public health will have to be compromised with other interests," Mendoza said. "If public health is compromised, like what the vape bill does, public health loses."

Southeast Asia Tobacco Control Alliance (SEATCA) Executive Director Dr. Ulysses Dorotheo likewise urged President Ferdinand Marcos, Jr to veto the vape bill, citing the President's earlier veto of the Bulacan Airport special economic zone. In rejecting the House Bill 7575. which seeks the establishment of the Bulacan Airport City Special Economic Zone and Freeport in Bulakan town, President Marcos noted that its provisions infringes on or conflict with other agencies' mandates and authorities. He also noted that the enrolled bill "lacks coherence with existing laws, rules, and

### ORDINANCE NO. 42-22

AN ORDINANCE PROHIBITING THE USE OF CASH CARDS ISSUED TO HOUSEHOLD BENEFICIARIES OF THE PANTAWID PAMILYANG PILIPINO PROGRAM (4Ps) AS LOAN COLLATERAL OR PAWN SECURITY IN THE MUNICIPALITY OF KAWIT, PROVIDING PENALTIES THEREFORE, AND FOR OTHER PURPOSES.

WHEREAS, the Pantawid Pamilyang Pilipino Program or 4Ps is a human development measure of government that provides CASH GRANTS to the poorest of the poor, to improve the health, nutrition and the education of children of the household beneficiaries aged

0-18. WHEREAS, the CASH GRANTS are distributed to the household beneficiaries through a Landbank CASH CARD issued to them. WHEREAS, it is a common knowledge that there is a prevalent scheme of using ATM Cards and the like to be used as loan collateral or security for acquiring loan whether for profit or not;
WHEREAS, in order to protect the interest of the 4Ps household beneficiaries from unscrupulous individuals or groups, and protect them from the excessive interest rates, lack of formal contracts, and limited mechanisms for filing complaints, an ordinance which is a valid exercise of the police power vested upon the Local Government Units pursuant to Section 19 of the Local Government Code of 1991 (RA 7160) needs to be enacted;

NOW, THEREFORE, BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF KAWIT IN A SESSION DULY ASSEMBLED:

shall be known and cited as "CASH GRANT PROTECTION ORDINANCE OF THE MUNICIPALITY OF KAW-

### SECTION II. DECLARATION OF POLICY

- a. It is hereby declared the policy of the Municipality to promote the general welfare of its inhabitants; b. It is likewise the policy of the Municipality to protect its inhabitants from deceitful machinations perpetrated by unscrupulous individuals, groups or entities; and viduals, groups or entities; and
  c. It is also the policy of the Municipality to help the national government in weeding out undesirable household beneficiaries from the

- SECTION III. COVERAGE.

  a. Individuals offering loan to household beneficiaries of Pantawid Pamilyang Pilipino Program or 4Ps requiring Cash Cards as collat b. Officers or Agents of entities like associations, cooperatives, companies, or corporations offering loan to household beneficiarie Pantawid Pamilyang Pilipino Program or 4Ps requiring Cash Cards as collateral; and c. All household beneficiaries of the program including those families in the modified cash transfer program in need of special protect as follows: street families;

  1. titnerant indigenous families
  2. families displaced by natural and manmade disasters
  3. families with a person with disability (PWD)
  4. child laborers
  5. children in conflict with the law
  6. families with members with terminal disease, and

- 6. families with members with terminal disease, and 7. victim of human trafficking.

### SECTION IV. PROHIBITED ACTS.

- a. It shall be unlawful for any individual mentioned in Section III (a), officers or agents of entities like associations, cooperatives, companies, or corporations with or without juridical personality to offer loan to household beneficiaries mentioned in Section I requiring Cash Cards as collateral; and
- b. It shall be unlawful for any household beneficiaries or any member of the families mentioned in Section III (c) to use their CASH CARD as collateral for a loan or as pawn security;

### SECTION V. PENALTIES.

- SECTION V. PENALTIES.

  1. For persons mentioned in Section III (a), a fine of Four Thousand Pesos (2,500.00) or imprisonment of four (4) months or both at the discretion of the court shall be imposed for the violation of this Ordinance.

  2. For household beneficiaries or any members mentioned in Section III (c), a fine of One Thousand Pesos (P 1,000.00) or imprisonment not to exceed two (2) months, or both at the discretion of the court shall be imposed for the violation of this Ordinance.

  3. Formal endorsement to the DSWD so the same can conduct investigation and impose disciplinary action based on their procedural guidelines in handling cash card pawning misdemeanors and their sanctions based on the context, merit, and gravity of the case.

SECTION VI DISPOSITION OF FINES

All fines collected in the enforcement of this Ordinance shall be deposited to the LGU/s Trust Fund and such shall be utilized for the programs and activities of the 4PS subject to the usual auditing and accounting rules and procedures.

SECTION VII. IMPLEMENTING RULES AND REGULATIONS.

The Municipal Social Welfare and Development Office is hereby mandated to formulate the implementing rules and regulations of this ordinance for its efficient and effective implementation, within sixty (60) days after its effectivity.

### SECTION VIII. REPEALING CLAUSE.

Any ordinance or executive orders, proclamations and administrative regulations or parts thereof which are inconsistent with any of the provisions of this ordinance are hereby repealed or modified accordingly.

### SECTION IX. SEPARABILITY CLAUSE.

If, for any reason a portion or portions of this Ordinance is declared unconstitutional or invalid, the same shall not affect the validity of the other provisions not affected thereby, pursuant to the provisions of RA 7160 otherwise known as the Local Government Code of 1991.



# 8 media poser arrested for extortion

Kampo Heneral Paciano Rizal, Sta Cruz, Laguna- Eight suspects who posed as media personalities and allegedly extorted money from a funfair owner was arrested in Calamba City, Laguna.

Laguna Police Provincial Commander Col Cecilio Ison Jr identified the suspects as Anne Cortez, Éric Floro, Rose Marie Malazarte, Benjamin Javier Jr, Theresa Regaza, Christoper Yu, Efren Regaza, and Rodamy Prado.

Based on the report of Calamba City Police, victim Jinggoy Cahanap, 34 years old, owner of the single stander amusement requested for police assistance.

According to the

victim, he was at Checkpoint Purok 1, Barangay Paciano, Calamba City, Laguna when the suspects on board a Toyota FX arrived and identified themselves as media personnel.


The victim said he was harassed by the suspects when he only gave P2,000.00 instead of the P8,000.00 weekly protection money while threatening him that if he refuses, his funfair will be forcibly closed.

Acting upon the report, personnel of Calamba City Police proceeded to the place of incident to validate the said report that led to the arrest of suspects.

Recovered from the suspects were several fictitious identification cards and the extortion money. It was also found out that the suspects are the same persons who were reporting false information through E-sumbong and PNP Info Text dragging the name of Calamba City Police and the Chief of Police.

Ison said, "We will investigate this matter. This is a rising concern which we must address to halt the modus operandi of these persons who are patrolling around funfair busiestablishments to extort money in exchange for 'the continuity of the business operations.' These culprits are seemingly the same persons who are sending us (PNP) thru social media and our hotline numbers. We have started to launch operations to address these concerns."
