# **Palace says af**

MANILA - Malacañang on Friday expressed concern over the detection of first case of monkeypox in the Philippines.

"This is not particularly fatal but it is of concern," said Press Secretary Trixie Cruz-Angeles in a Palace press briefing.

This, after the Department of Health (DOH) confirmed the first case of monkeypox in the country, involving a 31-year-old Filipino who returned to the country from an overseas trip last July 19.

The reverse transcription- polymerase chain reaction (RT-PCR) test result conducted Thursday showed that the unnamed patient is positive for monkeypox, said DOH officer-in-charge (OIC) Undersecretary for Public Health Services Team Beverly Ho.

The patient is ob-

serving strict isolation and monitoring at home, Ho said.

Despite the discovery of monkeypox in the country, Cruz-Angeles said the DOH is on top of the situation.

"So, the primary concern is to get the in-





EXCERPTS TAKEN FROM THE REGULAR SESSION OF THE SANGGUNIANG BAYAN OF THE MUNICIPALITY OF KAWIT HELD ON MAY 16, 2022 AT THE SB SESSION HALL.

AN ORDINANCE PROHIBITING THE USE OF CASH CARDS ISSUED TO HOUSEHOLD BENEFICIARIES OF THE PANTAWID PAMILYANG PILIPINO PROGRAM (4Ps) AS LOAN COLLATERAL OR PAWN SECURITY IN THE MUNICIPALITY OF KAWIT, PROVIDING PENALTIES THEREFORE, AND FOR OTHER PURPOSES.

WHEREAS, the Pantawid Pamilyang Pilipino Program or 4Ps is a human development measure of government that provides CASH GRANTS to the poorest of the poor, to improve the health, nutrition and the education of children of the household beneficiaries aged

WHEREAS, the CASH GRANTS are distributed to the household beneficiaries through a Landbank CASH CARD issued to them WHEREAS, it is a common knowledge that there is a prevalent scheme of using ATM Cards and the like to be used as loan collateral or

WHEREAS, it is a common knowledge that there is a prevalent scheme of using ATM Cards and the like to be used as loan collateral or security for acquiring loan whether for profit or not;

WHEREAS, in order to protect the interest of the 4Ps household beneficiaries from unscrupulous individuals or groups, and protect them from the excessive interest rates, lack of formal contracts, and limited mechanisms for filing complaints, an ordinance which is a valid exercise of the police power vested upon the Local Government Units pursuant to Section 19 of the Local Government Code of 1991 (RA 7160) needs to be enacted;

NOW, THEREFORE, BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF KAWIT IN A SESSION DULY ASSEMBLED:

SECTION I. TITLE
This ordinance shall be known and cited as "CASH GRANT PROTECTION ORDINANCE OF THE MUNICIPALITY OF KAW-

- I. It is hereby declared the policy of the Municipality to promote the general welfare of its inhabitants;

  b. It is likewise the policy of the Municipality to protect its inhabitants from deceitful machinations perpetrated by unscrupulous indi-
- viduals, groups or entities; and
  c. It is also the policy of the Municipality to help the national government in weeding out undesirable household beneficiaries from the 4Ps program.

#### SECTION III. COVERAGE.

- a. Individuals offering loan to household beneficiaries of Pantawid Pamilyang Pilipino Program or 4Ps requiring Cash Cards as collateral; b. Officers or Agents of entities like associations, cooperatives, companies, or corporations offering loan to household beneficiaries of Pantawid Pamilyang Pilipino Program or 4Ps requiring Cash Cards as collateral; and
   c. All household beneficiaries of the program including those families in the modified cash transfer program in need of special protection

- c. All household benchciaries of the program including as follows: street families;

  1. itinerant indigenous families

  2. families displaced by natural and manmade disasters

  3. families with a person with disability (PWD)

- 4. child laborers
  5. children in conflict with the law
- 5. children in connect with the raw6. families with members with terminal disease, and7. victim of human trafficking.

- SECTION IV. PROHIBITED ACTS.
  a. It shall be unlawful for any individual mentioned in Section III (a), officers or agents of entities like associations, cooperatives, companies, or corporations with or without juridical personality to offer loan to household beneficiaries mentioned in Section I requiring Cash Cards as collateral; and
  b. It shall be unlawful for any household beneficiaries or any member of the families mentioned in Section III (c) to use their CASH CARD as collateral for a loan or as pawn security;

- 1. For persons mentioned in Section III (a), a fine of Four Thousand Pesos (2,500.00) or imprisonment of four (4) months or both at the discretion of the court shall be imposed for the violation of this Ordinance.

  2. For household beneficiaries or any members mentioned in Section III (c),
  a fine of One Thousand Pesos (P 1,000.00) or imprisonment not to exceed two (2) months, or both at the discretion of the court shall be

- imposed for the violation of this Ordinance.

  3. Formal endorsement to the DSWD so the same can conduct investigation and impose disciplinary action based on their procedural guidelines in handling cash card pawning misdemeanors and their sanctions based on the context, merit, and gravity of the case.

#### SECTION VI DISPOSITION OF FINES

All fines collected in the enforcement of this Ordinance shall be deposited to the LGU/s Trust Fund and such shall be utilized for the programs and activities of the 4PS subject to the usual auditing and accounting rules and procedures.

SECTION VII. IMPLEMENTING RULES AND REGULATIONS.

The Municipal Social Welfare and Development Office is hereby mandated to formulate the impordinance for its efficient and effective implementation, within sixty (60) days after its effectivity andated to formulate the implementing rules and regulations of this

#### SECTION VIII. REPEALING CLAUSE.

Any ordinance or executive orders, proclamations and administrative regulations or parts thereof which are inconsistent with any of the provisions of this ordinance are hereby repealed or modified accordingly.

SECTION IX. SEPARABILITY CLAUSE.

If, for any reason a portion or portions of this Ordinance is declared unconstitutional or invalid, the same shall not affect the validity of the other provisions not affected thereby, pursuant to the provisions of RA 7160 otherwise known as the Local Government Code of 1991.

This Ordinance shall take effect after the requisite posting and publication in accordance with the provisions of the Local Government Code of 1991.

stressing that monkeypox is "not the same" as the coronavirus disease 2019 (Covid-19).

"First of all, it's only one case, number one. Number two, as you can see, it does not affect the entire population. Number three, this is not like Covid that can be spread by air very easily and could possibly be fatal," she said.

Monkeypox virus is transmitted with lesions, body fluids, and respiratory droplets, the World Health Organization (WHO) said.

Included among the primary transmission is intimate skin to skin

contact, (including sexually transmitted) as health authorities emphasize the importance of hand washing and avoid contact with suspect cases.

Upon detection of the recent case, the DOH immediately quarantined the person.

The symptoms of the disease include fever. intense headache. muscle aches, back pain, low energy, swollen lymph nodes and a skin rash or lesions.

The WHO said vaccination against smallpox may help stop the monkeypox virus transmission. (PNA)





On August 8, 1975, Presidential Decree No. 765 was issued by then President Ferdinand R. Marcos, Sr., establishing the Philippine Constabulary Integrated National Police or the PC/INP as the country's national police force, wherein the Fire Department was integrated into a national police force with the Philippine Constabulary as its nucleus.

Then, on January 29, 1991 pursuant to the provisions of Republic Act No. 6975, which established Department of the the Interior and Local Government (DILG), hereby created the Bureau of Fire Protection (BFP) as a uniformed agency under the Interior sector, together with the Philippine National Police (PNP) and the Bureau of Jail Management and Penology (BJMP).


