

food supply. We cannot just allow 'bahala na kayo (let them be)'," Marcos, as quoted by the Presidential News Desk (PND), said during his meeting with members of the League of Provinces of the Philippines (LPP) on Thursday.

This, as knowledged the local government units' (LGUs) vital role in promoting food secu-

Marcos said it is important to lay out plans for the provinces' cropping schedules, yield, soil problems, and use of fertilizers.

"This has to be

part of a plan, and that is why, more than ever, the President needs the help of the governors. Dati, ang agri-culture (Before, agriculture), for example, was really under the national government," he said.

Marcos also met with the Department of Trade and Industry earlier this week to ensure that cheaper fertilizers would be made available for farmers.

In July, Marcos ordered agriculture officials to come up with a farm-to-market road (FMR) masterplan that will serve as the administration's guide in

rity and empowering rural communities.

Marcos said the masterplan should contain regional maps detailing the exact lo-cations of the FMRs that will be built.

He added that the funding source, payment terms, and the time frame for project completion should be included in the FMR masterplan.

Digital cooperation. During the meeting with LPP, Marcos also expressed his intent for strengthened cooperation between the national government and LGUs in the field of digitalization.

Marcos issued the statement, as he noted that local governments are good when it comes to digital connectivity.

"Marami sa inyong medyo progressive, inunahan niyo na ang national government (Some of you are somehow progressive and faster in information dissemination than the national government). Now, we have to bring the system together. Kailangan 'yung information na hawak ng isang probinsya, ng isang agency, accessible doon sa kabila (The information each province or agency has must be accessible to others) as long as they have authorization," he said.

The national government and LGUs, Marcos said, must be "literally interconnected."

"So, that's another area where we are hoping that we can strengthen the cooperation - the planning, the coordination between national gov-ernment and local government," the President said.

In his first State of the Nation Address delivered on July 25, Marcos unveiled his administration's plan for digital transformation through the so-called "BroadBand ng Masa" project.

Marcos tasked the Department of Information and Communications Technology to ensure digital connectivity across the country, especially in geographically isolated and disadvantaged areas. (PNA)







FIRE INCIDENTS IN M' MANILA DOWN BY 69%

Significant decrease in fire occurrence recorded three years in a row

QUEZON CITY - For the past three years of sustained and relentless fire prevention campaign, fire incidents in Metropolitan Manila had drastically gone down by 69.96 percent in the second quarter of 2022 as compared to the same period in 2019.

The Bureau of Fire Protection National Capital Region (BFPNCR) recorded a total of 1,640 combined structure and non-structural fires in the first semester of 2019, larger by 850 fire incidents compared to the same period this year with only 790 incidents or almost 70 percent decrease.

D = 0L Also, in the first half of the year 2020 and 2021, the BFPNCR recorded 1,571 and 1,122 fire incidents, respectively.

In the collection of fire code fees, BF-PNCR records also revealed a huge increase in its tax collection by 43.89 percent in the first semester of 2022, from P211,314,670.50 2019 in to P331,542,377.52 this year. The records also showed that in the vear 2020, the BF-PNCR has collected only P98,626,250.87 fire tax due to the spell of pandemic COVID-19.

"The notable decrease in fire incidents, three years in a row, is a result of the collective

efforts by the BFPNCR Command and its field officials, particularly the district, city and municipal fire directors and fire safety inspectors," BF-PNCR Director C. Supt. Gilbert D. Dolot said.

"A nonstop and unyielding fire prevention drive is being implemented both in the business sector and the community, even during the height of the pandemic COVID-19 through the Expanded Oplan Ligtas na Pamayanan (OLP) program of the Bureau of Fire Protection," he added.

Some 1,670 BF-PNCR firefighters got infected by the dreaded COVID-19 virus, with 1,665 of them were healed from the disease.



transporting patients to hospitals and isolation wards, and giving jabs to eligible vaccine recipients," Dolot said.

The OLP is a contingency plan for any emergencies in the community that has four significant and reliable programs: Handang Pamayanan (ready com-Bayanihan munity); (civic unity and cooperation); Kaagapay (companion); and, Lingap (protective care).

Knowing the big impact of the program in the community, the Department of the Interior and Local Government had issued a Memorandum Circular No. 2019-40 on March 15, 2019 for the implementation of the program in all barangays nationwide, recognizing the responsibility and capabilities of the barangay units to mobilize resources for prompt response to natural hazards and hu-



man-induced disasters like fire.

OLP variety of programs include Interactive OLP on the Road, OLP Bayanihan, and OLP Online, among others, designed to reach the community through personal and online approach on fire preven-

The BFPNCR has also lined up a total of 44 Program, Activities and Projects (PAPs) for a faster and efficient public service, wherein 18 projects were already done while 24 others are still in progress.

BFPNCR trained, so far, around 509 fire volunteer organization with and without certificate of compliance (COC), and some 9,328 fire brigades with and without COC as well. To continue in fulfilling its mission to prevent destructive fires, BFPNCR also entered into Memoranda with various local government units and the private sector. Among the pacts collaborative agreement are: usufruct; the BFP use of locally procured fire engines, aerial ladders, rescue trucks, mobile kitchen, shelter truck and trailer, and firefighting supplies and equipment; and, 'On-the-Job Training' of students from different colleges and universities. At present, BFPNCR is manned by 3,705 highly-trained and professional firefighter-rescuers ready to respond 24/7 to any emergency
