# DepEd wants admin tasks off teachers' shoulder

MANILA – The Department of Education (DepEd) is planning to reduce the workload of teachers by removing administrative tasks from their stead and introducing a work-balancing tool they could

use.

In a press briefing, DepEd Spokesperson Michael Poa said this tool seeks to assess the working hours of teachers and how efficiently they are being spent.

Poa said the DepEd

is determined to hire not only more teachers but also non-teaching personnel to help them, by including a budget allocation for the hiring of 10,000 teachers by 2023.

## Riding-in-Tandem Shoots Japanese in General Trias

**C**alamba City - A Japanese national was shot by still two unidentified suspects at the parking lot of Nolbo Restaurant Barangay Bacao 1, General Trias City, Cavite at about 11:30 AM of September 15, 2022.

The victim was identified as Osamo Yamada, male, Japanese, 52 years old, Company Director of R TECH and a resident of Imus City, Cavite.

According to the report, the motorcycle-riding criminals approached and shot the victim twice while standing next to his

car using a short firearm. Victim sustained gunshot wounds on his abdomen and was brought to Divine Grace Hospital and is now in stable condition.

PRO4A Regional Director Brig Gen Jose Melencio Nartatez Jr. directly ordered Cavite PNP to conduct dragnet operations for the immediate identification and arrest of the suspects. "This is another challenge to Cavite PNP. I directed them to conduct prompt action on this matter and put behind bars these criminals. Huwag ninyong hayaan na malaya at patuloy na gumawa ng kasamaan ang mga

kriminal na ito," Nartatez said.

In a CCTV footage gathered by investigators, the suspects can be seen on board a green Yamaha Mio motorcycle. The driver was wearing an orange Lalamove uniform, while the back rider was wearing a black long sleeve shirt.

General Trias police has launched a massive manhunt to capture the suspects and know the motive behind the shooting. The authority encouraged the public to report any information and whereabouts of these suspects for the rapid resolve of the case. **(ROSELLE AQUINO)**

sonnel or ma-reduce kung kaya namang ma-reduce (So we can see their actual teaching time, their administrative tasks, which we want to be passed on to the non-teaching personnel, to reduce [the teachers' load] if it could be reduced)," he said.

Poa noted that they are targeting to launch the tool this school year, as part of their "aggressive" move to reduce the teachers' workload.

"Within the year malalabas po natin 'yan kasi nga po ito'y isang magandang tool para ma-identify muna natin kung ano 'yung ginagawa ng mga teachers natin sa field (We can release it within the year because it is a great tool that could identify the teachers' tasks on the field) or on the ground," he added.

Besides the target launch, Poa said, the DepEd central office would also implement a reduction of special

assignments during events, requiring teachers' participation, as well as municipal or provincial events initiated by the local government units.

"Na-ta-task 'yung mga teachers natin na sumali sa activities na ito. Hindi na po natin gagawin, babawasan na po natin hanggat makakaya para po (Teachers are tasked to join these activities, but we will no longer do it. We will reduce these activities as much as possible so) the teachers will have more time in the classrooms than outside activities," he said.

Face masks In consideration of Executive Order (EO) 3, which makes the use of face masks voluntary in open spaces, Poa said they have yet to coordinate with the Department of Health (DOH) to ensure the prevention of any unnecessary spike in coronavirus disease 2019 (Covid-19) cases in schools.

"Our learners usually spend their time inside the classrooms, so it's still mandatory. However, in the latest developments brought about by EO 3, we will coordinate with the DOH. We will consult the DOH because there are times our learners are in open spaces," he said in mixed English and Filipino.

Poa noted that the result of their consultation would be incorporated into their guidelines, which he said would be issued "very soon."

"What we want to prevent is a major surge that would fully exhaust our critical care system in the Philippines. So again, we are still enforcing the health standards in our schools," he added.

Besides this, the DepEd will also verify and consolidate data from regional offices to provide actual monitoring of Covid-19 infection among learners nationwide, he said. (PNA)

# PH should end moratorium in building school libraries

Government should resume building school libraries to improve student reading comprehension of which the Philippines ranked last among 79 countries tested in 2018, House Deputy Speaker Ralph Recto said.

The Batangas Representative said, the government should terminate the moratorium in building new libraries as he believes that a school without one is like a swimming pool

without water.

In 2006, a P210 million budget was allocated to build 60 library hubs and 12 big learning resource centers, a program that proceeded only until 2014.

"Library construction has taken a long vacation from the national budget as a distinct program with specific funding," Recto said.

"Maglaan tayo ng pondo para sa libraries sa 2023 budget. It's

time to turn the page and reverse the neglect of this vital school facility," he said

As a remedial measure, DepEd's proposed new buildings fund of P5.91 billion, which is only enough for 2,379 new classrooms, should be augmented in next year's national budget.

"Kung totoong 900,000 enrollees ang bagong lipat from private to public schools, 'yan pa lang 22,500 dagdag na rooms na ang

kailangan," Recto said.

The Philippines had the lowest test scores in reading comprehension among 79 countries which participated in the 2018 Programme for International Student Assessment (PISA) by the Organization for Economic Cooperation and Development.

Based on the United Nations Children's Fund report, less than 15 percent of schoolchildren are able to



read simple texts, in large part due to school closures brought by the ill-effect of the pandemic in the country's "learning poverty."

"Let's make sure that our young people will fall in love with books. The building book depots and reading centers could be the start of their beautiful

relationship with reading," Recto said.

"If we want our kids to read, read, read, we should build, build, build libraries with free wi-fi so that students can tap the "online universe of reading materials waiting to be explored by curious minds," Recto added.
