et us distinguish the difference between #Annulment vs. #Declaration of # Nullity of Marriage vs. #Legal Separation.

#Annulment of Marriage (It is valid until annulled- Marriage between the parties existed). Grounds are as follows:



The party is 18 below 21 and the marriage was solemnized without the consent of the parents, guardian or person having substitute parental authority over the party, in that order, unless after attaining the age of twenty-one, such party freely cohabited with the other and both lived together as husband and wife.

A party was of unsound mind, unless such party after coming to reason, freely cohabited with the other as husband and wife.

That the consent of either party was obtained by fraud unless such party afterward, with full knowledge of the facts constituting the fraud, freely cohabited with the other as husband and wife.

*That the consent of either party was obtained by force, intimidation, or undue influence, unless the same having disappeared or ceased, such party thereafter freely cohabited with the other as husband and wife.

*That either party was physically incapable of consummating the marriage with other, and such incapacity continues and appears to be incurable such was not disclosed to the other party.

Declaration of Nullity of Marriage (Marriage is void ab inition or void from the very beginning). There is no marriage to speak of!! Grounds:

*One or both parties are minors.

*Lack of authority of the solemnizing officer unless either or both parties believed in good faith that the solemnizing officer had the legal authority to

*Lack of marriage license, except if there was cohabitation for 5 years prior the marriage and there is no legal impediment for them to marry each other.

*Bigamous or polygamous marriages.

*Those contracted through mistake of one of the contracting parties as to the identity of the other.

*Incestuous marriages as defined in Article 37 of the Family Code.

*Void marriages by reason of public policy(between step-parents and step-children, between adopting parent and adopted child).

*Psychological Incapacity in relation to Art. 36 of the Family Code.

Legal separation of(merely the separation of spouses from bed and board- Article 63 of the Family Code) While it permits the partial suspension of marital relations, the marriage bond still exist. Grounds are as follows:

*Repeated physical violence or grossly abusive conduct directed against the petitioner, a common child, or a child of the petitioner.

*Physical violence or moral pressure to compel the petitioner to change religious or political affiliation.

*An attempt of respondent to corrupt or induce the petitioner, a common child, or a child of the petitioner, to engage in prostitution, or connivance in such corruption or inducement.

*Final judgment sentencing the respondent to imprisonment of more than six years, even if pardoned.

*Drug addiction or habitual alcoholism of the respondent.

*Lesbianism or homosexuality of the respondent.

*Contracting by the respondent of a subsequent bigamous marriage, whether in Philippine or abroad.

*Sexual infidelity or perversion.

*An attempt by the respondent against the life of the petitioner.

*Abandonment of petitioner by respondent without justifiable causes for more than one year. (Article 55 of the Family Code of the Philippines).





Two big-time drugs personalities operating in Rizal were arrested and P7 Million pesos worth of suspected shabu was confiscated by joint operatives of San Mateo PNP and Rizal Police Provincial Intelligence Unit in a buy-bust operation conducted last night, September 26, in Brgy. Gulod Malaya, San Mateo, Rizal.

Diadema Cielo Ba-

basa, alias "Kikay" and Betty Cielo Babasa, alias "Bet", both residents of San Mateo, Rizal, and notorious drug personalities in Rizal were arrested by PRO4A operatives during the operations.

Based on the report, alias "Kikay" was caught in the act of selling sachet containing suspected shabu to a police officer who acted as a poseur buyer, while another sachet containing suspected shabu was recovered from alias "Bet" during the conducted buy-bust operation One big bag and 8 sachet containing suspected shabu

weighing more or less 1.026 kilograms worth P6, 979,520.00 were confiscated from the suspects.

PRO4A Regional Director, Brig Gen Jose Melencio Nartatez, Jr lauded the operatives of San Mateo MPS and Rizal PPIU for the significant accomplishment against illegal drugs in the Province of Rizal.

"I want to congratulate our operatives for a job well done. I am overwhelmed by this success. It only proves that we are on the right track in our campaign against illegal drugs", Nartatez said.

Meanwhile, the Regional Director directed an in-depth investigation on possible involvement of the previously arrested drug personality identified as another "Babasa" last September 24, also in San Mateo Rizal wherein 1.6 million of shabu was likewise seized.


