Four DOST CWWTL staff pass DOH Certification Course for Drinking Water Sampler

Four laboratory staff of the DOST Cavite Water and Wastewater Testing Laboratory (CWWTL) completed the Certification Course for Drinking Water Sampler last 2 June 2022, facilitated online via the Zoom platform.

The Department of Health - National Reference Laboratory (DOH-NRL) conducted the one-day training covering lectures on standards for drinking-water quality, water sampling and evaluation results, and operational standards for water testing laboratories. DOH-NRL likewise tackled the Philippine National Standard for Drinking Water (PNSDW), consistent with the World Health Organization (WHO) frameworks for drinking-water safety. The DOST CWWTL is



one of the government water testing laboratories compliant to the policy.

All four staff from the DOST CWWTL namely Ms. Verjo Angelie M. Sisante (Registered Chemist and Laboratory Head), Ms. Joan Mae B. Acacio (Registered Medical Technologists and Laboratory Analyst for Microbiological Testing), Ms. Thea Mary Joyce M. Diloy (Registered Chemical Technician and Laboratory Analyst for Physico-Chemical

Testing) and Mr. Herbert Salas (Laboratory Staff) passed the post-lecture written examination, and were awarded with a Certificate of Proficiency by the DOH-NRL.

Bukod pa dito ay pinag-aaralan din ni Sara Duterte ang pag-bibigay ng komento ukol sa sahod ng mga guro sa bansa, pagpapatupad ng face-to-face classes, at pagpapatupad ng batas ukol sa mandatory ROTC. bang para sa tamang pagtugon ng gobyerno sa pangangailangan ng bansa sa mga panahon ng kagipitan. "In the Philippines, we have been able to adjust to the situation in terms of the importations from Ukraine and Russia. But these emergency measures that we have taken will not be sufficient in the long run. That's why we have to plan in a more thorough fashion than just responding," sabi ni Marcos. "I have asked the DTI, NEDA, and, of course, the DOF and DBM. I have asked them all to start to make forecasts, economic forecasts on what we would have to face for the rest of this year so that we can prepare," dagdag pa niya.

Bukod sa pagbibigay prayoridad sa agrikultura, kasabay ding pabilisin ang pag-unlad ng sektor na ito para malutas ang kalkulangan sa pagkain. "We are going back to basics and we will rebuild the value-chain of agriculture. And that is why I think it's important that the President take that portfolio so that, not only will we make it clear to everyone, what a high priority we put on the agricultural sector, but also as a practical matter so that things will move quickly because the events of the global economy are moving very quickly," sabi pa ni Marcos. "We have to be agile. We have to be able to respond properly in a very measured way as soon as there is a situ-

ation that needs to be addressed," dagdag pa niya. Ang pagpapaunlad sa agrikultura, na naki-taan ng malaking problema sa gitna ng COVID 19 pandemic sa bansa, ay isa sa mga ipinangako ni Marcos noong panahon ng kampanya. Secretary of the Interior and Local Government (SILG) Eduardo Año paid his concluding command visit to the Bureau of Jail Management and Penology (BJMP) National Headquarters in Quezon City on June 16.

During his visit, Año recalled how the BJMP has become a steadfast partner of the DILG in safeguarding public safety and engaging the community in the rehabilitation and development of persons deprived of liberty (PDL).
