PBBM wants immediate release of Phil IDs

MANILA – President Ferdinand Marcos Jr. has ordered the faster distribution of the national IDs under the Philippine Identification System (PhilSys) to enable Fili-

pinos to use it by 2023. This developed after his meeting with National Economic and Development Authority (NEDA) Director-General and Socioeconom-

ic Planning Secretary Arsenio Balisacan via teleconferencing on Wednesday.

first half of 2023)," Marcos said in a Facebook post on Thursday.

In a Palace press conference, Press Secretary Trixie Cruz-Angeles said the seamless implementation of PhilSys is "essential" to ensure the country's economic recovery amid the prevailing coronavirus disease 2019 (Covid-19).

Cruz-Angeles issued the statement, as she noted that PhilSys registrants would be given formal access to banking and other financial services.

"Bahagi nga po iyan ng ating economic recovery. So, necessary kasi 'yung national ID. Essential siya lalong-lalo na doon sa banking systems, sa pagtatayo ng maliliit na negosyo or kahit anumang negosyo. So sa credit system mahalaga rin po 'yung national ID system (The national ID system is necessary because that is part of our economic recovery. It is essential, especially in terms of banking systems or establishment of

any business, including small businesses. The national ID system is also important for credit system)," she said.

Over 13.7 million PhilSys IDs have already been delivered nationwide, the Philippine Postal Corporation (Post Office) said Wednesday.

The figure is equivalent to 94 percent of the 14.5 million Phil IDs turned over for dispatch, as of June 30.

Only six percent or 774,650 ID cards are being delivered by the Post Office in far-flung areas of the country, Postmaster General Normal Fulgencio said.

Republic Act (RA) 11055 or the PhilSys Act, signed by former president Rodrigo Duterte in August 2018, mandates the issuance of a national ID that will serve as a valid proof of identity for all Filipino citizens and resident aliens.

The national ID, which is given for free, will eventually replace all other government-is-

sued IDs, except the passport, driver's license, and UMID ID.

The PhilSys collates the Phil ID holder's full name, sex, date and place of birth, blood type, and address. It will also indicate if a person is a Filipino or a resident alien.

The Phil ID also contains the holder's front-facing photo, full set of fingerprints, and an iris scan.

The disclosure of one's marital status, mobile number, and electronic mail address is optional.

RA 11055 was signed to make government and private transactions simpler and faster.

The law tasks the Philippine Statistics Authority (PSA) as the implementing agency responsible for the overall planning, management, and administration of PhilSys, the government's central platform for all citizen and resident aliens of the Philippines.

In January this year, the PSA partnered with state-run Land Bank of the Philippines to support the national government's agenda of financial inclusion by providing PhilSys registrants with their own transaction accounts.

To hasten delivery of basic services

Davao City Rep. Paolo Duterte called on the PSA and the Bangko Sentral ng Pilipinas to accelerate the implementation of PhilSys project to further reduce red tape and haste the delivery of basic services and financial aid to poor families.

He said the national ID system would not only make the delivery of financial assistance swift and efficient, but also help weed out "false" beneficiaries and improve social protection targeting.

"We urge the BSP and PSA to come up with a good catch-up plan to speed up the implementation of this vital project," Duterte said in a statement on Thursday.

Duterte said a PSA plan to issue printable versions of the national ID with a corresponding mobile ID that can be accessed through the PhilSys app could be a step in fast-tracking the full implementation of the project.

He, however, stressed that PSA should continue printing the physical ID cards considering that around PHP4.84 billion has been allocated for the PhilSys project under the 2022 national budget.

"A well-maintained national ID system will help the government clean up its database of beneficiaries of social protection programs, such as the 4Ps (Pantawid Pamilyang Pilipino Program). Even those who dupe the system by getting senior citizen ID cards even though they are not yet qualified to avail of the benefits for seniors will be weeded out," Duterte said. Minor raped and murdered, minors responsible under custody

Ka m p o Heneral Paciano Rizal, Laguna - Two minors responsible of rape and murder of a 7 year old minor victim was taken into custody by Barangay Tanod of Barangay Landayan, San Pedro City, Laguna.

Col Cecilio Ison Jr, Acting Laguna Police Provincial Director, identified the minors as alyas Broccoli and alyas Totoy.

Based on police report, at around 10:00PM of July 6, 2022, inside a vacant house at # 297 Dulo, Purok 6, Barangay Landayan, San Pedro City, Laguna, alyas

Broccoli was drinking liqour. Alyas Totoy arrived together with the victim identified only as alyas Ava whose mouth was tied with a cloth. Afterwards, the minors carried the victim to the 2nd floor of the vacant house then raped and strangled her that caused her death

When alyas Broccoli, was taken into custody by Barangay Tanods because of a stolen cellphone, Broccoli stated that he is responsible for raping the victim found inside a vacant house, while alias Totoy killed the victim by strangling her neck.

Immediately, the Barangay Tanods went

to the place where alyas Totoy was found, escorted him and turned-over the minors to San Pedro Police.

Broccoli executed extra-judicial confession in his participation on the commission of the crime in front of his counsel, CSWD representative, his mother and his sister, assisted by a counsel.

The cadaver of the victim was brought to Miraculous Funeral Parlor in San Pedro City, Laguna for autopsy.

The minors are now in the custody of City Social Worker Development office (CSWD) of San Pedro City.

Ison said "The whole PNP Laguna express deepest condo-

lences to the whole family of the victim. On the other part, let us take this as a lesson to every parent and to all of us, to be more vigilant and give extra-care to our little ones. We also thank our force multipliers like the barangay tanods for the

prompt action that lead immediate arrest of the suspects."

Brig Gen Antonio Yarra, Regional Director of PRO Calabarzon also said. "This is a breakthrough of a solved heinous crime because of the active support of our force multipliers. It is indeed a proof that a crime prevention and even the solution of a crime is a shared responsibility of the police and the community."

NEW CALAX INTERCHANGE TO OPEN THIS 2 ND HALF OF 2022

Binan City - The Cavite-La-

guna Expressway (CALAX) is set to make a major milestone this 2022, as it eyes the operationalization of its upcoming interchange -Silang (Aguinaldo) Interchange in the latter part of the year. This will extend CALAX' operational sections from Mamplasan, Laguna,

to Aguinaldo Highway in Silang, Cavite with interchanges at Greenfield-Mamplasan, Laguna Technopark, Laguna Boulevard, Santa Rosa-Tagaytay, and Silang East.

Upon completion of the entire CALAX project, it will connect to the Manila-Cavite Expressway (CAVITEX) in Kawit, Cavite.

CALAX is a 45-kilo-

meter expressway, Public-Private Partnership (PPP) with the Department of Public Works and Highways (DPWH) as implementing agency, and with private proponent MPCALA Holdings Inc. (MHI), a subsidiary of Metro Pacific Tollways Corporation (MPTC), the toll road development arm of Metro Pacific Investment Corporation (MPIC).

MPTC is the biggest toll road developer and operator in the Philippines. Aside from CALAX and CAVITEX, MPTC also holds the concession rights for North Luzon Expressway (NLEX), NLEX Connector Road, Subic-Clark-Tarlac Expressway (SCTEX), and Cebu-Cordova Link Expressway (CCLEX) in Cebu.

TANZA, Cavite (PIA) — Muling

ipinaalala ng lokal na pamahalaan ng Tanza sa publiko na panatilihin malinis ang kanilang kapaligiran, sa gitna ng tumataas na bilang ng mga kaso ng dengue sa kanilang bayan.

Batay sa datos ng Tanza Rural Health Unit (RHU), pinakamataas ang bilang ng mga kaso ng dengue sa kanilang bayan tuwing buwan ng Setyembre.

Subalit ayon kay Rural Health Officer, Dr. Ruth Punzalan, na-alarma ang lokal na pamahalaan sa biglang pagtaas ng mga kaso ng sakit sa pagpasok ng kasalukuyang buwan.

“Ngayong nasa buwan pa lamang tayo ng Hulyo, lumalampas na tayo sa linya ng pagtaas ng mga kaso noong nakaraang taon,” ani Punzalan.

Bilang tugon, sinimulan na ng lokal na pamahalaan ang mga programa nito kontra dengue. Kabilang na dito ang pagpuksa sa mga posibleng pamugaran ng lamok at pamamah-

agi ng mga misting machine sa mga paaralan at barangay.

“Nakita natin na sa ibang bayan ay mayroon nang outbreak [ng dengue]. Salamat dahil dito sa atin ay mayroon lamang ilang kaso,” ani Mayor Yuri Pacumio. PTCAO spearheads CAVITE CULTURE EXPO 2022

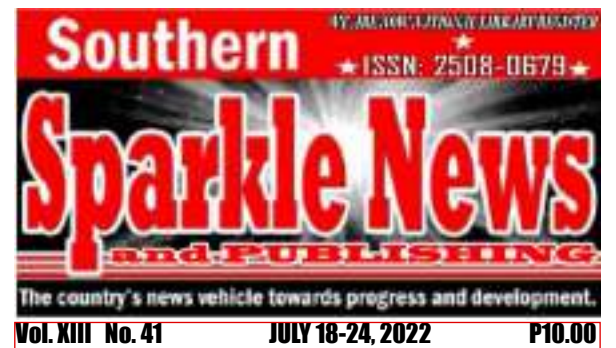


The Provincial Government of Cavite through the Provincial Tourism & Cultural Affairs Office (PTCAO)
