PBBM meets with DOH, DILG to assess Covid-19 situation

MANILA – President Ferdinand “Bongbong” Marcos Jr. on Thursday met with the officials of the Department of Health (DOH) and the Department of the Interior and Local Government (DILG) to assess the current coronavirus disease 2019 (Covid-19) situation in the country.

Marcos convened the meeting at Malacañan Palace in Manila, following the recommendation of

the Inter-Agency Task Force for the Management of Emerging Infectious Diseases (IATF-EID) to allow the optional wearing of face masks outdoors.

“Today, President Ferdinand R. Marcos Jr. met with key officials from the Department of Health (Philippines) and the DILG Philippines to assess the country’s Covid-19 situation in light of the IATF’s recommen-

dation to make face masks optional outdoors,” the Office of the President (OP) said in a Facebook post.

The OP, however, did not mention any decision made by Marcos with regard to the IATF-EID’s recommendation.

It, nevertheless, noted that Marcos sees as a positive development the continued drop in Covid-19 infections, amid his administration’s efforts to ramp up the nationwide vaccination drive.

6.8 Million Worth of Drugs Seized in Cavite, Suspect Arrested

LALAKI NA NASA LOOB NG PAMBABAENG CR SA ISANG MALL SA GENTRI, NANG-MAMANYAK NG MGA BABAE

Viral ngayon sa social media ang post ng isang concerned citizen ukol sa nangyari sa kanya mula sa isang CR sa Robinson's General Trias.

Batay kay Alex Dawn, uploader at biktima, nasa loob na siya ng isang cubicle sa CR ng naturang mall nang biglang may nag-slide ng isang pirasong tissue paper sa sahig habang mayroong nakatutok na camera ng cellphone na galing umano sa kabilang stall.

Matapos mabasa ang kabastusang nakasulat sa tissue ay kaagad umano niyang kinompronta ang tao sa naturang stall sa pamamagitan ng pagkalampag at paghiyaw sa kung sino man ang nagtatago roon.

“Walang masyadong tao sa loob ng cr, pero nag decide ako i-confront yung tao. Lumabas ako at pinag hahampas ko yung pintuan nung stall at nag demand na lumabas syang manyak sa. May isang ate na em-

ployee sa loob ng cr and sinabi nya na tatawag daw sya ng guard,” ani Alex.

“Pumunta ako sa entrance ng CR para i-advice yung mga papasok na merong lalaki sa loob ng CR ng BABAE. Sure enough, may lalaking lumabas galing sa isa sa mga stalls,” dagdag pa niya.

Matapos nito ay lumabas na ang lalaki na tila walang kasalanang ginawa at sinubukan pang magbigay ng rason.

“Nag reason pa yung manyak na hindi daw sya nag vi-video at nagkamali lang sya ng pasok ng CR. May dalawang ate na nag kkwentuhan sa entrance ng cr at sabi nila around 30mins na sila nandun and wala silang nakitang pumasok na lalaki so most likely kanina pa yung manyak sa loob at baka ilang victims na ang na videohan nya,” pagkukwento ni Alex sa kaniyang post.

“Very disappointing ang mabagal na pag respond ng mga guards

sa mall, knowing na ang daming assaults against women on top of kidnapping na nangyayari recently,” dagdag pa niya na ang tinutukoy ay ang security team ng naturang mall.

“I managed to get a few slaps and punches sa guy then sinundan namin sya at I grabbed his shirt dahil tatakas pa sya dahil ang tagal dumating ng mall guards,” pahayag niya.

Matapos nito ay kinuha umano ng mga rumespondeng security ang lalaki ngunit hindi niya sigurado kung dinala ba ito sa presinto.

“Security took him, I did not know what happened to him afterwards. If pina-pulis or pina-alis lang. Pero very questionable na parang kalmado lang yung manyak, parang matagal na nya ito ginagawa,” aniya. “But big thanks to all the women who were there with me at hindi ako pinabayaang mag isa. Please always be careful, scumbags are everywhere.” **(go cavite)**

PRO CALABARZON's One-Time Big-Time Operation Against Illegal Gambling Nets 1,162 Arrests

Camp B Gen Vicente P Lim, Calamba City - 1,162 individuals were caught during the regionwide conduct of One-Time-Big-Time (OTBT) Operations Against Illegal Gambling launched on September 6, 2022.

Police units of CALABARZON conducted 496 operations overnight and were able to arrest violators for cockfighting, playing Cara y Cruz, Pusoy, Tong-its, Lucky 9, Mah-

jong, Video Karera, Bookies, and other illegal numbers games. PHP 290,873.00 worth of bet money was confiscated from the violators who were identified as operators, financiers, and bettors.

PRO CALABARZON, Acting Reg Dir Brig Gen Jose Melencio Nartatez, Jr commended PRO4A police for such an exemplary effort to ensure the successful arrest of these violators who leads and enjoys such activities. “We will not let these unlawful ac-

tivities to proliferate in order to protect our citizenry from these illegal acts, particularly our children now that face to face classes have opened. They have no place in this region and we will hold all of them accountable to the law,” he said.

5 students hurt in a road crash incident in Cavite involving a PNP personnel

Camp B Gen Vicente P Lim, Calamba City - Five students were hurt following a road crash in General Mariano Alvarez, Cavite.

The victims were identified as Mark Christian Merillo, 16 years old, student, a resident of Blk30, L12 Brgy. Pulido, GMA, Cavite, Elijah Empas, 18 years old, student and a resident of Blk 32, L16 Brgy. Pulido, GMA, Cavite, Hazel May Peñaflores, 15 years old, student, and a resident of Blk 1, L70 Brgy. Poblacion 4, GMA, Cavite, Princess Sarah Arao, student, 15 years old, and a resident of Blk 33, L6 Brgy. Salud, GMA, Cavite and Lea Cortez, 15 years old, student, and a resident of Blk

21, L3 Brgy. Olaes, GMA, Cavite.

According to the police report, at about 6:15 PM of September 2, 2022, a Nissan Urvan URVAN with plate number AAQ-4143 is being driven by PSSg Anderson Videña, male, PNP member, currently assigned in GMA MPS, Cavite and detailed as Patrol member was traversing along Congressional Road from Barangay Poblacion 3 heading towards Barangay Memije, GMA, Cavite when he accidentally sideswiped the pedestrians who were walking along aforementioned road.

As a result, victims sustained minor injuries and were immediately brought at Carsigma Hospital located at Barangay Poblacion 1,

GMA, Cavite for treatment. The driver and vehicle involved are now under the custody of GMA MPS. Pertinent documents are now being prepared for filing of appropriate charges.

Meanwhile, PRO4A Regional Director Brig Gen Jose Melencio Nartatez Jr have instructed the Provincial Director of Cavite PPO to investigate properly and ensure no cover up, no whitewash and swift justice should be rendered in this case. He also instructed them to extend assistance to the victims.

"President Marcos welcomed the DOH report which noted a steady decline in Covid-19 cases. The DOH attributes the low positivity rate of 12 percent to the success of the government's intensified national vaccine rollout," the OP said.

The proposal to make the use of face masks optional was first broached by DILG Secretary Benhur Abalos Jr.

Abalos, citing data from different Southeast Asian nations, said there was barely a difference between number of Covid-19 cases in areas where wearing of face masks was mandatory and where they were partially or completely lifted so long as minimum public health standards are strictly observed.

DOH officer-in-charge

Rosario Vergeire backed the proposed optional wearing of face masks, but urged the public especially the vulnerable persons to continue wearing one.

Marcos' approval is needed before the IATF-EID's recommendation becomes a policy.

Press Secretary Trixie Cruz-Angeles reminded the public that the use of face masks remains mandatory, unless Marcos approves the proposal to make it voluntary.

As of Thursday, the country logged an additional 2,404 Covid-19 cases infections, raising the number of active cases to 24,032.

The country's total case load has now reached 3,898,882, according to DOH's Covid-19 tracker uploaded on its official website. (PNA)

DBP lends P1.286-B for first heart and brain center in CALABARZON



State-owned Development Bank of the Philippines (DBP) has granted P1.286-billion in funding support to a Batangas-based healthcare institution to enhance the delivery of basic and specialized health services in the Cavite-Laguna-Batangas-Rizal-Quezon (CALABARZON) region, a top official said.

DBP President and Chief Executive Officer Emmanuel G. Herbosa said the loan extended to Global East Medical Center Lipa, Inc. (GEAMC) under the Bank's Strategic Healthcare Investments for Enhanced Lending & Development (SHIELD) program will finance the construction of the first and only heart and brain center in Region IV-A.

"DBP's credit support to GEAMC Lipa is in line with the Bank's thrust of providing critical financial support to private healthcare providers for the improvement of the delivery of healthcare services to the Filipino people, especially those in the

country side," Herbosa said.

DBP is the sixth largest bank in the country in terms of assets and provides credit support to four strategic sectors of the economy – infrastructure and logistics; micro, small and medium enterprises; environment; social services and community development.

Global East Medical Center Lipa Inc. is a private corporation owned and operated by practicing medical practitioners and business experts in Lipa City. The new facility is expected to bolster the capacity of the region to cater to the growing demand for medical services which currently stands at 219,235 inpatient bed days and 150,621 outpatient visits.

Herbosa said that under the agreement, P1.136-billion will be utilized to partially finance the construction of a seven-storey Level 2 hospital strategically located along the J. P. Laurel National Highway in Lipa City while the remaining P150-million will cover

the acquisition of medical equipment and machineries.

He said that the projected expansion is a boon to the people of Lipa City and nearby municipalities, especially for patients with cardiovascular and cerebrovascular diseases being managed invasively or surgically.

"The project is also expected to decongest Metro Manila-based specialty hospitals while improving the bed capacity in the

province from 3,088 to 3,296 or a bed to population ratio of 1:817," Herbosa said.

DBP Executive Vice President for Development Lending Paul D. Lazaro said that as of May 31, 2022, DBP has approved 133 accounts under the SHIELD Program for a total of P35-billion with 20 of the projects located in Southern Luzon with aggregate funding of P6.5-billion.

"DBP is one with the National Government in its thrust to build specialty hospitals in various parts of the country, boost the local healthcare industry and provide accessible, quality healthcare services to the Filipino people," Lazaro said. — DBP
