vealed that they are now working with the POGOs to likewise require their workers to present proof that they are not wanted for criminal offenses in their respective countries.

Cases of kidnapping in the country have steeply gone up since 2017, most of them involved POGO workers.

Kidnapping involving POGO workers usually occurs after the recruited workers would be forced to go home after the salaries and perks that were promised to them are not met after their arrival in the Philippines. This year alone, 27 kidnapping cases involving POGO workers were already recorded by the PNP.

would then hire thugs, almost all of them Chinese and backed by Filipinos, to force the family to pay ransom in exchange for the release of their relatives.

Based on the PNP reports, the Chinese kidnappers would even resort to violence and torture in order to compel the relatives to pay the ransom.

Azurin earlier called for stricter rules that must be observed by POGOs for their workers, as he revealed that there was no clearcut policy since 2017 to check on the background and the status of foreign POGO workers in the Philippines.

He also revealed that the PNP was told

Azurin also ordered a crackdown on undocumented and overstaving POGO workers in the country and was the first to proposed that POGO workers must secure police clearance first before they are allowed to work in the country.

With POGOs now agreeing to the work requirements by government agencies. Azurin expressed confidence that everything about POGO will now be set right and will eventually lead to the end of involvement of POGO workers in various illegal activities.(Roselle Aquino)



PNP RELEASES CCTV CAPTURED PHOTO OF SLAIN BROADCASTER PERCY LAPID'S ALLEGED GUNMAN

The Philippine National Police National Capital Region Office (PNPNCRPO) had released the closed-circuit television (CCTV) captured photo of the alleged gunman who killed veteran broadcaster Percival "Percy Lapid" Mabasa in his car while on his way home to hold a live remote broadcast of his commentary show "Lapid Fire."

The incident occurred at around 8:30 in the evening on October 3 along Aria Street, Barangay Talon 2, Las Piñas City before Mabasa's car was able to enter the gate of BF Resort.

Latest police report based on gathered CCTV footagesshowed the alleged suspect, together with his companion waiting for Mabasa's vehicle to pass through their waiting spot along Zapote-Alabang Road across Las Piñas City Hall.

When they saw Mabasa's approaching vehicle, the assailants rode their motorcycle and tailed Mabasa down to Aria Street where the hitman fired shot at the victim who is driving alone in his vehicle before reaching the gate of BF Resort.

Mabasa sustained two gunshot wounds that caused his untimely demise.


The police officials, together with Department of the Interior and Local Government Secretary Benhur Abalos, Jr., asked the public to help in solving the brazen attack by giving important information

as to the identity and whereabouts of the perpetrators of the crime.

A total of P1.5 million bounty is being offered to anyone who can give substantial information for the arrest of the assailants. Businessman lawyer Alexander Lopez had offered P1 million, while Secretary Abalos shared P500,000 for a total bounty of P1.5 million for the arrest of the killers.

In his opinion, Ab-



alos believed that the intention to kill Mabasa is somewhat personal for someone to hire a professional assassin to murder the broadcaster.

Mabasa is who was a radio commentator at DWIZ 882 KHZ is regularly airing his hard-hitting commentary show "Lapid Fire" in DWBL 1242 AM Radio. He is also a staunch critic of the Duterte administration and some officials of President Ferdinand Marcos Jr.
