





PROMPT POLICE RESPONSE OF CIDG RIZAL **DETECTIVES RESULTED IN THE ARREST OF A GUNMAN RIGHT AFTER SHOOTING HIS VICTIM**

a m p BGen Vicente Lim. Calamba City - Detectives from CIDG Rizal PFU led by Maj Leopoldo Cajipe under the supervision of Lt Col Joel Manuel Ana, Officer-In-Charge of CIDG RFU 4A, arrested in flagrante delicto gunman Richard Lumbab right after shooting his victim Alfredo Badloza on November 3, 2022 at NHA Avenue, Sitio Padilla, Brgy. San Isidro,Antipolo City, Rizal.

The suspect was chasing the victim from interior alley until they reached NHA Avenue where the suspect fired his gun five times, hitting the victim twice causing the latter to fall unconscious on the

ground. The gunshots were heard by detectives of CIDG Rizal PFU whose office is just nearby the place of the incident.

As the suspect was about to finish off the victim, the responding personnel from CIDG Rizal, arrived just in time to foil the plan, and placed the suspect under arrest.

Cnfiscated from him was ine .38 Smith and Wesson revoler with defaced serial number loaded with one (1) round of live ammunition and five rounds of empty shells, 36 rounds live ammunitions for caliber 38 and 2 knives.

Investigation disclosed that the suspect was hired by a certain Jojo Cañete to kill the victim for P7,000.00. The victim averred that Cañete brought the suspect to his home apparently to kill him.

The rescued victim was immediately brought to Antipolo District Hospital for medical treatment and is now in stable condi-

The apprehended suspect and confiscated pieces of evidence were brought to CIDG Rizal PFU office for documentation and proper disposition, while a follow up operation was conducted against the at large suspect Cañete.

Ana commended the personnel of CIDG Rizal PFU for their prompt police response and sound judgment that saved the life of the victim and led to the arrest of the criminal. (ROSELLE AQUINO)

Undas 2022 in CALABARZON, Generally Peaceful

P Lim, Calamba City -Police Regional Office CALABARZON noted a generally peaceful celebrarion of 'Undas 2022' in all areas in the region, according to the reports from the five Police Provincial Offices.

Based on the monitoring done by this office, there were a total of 326,923 cemetery goers in the 584 cemeteries and 44 columbarium in the region. Remarkably, there were no recorded violent incidents related to Undas. However, authorities confiscated 179 prohibited items such as bladed weapons, sound equipment alcoholic drinks brought by cemetery goers which were earlier declared as contraband.

Nartatez lauded the different police stations and other units in the region for doing their duties and responsibilties in ensuring a

peaceful observance of All Saints Day or Undas.

'We also acknowledge the community in adhering to the policies of their respective Local Government Units and the massive campaign on Ligtas Undas Tips," Nartatez said.

Earlier, PRO CAL-ABARZON deployed a total of 7, 706 person $nel\ starting\ on\ \bar{O}ctober$ 29, 2022 as soon as the full alert status was declared by the PNP National Headquarters. "The mobilization of our troops were augmented by personnel from other agencies such as the AFP, BFP, and PCG together with our Force Multipliers," RD Nartatez added.

Aside from the establishment of checkpoints, the Municipal and City Police Stations also intensified their police presence and visibility in strategic areas and the cemeteries, and established Police Assistance Desks to assists motorists and travelers. (ROSELLE AQUINO)





HPG COP BUSTED FOR USING RECOVERED VEHICLE

BGen Vicente Lim. Calamba City - Agents of the Criminal Investigation and Detection Group conducted law enforcement operations on Thursday, October 20, 2022.

The Acting Director of CIDG, Brig Gen Ronald Lee identified the arrested person as Patrolman Anthony Lacandazo, 42 years old, married, and a resident of Sta Rosa, Laguna presently assigned with RCIT, HPG 4A.

Accordingly, the suspect was arrested by joint elements of the CIDG Anti-Organized Crime Unit together with the HPG 4A mobile team and PNP IMEG 4A.

"We have a series of Intelligence reports regarding the involvement of Patrolman Lacandazo using an evidence vehicle that was stolen in a robbery hold-up incident on July 20, 2022, that transpired in Ayala Alabang, Muntinlupa." Lee said.

The suspect was arrested at about 06:47 PM of October 20, 2022, while driving a stolen vehicle after it was flagged down by the HPG together with the elements of AO-CU-CIDG and IMEG due to unlawful transfer of vehicle plate.

Among the items taken as evidence from the suspect were a mobile phone, a white Nissan Van 350 with the license plate NDV 9038. and Plate number NCU 8461 which was originally assigned to Nissan Terra 2019 model.

The accused is now in the custody of the CIDG-AOCU for proper disposition and filing of appropriate charges.

'Manhunt operations are still ongoing to apprehend and arrest Lacandazo cohorts. The CIDG also intensifies the internal cleansing program of the PNP and will deal with rogue cops who continue to tarnish the good reputation and image of the police force." Lee added. (ROSELLE AQUINO)



DPWH – JICA HOLD FIRST MEETING ON ROAD DISASTER IN MOUNTAI

MANILA--The Department of Public . Works and Highways (DPWH), joined by Japanese experts, held the first of a series of meetings to discuss the work plan in improving the capabilities of DPWH and its engineers in incorporating the latest technologies to address the problem of road disasters in mountainous areas.

DPWH Secretary Manuel M. Bonoan stressed the importance of the meeting specially to the continuing program of the Department on disaster risk reduction and climate change adaptation.

Secretary Bonoan has earlier created a Joint Coordinating Committee (JCC) chaired by DPWH Senior Undersecretary Emil K. Sadain to ensure the effectiveness and success of the on-going implementation of the Technical Cooperation Project on Road Disaster Preventions and other Countermeasures on Mountainous Roads in the Philippines, under the assistance of the Japan International Cooperation Agency (JICA).

The meeting held at the DPWH Head Office in Manila was participated by DPWH Senior Undersecretary Sadain; IICA Senior Representative Koronuma Kenji; Embassy of Japan in the Philippines Second Secretary Tomohiro Matsubara: DPWH Assistant Secretaries and JCC Vice Chairpersons Constante A. Llanes Jr. and Eric A.



Ayapana; JCC members and Bureau Directors Melvin B. Navarro, Aristarco M. Doroy, Edwin C. Matanguihan, Reynaldo Faustino, Medmier G. Malig; Unified Project Management Office (UPMO) Project Director Benjamin A. Bautista; Regional Directors Khadaffy D. Tanggol, Ernesto S. Gregorio Jr., and Rev Peter B. Gille; and Service Director Rhalf B. Cawaling, as well as Japanese experts Project Leader Kuwano Takeshi, Iwasaki Tomoharu, Takizawa Masahito, Kawato Katsuhshi, Aoki Kazuya, and representatives from the National Economic Development Authority (NEDA).

Undersec-Senior retary Sadain said that the cooperation between Philippines and Japan will help facilitate development, transfer and dissemination of relevant technologies, not just in mitigation, but also in the reduction of risks posed by disas-

A work plan was presented by the JICA Project Team to establish coordination with the concerned Technical Working Groups (TWGs) for effective collaboration and smooth conduct of the project.

Secretary Bonoan said that the DPWH can take advantage of the technical assistance in order to come up with a safe and resilient infrastructure.

Japanese will assist the Philippine government with technology transfer which will enhance the capability on implementation of permanent countermeasure works and response for slope disaster, enhance capability to establish hazard maps for road disaster risk reduction, and improve the operational capability on road disaster information management based on the Road Disaster Information System to be developed.

Given the amount of expertise that is gathered, I am confident that the first meeting will be able to gather timely development outcomes, added Senior Undersecretary Sadain.

The DPWH JCC members and JICA is set to meet for the second meeting on June 2023 for project evaluation and monitoring. (Dpwhpio/Renante Arjay Jarobel)
