from 2.68 million in August, according to data from the Philippine Statistics Authority (PSA) released Tuesday.







ment rate this year is already "close to the pre-pandemic level", which was at 5.1 percent in 2019.

"This is a good sign. The economy is trying very hard to grow," Marcos was quoted as saying in a press statement from Malacañang.

He reiterated his commitment to improving the quality of jobs to address underemployment while bolstering job opportunities in the country.

"Ever since we started with the economic team, even before I took office, we really concentrated on the creation of jobs. And that's why it is having the effect now of bringing down our unemployment rate," he added.

Marcos recognized that rising inflation remains a concern under his administration but expressed confidence that the country could sustain the positive momentum with a lower unemployment rate.

"We just have to be able to tolerate the shocks that are coming from abroad. But otherwise, the economy is moving in the right direction," he added.

He also said accelerating job generation remains among the "top priorities" of his administration.

With the decline in unemployment, the PSA said employment rate improved to 95 percent, the highest recorded rate since January 2020.

The significant de-escalation of community quarantine restrictions translated to an employment cre-

ation of 4 million yearon-year, bringing the total employment to 47.6 million in September this year.

Socioeconomic Planning Secretary Arsenio Balisacan earlier said the improved joblessness survey results show "the gains of the full reopening of our economy." "The government will leverage this momentum by strengthening policy interventions and investing in innovation and technology systems geared toward generating higher quality employment that provides adequate income for Filipino workers and their families," he said. 

# One peso budget for OMB pushed by Senator Jinggoy



A P1 budget for the Optical Media Board (OMB) in next year's P5.286-trillion national budget is suggested by Senator Jinggoy Ejercito Estrada, due to the agenalleged lackluster cv's performancefor the past

The senator cited the agency's zero collection, no apprehension of violators, and zero performance in general.

'One year in office, wala talagang ginawa, zero performance. That's why on Monday, during continuing budget plenary deliberations in the Senate, I will propose a one-peso budget for OMB," the lawmaker said.

On October 18, upon learning of the OMB's proposed P75.858-million appropriations for 2023. Estrada questioned its chairman Jeremy Marquez onhis agency'salleged boring

performance since he heads the regulatory office to oversee the protection and promotion of intellectual property rights in digital form.

"During your term, there were zero administrative cases filed against violators of RA 9239 from November 2021 when you took over until about July of this year 2022. In contrast, the OMB was averaging 200 administrative cases filed each month before you took over," Estrada said.

Compared with predeces-Marquez's sors, the OMB collected an amount of P560.000 in 2018; P1.83 million in 2019: P350.000 in 2020; and P2.3 million in 2021 in administrative penalties, Estrada bared.

"And during your term, zero collection and no seizures of counterfeit and illegal storage devices from November 2021 when you took over until August of this year. In fact, you only ordered the OMB agents to conduct seizure operation against violators of RA 9239 just recently for you to have

something to report for the budget deliberations in both Houses of Congress," Estrada said.

The collected amount from OMB seioperations bezure 2018 to 2021 tween from P71.65 ranges million to as much as P309.9 million, but when Marquez took over it went down to only P100,000, the senator said.

When asked to explain, Chairman Marquez saidthe conduct of seizure operations is not necessary anymore since the illegal selling of pirated DVDs is no longer as extensive as before.
