PNP-PDEA JOINT OPS YIELDED P251.6M ILLEGAL DRUGS IN IMUS CITY, TWO BIG TIME DRUG DEALERS FALL

Police General Rodolfo Azurin Ir lauded the PNP drug operating units for the successful anti-illegal drugs operation on Saturday evening, November 12, 2022 in Barangay Buhay na Tubig, Imus City which yielded P251.6 million of suspected illegal drugs and arrested two big time drug peddlers.

Citing reports from Brig Gen Narciso Domingo, Director, PNP Enforcement Drug Group, and Brig Gen Melencio Nartatez, Regional Director, PRO4A, Azurin announced the arrest of Datu Ali Sampulna, male, 38, jobless and Almira Sampulna, female, 30, married, online seller, both resident of Cotobato City.

The two drug suspects were arrested in a joint buy-bust operation launched by operatives of PNP Drug Enforcement Group-Special Operations Unit 4B (PDEG-Drug SOU4B), PNP Enforcement Group 4A (PDEG4A), Cavite Provincial Intelligence Unit, Imus City Police Station, Regional Drug Enforcement Unit 4A and Philippine Drug Enforcement Agency.

Initial investigation disclosed that suspects were caught in the act of selling more or less one (1) kilogram of suspected shabu with an estimated pice of P6,800,000.00.

Another evidence confiscated on the possession of the suspects were one (1) white styro foam box containing more or less thirty six (36) kilograms of suspected shabu with an estimated price of P244,800,000.00, (1) one piece genuine one peso bill thousand dusted with ultra violet powder placed on top of ten (10) bundle of boodle money with a total of one (1) million (1,000,000.00)pesos placed inside a plain brown paper bag; one (1) piece yellow green tickler with label limelight notebook, one (2) units cellular phone (iPhone) color white and silver, one (1) pink pouch containing assorted Identification Cards and assorted remittance receipt.


The total value of illegal drugs confiscated in the anti-illegal drug operations weight more or less 37 kilograms with total price of P251,600,000.00.

Through holistic approach as the new face of anti drug prevention campaign of the government, PGen Azurin vowed that the PNP would remain relentless in its anti-illegal drug operations and in its drive to put a stop to the illegal drug trade in the country.



enator linggoy Ejerci-Estrada to is bent on amending the law to

assure equal and inclusive benefits to sportsmen who have brought honor and pride to the country, that will also level the playing field among able-bodied athletes and those with disabilities insofar as the grant of cash incentives is concerned.

"Hindi dapat mag-

ing batayan kung may kapansanan ba o wala ang isang atletang lumasa international hok competition at nagbigay ng karangalan sa bansa sa pagbibigay ng kaukulang incentives," Estrada said.

The Constitution guarantees the protection and security of every citizen from discrimination, exploitation and other forms of violence, and so, the disabled person shall be granted with the same civil rights as other human beings.

Estrada has filed Senate Bill No. 1442, seeking to amend Section 8 of RA 10699 or "National Athletes the and Coaches Benefits and Incentives Act," to institutionalize equal cash incentives to na-

athletes with tional disabilities who win medals in international sports competitions.

The measure aims to resolve the inconsistency of financial benefits among national athletes who shows the same level of commitment, hard work, and excellence in the field of sports.

"Our para-athletes should be entitled to the same cash incentives as other national athletes. Our laws should treat everyone equally especially if we're striving for the promotion of sports excellence," Estrada stressed.

In the proposed paralympimeasure, ans who bring home gold, silver, and bronze medals in Summer and Winter Olympics shall

be entitled to P10 million, P5 million, and P2 million cash incentives, respectively.

Under RA 10699, only half of the proposed douceur is being given to paralympians who canwin the gold, silver, and bronze medals.

Estrada further proposed the granting of P2 million to gold medalists in the Asian Para Games, as well as increasing the current P150,000 incentive to P300,000 for those who will bag the gold medal in the ASE-AN Para Games.

The seasoned lawmaker is also seeking to double the current cash incentives for silver and bronze medalists in Asian Para Games and ASEAN Para Games. (Benjie J. Murillo)
