Marcos orders PSA to spee printing of digital nat

Ferdinand R. Marcos Jr. on Tuesday directed the Philippine Statistics Authority (PSA) to ensure the prompt printing of electronic Philippine IDs

(ePhilIDs), the digital version of the Philippine Identification System (PhilSys) ID.

"Let us print out as much as we can and then isunod natin 'yung physical ID as soon as we can," Marcos said in a meeting with National Economic and Development Authority (NEDA) Secretary Arsenio Balisacan and PSA officials.

He issued this reminder following issues over printing capacity such as the "late start of the flow of data and the volume of the data (cont. p.2)

Currently, the data flow from PSA to the Bangko Sentral ng Pilipinas (BSP) has been rectified.

PSA Undersecretary Dennis Mapa, for his part, assured that his agency continues to work with the BSP in further expediting and boosting the volume of PhilID production and printing.

Mapa earlier pointed to the influx of registrants in the PhilSys for the delay in the printing of national ID cards.

In October, the PSA started the implementation of the printed digital version of the PhilID.

The PSA said it already issued over 2 million ePhilIDs at PhilSys registration centers nationwide as of Novem-

The printed ePhilID bears the same information as the physical PhilID card, containing the registered person's demographic data, front-facing photograph, PhilSys Card Number (PCN), generation date and QR code.

It allows faster and more seamless transactions in accessing financial and social protection services requiring proof of identity, subject to authentication.

The PSA, an attached agency of NEDA, is the implementing agency responsible for the overall planning, management and administration of PhilSys, the government's central platform for all citizen and resident aliens of the Philippines, according to Republic Act 11055 or the Philippine Identification System (PhilSys) Act.

Marcos earlier directed the PSA to issue 30 million PhilIDs by the end of 2022 and register 92 million of the country's population in the PhilSys by mid-2023.

P7.3 B PANGUIL BAY BRIDGE NOW 61% IN STATUS





ORTH-ERN MINDAN-AO—The Department of Public Works and Highways (DPWH) reports continued progress in the design and build of 3.17-kilometer Panguil Bay Bridge that will connect the City of Tangub in Misamis Occidental to the Municipality of Tubod in Lanao del Norte.

In his report to DPWH Secretary Manuel M. Bonoan, DPWH Senior Undersecretary Emil K. Sadain said that the DPWH Unified Project Management Office Roads Management Cluster 2 (UPMO-RMC2) (Multilateral) together with the project contractor Namkwang Engineer-& Construction Corporation in Joint Venture with Kuk-

this City.

Engineering dong Construction Co., Ltd. and Gumgwang Construction Co., Ltd. and consultant Yooshin Engineering Corporation in joint venture with Pyunghwa Engineering Consultants Ltd. and Kyong-Ho Engineering & Architects Co., Ltd. are exerting utmost effort as fast as possible to accelerate the vast pipeline of superstructure construction activities for the Panguil Bay Bridge Project which the longest crossing sea bridge is at 61 percent to date.

The bridge costing \$\mathbb{P}7.375\$ Billion, financed by a loan agreement between the Government of the Philippines and Korean Export Import Bank not only represents a long dream come true of the people of Lanao Del Norte and Misamis Occidental but

a milestone highlighting how the design and construction of a modern bridge with sea offshore excavation depth of up to more than 50 meters has evolved, added Senior Undersecretary Sadain.

Secretary Bonoan said that the administration of President Ferdinand R. Marcos is not only ensuring continuity of major infrastructure projects started by the previous administration, but also aims to fast-track completion to get Philippines back on the road to economic recovery from the pandemic.

Senior Undersecretary Sadain, who has overall supervision of all flagship projects being implemented by the Department under the continuing Build Better More Program, conducted construc-

tion site inspections on Wednesday, December 7, 2022 at the Panguil

Bay Bridge Project. He was joined in the field inspection by Undersecretary Maximo L. Carvajal; Assistant Secretary Eric D. Ayapana; UPMO Project Directors Sharif Madsmo H. Hasim and Benjamin A. Bautista; **Bureau of Construction** Director Aristarco M. Doroy and Assistant Director Edgardo C. Garces: Director Randy R. Del Rosario; and Project Managers Teresita V. Bauzon, Francisco M. Sawali, and Marlon V. Galerio.

The construction blitz started following the full completion of all the 54 bored piling works to allow the start of construction of the 36 abutment and pier column, 32 coping, and commence on both ends at Tubod and Tangub City the incremental launching method (ILM) for the superstructure.

DPWH has been continuously improving and expanding the capacities of road network through building of inter-island bridges to meet the increasing demands of the Philippine economy.

Bridging the geographical gap between Tubod and Tangub City/Ozamis City area, Panguil Bay Bridge will reduce travel time between Lanao Del Norte and Misamis Occidental from two (2) hours to just seven (7) minutes. While construction by about 336 manpower takes place round-the-clock to complete the project by December 2023, the bridge construction was affected during this last quarter of 2022 by a climate in the project area that is often rainy with strong currents of Panguil Bay.

Officially started on February 2020, the design and build of Panguil Bay Bridge have been pushed back attributed to restrictions of work at the height of pandemic and material/ supply chain issues, additional design time and delays in the arrival and release of equipment from abroad.

The Panguil Bay Bridge Project has a main bridge (extra-dosed type) with a length of 320 meters, 1,920 meter approach bridge made of prestressed concrete girder, and approach road. (Dpwhpio/Renante Arjay Jarobel)

800k worth of wildlife saved by DENR CALABARZON and CIDG Laguna



alamba City, Laguna The Department of Environment and Natural (DENR) Resources CALABARZON, through its Enforcement Division (ED), Licenses, Patents and Deeds Division (LPDD), assisted the Criminal Investigation and Detection Group (CIDG) Laguna PFU in a 10-hour joint wildlife buy-bust operation at Sitio 4, Barangay Oogong, Sta. Cruz, Laguna last November 18, 2022.

The joint operation was done in response to the request for assistance of the CIDG on an alleged illegal wildlife

trading operation in Calamba City, Laguna.

Recovered from the operation were 185 heads of various exotic wildlife species of Reptiles and Arachnids with an estimated market value of more or less Php 800,000.00.

Confiscated wild-life includes Ball Python (Python regius), Emperor Scorpion (Pandinus imperator), and Mexican Rose Tarantula (Aphonopelma Pallidum) which are classified as Appendix II in the Convention on International Trade in Endangered Species of Wild Fauna and Flora (CITES).

Other non-CITES confiscated wildlife

were Leopard Gecko (Eublepharis macularius), and adult and juvenile Bearded Dragons (Pogona vitticeps).

According to the LPDD, the illegal wild-life trader is a holder of a Certificate of Wild-life Registration for pet hobbyist purposes only and not for commercial trade.

All confiscated wildlife species were turned over to the Regional Wildlife Rescue Center in Calauan, Laguna for custody. Likewise, proper criminal charges will be filed against the suspect for violating Republic Act No. 9147 also known as the Wildlife Resources Conservation and Protection Act.

"DENR CALABARZON will continue collaborating with other law enforcement agencies to combat illegal wildlife trade and other illegal environmental activities", said ED Chief Annabelle M. Barquilla.


