### **6 FAMILY MEMBERS ARE KILLED WHILE 1 IS CRITICAL IN A ROAD ACCIDENT IN LAGUNA**

bers of a family were killed ater the pick-up they were riding turned turtle in Calamba City, Laguna Friday morning.

In a report from Calamba City Police, those killed were identified as Jhomel Hernandez Licas, 26, who is the driver and passengers Ruel Hernandez Dimail-Jonel Hernandez, 29; Medel Hernandez, and Angelo Her-32: nandez, 24 all from

Barangay San Roque, Tagkawayan, Quezon. The 6th victim remains unidentified.

Still in critical condition in a hospital is Marvin Hernandez, 22.

Witnesses told investigators that the pick-up truck were running at full speed at the curved portion of the national highway in the boundary of Barangay Paciano and Barangay San Cristobal, Calamba City.

Because of the speed, the pick-up truck swerved in the opposite

lane almost hitting a motorcycle and a passenger jeept.

The driver lost control of the steering wheel and turned turtle. The passenger were all pinned down and were retrieved by Calamba PNP, Calamba BFP and Laguna STAC

rescue teams. Four of the passengers died at Calamba Doctors Hospital while two were decared dead on arrival at Global Medical Care in Cabuyao City.(ROSELLE AQUINO)

tended. I know that it will not be the last, and that we will continue to break ground in different parts around the country para naman 'yung ating pinapangarap na (to achieve our goal of building) 1 million homes a year," he said. "'Pagka naabot natin, at least napakalaking bagay na 'yan na nabigyan natin ng solusyon ang problema ng pabahay ng ating mga kababayan (That would be a big help if we are able to fulfill our goal of providing a solution to the housing problem faced by our countrymen)," fellow Marcos added.

Marcos thanked the Department of Human Settlements and Urban Development (DHSUD), as well as the local government units (LGUs), for their role in the implementation of the Pabahay Pambansang Para sa Pilipino Program. He also expressed confidence in the success of the housing projects. "All of these things have to come together. It is not a question. Marami na tayong experience (We already have an experience)," Marcos said. "I hope that we'll continue at this rate, at kailangan na kailangan nating gawin ito (and we have to do this). This is one of the many actually that we are going to break ground and I hope soon." In November this year, Marcos pledged to build at least 1 million houses every year, as part of his administration's effort to address the housing backlog in the nou-the country. The Pambansang Pilinj-

The Pambansang Pabahay Para sa Pilipino Program is a flagship housing project of the Marcos administration which aims to provide around 6 million Filipino beneficiaries safe, affordable and comfortable homes.

A memorandum of agreement was signed between the DHSUD and government financial institutions to fund the department's housing projects.Once completed, the community township in Palayan City, Nueva Ecija will give rise to 44 towers that can accommodate 11,000 housing units.

The housing project will also feature several amenities and infrastructures, including a market area, livelihood center, health center and elementary school. The project is expected to generate around 1.7 million jobs every year from 2023 to 2028. Meanwhile, House Speaker Martin Romualdez lauded President Marcos Ir.'s inauguration of the 11,000 housing units under his administration's flagship Pambansang Pabahay para sa Pilipino Program in Barangay Atate in Palayan City, Nueva Ecija. "Building 6 million houses is the target of President Marcos Jr., I am very confident we can achieve this through our unity in purpose and the cooperation of all stakeholders in the program," said Romualdez, who accompanied the President during the event.

He said the 6 million houses may be just another target to accomplish, but imagine giving 6 million families houses they can call their own.

That is not only addressing the housing backlog, it is also realizing the dreams of millions of Filipinos who yearn for a house they can call their own, Romualdez added, saying this will go a long way in addressing the housing backlog in the country.

"President Marcos is addressing the country's woes on all fronts almost simultaneously: food security, foreign investments, jobs and livelihood, public order and safety, health and social protection, and now social services like hous-ing," he said. "We in Congress will do everything to support our President in all of his programs because we also believe that if we work as one, we can achieve even the greatest of ambitions. means of transport in Central Luzon as it form an important east-west link for the expressway network of Region 3 to ensure a continuous seamless traffic flow for the motoring public from Metro Manila and vice versa passing thru NLEX, SCTEX/TPLEX.

This project is part of the government's vision of easing traffic congestion and will shorten the usual travel time of 70 minutes between Tarlac City and Cabanatuan City to just 20 minutes.

The project is one of the key infrastructures with funding assistance from the Government of Japan thru Japan International Cooperation Agency (JICA) and is included in the Luzon Spine Expressway Network projects aimed at reducing travel time from the northernmost part of Luzon, Ilocos, to the southern most part, Bicol, by over 50 percent via the construction of high standard highway network.

### DPWH TARGETS CENTRAL LUZON EXPRESSWAY 25-KM OPERATIONAL BY 1ST HALF OF 2023



MANILA The expressway project in Central Luzon at the connection of Subic-Clark-Tarlac Ex-(SCTEX)/ pressway Tarlac-Pangasinan-La Union Expressway (TPLEX) in Tarlac City, Tarlac is targetted by the Department of Public Works and Highways (DPWH) to be operational up to San Juan, Aliaga, Nueva Ecija toward the first half of 2023

In his report to DPWH Secretary Manuel M. Bonoan, Senior Undersecretary Emil K. Sadain said that the DPWH Unified Project Management Office Roads Management Cluster 1 (DPWH-UP-MO RMC1) is currently working on the completion of additional seven (7) kilometer segment from Guimba-Aliaga intersection to Road San Juan Interchange that will extend to 25 kilometers the already accessible 18-kilometer

section of the Central Luzon Link Expressway (CLLEX).

The DPWH UPMO RMC 1 team with the contractors and consultants have worked hard to overcome challenges along the way, such as bad weather, right of way issues, difficulty in the transport of construction materials, and Covid-19 impact that caused some delays, added Senior Undersecretary Sadain.

Other than the four (4)-lane two (2)-way expressway with design speed of 100 kilometers per hour, DPWH is also undertaking the construction of three (3) interchanges namely Zaragoza, Aliaga and San Juan that will allow motorists from the secondary and provincial roads to access CLLEX.

When fully completed, this 30-kilometer CLLEX Project will facilitate fast, safe, comfortable and reliable (cont. p.5)
