BIÑAN CITY CELEBRATES ARAW NG BIÑAN

government unit officially opened its threeday annual celebration of Araw ng Biñan, on Thursday, Feb. 2 thru Araw Ng Biñan Grand People's Parade participated by city



local schools, youth organizations, socio-civic groups, and business establishments.

On February 2, 2010, by virtue of Republic Act No. 9740, Biñan became a component city after its voters accepted the ratification in the plebiscite. It became the 4th city in the province of Laguna and 139th in the Philippines.

Under the leadership of Mayor Arman Dimaguila, Jr., Vice Mayor Angelo "Gel" B. Alonte and Biñan Rep. Marlyn "Len" B. Alonte-Naguiat, the city of Biñan has been the recipient of numerous awards and accolades, in recognition of the sustained efforts of its city leaders to promote Biñan as a

center of trading and commerce in Southern Tagalog and as an outstanding heritage tourism destination. During his speech, Dimaguila said they did not spend on Christmas displays last December as it was focused on renovating the plaza, nestled at the center of the city's historical district.

Kinikilala na rin tayo ngayon bilang "Trading and Commerce Center of the South" at isa sa mga exciting destinations sa bansa.'

"Marami bayan ang nagpatayo ng magagarang buildings, mga istruktura na talagang mga kilalang arkitekto pa ang gumawa. Pero sabi nga ni BJ, isang bagay ang hindi nila kayang gawin - 'yun ay bigyan ng kaluluwa ang bawat building na ginagawa nila (Many cities have built extravagant buildings, structures created by wellknown architects. But as BJ said, there is one thing they could not do - give each building a soul)," Dimaguila said, referring to Biñan City Culture, History, Arts and Tourism Office head Bryan Jayson Borja.

The revival of Biñan Heritage District is one of the seven major programs under Balik-Biñan, a project named one of the Ten Outstanding Local Governance Programs in the 2022 Galing Pook Awards.

One of the prominent buildings in the district is the Historic Alberto Mansion - the

ancestral home of Dr. Jose Rizal's mother, Teodora Alonso.

Biñan City's "Balik Biñan Project: Tourism Development Through Heritage Conservation" was touted as one of the Top 10 awardees of the Galing Pook Awards (Please read story on C2). "Biñan is a rich city because of the Biñanenses. They are a very cooperative people. For as long as they know that we, their local government officials, are doing everything for the benefit of Biñan City, we can count on their support," said Dimaguila.
"We saw this during

the pandemic. The LGU was very successful because the Biñanenses trusted and supported us. We were also not blind about our shortcomings and we did our best to make up for this and address all their concerns. We are also committed to the development of our city," he added.(ROSELLE AQUI-

Quezon Drug Units seizes over 2M worth of Shabu, 2 Drug Suspects Arrested

BGen Vicente Calamba City - Drug Units of Quezon Police Provincial Office and General Luna Municipal Police Station in coordination with the Philippine Drug Enforcement Agency Quezon and Gen Luna nabbed two drug suspects one of which is a high value individual and seized ₱2,040,000.00 worth of illegal drugs during a joint buy-bust operation conducted on 01:45 AM of January 29, 2023, at Sitio Malalim, Barangay San Jose, Gen Luna, Quezon.

Based on the report, joint operatives conducted buy bust operation that led in the arrest of a high value individual and a cohort.

The joint operatives identified the suspects as Melody Palatino0p alias "Mami", 41 yrs old and listed as high value individual (HVI) in Quezon PPO Drugs watchlist, and Marie Maaño alias "Marie", female, 45 yrs old. Both suspects are presently residing at Sitio Malalim, Brgy San Jose, Gen Luna, Quezon. Confiscated from their possession were 20 sachets containing suspected shabu weighing 100 grams valued at ₱2,040,000.00 and monetary bill as boodle money. PRO CALABAR-

ZON Regional Director, Brig Gen Jose Melencio Nartatez, Jr lauded the remarkable accomplishment of the joint operatives that resulted in the arrest of the suspects who are known as big time drug dealer in the Municipality of Gen Luna, Quezon.

"Another high val-

ue individual fell in the hand of the authorities. We will never cease to operate and pursue those criminals especially those who are involved in illegal drugs. Rest assured that we will bring these suspects to conviction and make sure that they will never go back to drug trading. I also encourage the community to cooperate with the police so that the other suspects involved in the drug trading will also be arrested and put behind bars." Nartatez

Meanwhile, suspects and seized evidence are now under the custody of Gen Luna MPS for proper disposition and documentation. Suspects will be facing charges for violation of Sec 5 and 11 of Art II of RA 9165. (ROSELLE AQUINO)

A chatbot is a computer program that uses AI and natural language processing to understand customer questions and automate responses to them, replacing human conversation, according to American multinational technology corporation IBM.

The Philippine BPO industry earns around USD30 billion yearly, the same as the contribution from the remittance of overseas Filipino workers (OFWs), according to Honti-

The senator said BPO, OFW and tourism earnings sustain the country's import intensive growth stands.

If this industry gets into trouble, then dollars become scarce, they become more expensive, and the peso devalues. A pathway to entry into the middle class will also disappear," Hontiveros said.

The senator added that while preparing for the future of AI in the country, the DTI should simultaneously have a stronger campaign to protect the industry and its workers.

Hontiveros the DTI and Department of Information and Communications Technology must ensure sustained improvements in connectivity so that the work-anywhere model that is now central for talent retention will remain technically feasible even as clients' service standards continue to rise.

"The DTI should constantly highlight the particular care and attention that Filipino workers offer, a kind of service and human connection that no chatbot can ever provide," Hontiveros said. (PNA)

separate comfort rooms for men and women.

DOST-CALABARZON, LSPU-LB launch Al system to boost lakewater monitoring in Laguna



aking off from the last ment of the Sensing Environmental Parameters through Telemetry (SENTRY) project last 2015, DOST-CALABAR-ZON has partnered with the Laguna State Polytechnic University of Los Baños (LSPU-LB) to launch a leveled up version of this system now called the Enhanced Sensing Environmental Parameters through (e-SEN-Telemetry TRY). The launch of the e-SENTRY was conducted last 30 January 2023 at the Alligator Lake in Ba-

rangay Tadlac, Los Baños, Laguna.

The activiaimed to deploy e-SENTRY to aid in the monitoring of lakewater quality for the people of Tadlac. Through DOST-CAL-ABARZON's support, the said system will now be led and implemented by the LSPU College of Computer Science under the project, "Integration of Predictive Environmental Models Using Deep Learning Analytics in the Systems Implementation-Design" and is set to be further deployed in other areas.

Key officials were present to give their messages of sup-

port including Ms. Emelita P. Bagsit, Regional Director of DOST-CALABAR-ZON; Engr. Francisco R. Barquilla III, Assistant Regional Director for Tech-Technical Operations of DOST-CALABAR-ZON; Dr. Bobby Agatep, Vice President Research and Development to represent Dr. Mario R. Briones, University President of the LSPU System; Engr. Manuel Luis R. Alvares, Campus Director of LSPU-LB; and Mr. Jonardo R. Asor, Project Leader of e-SENTRY.

A ribbon cutting was conducted after each message. Hon. Ambito L. Meneses also gave their Closing Remarks.

In his message, Hon. Meneses expressed the need to look for alternative sources of drinking water for the community of Tadlac. The e-SENTRY, through its various water quality parameters and meteorological datasets, is built to estimate the ecological carrying capacity (ECC) of lakes which can help in strategizing approaches in management,

aquaculture development, and ecotourism.

2023, For e-SENTRY project targets to gather water quality (through the SENTRY stations) and meteorological datasets (from DOST-PAGASA) construct robust predictive simulation models based on deep learning algorithms to estimate ECC of lakes. The project is also developing an application software

for end-users, such as water monitoring and regulatory agencies, including Local Government Units, to monitor the data gathered by SENTRY stations.

To date, the project has already developed an information system prototype, and has been slowly building an online lake database. The project is anticipated to be completed in August 2023.
