DepEd: Working across sectors to address classroomshortage



MANILA – A Department of Education (DepEd) official on Monday called for a whole-of-society approach to address the perennial problem of classroom shortage.


In a speech, DepEd Undersecretary for School Infrastructure and Facilities Epimaco Densing III said support from various sectors will help solve infrastructure challenges.

"We want to make sure that we have non-government organizations, private

institutions, civil society organizations, and development partners to bring in the additional funding for us to add more classrooms outside of the budget provided for by the government, and this is something that all of us need to realize," he said during the National Planning Conference on the School Building Program in Zambales province.

Undersecretary for Administration Kristian Ablan said the DepEd field offices must be resourceful in addressing the problem.

"Let's think out of the box, RDs (regional directors) and SDSs (school division superintendents), let's discuss how we can be more efficient in planning and using the BEFF (Basic Educational and **(cont. p.8)**

The construction of the covered courts started last November 15, 2022 and it was completed on February 15, 2023 with a total cost of Php6,813,572.40. This project was supported by the Provincial Government of Cavite under the leadership of Governor Juanito Victor C. Remulla in line with the modernization program of the PNP.

Aside from this project, additional mobility and communication equipments were donated: 25 units of Toyota Wigo with an amount Php14,035,00.00; of 1 Lot of UHF/FM Digital Repeater with GPS with unit cost of Php9,705,287.00; 50 units of UHF/FM Digital Base Radio amounting to Php2,800,850.00; 120 Units of UHF/FM Digital Mobile Radio amounting to Php4,922,040.00; and 500 units of UHF/ FM Digital Portable Radio amounting to Php18,888,500.00 with a total amount of Php50,351,677.00.

RD Nartatez, Jr., praised the leadership of Hon. Juanito Victor C. Remulla, for this project, as these new establishments and communication and mobility equipment will boost the morale of the members of the Cavite Police.



TWO TOWNS IN QUEZON DECLARED INSURGENCY-FREE

municipalities in Quezon were declared Stable Internal Peace and Security (SIPS) after successfully meeting the criteria established under the phases of normalization per Revised Implementing Ioint Rules and Regulations to Executive Order 546 Series of 2006, specifically the absence of recorded NPA violent activities for at least one year.

The program also involves the redeclaration of CPP-NPA-NDF as Persona Non Grata in both municipalities as well as the signing of the Pledge of Commitment of all stakeholders particularly the local officials from the municipal level, including the different Barangay Chairmen and SK Presidents.

The activity was successfully conducted thru the collaborative and consultative efforts of the Municipal Task Force to End Local Communist Armed Conflict (MTF-ELCAC) of General Nakar and Infanta chaired by Hon. Widening of C.A. Yulo Avenue in Calamba, Laguna Now Complete



Dehe partment Public of Works and Highways (DPWH) recently completed its road widening project along C.A. Yulo Avenue

connecting South Luzon Expressway (SLEX) and leading to industrial parks in Canlubang, Calamba City, Laguna. With the allocation

of ₱101.32 Million, the project covers the construction of 1.4 kilometer, 14-meter-wide additional concrete

pavement that can accommodate four (4) more lanes. The project has a 1-meter center island and streetlights.

"With the completion of widening, the public will be able to utilize 6 lanes highway or 3 lanes per direction," said Regional Director Jovel G. Mendoza of DPWH Regional Office No. IV-A.

"In addition to facilitating better connectivity, this will significantly promote trade and economic activities in the area," added Regional Director Mendoza.

Other improvements are currently ongoing such as the 1.6-meter widening on both sides of the ex-1.4-kilometer isting length, and provision of drainage, sidewalk, curb and gutter.

The provision of bicycle facilities is also considered in the 2023 implementation consistent with the continuing efforts of the DPWH to support the promotion of active modes of transport.(DPWH)

Facilities Fund) but not just limit it to that," he said.

Ablan said the DepEd body should look into other possible means to build classrooms.

Meanwhile, the DepEd's field offices expressed elation over the renewal of coordination between the DepEd and the Department of Public Works and Highways (DPWH).

"If there are stateof-the-art and complete school facilities, the commitment of teachers will be renewed and the achievement of learners will also definitely increase," DepEd SOCCK-SARGEN regional director Carlito Rocafort said.

Vice President and Education Secretary Sara Duterte earlier vowed to prioritize addressing infrastructure challenges in DepEd which affect students' learning spaces.

Duterte said 6,000 classrooms are targeted to be built this year, with DepEd allocating PHP15.6 billion in funds for the construction of new school buildings. (PNA)

Meanwhile, the construction of Segment 3-B from Sucat to E. Rodriguez (RSG Subdivision), according to the latest project timeline of CIC, is set to begin in the third quarter of the year.

CAVITEX C5 Link project is a 7.7-kilometer 2x3 lane expressway that will connect CAVI-TEX R1 to C5 Road in Taguig. It is expected to serve 40,000 vehicles per day: reducing travel time to Makati and Taguig from Parañaque City, Las Pinas City, and Cavite Province by forty-five (45) minutes; and decongesting traffic in Metro Manila.
