China top source of imported fish for PH despite poaching



While the Chinese fishing militias help pull off the so-called great ocean robbery, by serving the dual purpose of harassing Filipino boats and ships, and by harvesting the bounty of West Philippine Sea (WPS), both done in illegal and dangerous manners, China still remains the top source of the country's imported fish, Deputy Speaker and Batangas Representative Ralph G. Recto said. Because of this Chinese blockade, share of our fish catch in the WPShas dwindled to 7 percent of total national fisheries production, according to Bureau of Fisheries and Aquatic Resources.

Thefencing off action made by China in Bajo de Masinloc (Scarborough Shoal) has claimed the country's exclusive economic zone territory as its backyard fishpond, and declaring it off limits to its true owners -- the Filipinos.

Some of the fish it feeds its 1.412 billion citizens are poached from Philippine waters, vacuum-cleaned from our rich reefs.

The value of this stolen fish is in the billions of pesos, not annually, but monthly, Recto said.

If harassing fisher-

men were a water sports in the Asian Games, China will sweep all the medals, as it treats the entire WPS as its exclusive practice area.

Chinese constriction of WPS cripples a pillar of our food security, as that area contributes almost 30 percent of commercial fisheries output.

And as we grapple with fish shortage, part-

ly due to the fact that our access to WPS has been denied, we resort to imports, Recto a former senator said.

And the painful irony is that we buy fish from China – the very source of our discontent.

By value, China is the number one source of our imported fish, accounting for a robust [cont. p.17]



PMCJ: US where is the finance for 1.5 C?

ANILA, PHILIPPINES —

The Philippine Movement for Climate Justice (PMCJ) the Asian Peoples' Movement on Debt and Development (APMDD) trooped towards the United States (US) Embassy in Manila on Friday to demand the US government to deliver its climate finance owed to the Southern Countries. This is one of the demonstration series across Asia led by APMDD to remind the US of its obligations before the Second Pledging Conference of the Green Climate Fund (GCF) to be held on October 5 in Germany.

PMCJ National Coordinator Ian Rivera remarked: Rich, developed countries are largely responsible for the climate crisis. Their rapid and unsustainable growth is paid for by the destruction of the atmospheric space, but developing countries only contribute little to climate change yet experience the worst effects. It is only just and fair that these rich countries pay reparation."

The US is the largest polluter contributing to climate change vet it blocked the establishment of the Low-Debt Climate Fund (LDF). This fund could have assisted nations which are most vulnerable and affected by the effects of climate change, such as the Philippines. Instead, the US was inclined towards loans to fund the climate mitigation efforts of developing countries. This would further plunge these countries into high debt.

Rivera added: "Until today, the US is still promoting the development of fossil fuel companies. Together with their corporations, they should be obligated to finance the developing countries and communities to undertake adaptation and mitigation actions for these countries to survive the climate onslaught. The Par-■ is Agreement should be geared to create a system that penalizes dirty and deadly energy while encouraging the development of clean renewables."

In the Philippines, climate financing is crucial in strengthening our climate di-saster response and ensuring a just transition to renewable energy. As calamities ravage the country, communities need to be equipped with the proper knowledge, and provisioning of technology, finance, and infrastructure to face these hazards.

Further, since workers will be displaced as fossil fuel plants shut down, funding will be required for provisions until they are trained and designated in green jobs.
