"Currently, there are some provincial jails which are not overcrowded,



# Sen. Legarda bats for minimum wage increase

ident Pro
Tempore Loren Legarda
expressed her support
for a bill increasing the
daily minimum wage
by P100 in the private
sector to uplift families
from poverty.

The four-term senator co-authored and co-sponsored Senate Bill 2534, which Senate passed on second reading

"It is high time we increase the minimum wage across the board in the private sector to alleviate the financial strain on families," said Legarda during her co-sponsorship speech.

"By ensuring that families earn a fair wage, we can address concerns about basic necessities. This will enable families to enjoy more fulfilling and stable lives. This is a matter of economic justice and basic human dignity," she added.

The minimum wage of all workers in the private sector, whether agricultural or non-agricultural, shall be increased by P100 a day upon the effectivity of the law.

Any employer found to have violated the law, if passed, will be fined between P25,000 to P100,000, or imprisonment between 2-4 years, as well as awarding back pay.

Per the Philippine Statistics Authority (PSA), a Filipino family of five would need at least P13,797 a month or P460 a day to make ends

"By increasing the minimum wage, there is a chance to lift individuals out of poverty. There is a chance for them to be more productive, to pay more taxes, to spend more in our economy, and to be able to live a life that they deserve," asserted Legarda.

The senator added that workers cannot be ignored and must be protected at all costs as they carry the country's economy.

The last time a legislated national wage hike in the Philippines was carried out was in 1989 through Republic Act 6727, or the Wage Rationalization Act, which raised the national minimum wage from P64 to P89

After the enactment of laws such as RA 11534 or the Corporate Recovery and Tax Incentives for Enterprises (CREATE) Act, which lowered the corporate income tax rate, it is now time to prioritize the workers' welfare.

"We cannot ignore the plight of our workers. They are the ones carrying this economy, and we must protect them at all costs. We must not tolerate inequality and poverty. This is why we must pass this measure," Legarda concluded.

Filipinos and the world with her charisma, authenticity, and sense of purpose, is redefining contemporary Filipino culture on a global stage. AN ORDINANCE FORMULATING THE CHILD LABOR FREE PROGRAM OF THE CITY OF CALAMBA, ALLOCATING FUNDS THEREFOR AND FOR OTHER PURPOSES.

Bo it ordained by the Sanggunian Paniungsod of the City of Calemba in session assembled, that:

ection 1. Title, This Ordinance shall be known as the "Child Labor Free Ordinance of the

Section 2. Definition of Terms. As provided for under RA No. 7518, as amended, and Department of Labor and Employment (DOLE) Department Order No. 65-04:

- a. "Children" refers to person below eighteen (18) years of age or those over but are unable to fully take care of themselves or protect themselves from abuse, neglect, cruelty, exploitation or discrimination because of a physical or mental disability or
- b. "Child abuse" refers to the maltreatment, whether habitual or not, of the child which includes any of the following:
  - 1. Psychological and physical abuse, neglect, cruelty, sexual abuse and emotional maltreatment,

  - Any act by deeds of words which debases, degrades or demeans the intrinsic worth and dignity of a child as a human being;

    3. Unreasonable deprivation of his basic needs for survival, such as food and shelter; or

    4. Failure to immediately give medical treatment to an injured child resulting in serious impairment of his growth and development or in his permanent incapacity or death.

- impairment of his growth and development or in his permanent incapacity or death.
  "Child labor" refers to any work or economic activity performed by a child that subjects him/her to any form of exploitation or is harmful to his/her health and safety or physical, mental or psychosocial development;
  d. "Working Child" refers to any child engaged as follows:
  1. When the child is below eighteen (18) years of age, in work or economic activity that is not child labor as defined in the immediately preceding sub-paragraph; and,
  2. When the child is below lifteen (15) years of age, (i) in work where he/she is directly under the responsibility of his/her parents or legal guardian and where only members of the child's family are employed, or (ii) in public entertainment or information.
  e. "Emptover" refers to any person, whether natural or juridical who, whether for valuable
- e. "Employer" refers to any person, whether natural or juridical who, whether for valuable consideration or not, directly or indirectly procures, uses, avails itself of, contracts out or otherwise derives benefit from the work or services of a child in any occupation, undertaking, project or activity, whether for profit or not. It includes any person acting
- in the interest of the employer;
  "Workplace" refers to the office, premise or worksite where a child is temporarily or

- habitually assigned. Where there is not fixed or definite workplace, the term shall
- include the place where the child actually performs work to render service or to take an assignment, to include households employing children;

  "Forced labor and slavery" refers to the extraction of work or services from any person by means of enticement, violence, intimidation or threat, use of force or coercion, including deprivation of freedom, abuse of authority or moral ascendancy, debt bondage or deception;
- or deception;
  "Worst forms of child labor" shall refer to any of the following:

  1. All forms of slavery, as defined under the "Anti-trafficking in Persons Act of 2023", or practices similar to slavery such as sale and trafficking of children, debt bondage and serfdom and forced or compulsory labor, including recruitment of children for use in
- armed conflict;
  The use, procuring, offering or exposing of a child for prostitution, for production of pomography or for pomographic performances;
- The use, procuring, offering of a child for flegal or fillott activities, including the production or trafficking of dangerous drugs or volatile substances provibited under
- works which, by its nature or the circumstances in which it is carried out, is hazardous or likely to be harmful to the health, safety or morals of children, such
  - Debases, degrades or demeans the intrinsic worth and dignity of a child as a human being; or,

    b. Expose the child to physical, emotional or sequal abuse, or is found to be highly

  - Expose the child to physical, emotional or sexual abuse, or is found to be highly stressful psychologically or may prejudice morals; or, is performed underground, underwater or at dangerous heights; or, is performed underground, underwater or at dangerous heights; or, is power-driven or explosive power-actuated tools; or, Exposes the child to physical strength or contortion, or which requires the manual transport of heavy loads; or, is performed in an unhealthy environment exposing the child to hazardous working conditions, elements, substances, co-agents or processes involving ionizing, radiation, fire, flammable substances, notious components and the like, or to extreme temperatures, noise levels or vibrations; or, is performed under particularly difficult conditions; or, exposes the child to biological agents such as bacteria, fungi, viruses, protozos, nematodes and other parasites; or, Involves the manufacture or handling of explosives and other pyrotechnic products.

Section 3. Committee Against Child-Labor in Calamba (CALC). A committee shall be created to determine the proper compliance, administration and implementation of this Ordinance. It shall consist of the following:

Section 4. Functions. The CALC shall have the following functions:

Section 5. Budget Allocation. The City Government of Calomba shall allocate an initial amount of Two Million Pesos (P2,000,000.00) for the implementation of this Ordinance.

Section 6. Repeating Clause. All other Ordinances, and/or parts thorsof, contrary to or inconsistent with the provisions of this Ordinance are hereby repeated, modified or smember

Sociales 7. Separability Classic. If for any reason, any provision of this Ordinance a declared to be unconstitutional by a court of competent pulseticion, the remaining provisions not affected shall remain to be in force and effect.

Section 8. Effectivity Chause. This Chainance shall take effect upon to publication and completely with all procedures required under Republic Act No. 7160, otherwise known as the Local Government Lode of 1991.
