



In line with its campaign to achieve a Drug-Free workplace, RHPU4A recently held an anti-drug prevention campaign for transport groups to include motorcycle operators or TODA to ensure a drug-free workplace and ensure the protection, safety, and security of the commuters and motorists in the entire region.

RHPU4A is one with Brig Gen Alan Nazarro's campaign in making the Highway Patrol Group a drug-free National Support Unit of the PNP. As one of the operating arms of this group and to ensure that this goal is being achieved, a random drug test was conducted on RHPU4A personnel to determine whether there are personnel involved in the use of prohibited drugs.

amp BGen Vicente P Lim, Calamba City Two individuals found themselves in police custody after being apprehended for multiple violations.

Alias "Jerome" and Alias "Christopher" were arrested by the Calamba Component City Police Station on the afternoon of October 8, 2023, for various offenses, including traffic infractions in Calamba City, breaching the Omnibus Election Code's gun ban, possessing p2,720,000.00 worth of illegal drugs, as well as resisting arrest along Manila South Rd, Purok 2, Brgy. Parian, Calamba City.

The incident began when police officers stationed at a COMELEC checkpoint in Calamba stopped a black Yamaha FZ motorcycle for lacking a license plate and violating the Calamba City Traffic Code due to the rider's wearing of slippers.

officers re-The quested the driver's license and necessary motorcycle documents.

During the routine inspection, suspicion arose when Alias "Jerome," one of the suspects, opened a backpack placed in front of him on the motorcycle's fuel tank. In plain view, one of the officers spotted 2 pieces of suspected drug paraphernalia, including a water pipe or an improvised tool that necessitated a standard procedure with a more thorough inspection.

Meanwhile, the second suspect, Alias "Christopher," resisted the officers, leading to a physical altercation with three PNP personnel before being subdued. A subsequent search of the suspects' belongings yielded 400 grams of Shabu, valued at P 2,720,000. Additionally, a caliber .45 pistol and a Magnum .22 revolver were confiscated from the suspects, along with Php 1,260.00 in cash found in the same backpack.

Brug Gen Paul Kennet Lucas, Acting Regional Director of Police Regional Office CALA-BARZON, commended the vigilant and swift action taken by the police officers manning our COMELEC checkpoint. "The arrest of the suspects underscores our commitment to upholding the law and ensuring the safety and security of our community as we prepare for a peaceful and successful Barangay and Sangguniang Kabataan Election 2023 in our region," Lucas stated.(ROSELLE AQUINO)



RESOLUTION NO. 518
Series of 2023

A RESOLUTION APPROVING CITY ORDINANCE NO. 777, SERIES OF 2023.

WHEREAS, City Ordinance No. 445, Series of 2009, was enacted to promote the adoption and utilization of Closed Circuit Television (CCTV) systems in selected business establishments within the jurisdiction of the City of Calamba, with the aim of enhancing the City's crime-solving capabilities and preserving visual evidence;

WHEREAS, the Department of the Interior and Local Government (DILG) has issued Memorandum Circular No. 2022-060 directing cities/capital towns to require the installation of CCTV systems for certain business establishments in accordance with Section 16 (General Welfare Clause) of Republic Act No. 7160 or the Local Government Code of 1991 to support the maintenance of peace and order and public safety subject to compliance with the privacy safeguards stipulated under NPC Advisory No. 2020-04;

WHEREAS, it is an accepted and proven fact that installation and operation of CCTV cameras, as a growing advanced surveillance and security technology worldwide, provide business establishments, schools, churches, hospitals, terminals, government offices and homes, among other the benefits of:

- a. Deterring disorder and violent crimes of potential offenders;
- b. Combating theft, burglary and other property crimes; and,
- c. Providing a safer environment thereby giving "peace of mind" and "reduced fear of crime" feelings to business owners, employees, workers, students, and the public.

WHEREAS, the installation of CCTV in all business establishments, as well as in schools, hospitals, and government offices, serves as an effective safeguard or deterrent against the commission of crimes and can be used as a tool for the safety and protection of the local constituents considering the current wide ratio of the number of law enforcers as against the total population in the city;

CITY ORDINANCE NO. 7.7.7.

AN ORDINANCE REPEALING CITY ORDINANCE NO. 445, SERIES OF 2009, OTHERWISE KNOWN AS "AN ORDINANCE REQUIRING ALL COMMERCIAL ESTABLISHMENTS, RESTAURANTS, FOOD CHAINS, INCLUDING PRIVATE HOSPITALS IN THE CITY OF CALAMBA WITH AN INITIAL CAPITAL OF ONE MILLION PESOS (P1,000,000.00) TO INSTALL CCTV CAMERAS ON STRATEGIC LOCATIONS WITHIN THEIR BUSINESS PREMISES AND IMPOSING PENALTIES FOR ITS VIOLATION".

Be it ordained by the Sangguniang Panlungsod of the City of Calamba in session assembled, that:

SECTION 1. TITLE OF ORDINANCE. This Ordinance shall be known and cited as "An Ordinance Mandating Covered Business Establishments and Government Offices, Facilities, and Amenities Operating within the Territorial Jurisdiction of Calamba City to Install Closed Circuit Television (CCTV) System, Providing Minimum Specifications, Privacy Safeguards and Restrictions, and Penalties for Violation

Thereof".

SECTION 2. DEFINITION OF TERMS.

BUSINESS ESTABLISHMENTS – Refer to enterprises, whether owned or operated by an individual, partnership, corporation, or cooperatives, that are duly organized and recognized under Philippine laws.

CALAMBA CITY INCIDENT COMMAND CENTER – refers to a special command center under the Office of the City Mayor, serving as an emergency call center with a facility that can accommodate calls through telephone, cellular phone and radio, all recorded 24 hours/7 days a week and operates the CCTV cameras 24 hours/7 days a week, with recording in the key areas of Calamba City.

CLOSED-CIRCUIT TELEVISION OR CCTV – refers to Closed-Circuit Television Camera with night vision capability that can produce images or recordings for surveillance purposes, and can either be camera, or digital still cameras; a television transmission system applied for security and surveillance purposes, using video cameras to transmit a signal via cable or wireless transmitter/receiver to a specific place, on a limited set of monitors.

DIGITAL VIDEO RECORDER - refers to a device or equipment attached to a CCTV Camera to record video images captured by CCTV Cameras, with a minimum of seven (7) day recording capability.

FEEDS - visual information or images transmitted by video surveillance cameras to the monitors.

FEED LOCATIONS – areas that are covered or viewed by video surveillance cameras.

GOVERNMENT - refers to national and local governments, including barangays.

HIGH RISK AREAS – refers to commercial/business establishments and other places and spaces with common business areas where there is greater degree of susceptibility to occurrence of accidents or criminalities due to numerous financial, social or business interactions, or their distance from the nearest law enforcement outpost/station or places and spaces where critical properties/facilities of the City are situated.

MONITORS – refer to the screens or other devices on which feeds are viewed.

NATIONAL LAWS – refer to those laws passed by Congress and signed by the President relative to this subject matter.

PRACTICE OF PROFESSION – refers to the exercise or employment of any particular profession which requires extensive education or specialized training.

RECYCLING — refers to the process of which records or tapes of feeds or visual information may be erased through the overrun by another or new visual information.

SATELLITE BRANCHES/OFFICES – refer to small extension offices of business concerns such as banks or any financial institutions.

DESIGNATED SECURITY PERSONNEL – police or civilian personnel authorized to operate or use particular CCTV camera/s acknowledged by the owner.

SECTION 3. SCOPE AND APPLICATION. This Ordinance shall cover the following business establishments within the territorial jurisdiction of the City of Calamba as well as national/local government/barangay offices, facilities, and amenities, except for those business establishments under the Barangay Micro Business Enterprises (BMBE) Law with an initial investment of less than Two Hundred Fifty Thousand Pesos (\$\bigsep\$250,000.00):

- Banks, financial institutions, pawnshops, money lenders, money remittance services, money changers and the like;
- Business establishments that are part of a national chain or have several branches in other parts of the country, such as restaurants/fast food chains, 24-hour convenience stores, drugs stores and the like:
- Shopping malls, shopping centers, supermarkets, wet markets or palengke/talipapa, and other similar establishments;
- Transport terminals/stations;
- · Hospitals, laboratories, clinics, and other medical facilities;
- Theaters, movie houses, perya, arcades, internet cafes, and other places of entertainment that draw in a considerable number of customers;
- Car dealerships, gasoline/fuel refilling/service stations, vehicle maintenance/service stations;
- All educational establishments and churches in the City of Calamba, whether private or public irrespective of their locations;
- All local government facilities, buildings and high-risk areas whether privately of publicly owned;
- Private and public resorts;
- Other business establishments which the Sangguniang Panlungsod deems proper considering the type of business and potential risks in their respective areas; and,
- All national/local/barangay offices, facilities, amenities operating within the territorial jurisdiction of Calamba City.

The abovementioned business establishments are required to install CCTVs which shall be maintained in proper working condition at all times, shall be in continuous operation and shall meet the minimum technical specifications set by this Ordinance.



The establishment or facility covered by this Ordinance shall post signage indicating that the establishment facility is being monitored by the CCTV cameras with areas visible to the public.

SECTION 4. REQUIRED MINIMUM TECHNICAL SPECIFICATIONS. The CCTV system to be installed must meet the following minimum specifications pursuant to DILG Memorandum Circular No. 2022-060:

CAMERA

- High-Definition Analog of at least 2 Megapixel Digital Camera;
- 0.1 Lux Illumination;
- Should have auto-iris focus lens (either fixed or vari-focal);
- 2.8 mm to 3.6 mm Focal Length;
- Auto-Iris Focus Lens (Fixed/vari-focal);
- 1/30s to 1/50,000s shutter speed;
- > 50-meter Infrared range;
- 120dB Wide Dynamic Range;
- Pan and Tilt adjustment of 0 degrees to 180 degrees and Rotate adjustment of 0 degrees to 360 degrees; and,
- Outdoor cameras must be vandal-proof with IP 66 weatherproof Casing.

VIDEO/AUDIO RECORDER

- Hybrid Type (accepts Digital and Analog signal), Minimum of four (4) camera input;
- Video and Audio Stream Input;
- H.264 (Advanced Video Coding) Video Compression and G.711u Audio Compression;
- 30 frames per second (FPS) recording capability per camera;
- Analog High-Definition Input (1080@25FPS, 1080p@30FPS, 720p@25FPS, 720@30FPS);
- Hard Disk Drive storage system with enough capacity to accommodate the prescribed retention period below. (4TB Capacity is approximately sufficient for 40 days of recording for DVR with 4 cameras at 1080p0; and,
- Time stamping feature.

VIDEO/AUDIO OUTPUT

- 720p or 1080p resolution;
- 30 FPS;
- At least 10 Megabits per second (Mbps) video Bitrate and at least 64 kilobits (Kbps);
 and,
- Audio Bitrate

OTHER COMPONENTS

- At least four (4) cameras covering the areas of transaction and risk. Provided that, at least one camera must be facing the street from the entrance (when applicable), with the actual number of cameras to depend on the size of the establishment and nature of business, as determined by the Sangguniang Panlungsod;
- Should have centralized power supply for the DVR and cameras; and,
- Should have appropriate Uninterruptible Power Supply (UPS) to provide standard and reasonable back-up power to the Video Recorder and its cameras.

SECTION 5. INSTALLATION GUIDE.

- Cameras must be installed at a secured location with maximum area of coverage of entrances/exits and areas of transaction or risk, ensuring that there will be no blind spots.
- The Video Recorder must be mounted in a secured/concealed location to protect the video footage from theft and/or deliberate destruction/tampering.
- Whenever possible, a back-up file stored in the DVD Disk (on-site or remotely) shall be recorded for archiving purposes.
- If feasible, a dummy CCTV camera shall be installed in a conspicuous area in order to deter possible criminal acts and to protect the camera and the video footage.
- Signage indicating that the establishment/area is monitored by a CCTV system must be installed in areas that are visible and obvious to the public, using clear, plain, and concise language.
- At least one staff or employee should be trained to operate the CCTV system.

SECTION 6. MINIMUM COVERAGE. All the establishments mentioned under Section 3 hereof shall be required to install CCTVs as to afford a full coverage of the following:

- A. FROM THE INTERIOR OF THE ESTABLISHMENT:
 - All entrances/exits; and,
 - The center of business activity in the establishment (including the tellers, cashiers, cash registrars, sales counters or areas leading to the vault/safe) according to the nature of business/operations of the establishment.
- B. FROM THE EXTERIOR OF THE ESTABLISHMENT (When the establishment is not located inside a mall or building which has its own exterior cameras):

- All entrances/exits;
- From the entrances/exits, a clear view to and from the street/s abutting the
 establishment, including frontage thereof, taking into particular consideration the
 clarity of shots in relation to the angles thereof; and,
- Parking lots and drive-through lanes (when applicable).

SECTION 7. IMPLEMENTING OFFICES. The Public Order and Safety Office (POSO) shall be responsible for the verification and determination of the relevant establishments' compliance with the provisions of this Ordinance. The POSO shall specify when compulsory inspection of the installed CCTVs shall be conducted before the necessary clearance or certification may be issued. This clearance or certification shall be a mandatory requirement for the issuance or renewal of a business permit or license by the Business Permits and Tricycle Franchising Office (BPTFO). The POSO may thereafter conduct inspections during reasonable hours to determine continued compliance with this Ordinance post-issuance or renewal of such establishments' business permit or license by the BPTFO. For all these purposes, authorized/designated POSO personnel of the City Government of Calamba shall seek the advice and assistance of the Local Chief of Police or his duly authorized representative/s.

SECTION 8. COMPLIANCE. Businesses covered by the scope of this Ordinance shall have a period of ninety (90) days from the effectivity of the same within which to comply with the provisions hereof. In case that the corporations or old business establishments subject for renewal cannot comply due to valid reason, they should secure an undertaking.

This period may, at the discretion of the implementing office and for a valid cause presented, be extendible for another 30 days in the first year of its implementation.

SECTION 9. PERIOD OF INSPECTION. Authorized/designated personnel of the Public Order and Safety Office of the City Government of Calamba, joined by any available Barangay personnel/officials, shall begin inspecting business establishments covered by this Ordinance three (3) months after the publication of this Ordinance, prior to the issuance of barangay certification, business clearance, and permits. Provided that, concerned POSO personnel shall present an office order duly issued by that Office and approved by the Office of the City Mayor or its duly authorized representative. Provided further, that a regular semestral surprise inspection to determine the continuous usability of the CCTV units shall be done by POSO at their convenience and availability during office hours/working days only. Establishments found not complying with this Ordinance shall be issued a Notice of Non-Compliance by the Office of the City Mayor, and liable establishments must comply with such notice within one (1) month after receipt of said notice.

SECTION 10. PRESERVATION OF VIDEO RECORDINGS. The owner/s of the business establishments shall preserve the camera recording for at least three (3) weeks (21 days). After twenty-one (21) days, the records or tapes of the feeds may be recycled or destroyed unless a proper request for a specific log of any given feed has been made. In such cases, the properly requested specific record/s of feeds must be turned over, in its original and unadulterated form and substance, to the proper requesting authority.

SECTION 11. PRIVACY SAFEGUARDS AND RESTRICTIONS (CONFIDENTIALITY AND NON-DISCLOSURE OF VIDEO RECORDINGS). The operator, owner, or manager of the establishment shall maintain the privacy and confidentiality of the video feeds, and recordings obtained as a result of the surveillance performed in accordance with this Ordinance. To ensure this, the owner and/or manager shall prohibit the use, viewing, copying, disclosure, or publication of said video feeds and recordings. Establishments covered by this Ordinance are, therefore, required to strictly comply with the National Privacy Commission's Guidelines on the use of CCTV systems as detailed in NPC Advisory No. 2020-04.

SECTION 12. ACCESS TO RECORDINGS. If a crime has been committed, or the operator, employee or owner of the establishment has reason to believe that a crime has been committed and has been recorded by the CCTV, they shall immediately contact the nearest police station and provide access to the pertinent recordings to the police and other investigators.

The operator, employee, or owner of the business establishment shall also make the camera recordings available to law enforcement authorities engaged in criminal investigation upon written request from the authorized or designated officer thereof, specifying the particular time and day covered by the request.

The captured video footage or images may be used at any time to satisfy the written order or subpoena of any court or body with competent jurisdiction.

SECTION 13. ALLOWED USE AND DISCLOSURE OF VIDEO FEEDS. The use, viewing, copying, or disclosure of the video feeds and recording obtained pursuant to the surveillance performed in accordance with this Ordinance shall only be allowed in the following cases:

- Use, viewing, copying, or disclosure to a member or officer of a law enforcement agency in connection with and limited to the investigation or prosecution of an offense punishable by law or regulation;
- Use, viewing, copying, or disclosure in connection with any pending criminal or civil proceeding; and,
- C. Use, viewing, copying, or disclosure that may be necessary for persons to determine whether or not an offense was committed against their person or property, to ascertain the identity of a criminal perpetrator, and to determine the manner by which an offense was perpetrated.

It shall be the responsibility of the owner and/or the manager to ensure that the conditions for use, viewing, copying, or disclosure of video recordings are reasonably



established before giving access to requesting parties. The extent of video recordings to be used, viewed, copied, or disclosed shall be limited to the images pertaining to the abovementioned instances.

SECTION 14. DATA SUBJECT REQUEST FOR ACCESS. Any person whose image is recorded on a CCTV system has the right to reasonable access and/or be supplied with a copy of their own personal data from the footage, subject to the provisions of Section 13 of National Privacy Commission Advisory No. 2020-04.

SECTION 15. POLICIES AND PROCEDURES FOR ACCESS AND OBTAINING A COPY. The following shall be considered:

- 1. Use of a standard form for request for access, provided, that a request for access containing information sufficient to process the request should be acted upon even if a standard from is not used:
- 2. Verification of the identity of the individual requesting for access through the presentation and/or submission of supporting documentation, provided, that the required information is only to the extent necessary to confirm such identity;
- 3. For persons requesting access for and on behalf of another, the owner or manager may request for evidence of proper authorization and other supporting documents to validate the authority and identity of the representative, as well as to confirm the identity of the requesting party;
- 4. Purpose/s of the request for access, which should not be contrary to law, morals or public policy and;
- 5. Sufficient details on the requested footage, such as the specific date/s, approximate time, location, among others, to enable the owner or manager to locate such

SECTION 16. DENIAL OF REQUEST. The owner or manager may refuse to provide a copy of CCTV footages or access thereto in the following instances:

- 1. Incomplete information regarding the requested CCTV footage, as stated in the preceding section;
- 2. The access request is frivolous or vexatious. The determination of what constitutes frivolous or vexatious may be made on the basis of the particular circumstances of the request:
- 3. Purpose for viewing or obtaining a copy of the footage is contrary to law, morals, or public policy:
- 4. The burden or expense of providing access would be unreasonable or involve disproportionate effort on the part of the owner or manager;
- 5. The footage has been deleted by the time the owner or manager receives the request, pursuant to its documented retention policy; and,
- 6. If sharing the footage could put an ongoing criminal investigation at risk.

If the owner or manager denies a request for CCTV access, it shall provide the requesting party with a written justification for such denial.

SECTION 17. PROHIBITION. The viewing of recorded or captured video footage or images shall be made with due respect to the privacy of individuals pursuant to the Constitution and

SECTION 18. PENALTIES, FINE, AND REVOCATION OF PERMIT. The following penalties be imposed for non-compliance with the provisions of this Ordinance:

- A. New business establishments shall not be given a business permit if it has not complied with this Ordinance.
- B. Old business establishments shall not be given a renewal of their business permits if they have not complied with this Ordinance.

Likewise, any violation of the substantive provisions of this Ordinance shall be punishable by:

For the business establishments of corporations:

: Three Thousand Pesos (\$\bar{2}\$3,000.00) shall be imposed For the first offense For the second offense : Five Thousand Pesos (₱5,000.00) shall be imposed

For the third offense : Revocation of Mayor's Permit

For the government agencies:

For the first offense : Three Thousand Pesos (\$\mathbf{P}\$3,000.00) shall be imposed For the second offense : Five Thousand Pesos (₱5,000.00) shall be imposed

For the third offense : Administrative Case

SECTION 19. APPEAL PROCESS. Any establishment found to be in violation of this Ordinance may appeal the findings to the Office of the City Mayor after the third offense within 15 days from the receipt of notice. The decision of the City Mayor shall be final and no motion for reconsideration shall be entertained thereafter, subject to such remedial measures as may be then available under the law or Rules of Court.

SECTION 20. NO CONTEST PROVISION. Any person, natural or juridical, who is

apprehended or cited for violation of this Ordinance and does not wish to contest the notice of violation, and is willing to pay voluntarily the fine imposed upon him/her prior to the filing of formal charges with the proper court shall be allowed to pay said fine to the City Treasurer to avoid being criminally prosecuted within three (3) working days from apprehension, otherwise the case shall be prosecuted.

SECTION 21. SOCIAL RESPONSIBILITY PROVISION.

- A. It is the social responsibility of the owners of business establishments covered by this Ordinance to allow law enforcement agencies to view the recorded videos in their CCTVs and to provide a copy thereof within seventy-two (72) hours of any footage then upon request in writing by any law enforcement agency, in aid of investigation. Non-compliance to the written request shall be penalized by suspension of Mayor's Permit and a fine of Five Thousand Pesos (₱5,000.00).
- B. Likewise, it is the social responsibility of the owner of business establishments covered by this Ordinance to protect the captured images of their CCTV camera/s and they are not allowed to share or upload maliciously or publicly any part or all of the captured images via digital form or print without the prior approval of the person/s subject of the video. Violation of this provision shall be penalized by cancellation of Mayor's Permit and a fine of Five Thousand Pesos (₱5,000.00).

SECTION 22. TECHNICAL WORKING GROUP. The Administrative Department will take lead upon creation and organization of the Implementing Rules and Regulations (IRR) within 60 days upon approval of this Ordinance and the following local departments were mandated to collaborate as well as tasked to assist in the creation of the IRR:

- a. Philippine National Police (PNP) Chief/OIC;
- b. Public Order and Safety Office (POSO) Department Head/OIC;
- Business Permits and Licensing Office (BPLO) Department Head/OIC;
- City Treasury Department Head/OIC;
- ABC Chairman & Barangay Affairs; and,
- Information, Investment Promotions and Employment Services Office (IIPESO) for the information dissemination.

SECTION 23. SEPARABILITY CLAUSE. If, for any reason, any section of this Ordinance shall be held unconstitutional or invalid, other sections which are not affected thereby shall continue to be in full force and effect.

SECTION 24. REPEALING CLAUSE. All Ordinances, rules and regulations or parts thereof in conflict with this Ordinance are hereby repealed, provided that the rights that are vested upon the effectivity of this Ordinance shall not be impaired.

SECTION 25. EFFECTIVITY. This Ordinance shall take effect fifteen (15) days following its publication in a local newspaper of general circulation.
