



ly connects to Aguinaldo Highway, seamlessly transports motorists towards tourist destinations in Tagaytay, Silang, Dasmarinas, and other nearby cities and municipalities in the province of Cavite.

Meanwhile, MPCA-LA states that construction for the remaining portion of the CALAX Cavite Segment continues in full swing. The next interchange will be a 7.9km 2x2 lane expressway that will extend from Silang (Aguinaldo) Interchange to Governor's Drive in General Trias.

As of the date, more than 95% of the right-of-way for this segment has already been acquired, and the team has already begun earthworks and bridge constructions.

'Governor's Drive will be the second-longest segment of CALAX, spanning almost 8km in length. We target to open it to the motoring public before the end of 2024. Through this interchange, we aspire to revolutionize our motorist travel experience, by connecting communities and helping improve the economy of the region," shared Mr. Raul L. Ignacio, President, and General Manager of MPCALA.

Looking CALAX is set to reach a total length of 45 kilometers by 2025, featuring eight strategically positioned interchanges: Technopark, Laguna Boulevard, Santa Rosa-Tagaytay Road, Silang East, Silang (Aguinaldo), Governor's Drive, Open Canal, and Kawit Interchange. CALAX will seamlessly connect with the Manila-Cavite Expressway (CAVITEX) in Kawit, further unifying key regions. Presently, operational segments span from Mamplasan Rotunda up to the Silang (Aguinaldo) Interchange.

MPCALA, a Metro Pacific Tollways Corporation (MPTC) subsidiary, is the leading mobility infrastructure and solutions provider in the Philippines. PRO CALABARZON Hauls 1.9 M Worth of Fake Cigarettes in Laguna

amp BGen Vicente P Lim, Calamba City – Joint operatives from the Regional Intelligence Division 4A and San Pablo City Police Station conducted a joint operation against Illicit whites or counterfeited tobacco product which resulted in the arrest of a suspect and confiscation of P1,975,350 worth of counterfeit cigarettes on November 24, 2023 at Tropical Subdivision, Brgy Concepcion, Pablo City.

Based on the report, the joint operatives assisted the ITP Executive from Philip Moris & Fortune To-Corporation bacco Incorporated during the conduct of joint operation against counterfeit PMFTC products. Authorities arrested the suspect idenrified only as alias "Shiela" female, 49 and resident of Brgy. Concepcion, San Pablo City, La-Confiscated guna. evidence from her possession and control are 36 boxes of assorted counterfeit cigarettes with estimated value amounting to P1,975,350.

Earlier, an illegal tobacco manufacturing facility and warehouse were also busted by the operatives of PRO 4A in Agoncillo, Batangas. accomplish-This ment is the result of the continuous campaign of PRO 4A against the proliferation of smuggled and counterfeit tobacco products in the CAL-ABARZON region.

ZO Regional Director BGen Paul Kenneth Lucas directed all the operating units to conduct thorough investigation regarding the illegal manufacturing and smuggling of tobacco products which hamper legal manufacturers of cigarettes which affects the economy by evading taxes. "Tututukan natin ang ating operasyon laban sa smuggling at manufacturing ng mga pekeng sigarilyo. Inatasan ko na ang ating mga Provincial Directors na magsagawa ng malalimang imbestigasyon at intelligence gathering upang maubos natin ang mga illegal na pagawaan at imbakan ng mga pekeng sigari-lyo," he said.

PRO CALABAR-

"Sa ating mga kababayan, mangyaring ipagbigay alam lamang sa inyong kinauukulan kung mayroon kayong nalalaman sa mga kahina-hinalang facility o factory dahil hindi lamang ekonomiya natin ang sinasabotahe ng mga iligalista, ilang mang-gagawa din at mga tobacco farmers ang nawawalan ng kita dahil sa paglaganap ng smuggled at pekeng sigarilyo" he added.

Meanwhile, the arrested suspect will face charges for Violation of RA 8293 or Intellectual Property Code of the Philippines. The confiscated contraband will be turned over to the appropriate authorities for further investigation. (ROSELLE AQUINO)



Authorities nab 33 suspects in crackdown against cigarette smuggling

Vicente P Lim, Calamba City -Law enforcement authorities from Agoncillo Municipal Police Station led by the Regional Intelligence Division Special Operations Unit, Intelligence Units of Batangas Police Provincial Office and the Bureau of Internal Revenue Region No. 9A-CABAMIRO (Cavite-Batangas-Oriental Mindoro-Occidental Mindoro-Romblon) apprehended 3 suspects involved in cigarette smuggling during a buybust operation morning of November 23, 2023 at Brgy Adia, Agoncillo Batangas.

A box of smuggled cigarettes worth P32,000 and buy-bust money amounting to P200,000.00 were confiscated, underscoring the success of operation.

Following this iniaccomplishment, authorities launched a comprehensive follow-up operation also at Brgy Adia, Agoncillo, Batangas aimed at dismantling the larger network responsible for the influx of smuggled cigarettes into the Philippine market. It resulted in the arrest of an additional 30 suspects. Among the apprehended were 8 Chinese and 22 Philippine residents highlighting the transnational nature of the illegal trade.

The follow-up operation uncovered a significant cache of smuggled cigarettes, further emphasizing the magnitude of the organized smuggling network. The combined efforts of law enforcement authorities in the region and the BIR led to the seizure of 4 production machines, 30 sacks containing pure tobacco and packing materials

amp BGen With sufficient commercial quantity, 331 boxes of cigarettes confiscated at Adia Warehouse and 341 boxes of cigarettes confiscated at Pansipit warehouse. All with estimated cost of P21,858,200.00 categorized as illegal by the BIR.

The production machines and other equipment, raw materials, vehicle, and other confiscated items are estimated to cost P300 million.

"The illegal trade of smuggled cigarettes undermines legitimate businesses, deprives the government of crucial tax revenue, and poses a direct threat to the economic well-being of our community. By dismantling this network, we are not just upholding the law; we are safeguarding the economic interests and prosperity of our country," BGen Paul Kenneth Lucas said in a statement.

The suspects arrested in both operations will face charges related to smuggling, illegal trade, and other offenses in accordance with Sections 6 (c), 15, 130, 131, 141, 142, 144, 145, 171, 172, 260, 263, 263-A, 265, 265-B, and 279 of the National Internal Revenue Code of 1997. The confiscated contraband will be turned over to the appropriate authorities for further investigation and disposal.

Lucas expresses its gratitude to the public for their continued support and cooperation. "The Police Regional Office CALABARZON in cooperation with other law enforcement agencies remain steadfast in its mission to uphold the rule of law and protect the citizens from the detrimental effects of illegal activities," he said.
