

ALAMBA CITY, Laguna - The Calamba Component City Police Sta tion said on Tuesday it is using motorized railroad cars to bring law and order to parts of this city that are inaccessible to the traditional

patrol car. Lt. Col. Milany Martirez, Calamba's police chief, told reporters these small vehicles allow policemen to patrol neighborhoods situated along the railroad tracks, specifically Barangay Parian all the way to Barangay Paciano Rizal. By deploying railroad cars equipped with advanced surveillance and communication gadgets, law enforcement officers can now operate in communities whose streets are too narrow for police cars to pass, she said. "This strategic deployment aims to bolster efficiency and effectiveness in crime deterrence, leveraging available mobility resources to their fullest potential," Martirez said.

A small four-wheeled railroad car propelled by a hand-operated mechanism or by a small motor is also called a "handcar."

In this case, the handcars being used by the Calamba police are propelled by small motors that are more often used to power small boats.


Martirez said the railroad vehicles are being used in conjunction with the city's newly-launched Police Community

Response and Monitoring (PCRM) Box network, which are small police A PCRM Box positioned in Barangay Parian's Purok 6 also serves as vital hub for public access to police assistance during emergencies.

Equipped with state-of-the-art communication devices, drone technology, first aid provisions, and rescue tools, these facilities ensure swift and effective response to crime incidents and accidents, she added.

Moreover, Martirez underscored the importance of synergizing with local authorities, including members of the Barangay Peace and Order Council (BPO) and Barangay Public Safety Officers (BPSO) to reinforce patrolling and monitoring efforts "Through this multi-stakeholder partnership, the police aims) to create a formidable frontline against crime while fostering a sense of security and trust within the community," she said. 



A RESOLUTION APPROVING CITY ORDINANCE NO. 799, SERIES OF 2024.

WHEREAS, on June 25, 2021, Executive Order No. 141, otherwise known as "Adop as a National Priority the Implementation of Measures to Address the Root Causes of the Ro Number of Teenage Pregnancies and Notilizing Government Agencies for the Purpose," issued which prioritizes interventions to prevent teenage pregnancies, and promoting youth dization.

WHEREAS, Section V of Department of Health (DOH) Administrative Order 2019-0026, otherwise known as "National Policy in the Provision of Birthing Assistance to Primigravid and Grand Multigravida Women," states that all primigravid (GI) and grand multigravida (GS and above) women shall be directly supervised by a doctor, preferably an obstetrics specialist, during the antenatal, delivery, and postrulal periods in a well-equipped facility with comprehensive emergency obstetrics and newborn care (CEMONC);

WHEREAS, DOH Administrative Order No. 2017-0012, otherwise known as "Guidelines on the Adoption of Baseline Primary Health Care Guarantees for All Filipinos," identified guaranteed population-based and individual-based primary health care interventions for each life stage, aiming to enhance citizens' knowledge and understanding of their health guarantees;

WHEREAS, DOH Memorandum No. 2020-0319, "Interim Guidelines on COVID-19 anagement of Pregnant Women, Women About to Give Birth and Newborns", further provides commendations from WHO Clinical Management, supporting protocols and guidelines for preventing, controlling, and treating infectious diseases during the prenatal, childbirth, immediate postpartum, and postpatal periods;

WHEREAS, on December 6, 2021, the Sangguniang Panlungsod enacted City Ordinance No. 730, Series of 2021, also known as "An Ordinance Mandating All Pregnant Women in the City of Calamba to Have Childbirth Attended by a Skilled/ Registered Health Professional or Trained and Registered Midwife and Penalizing Violations Thereof" to reduce maternal and neonatal mortality due to inadequate skills or training of birth attendants;

WHEREAS, on March 13, 2024, the Committee on Health and Sanitation of aniang Panlungsod conducted a meeting and determined that there is a need to amend ovision of the aforementioned ordinance to include, among others, the newly identified es and services for the Maternal, Newtorn, Child Health, and Nutrition Program, thereby mentions in amendment. Sangguniang P the provision o activities and s ding its amend

NOW THEREFORE, on motion of Councillor Dyan DV. Esp, unanimously seconded by all the members present, be it resolved as it is hereby resolved by the Sangguniang Panlungsod of Calamba City in session assembled, to approve City Ordinance No. 799, Series of 2024, to wit:

## CITY ORDINANCE NO. 799

AN ORDINANCE AMENDING SECTIONS 5, 6, 11, AND 14 OF CITY ORDINANCE NO 730 ENTITLED "AN ORDINANCE MANDATING ALL PREGNANT WOMEN IN THE CIT OF CALAMBA TO HAVE CHILDBIRTH ATTENDED BY A SKILLED/ REGISTERED HEALTH PROFESSIONAL OR TRAINED AND REGISTERED MIDWIFE AN PENALIZING VIOLATIONS THEREOF."

Be it ordained by the Sangguniang Panlungsod of Calamba City in session assembled, that:

SECTION 1. Section 5 of City Ordinance No. 730 is hereby amended to read as follows:

"SECTION S. The operation and management of the Calamba City Health BEMONC facility shall cover and extend to the following:

5.1 WOMEN'S HEALTH AND SAFE MOTHERHOOD SERVICE DELIVERY -assure the safety of mothers and newborns, BEMONC health personnel are allowed perform the following standard of care.

ON MATERNAL CARE: Farenteral administration of anti-convulsant, antibiotics, oxytocin and steroids for preterm programcies Assisted vaginal birth delivery Manual removal of placenta Removal of retained products of conception

Assisted vaginal delivery during imminent breech delivery Repair of vaginal tear or laceration

ON NEWBORN CARE:

Cord care Skin to skin contact Newborn Resuscitation Initiation of Breastfeedir Vitamin K administration

ON PRIMARY CARE SERVICES ESPECIALLY DURING PREGNANCY AND POSTPARTUM

Mental health services (screening and counseling) During emergency 1) mental health and psychosocial services MHPSS 2) Minimum Initial Service Package for motherhood MISP commodities: water treatment with hyposol, Jerry cans, clean delivery kts, hygiene kts;

5.2 MEASURES TO BE OBSERVED FOR OUTPATIENT CARE - During prenatal visits,

postpartum and postnatal follow-ups of women during their prognancy and after delivery shall observe the following:

- hygiene; Strict hand hygiene, respiratory hygiene, and the use of surgical mass patients, with or without respiratory symptoms (Do Not put on a face and/or face shield on the newborn); Contact and droplet precautions for all suspect, probable, and confirmed b.;

- cases; Triage and early recognition, and prioritizing care of symptomatic patients; Separate waiting room or area for symptomatic patients; Educate patients and other household members on early recognition of symptoms, basic precoutions, and which health care facility to go to; Consider modifications to standard protocols for antenatal visits and procedures, depending on levels of community quarantine including use of telehealth, reducing the number of clinic visits."

SECTION 2. Section 6 of City Ordinance No. 730 is hereby amended to read as follows:

"6.2 All primary care facilities with basic emergency obstetric and newborn care, care (BEMONC) capabilities shall have a referral arrangement with comprehensive emergency obstetric and newborn care (CEMONC) facility and/or partner Obstetrician and Rediatrician to ensure non-refusal of patients within their Health Care Provider Network"

6.3 If referral to CEMONC may pose further risk to the patient due to any difficulties, BEMONC facilities may cater patients regardless of their parity as long as the pregnant mother has no comorbidities, provided the following conditions: 1) BEMONC trained physician is present; 2) emergency transport whilde is on standby; and 3) referral hospital is available in cases of emergency complications;

6.4. That upon doctor's prudent assessment of the case and in extreme situations where an appropriate referral facility or specialist is not available, a doctor who is a general practitioner and trained on basic emergency obstatric and newborn care may assist in the delivery of G1 and G5 or higher gravidity in a well-equipped birthing center;"

SECTION 3. SECTION 11 of City Ordinance No. 730 is hereby amended to read as follo

"SECTION 11. ROLE OF THE BAILANGAY. The Barangay shall see to it that all pregnant women in their community shall be reported and monitored to prevent sudden and/or unexpected and registered midwives, nurses and professional health care providers will not be accepting any home birth contracts and/or services from pregnant women or their families.

11.1 ROLE OF THE SANGGUNIANG KARATAAN - The Sangguniang Kabataan (SKs) shall endeavor to identify and implement viable programs, activities, and projects and allocate a portion of their budget, as necessary, towards the following objectives:

- a. Educating the youth on adolescent sexual and reproductive health, even in a non-formal education setting, and normalize respectful dialogue on sexual and reproductive health matters;
  b. Providing youth-friendly and rights-based measures to support pregnant girls and young mothers to continue and complete their education;
  c. formulating retention strategies and ife skills programs for pregnant girls and young mothers, which may include vocational training opportunities;
  d. Following-up on pregnant girls or young mothers who have dropped out of school, through targetel outreach and support programs; and
  e. Ensuring the functionality of Barangay Anti-violence against women and their children's desks."

#### SECTION 4. SECTION 14 of City Ordinance No. 730 is hereby amended to read as follows:

"SECTION 14. GENERAL AND ADMINISTRATIVE PROVISIONS. The ing are the general and administrative provisions in the implementation of this following are ordinance.

- a. The Barangay Council shall allow the use of their barangay patrol vehicle/service vehicle to pregnant women on the due date of pregnancy to the hospital or any authorized birthing facility.
  b. The City Mayot, with the assistance of the City Health Office, shall issue implementing rules and regulations in the implementation of this ordinance.
  c. Traditional birth attendants, midwives, and health attendants are prohibited from accepting borne birth deliveries. The barangay shall implement quick response guidelines and actions should an expectant mother give birth outside of her due date. ibei
- Expectant mothers are inquired to deliver in any accredited birthing facility and hospital of their choice under the direct supervision and care of skilled, registered, and licensed birth attendants, such as midwives, numes, and doctors. đ. -

14.1 All birthing centers and providers of BEMONC shall strictly adhere to the following

- a. Attach a brief history, reason for referral, partograph, antenatal record and women's birth plan;
  b. Notify the ambulance or patient transport vehicle driver;
  c. Assign a midwife or nume to accompany and properly endorse the patient to the referral facility;
  d. While the patient is in transit, communicate (via call or SMS) with the referral facility to alert them of the patient's arrival;
  a. Follow up on the referred patient's condition on a daily basis; and,
  f. Endorse the patient back to the primary care facility once for discharge for reintegration into the community and ensure continuity of care.

14.2 The Guidelines and Protocols for Maternal, Newtorn, and Child Health Nutrition (MNCHN) core package of services in Calamba City shall be strictly implemented;\*

SECTION 5. SEPARABILITY CLAUSE. If, for any reason, any part or provision of this Ordinance is held to be unconstitutional or invalid, the other parts or provisions hereof, which are not affected hereby, shall continue to be in full force and effect.

SECTION 6. REPEALING CLAUSE. Any ordinances and existing rules inconsistent with the ordinance shall be repealed or amended accordingly.

SECTION 7. EFFECTIVITY CLAUSE. This Ordinance shall take effect after completion of publication or posting requirements in accordance with the provisions of the 1991 Local publication or posting req Government Code.






## Medical and Dental Mission in Brgy. Javalera serves hundreds of constituents.


