## Cayetano, muling nanawagan na ipagbawal ang lahat ng uri ng sugal

uling nanawagan si Senador Alan Peter Cayetano nitong Huwebes na itigil ang lahat ng uri ng sugal sa bansa, partikular na ang online gambling,



e-sabong, at ang kontrobersyal na operasyon ng Philippine Offshore Gaming Operators (POGOs).

"Ako yung siguro pinaka-outspoken, even when I was (House) Speaker, against all forms of gambling especially online e-sabong and POGO," sabi ni Cayetano sa kanyang panayam sa media nitong July 18, 2024.

'That's why, to this date, the city of Taguig did not allow any POGO operations. It's because, now, it's just like legal gaming forms - parating may unintended consequences yan," dagdag niya.

Noong 2022, naghain si Cayetano ng Anti-Online Gambling Act o Senate Bill No. 63 upang ipagbawal ang anumang uri ng pagsusugal sa internet at magpataw ng mga parusa sa online wagering at betting.

Kasama ang panukalang ito sa mga tinalakay ng Senate Committee on Ways and Means sa pagdinig nitong Martes upang mapabuti ang regulasyon ng bansa sa online gambling. Kasabay nito ang panukalang inihain ng Committee Chair na si Senator Sherwin Gatchalian upang gawing ilegal ang operasyon ng POGO sa bansa.

Sa kanyang panayam sa media, idiniin ni Cayetano na malaki ang negatibong epekto ng paglaganap ng POGO sa moral ng mga Pilipino kaysa sa maaaring benepisyo nito sa ekonomiya ng bansa.

"Of course, ang argument pa rin ng PAGCOR (Philippine Amusement and Gaming Corporation) ay y'ung revenues. Hindi natin kinukwenta kung magkano ba ang ginagastos natin sa peace and order. Magkano ba yung nawawala sa scams o panloloko?" aniya.

Binanggit din ni Cayetano na dapat alalahanin ang mga posible pang epekto ng online gambling sa mga Pilipino at sa susunod na henerasyon.

"Ano ba y'ung tinatanim natin sa next generation? Wala pa akong country na nakikita [na tumatangkilik] sa mga online gaming na talagang umunlad," sabi niya.###

## **Cayetano: Emergency Response Department needed amid** growing extreme weather events

enator Alan Peter Cayetano is urging

the government to establish an Emergency Response Department (ERD) as a decisive action to bolster the nation's resilience against the growing threat of extreme weather events due to climate change.

The senator's call comes after typhoon

"We have to seriously consider establishing an Emergency **Response** Department or we'll leave our kababayan defenseless in the face of climate

change," he added. Cayetano also cited other calamities such as the sudden phreatic eruptions occurring from Mayon Volcano since July 18. The volcano remains at Alert level 1.

> WHEREAS, the Office of the Provincial Health Officer shall set the direction, development, SK Provincial Federation implementation and coordination of disaster risk reduction and management in all health programs and activities;

> > WHEREAS, the Office of the Provincial Health Officer, Municipal, Component City Health Offices, Provincial, District, City and Municipal Hospitals have

to adopt an Integrated Disaster Risk Reduction preparedness and response to public health and Management (DRRM), and climate change mitigation and adaptation approach and to develop province-wide health systems (PWHS) with timely, effective, and efficient preparedness and response to public health emergencies and disasters. Moreover, the National Objectives for Health (2017-2022) espouse the development of resilient health systems to manage health risks brought about by natural, biological, technological, and societal hazards;

WHEREAS, to realize these goals, it is vital to institutionalize the Province of Cavite (DRRM-H) at all levels of the health system. To support this, Administrative Order (A.O) No. 2019 - 0046, or "The National Policy of Disaster Risk Reduction and Management in Health" provides strategies for the institutionalization of Disaster Risk Reduction Management and Administrative Order (A.O.) No. 2020-0036 provides guidelines on the institutionalization of Disaster Risk Reduction and Management in Health in the Province-Wide Health System (PWHS);

NOW, THEREFORE, on motion of Hon. Salazar and Hon. Remulla, duly seconded by Hon. Ambion and unanimously approved by the Members present, be it enacted by the Sangguniang Panlalawigan of Cavite in a session duly assembled that:

## **CHAPTER I: TITLE OF THE ORDINANCE**

SECTION 1. Title of the Ordinance - This ordinance shall be known as: "AN ORDINANCE INSTITUTIONALIZING A FUNCTIONAL DISASTER RISK **REDUCTION AND MANAGEMENT IN HEALTH (DRRM-H)** IN PROVINCE-WIDE HEALTH SYSTEMS (PWHS) IN THE **PROVINCE OF CAVITE**"

emergencies and disasters, and other means to ensure delivery of population-based health services.

#### **SECTION 3**. General Objectives. This Ordinance seeks to:

a. Institutionalize a functional DRRM-H system within the Province-Wide Health System (PWHS) to manage and mitigate the constant threat of emergencies and disasters in the Province and their esultant negative health consequences including climate change;

b. Organize and implement a functional DRRM-H procedures and system through technical mechanisms on the DRRM-H core processes: Governance, Service Delivery, Resource Management and Mobilization, and Information and Knowledge Management.

c. Promote the involvement and participation of all sectors and all stakeholders concerned, at all levels, especially the local community, and;

d. Secure sustainable investments in а functional DRRM-H system to improve health and ensure efficient allocation and outcomes equitable use of health resources.

SECTION 4. Scope And Coverage. This Ordinance shall include and cover:

All public and private healthcare facilities, local and international stakeholders/partners within the territorial jurisdiction of the Province of Cavite.

SECTION 5: Definition Of Terms. As used in this Ordinance, the following terms shall mean:

a. Disaster Risk Reduction and Management in Health (DRRM-H) – an integrated, system-based, multi-sectoral process that utilizes policies, plans, and strategies to reduce health programs, risks due to disasters and emergencies, improve preparedness for adverse effects and lessen adverse impacts of hazards to address needs of affected population with emphasis on the vulnerable group. b. DRRM-H Institutionalization – establishment of a functional DRRM-H System, which includes the following minimum key indicators: approved, updated, tested, disseminated DRRM-H Plan with budget allocation, organized and trained Health Emergency Response Teams, available and accessible essential Health Emergency Commodities and Emergency Operations Center, with command and control,

SECTION 2. Declaration of Principles and Policies. It is the policy of the Province to ensure support for the promotion of the health and safety of all Cavitenos. The Province shall adopt the following:

a. Specific, Measurable, Achievable, Relevant, Time-bound, and Evidence-based means to institutionalize and organize a functional DRRM-H system that supports the province-wide health system, that is resilient to emergencies and disasters; and

b. People-centered, equitable, and accessible DRRM-H system able to initially operate and guarantee a timely, effective, and efficient



communication and coordination.

c. Functional DRRM-H System - an operational building activities; system that is a contracting network that manages/ mitigates the adverse effects/impacts and health consequences of emergencies/disasters including climate change in the province-wide health system and is concretized by investment in and conduct of core process namely (1) Governance, (2) Service Deliver, (3) Resources

Management and Mobilization, (4) Information and Knowledge Management to guarantee timely, effective, and efficient preparedness and response to public health emergencies and disasters, and other means to ensure uninterrupted delivery of population-based health services.

## **CHAPTER II. ROLES AND RESPONSIBILITIES**

SECTION 6. **Roles and Responsibilities.** The following shall be the role and responsibilities of implementers and other stakeholders of the DRRM-H system, which would include but not limited to the Health Care Provider Network (HCPN):

a. Provincial Health Board shall exercise their administrative and technical supervision over health facilities and services, health personnel, and all other resources within their territorial jurisdiction;

b. Office of the Provincial Health Officer as the principal implementer of this Ordinance, under the stewardship of the Provincial Health Board shall be responsible for the integration and supervision to organize and manage the institutionalization of DRRM-H in the PWHS, at the same time also represent the health sector in relevant DRRM activities or delegate such function as necessary;

c. Ensure managerial, technical, and financial integration through the City/Municipal Health Officers to enforce the implementation of PWHS

f. Participate in capacity and capability-

g. Promote and advocate DRRM-H through various platforms applicable and accessible;

h. Implement mechanisms to monitor and evaluate initiatives on the program and report progress;

i. Collaborate and build DRRM-H capacities of City/Municipal-Wide Health Systems (C/MWHS) through viable partnerships;

j. Invest and upgrade systems in DRRM-H supported by the Local Investment Planning for Health, Special Health Fund, and the Provincial Health Department fund of the Local Government.

## CHAPTER III. IMPLEMENTING MECHANISMS

SECTION 7. Institutionalizing DRRM-H System in Province-Wide Health Systems (PWHS). The Office of the Provincial Health Officer shall endeavor to integrate all local health systems into PWHS and create appropriate an organizational structure for the operation and staffing of DRRM-H in accordance with the approved standards and guidelines by the Civil Service Commission and as stipulated in the UHC IRR.

## A. Managerial Integration in a Functional DRRM-H System

A.1 Organizational Structure of the DRRM-H unit at the Provincial level.

The Office of the Provincial Health Officer, as approved by the Provincial Health Board, shall determine the establishment and composition of the DRRM-H Planning Committee.

The DRRM-H Planning committee is spearheaded by the Provincial Governor, the Provincial Health Officer as Incident Commander, the Provincial Health Officer I as the Health Emergency

d. Ensure compliance with the latest standards on DRRM-H;

e. Together with the Provincial/City/Municipal Disaster Risk Reduction Management and Office (P/C/MDRRMO), Public Health Units, Epidemiological Surveillance Units, and Health Promotions Units deliver the expected DRRM-H function, essential health services and resources in all phases of emergency/disaster.

• DRRM-H Unit shall effectively and efficiently deliver uninterrupted health services and work jointly with the Local Government Units (LGUs) to include but not limited to local epidemiology surveillance, disease prevention and control, and health promotion to affected

populations at appropriate levels of care of the Health Care Provider Network (HCPN) and/or of the Apex Hospital.

• Guarantee safety in the health facility through A.O.No.2013-0014 "Policies and Guidelines on Hospital Safe from Disaster.

## **B.3. Resource Management and Mobilization**

• Within the effectivity of this ordinance, process algorithms shall be developed and shall be attached as an annex to the Operational Guidelines developed for Service Delivery.

## **B.4.Information and Knowledge Management**

• A functional Public Health Operation Centershall maintainits counter part for effective and efficient command, control, coordination, and communication, establish systems for assessment of gathered data and information, analyze forecast risk trends, bolster early warning systems, monitor response intervention, evaluate results for improvement for future implementation and upgrade and update reporting system on DRRM-H Province-wide health system.

## C. Financial Integration in a Functional DRRM-H System/ Resource Availability

The Provincial Health Board shall implement financial integration subject to National Guidelines following the terms of partnerships in effect for the Province. The funds necessary for the lead and oversee the regular monitoring and evaluation the implementation of of а functional DRRM-H I† system. other may designate relevant office/s or authorized representatives to carry out monitoring activities provided that all data gathered shall be submitted to and consolidated by the PHO for regular reporting to the Provincial Health Board. These data shall also be used to decide on the reporting which frequency of can be periodically modified as necessary based on performance and recommendation. Results available the shall be made to Department of Health its regional and counterparts/ representatives as requested.

## **CHAPTER V. MISCELLANEOUS**

SECTION 9. Implementing Rules and Regulations (IRR). The Provincial Governor may issue appropriate and

relevant rules and regulations, as necessary for the proper implementation of any provisions of this Ordinance.

**SECTION 10. Separability Clause.** If any part or portion of this Ordinance is declared invalid or unconstitutional, other provisions not affected thereby shall remain in full force and effect.

**SECTION 11. Repealing Clause.** All ordinances, resolutions and executive orders inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly.

**SECTION 12. Effectivity.** This Ordinance shall take effect after compliance with publication and posting requirements.

WHEREAS, Section 16 of Republic Act No. 7160 empowered local government units to exercise such powers as may be necessary to promote the general welfare.

WHEREAS, Section 11 (3) (vi) of Republic Act No. 10160 (the "Charter of the City of Bacoor") gave the Sangguniang Panlungsod the power to regulate the operation of tricycles and grant franchises for the operation thereof within the territorial jurisdiction of the City.

WHEREAS, Section 11 (5) (v) of RA 10160 further provides that the Sangguniang Panlungsod has the power to regulate the use of streets, avenues, alleys, sidewalks, bridges, parks and other public places.

WHEREAS, the Bacoor Traffic Management Department reported to the Sangguniang Panlungsod that the number of electric vehicles on the various roads of the City of Bacoor has dramatically increased since the end of the COVID-19 pandemic and new policies must be implemented in order to ensure that the smooth flow of vehicular traffic and the safety of the general public is maintained.

WHEREAS, the City Government supports the Department of Transportation's (DOTr) "Active Transport Program" which aims to expand the protected bicycle lane networks in the country to 2,400 kilometers by 2028.

WHEREAS, a study conducted by the BTMD revealed that none of the electronic bicycles and electronic tricycles now plying the roads of the City are registered with the LTO or with the city government and many of the people driving the same does not have a valid driver's license.

NOW, THEREFORE, this Ordinance is hereby enacted by the 5th Sangguniang Panlungsod of the City of Bacoor, Cavite, to wit:

SECTION 1. Title. This Ordinance shall be known as the "Protected Bicycle Lanes Ordinance of the City of Bacoor".

SECTION 2. Definition of Terms. As used in this Ordinance, the following terms shall be defined as:

1. Protected Bicycle Lane — is a lane on selected public roads within the City of Bacoor that can be exclusively used by bicycles, electronic bicycles, and electronic tricycles segregated from various motorized vehicles by parking barriers, concrete barriers or other physical barriers.

2. Bicycle — a vehicle with a handlebar for steering, two wheels, a saddle seat, and pedals by which it is propelled.

3. Electric Vehicles — are motor vehicles powered by electric motors with power storage charged directly from external sources. The definition includes hybrid vehicles.

4. Electric Mobility Scooter (Electric Kick Scooter) - are two, three or four-wheeled vehicles, with or without operable pedals, powered by electrical energy with less than 300-wattage capable of propelling the unit up to a maximum speed of 12.5 km/hr.

or more persons.

11. Owner of Electric Vehicle — the person who bought the electric vehicle and whose name appears on an official receipt issued by the seller of the said vehicle.

12. Pedicab — two-wheeled bicycle with a sidecab which may or may not be operating as a public utility vehicle used to transport passengers and goods.

13. Personal Mobility Scooter - are self-propelled wheelchairs intended to help the invalid or sick to move around.

14. Public Roads — roads situated in the City of Bacoor that are fully or partly constructed or maintained using public funds.

15. Tricycles — are two-wheeled motorcycles with a sidecab which may or may not be operated as a public utility vehicle used to transport goods or passengers or both.

SECTION 4. Establishment, Construction, and Design of Protected Bicycle Lanes. The City Engineering Office of the City of Bacoor, Cavite is hereby directed to establish and construct protected bicycle lanes on the following public roads within the City of Bacoor:

> 4.1. Aguinaldo Highway 4.2. Bacoor Boulevard 4.3. Molino Road (Zapote -Paliparan Road) 4.4. Tirona Highway 4.5. Evangelista Street 4.6. Bacoor -imus By Pass Road and

4.7. Daang- Hari Road,

The exact length, location, and design of the said bicycle lanes shall be determined by the City Engineer with the approval of the City Mayor

subject to availability of funds and the road conditions where the said protected bicycle lanes are intended to be established. SECTION 5. Exclusive Use and Prohibition. The said protected bicycle

lanes, once constructed and opened to the public, shall be exclusively used by bicycles. All types of motor vehicles including electronic vehicles, tricycles, motorcycles, and hybrid vehicles are prohibited from using the said lanes. For safety reasons, pedestrians and joggers shall only be allowed to cross the said lanes but not to run or jog on them.

The following e-vehicle categories shall only be used on roads situated within residential subdivisions.

a) Category L1 (e-Moped 2w)

b) Category L2 (e-Moped 3w)

c) Category L3 (e-Motorcycle)

d) Category L4 and L5 (e-Tricycle/e-Three Wheeled Vehicle)

- e) Bicycles
- f) Pedicabs

SECTION 5. Penalties. The following penalties shall be imposed against any person who shall violate this Ordinance upon their conviction by a court of law:

5.1. For Operating a Motor Vehicle, Tricycle, Motorcycle, Electronic Vehicle or Hybrid Vehicle on Protected Bicycle Lanes: The driver and/or registered owner of the motor vehicle, tricycle, motorcycle, electric vehicle, or hybrid vehicle shall pay a fine of Php 2,500.00 for operating the same on the protected bicycle lanes as defined in this Ordinance or its implementing rules and regulations.

5.2. For Destroying or Damaging Protected Bicycle Lane Barriers: The person/s who destroy or damage the barriers installed by the government along protected bicycle lanes shall pay a fine of Php 2,500.00.

5.3. For Defecating, Urinating, Spitting, Littering, Loitering, or Impeding Traffic Flow on Protected Bicycle Lanes: Any person who defecates, urinates, spits, litters, or loiters on the protected bicycle lanes or does any act that impedes the flow of traffic on the said lanes shall pay a fine of Php 2,500.00.

SECTION 6. Manner of Implementation; Implementing Rules and Regulations. In the implementation of this Ordinance and in the formulation of its implementing rules and regulations, the BTMD, E-Governance Department, and the City Legal Services Office are hereby directed to comply with the pertinent provisions of City Ordinance No. 228-2022 (the "Uniform Procedure Implementation Procedure Ordinance of Bacoor") and other pertinent city ordinances and laws. The City Legal Services Office is hereby directed to submit the implementing rules and regulations of this Ordinance for the approval of the City Mayor not later than sixty (60) working days from the date of effectivity hereof

5. Category L Electric Vehicle - are motor vehicles with less than four wheels and including 4-wheeled vehicles with restrictions on maximum speed, maximum mass and maximum rated power.

6. Category L1 (e-Moped 2w) - a two-wheeled vehicle, with or without pedals, powered by electrical energy capable of propelling the unit up to a maximum speed of 50 km/hr. For regulation purposes, they are further classified into Category L1a and L1b. E-bikes fall under this category.

7. Category L2 (e-Moped 3w) - a three-wheeled vehicle, with or without pedals, powered by electrical energy capable of propelling the 7 unit up to a maximum speed of 50 km/hr. For regulation purposes, they are further classified into Category L2a and L2b.

8. Category L3 (e-Motorcycle) - a two-wheeled vehicle, powered solely by electrical energy capable of propelling the unit more than 50 km/ hr.

9. Category L4 and L5 (e-Tricycle/e-Three Wheeled Vehicle)— a three-wheeled motor vehicle powered solely by electrical energy with a minimum rated power of 1000 W capable of propelling the unit to no more than 50 km/hr and having a maximum curb weight of 600 kg. It is designed for the carriage of goods, cargoes, freights and passengers. They could be symmetrically or asymmetrically arranged in relation to the longitudinal median plain. Categories L4 and L5 refers to the asymmetrical and symmetrical versions respectively.

SECTION 7. Payment/Use of Fines. All fines imposed in this Ordinance must be paid directly, or through digital means, with the Office of the City Treasurer. The fines collected due to the implementation of this Ordinance shall form part the general funds of the City Government and may be used for the development and maintenance of registration database created by virtue of Section 4 hereof or for any other purpose related to traffic management and the maintenance of peace and order in the City of Bacoor.

SECTION 8. Separability Clause. In case any part of this Ordinance is found to be invalid or unenforceable by a court of law, the remaining parts of this Ordinance will still be valid and enforceable.

SECTION 9. Repeal Clause. All ordinances, resolutions, and executive orders that are inconsistent or are in conflict with the provisions of this Ordinance are hereby repealed or modified accordingly.

SECTION 10. Effectivity. This Ordinance shall become effective immediately after it has been published at least once in a newspaper of general circulation in the Province of Cavite and after a copy hereof has been posted on at least three (3) conspicuous places within the City of Bacoor, Cavite.

WHEREAS, during a meeting between the members of the Sangguniang Panlungsod and the City Mayor, it was disclosed that the Environmental Protection and Sanitation Fees being collected by the City Government at present are not enough to defray the cost of inspecting and regulating various establishments and residences covered by the said fee. Moreover, it was reported by the City Mayor that the cost of hauling the solid waste generated by residents of the City is continuing to rise and will soon be beyond the present financial capabilities of the City Government.

WHEREAS, the City Mayor also reported that the Local Disaster Risk Reduction Management Fund of the City is not enough to finance the various projects that the City Government intends to implement in anticipation of the various challenges that Bacoor will face due to the effects of climate change such as power outages, more severe flooding, water and food shortages, and unusually hot days.

WHEREAS, the Sangguniang Panlungsod has the power to pass ordinances that will promote the general welfare, protect the environment, and make preparations to mitigate the effects of various disasters including the raising of revenues that will make the performance of the said duties possible.

NOW THEREFORE, be it ordained by the 5th Sangguniang Panlungsod that:

Section 1. Imposition of Climate Change Adaptation Fee. The owners of all residential lots and buildings in the City of Bacoor shall be required to pay a Climate Change Adaptation Fee in accordance with the following schedule:

AN ORDINANCE PROHIBITING THE EXECUTION OF DEMOLITION ORDERS WITHOUT PRIOR CONSULTATION AND COORDINATION WITH THE HOUSING, URBAN DEVELOPMENT, AND RESETTLEMENT DEPARTMENT (HUDRD) OF THE CITY OF BACOOR, CAVITE, REQUIRING THE BACOOR CITY POLICE TO STRICTLY IMPLEMENT SECTION 28 OF THE URBAN DEVELOPMENT AND HOUSING ACT OF 1992, AND PROVIDING PENALTIES FOR VIOLATIONS HEREOF.

WHEREAS, Section 10, Article XIII, of the 1987 Constitution provides that "urban or rural poor dwellers shall not be evicted nor their dwellings demolished, except in accordance with law and in a just and humane manner. No resettlement of urban or rural dwellers shall be undertaken without adequate consultation with them and the communities where they are to be relocat-





#### ed."

WHEREAS, Section 28 of Republic Act No. 7279 (the "Urban Development and Housing Act of 1992") provides that:

"SECTION 28. Eviction or demolition as a practice shall be discouraged. Eviction or demolition, however, may be allowed under the following situations:

(a) When persons or entities occupy danger areas such as esteros, railroad tracks, garbage dumps, riverbanks, shorelines, waterways, and other public places such as sidewalks, roads, parks, and playgrounds;

(b) When government infrastructure projects with available funding are about to be implemented; or

(c) When there is a court order for eviction and demolition.

In the execution of eviction or demolition orders involving underprivileged and homeless citizens, the following shall be mandatory:

(1) Notice upon the affected persons or entities at least thirty (30) days prior to the date of eviction or demolition;

(2) Adequate consultations on the matter of resettlement with the duly designated representatives of the families to be resettled and the affected communities in the areas where they are to be relocated;

(3) Presence of local government officials or their representatives during eviction or demolition;

(4) Proper identification of all persons taking part in the demolition;

(5) Execution of eviction or demolition only during regular office hours from Mondays to Fridays and during good weather, unless the affected families consent otherwise;

(6) No use of heavy equipment for demolition except for structures that are permanent and of concrete materials;

(7) Proper uniforms for members of the Philippine National Police who shall occupy the first line of law enforcement and observe proper disturbance control procedures; and

(8) Adequate relocation, whether temporary or permanent: Provided, however, That in cases of eviction and demolition pursuant to a court order involving underprivileged and homeless citizens, relocation shall be undertaken by the local government unit concerned and the National Housing Authority with the assistance of other government agencies within forty-five (45) days from service of notice of final judgment by the court, after which period the said order shall be executed: Provided, further, That should relocation not be possible within the said period, financial assistance in the amount equivalent to the prevailing minimum daily wage multiplied by sixty (60) days shall be extended to the affected families by the local government unit concerned.

This Department of the Interior and Local Government and the Housing and Urban Development Coordinating Council shall jointly promulgate the necessary rules and regulations to carry out the above provision." (Boldfacing supplied)

WHEREAS, Section 29 of RA 7279 further provides that "within two (2) years from the effectivity of this Act, the local government units, in coordination with the National Housing Authority, shall implement the relocation and resettlement of persons living in danger areas such as esteros, railroad tracks, garbage dumps, riverbanks, shorelines, waterways, and in other public places such as sidewalks, roads, parks, and playgrounds. The local government unit, in coordination with the National Housing Authority, shall provide relocation or resettlement sites with basic services and facilities and access to employment and livelihood opportunities sufficient to meet the basic needs of the affected families."

WHEREAS, the Commission on Human Rights issued Advisory CHR (IV) No. A2011-003 on the right to adequate housing and humane treatment of informal settlers, which was supported by the Department of Interior and Local Government (DILG) Memorandum Circular No. 2011-182.

WHEREAS, despite the aforementioned panoply of laws and government regulations on the eviction of informal settler families and the demolition of their dwellings, the Sangguniang Panlungsod learned that a number of private entities have recently conducted illegal demolition activities within the City of Bacoor, Cavite, in violation of the said provisions of law and government regulations.

**WHEREAS**, the City Government believes that the right of every Bacooreño to be treated with respect and dignity — including the poor and dispossessed — should be upheld by all.

**WHEREAS**, by disallowing illegal demolition activities from occurring within its jurisdiction, the City Government will be able to comply with its duty to provide decent housing to informal settler families as provided by law.

NOW THEREFORE, be it ordained by the 5th Sangguniang Panlungsod of

porary removal against the will of individuals, families, and/or communities from the homes and/or land which they occupy without the provision of and access to appropriate forms of legal or other protection.

4.4. Eviction or Demolition Orders are lawful, written directives of a court of competent jurisdiction addressed to various persons in authority to cause the eviction and/or demolition of objects, persons, and/or communities.

#### SECTION 5. Prohibited Act/s. The following acts shall be prohibited:

5.1. Execution of eviction or demolition orders by court employees/ personnel in case of court-assisted eviction or demolition, or by government agencies concerned, or by private individuals concerned in case of extrajudicial eviction or demolition, without notifying the affected persons or entities at least thirty (30) days prior to the date of eviction or demolition as mandated by law or relevant government regulations.

5.2. Execution of eviction or demolition orders without adequate consultations on the matter of resettlement with the duly designated representatives of the families to be resettled and the affected communities in the areas where they are to be relocated.

5.3. Conducting eviction or demolition activities/operation without the presence of officials of the Housing, Urban Development, and Resettlement Department of the City of Bacoor, Cavite or their representatives during the said eviction or demolition. The conduct of eviction or demolition activities shall proceed notwithstanding the absence of representatives from the LGU or HUDRD, provided that such representatives have been duly notified in writing.

5.4. Failure of persons taking part in the demolition or eviction operation/s to wear proper identification during the said activity. "Proper identification" refers to the official identification cards issued by the City Government of Bacoor. Additionally, LGU representatives may wear official city uniforms to facilitate easier identification.

5.5. Execution of eviction or demolition outside the allowable period between 8:00 a.m. and 3:00 p.m. from Mondays to Fridays, during bad weather, or within a few days after a particular community has been victimized by a fire incident or a natural/man-made disaster such as earthquakes, typhoons, or acts of arson.

5.6. Use of heavy equipment for demolition except for structures that are permanent and of concrete materials.

5.7. Failure of members of the Philippine National Police or employees of the city government or the barangays of the City of Bacoor, Cavite to wear proper uniforms while they are participating in court ordered demolition or eviction activities.

5.8. Conducting eviction or demolition activities that are: (a) not sanctioned by a court of law, (b) not involving persons or entities that occupy danger areas such as esteros, railroad tracks, garbage dumps, riverbanks, shorelines, waterways, and other public places such as sidewalks, roads, parks, and playgrounds, or (c) not related to a government infrastructure project with available funding that is about to be implemented; and

5.9. Forced or illegal eviction/demolition.

**SECTION 6. Implementing Body.** This Ordinance shall be implemented jointly by the HUDRD and by the Office of the City Legal Service in coordination with the officials of all barangays within the City of Bacoor, as well as personnel/officers of the Bacoor City Police.

**SECTION 7. Penalties.** A fine of Five Thousand Pesos (Php 5,000.00) and imprisonment of three (3) months but not more than nine (9) months shall be imposed against any person who violates this Ordinance upon conviction by a court of law.

**SECTION 8. Implementing Rules and Regulations.** The HUDRD and the OCLS are directed to submit, for the approval of the City Mayor, the draft of the Implementing Rules and Regulations of this Ordinance not later than sixty (60) working days from the date of effectivity hereof.

**SECTION 9. Repeal.** All ordinances, resolutions, and executive orders that are inconsistent with the provisions hereof are hereby repealed and shall be modified accordingly.

**SECTION 10. Effectivity.** This Ordinance shall take effect immediately after it has been approved by the Sangguniang Panlalawigan and after it has been published at least once in a newspaper of general circulation within the City of Bacoor, Cavite.

2.2. Give informal settler families access to decent housing while assisting landowners in the fruitful use of their real properties.

2.3. Uphold the human rights of the poor; and

2.4. Implement policies that will create an atmosphere of mutual respect and understanding between landowners and informal settler families, promote peace and order, and eradicate long-standing social inequalities related to housing.

**SECTION 3. Coverage.** This Ordinance shall cover all eviction and demolition activities involving underprivileged and homeless citizens or informal settler families residing within the City of Bacoor.

**SECTION 4. Definition of Terms.** As used in this Ordinance, the following terms shall be defined as:

4.1. Demolition is the dismantling of man-made structures.

4.2. Eviction is the removal of persons and their personal belongings from a structure that may or may not be subject to demolition.

4.3. Forced or Illegal Eviction/Demolition is the permanent or tem-


