# Cavite Governor Distributes Incentives to BHWs and BNSs

**T**he Provincial Government of Cavite,

under the leadership of Governor Athena Bryana Tolentino, distributed incentives for Barangay Health Workers (BHWs) and Barangay Nutrition Scholars (BNSs) for the third and fourth quarters of 2024. The ceremonial turnover



of cheques amounting to ₱24,480,000 for BHWs and ₱9,384,000 for BNSs was held on December 4, 2024, at the Tagaytay International Convention Center in Tagaytay City.

Governor Tolentino together with Tagaytay Mayor Bambol Tolentiono personally handed over the cheques to Dr. Nonie John Dalisay, Provincial Health Officer along with some BHW



and BNS. The event was graced by some members of the Sangguniang Panlungsod, who expressed their full support for the health and nutrition initiatives of the province.

In her message, Governor Tolentino emphasized the vital role of BHWs and BNSs in ensuring the well-being of Caviteños, especially in grassroots communities. The distribution of

incentives marks the provincial government's continued commitment to recognizing and supporting the invaluable contributions of community health and nutrition workers.

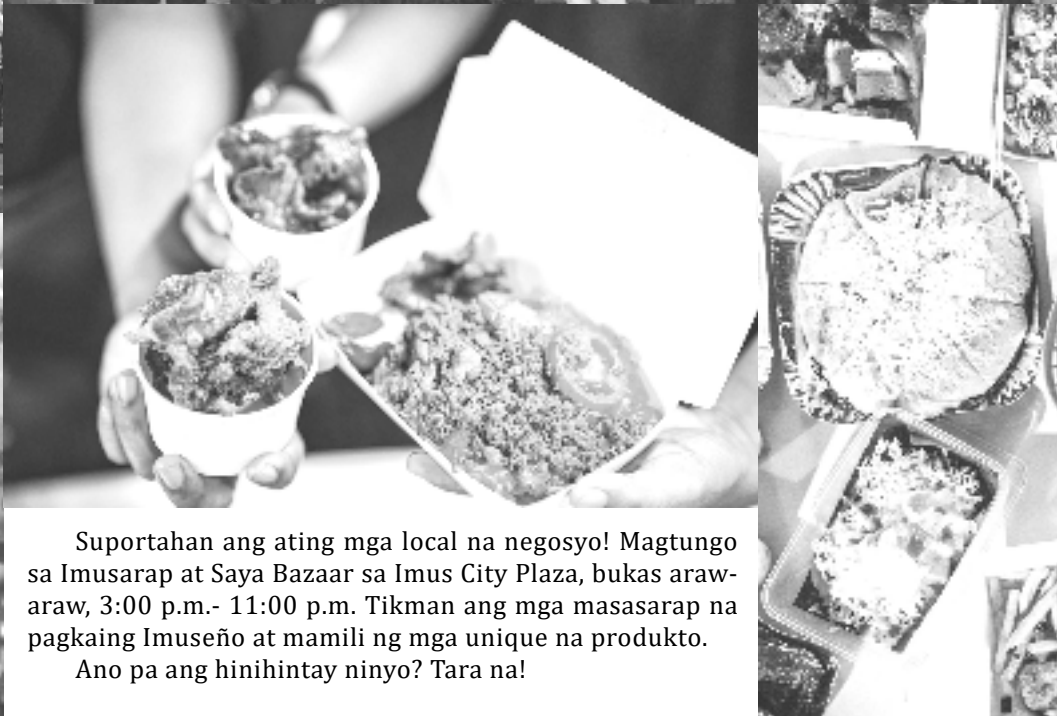
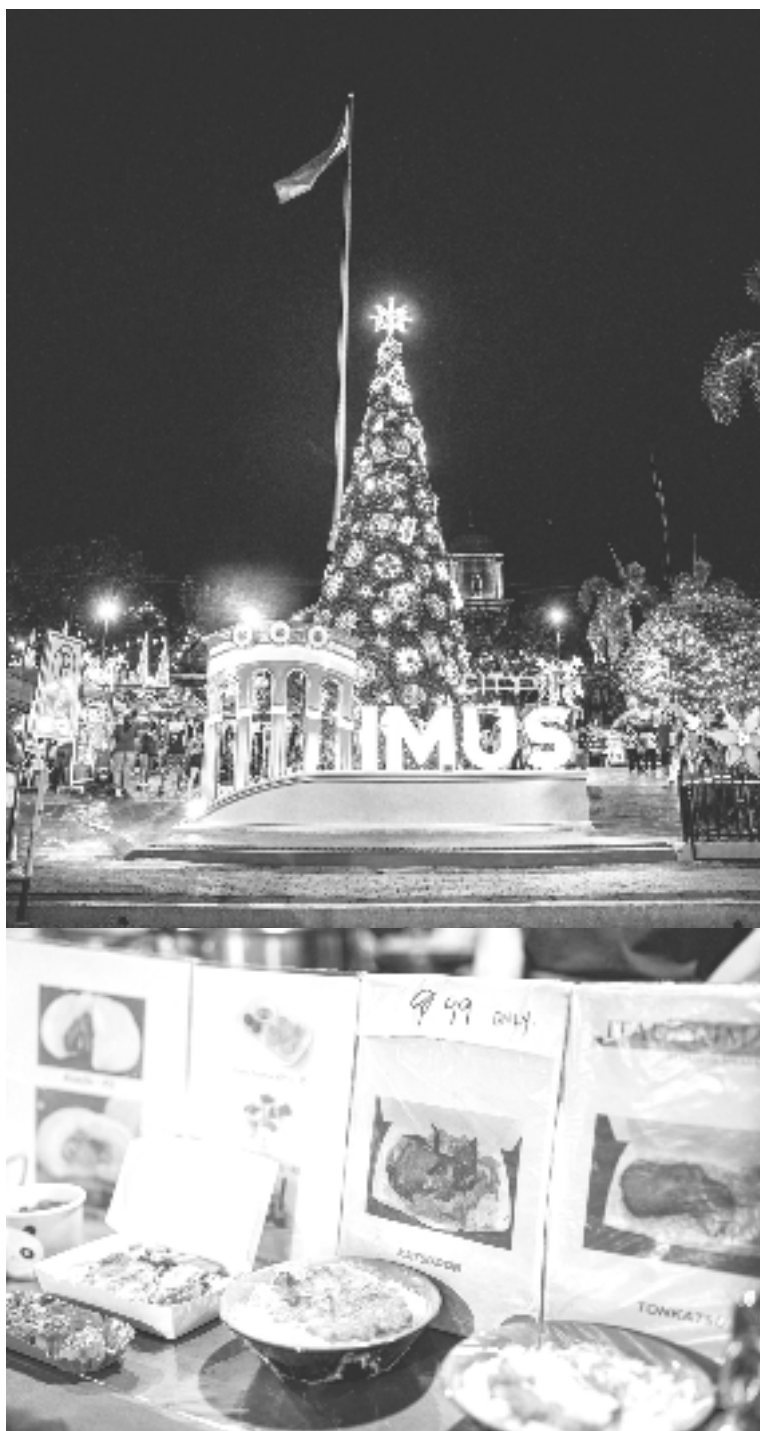

# Search for the next CCC President

The CCC Board of Trustees through BOT Resolution No. 64 S. 2024 formally and publicly announces that the SEARCH FOR PRESIDENT is now OPEN.

## Minimum Qualifications

The minimum qualifications of any applicant for the CCC Presidency shall be:

- Not less than thirty-five (35) years old and not a day older than the sixtyfirst (61st) birthday at the time of application;
- A Filipino citizen;
- Holder of an earned doctorate degree that is defined as level 8 in the PQF under RA No. 10968, awarded by a CHED-recognized HEI or foreign institution accredited by its higher education ministry/commission or appropriate regulatory body;
- With proven track record as HEI administrator (e.g., president, vice president, dean, campus administrator, director) or high-level management executive / administrator, whether in the public or private sector, for at least five (5) years; Nomenclature of the position is high level management; and,
- Must not have been convicted for a crime involving moral turpitude, or an offense punishable by imprisonment for a period exceeding six (6) years, or suspended administratively for twelve (12) months, or dismissed from the service. The BOT may set additional minimum qualifications it deems fit.



## Documentary Requirements for CCC Presidential Applicants

Interested applicant must submit one (1) set of original and six (6) certified photocopies of the following documents to the SCP Secretariat (Calamba City Human Resource Management Office, 2nd Floor, Left Wing, New City Hall Complex, Chipeco Ave. Barangay Real, Calamba City, Laguna, 4027):

- Formal application letter addressed to:

City Mayor and Chairman of the Board of Trustees  
Calamba City, Laguna
- Detailed curriculum vitae, attested and signed by the applicant;
- Transcript of records, training certifications, professional accreditations, diplomas, and employment / service records;
- Published research work, if any;
- Signed and notarized statement containing the Proposed Vision, Mission and Development Goals for the LUC by the applicant;
- Certificates/clearances from the following government agencies, obtained not more than three (3) months from the filing date of the application indicating that the applicant has not been found guilty in any administrative and/or criminal case:
  - National Bureau of Investigation (NBI)  
Sandiganbayan
  - Civil Service Commission (CSC)
  - Office of the City/Provincial/Regional Prosecutor
  - Ombudsman (for government employees)
  - Institution/Company where the applicant is presently employed

- In case of delay in the issuance of the agency/office concerned due to pandemic or fortuitous events, proof of payment of application fee may be used in the application subject to submission of the Certificates/Clearances at the time of the pre-evaluation process by the SCP. The deadline of which can be set by the Search Committee.
- Birth certificate authenticated by the Philippine Statistics Authority;
- Medical certificate of physical fitness issued by a physician from a government health institution not in



- any way connected with the applicant or the LUC applied for;
- Drug testing certificate pursuant to the CSC memorandum Circular No. 13, s. 2017;
- Neuro-psychiatric examination result obtained from a government health institution. In the case there is none, the neuro-psychiatric examination result shall be obtained from a DOH-accredited institution not connected with the applicant;
- Notarized Statement of Assets, Liabilities, and Net Worth (SALN);
- Duly accomplished, computerized, and notarized Personal Data Sheet (CSC Form 12); and
- Other documents that may be required by the Board of Trustees.

- The documentary requirements shall be submitted on or before the deadline specified in the published notice of search and call for application.
- 
- An applicant who does not meet any of the above minimum qualifications and fails to submit any of the documentary requirements shall automatically be disqualified from the search process.

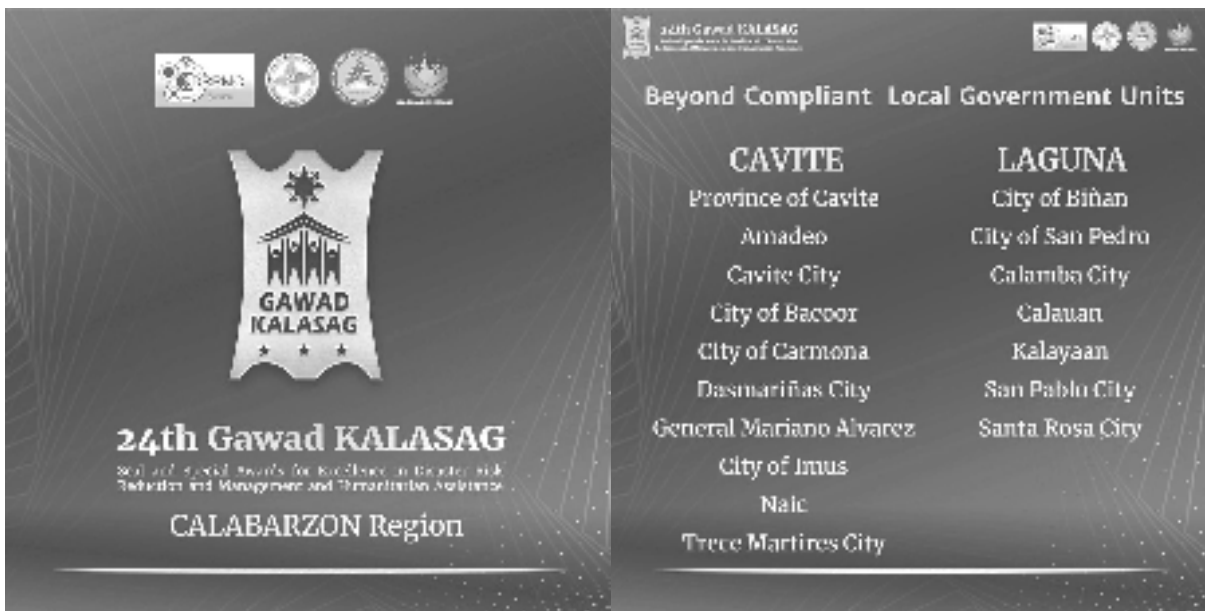

## NPA terrorist dies in Batangas encounter

CAMP CAPINPIN, Rizal - One terrorist NPA dies following an encounter between the Army's 2nd Infantry Division (2ID) and the armed group in Lobo, Batangas, Wednesday, December 4, 2024.

Per reports from the 202nd Infantry Brigade, troops belonging to the 59th Infantry Battalion were conducting routine security operations at Barangay Balibago when the rebels fired upon them.

It resulted in a 20-minute firefight before the terrorists fled the site.

An NPA terrorist identified as Rey Delos Santos alias Japeth, Roy, and Ren died during the encounter, while one soldier sustained

minor injury.

A former rebel who is already helping the government in its peace campaign disclosed that the death of Delos Santos is another reduction to the already skeletal strength of the terrorists operating in Batangas.

The troops also recovered two high-powered firearms, two anti-personnel mines, and a magazine at the encounter site.

"While the soldiers do not rejoice in the deaths of our fellow Filipinos, we have a solemn duty to uphold peace, protect our people, and enforce the rule of law," said Maj. Gen. Cerilo Balaoro Jr in a statement.

Balaoro reiterated his call to the remnants of the NPA terrorists to lay down their arms and return to the folds of the law where they can avail the programs of the Enhanced Comprehensive Local Integration Program (E-CLIP), so they could start anew and contribute to the peaceful development of our nation.

"With the help of our people, our line agencies, and various stakeholders, we will not rest on our laurels until our people and our community are free from the turmoils brought about by the terrorist NPA in Southern Tagalog and its neighboring regions," concludes Balaoro.

## Police intensifies campaign against Illegal Gambling in Calabarzon

"This conference reaffirms our commitment to maintaining a peaceful and orderly election," said Malinao. "By identifying and addressing potential

threats early, we aim to create a safe environment where voters can exercise their democratic rights without fear."

The BPPO also emphasized the importance of collaboration with local government units, community leaders, and other stakeholders in implementing comprehensive election security measures.

As preparations for the 2025 elections intensify, the Batangas PPO remains steadfast in its mission to uphold law and order, reinforcing its role as a pillar of public safety and trust in the region.

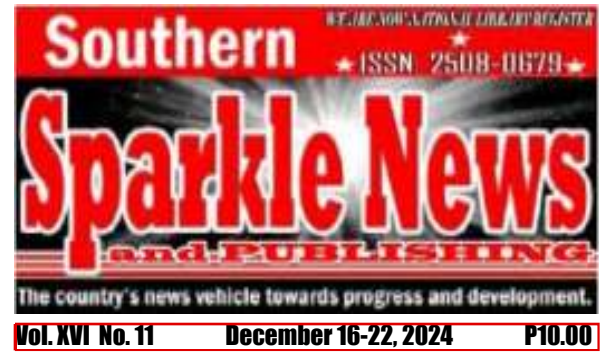
