PROVINCIAL ORDINANCE NO. 472-2025

AN ORDINANCE STRONGLY PROMOTING PARALYMPIC AS RECREATIONAL WELLNESS PROGRAM IN THE PROVINCE OF CAVITE AND PROVIDING FUNDS THEREOF

WHEREAS, it is the policy of the State to promote a more inclusive society, give its full support in fostering the well-being of persons with disabilities and institute efforts necessary to uphold their integration into mainstream of the society;

WHEREAS, Article II Section 13 of the 1987 Philippine Constitution recognizes the vital role of the youth in nation-building and shall promote and protect their physical, moral, spiritual, intellectual, and social well-being. It shall inculcate in the youth patriotism and

nationalism, and encourage their involvement in public and civic affairs;

WHEREAS, Article XIV Section 19 of the same Constitution states that it shall promote physical education and encourage sports programs, league competitions, and amateur sports, including training for international competitions, to foster self-discipline, teamwork, and excellence for the development of a healthy and alert citizenry;

WHEREAS, Republic Act No. 7277, otherwise known as the "Magna Carta for Disabled Persons", provides that disabled persons have the same rights as other people to take their proper place in society;

WHEREAS, Section 468 (a)(5)(vi) of Republic Act No. 7160, also known as the "Local Government Code of 1991", provides that the Sangguniang Panlalawigan, as the legislative body of province, shall enact ordinances that will provide for the care of paupers, the aged, the sick, persons of unsound mind, abandoned minors, abused children, disabled persons, juvenile delinquents, drug dependents, and other needy and disadvantaged persons, particularly children and youth below eighteen (18) years of age; subject to availability of funds, establish and support the operation of centers and facilities for said needy and disadvantaged persons; and facilitate efforts to promote the welfare of families below the poverty threshold, the disadvantaged, and the exploited which shall ensure the efficient and effective delivery of the basic services and facilities as provided for Under Section 17 of this Code;

WHEREAS, Section 16 of the same Code states that every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

- over -

WHEREAS, pursuant to CALABARZON Regional Committee on Disability Affairs (RCDA) Resolution No.05 Series CY 2024, A Resolution Urging Local Government Units of CALABARZON to Develop an Inclusive Sports Program Mainstreaming Disability In Sports Activities Including Persons With Disabilities, And To Organize A Sports Activities Including Sports Club;

NOW, THEREFORE, on motion of Hon. Bencito, Hon. Enriquez and Hon. Belamide duly seconded by Hon. Sison and unanimously approved by the Members present, be it enacted by the Sangguniang Panlalawigan of Cavite in a session duly assembled that:

SECTION 1. SHORT TITLE. This Ordinance shall be known and cited as the "**CAVITE PARALYMPIC ORDINANCE**".

SECTION 2. DECLARATION POLICY. It is hereby declared the policy of the Provincial Government of Cavite to strongly encourage LGUs, Public and Private Institutions including NGOs to promote sports activities for the person with disabilities including children with special needs in participating to Annual Paralympics or Paragames to ensure the rehabilitation, self-development, self-reliance and their integration into the mainstream of society.

SECTION 3. DEFINITION OF TERMS. For the purpose of this Ordinance, the following terms shall mean:

1.Paralympic Games – also known as the Games of the Paralympiad, is a periodic series of international multisport events involving athletes with a range of disabilities.

2.Persons With Disability – are those suffering from restriction of different abilities, as a result of a mental, physical or sensory impairment, to perform an activity in the manner or within the range considered normal for a human being.

3.Disability - shall mean (1) a physical or mental impairment that substantially limits one or more psychological, physiological or anatomical function of an individual or activities of such individual; (2) a

record of such an impairment; or (3) being regarded as having such an impairment.

SECTION 4. COVERAGE. This Ordinance shall apply to all Persons with Disability athletes with eligible impairment on physical, visual and intellectual who are bonafide residents of the Province of Cavite.

SECTION 5. IMPLEMENTING AGENCY. The Office of the Provincial Persons with Disability Affairs Officer (OPPDO) is hereby designated to formulate plans and activities in coordination with the Office of the Provincial Social Welfare and Development Officer (OPSWDO), Office of the Provincial Youth Development Officer (OPYDO) and Office of the Provincial Health Officer (OPHO). The Department of Education (DepEd), Commission on Higher Education (CHED), Non-Government Organizations (NGOs), and the Local Government Units (LGUs), thru the Federation of the Sangguniang Kabataan (SK) in the Province of Cavite, are hereby enjoined to be involved to be able to reach the grass roots and carry out the purposes of this Ordinance.

SECTION 6. ACTIVITIES. Related activities shall be promoted to embolden the participation of Persons with Disabilities in sports and recreational activities in the Province of Cavite, these may include the following but not limited to:

1.Paralympic Festival, such as:

- a.Swimming intellectual disability (boys and girls);
- b.Swimming orthopedically handicap (boys and girls);
- c.Relay (visually impaired boys and girls);
- d.Athletics intellectual disability 15 years old and below (boys and girls);
- e.Athletics intellectual disability 16 years old and above (boys and girls);
- f.Bocce for intellectual disability (2 boys and 2 girls);
- g.Goalball for visually impaired (2 boys and 2 girls);
- h.Chess (boys and girls)
- i.Para Tenpin bowling (boys and girls)
- j.Long jump (boys and girls)

2.Free Medical Fitness Services;

3.Awareness campaign (inclusivity of Persons with Disabilities in sports).

SECTION 7. CREATION OF PROVINCIAL TECHNICAL WORKING GROUP (PTWG). The Provincial Government of Cavite thru the OPPDAO shall create the Technical Working Group for the implementation of this Ordinance.

a.Composition of PTWG. The PTWG shall be composed of the following:

Chair:	Provincial Governor
Vice Chair:	President, Federation of Sangguniang Kabataan/ Chair, Committee on Sports and Youth Development
Secretariat:	Head, Office of the Provincial Persons with Disability Affairs Officer Head, Office of the Provincial Youth Development Officer
Members:	Chair, Committee on Social Services, Family, Women, Children and Elderly;
	Chair, Committee on Finance,Budget, and Appropriations
	Chair, Committee on Human Rights
	Head, Office of the Provincial Social Welfare and Development
Officer;	President, Federation of Persons with Disability Cavite, Inc. Officer
	Representative, Department of Education (DepEd)

Representative, Commission on Higher Education (CHED)

b. Duties and responsibilities of PTWG – The PTWG shall perform the following duties and responsibilities:

1.Formulates, plans and organizes programs of activities for the Paralympics.

2.Coordinates and collaborates with LGUs and different institutions for the conduct and supervision of this activity.

SECTION 8. FUNDING. It shall be funded and appropriated annually in the Office of the Provincial Persons with Disability Affairs Officer (OPPDO) of the Provincial Government of Cavite.

SECTION 9. SEPARABILITY CLAUSE. If any part or portion of this ordinance is declared invalid or unconstitutional, other provisions not affected thereby shall remain in full force and effect.

or, through the Office of the Senior Citizens Affairs (OSCA) and in partnership with the National Commission of Senior Citizens (NCSC), distributed cash gifts to 141 senior citizen beneficiaries today. The event, held at the Revilla Hall, marked the second batch of cash gift distribution under the Expanded Centenarian Act, also known as the "Revilla Law."

Mayor Strike B. Revilla, along with Atty. Venus De Castro, OSCA Head, and representatives from the NCSC Cluster 3, Regional Office 4A, led the distribution. The law provides a P10,000 cash gift to senior citizens who reach the ages of 80, 85, 90, and 95, in addition to the P100,000 given to centenarians. This law was authored and enacted with the support of Senator Ramon "Bong" Revilla Jr. Mayor Strike B. Revilla emphasized the City Government's commitment to the welfare of senior citizens, highlighting the establishment of a Senior Citizens Home in 2023. The home provides free care, meals, and check-ups for senior citizens who are without family support. "If you have no one to care for you, the City Government of Bacoor will be there for you," Mayor Strike stated. The distribution of cash gifts under the "Revilla Law" is a testament to the City Government's dedication to ensuring the well-being of its senior citizens. City Government of Bacoor
